## Additional Information

Jesse H Arnold enlisted on 1 November 1862 at Fayette, Missouri as a Sergeant in Co D, 2<sup>nd</sup> Battalion Enrolled Missouri Militia and was order into active service on 1 November 1862.

*Enrolled Missouri Militia (EMM) were formed under orders from the Union command in Missouri. EMM required all fighting age males to enroll in the militia unless they made a statement of secessionist sympathies to the Provost Marshal.*

Jesse H Arnold's father, John, was a veteran of the War of 1812. He enlisted 27 August 1814 as a Private in Captain Cooper's Company, Missouri Militia. He was discharged 25 October 1814.

Jesse H Arnold was president of the Orange Public Library in 1890. He was also the vice-president of the Bank of Orange and is credited for establishing the Orange County College.
