- Enlisted as a Private in Company E, 2nd Cavalry Regiment Kansas on 14 Sep 1861. Promoted to Full Quartermaster (Regimental) on 15 Feb 1862.
- Enlisted as a 1st Lieutenant in Co H, 2nd Infantry Regiment Arkansas.
   Promoted to Full Captain on 29 Jun 1864.
   Mustered Out Co H, 2nd Infantry Regiment Arkansas on 8 Aug 1865.
- 9<sup>th</sup> Kansas and 12<sup>th</sup> Kansas Infantry appear to have been Militia Units in 1864 called into brief service repel Price's Invasion.
- Served as Sheriff in White Oak Township, Franklin County, Arkansas after the Civil War
- Charles Berry's father fought with the Indiana Militia during the war of 1812
