Howland's Company or the Battle Creek Engineers Corps

Company was organized at Battle Creek, Michigan on September 16, 1861 and mustered into Federal service on October 9, 1861. Major General H. W. Halleck when in charge of the Department of Missouri decided that the Company did not meet Federal organizational standards and was disbanded and mustered out January 8, 1862.

Mustered out on 8 January 1862 at Saint Louis. Enlisted in Co A, Michigan 7th Cavalry Regiment on 13 October 1862. Promoted to Full 1st Sergeant on 01 January 1864. Promoted to Full 2nd Lieutenant on 24 May 1865. Mustered out on 16 August 1865 at Fort Leavenworth, Kansas
