Plummer Magoon, 32, born in Canada and residing in Girard, Macoupin County, Illinois joined in Co H, 122nd Illinois US Infantry 10 August 1862 for a period of 3 years. Married and working as a carpenter he mustered in 4 September 1862 at Carlinville, Macoupin County, Illinois and mustered out 15 July 186 at Mobile, Mobile County, Alabama.
