Jasper N. Markle enlisted on 14 August 1861 at Camp Chase in Columbus, Ohio, and mustered out on 29 August 1864 near Atlanta, Georgia.

Jasper N. Markle had two brothers that served during the Civil War.

- Samuel Johnston Markle, served in Company B of the 30th Ohio Infantry Regiment.
- Abraham B. Markle served in the 129th Illinois Infantry Regiment, and is also buried in Orange County.

Dr. J N Markle came to Long Point, Livingston County, Illinois in 1873 and operated the first drug store in connection with his practice.
