Philip Spencer, age 15, enlisted on 15 March 1865 at Wheeling, West Virginia, mustered out 30 June 1865 at Wheeling, West Virginia. He served under General George Custer and participated in the Battles of Droop Mountain and Cedar Creek. He was in the home guard prior to the war.

Philip Spencer was an accomplished violinist playing an instrument that was purported to have been constructed in 1770. He continued to entertain friends with old time songs even after becoming blind.
