Additional Information

Enlisted in Tarrant County Mounted Rifleman 17 June 1861. Service was generally for 12 months in Texas State Troopers Units. Enlisted in Co H, 2nd Cavalry on 11 August 1863, in Tarrant County, Texas, for a period of 6 months and served until 31 December 1863.

In the three censuses, Thomas Sprouse gives his birth state as South Carolina. In the Guinn book and in the cemetery records, his birth state is given as Mississippi. He is found in the 1839 tax list of Neshoba County, Mississippi, and then in the 1847 tax list of Crawford County,

Arkansas. The Sprouse family in Mississippi seems to be connected to Vinson Sprouse in South Carolina, so Thomas would probably be a part of this family, but his parents have not been identified. The conflicting reports about state of birth may suggest that he was born in South Carolina but grew up in Mississippi.

Thomas' daughter, Margaret Mahala, married Robert Lee Shaw who is the brother of James Franklin Shaw, a veteran of the Confederate Army who is buried in Orange County, California.

Frank Shaw, son of Margaret Mahala Sprouse and Robert Lee Shaw, married Eizabeth Alsbach who is the niece of Henry Oscar Alsbach, a veteran of the Union Army who is buried in Orange County, California.
