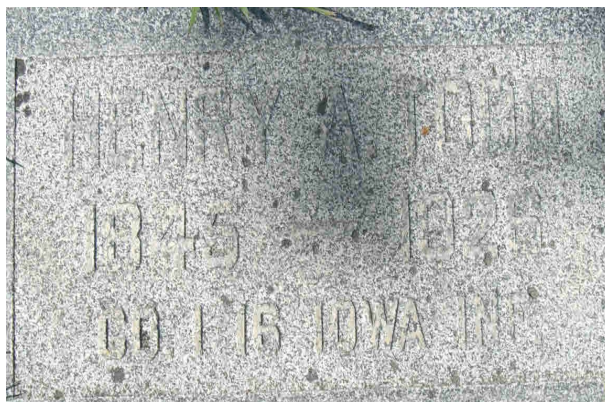

Henry Todd enlisted in Company B 38<sup>th</sup> Iowa Infantry 5 May 1863 at Sigourney, Keokuk County, Iowa, mustered out 10 June 1863 at Davenport, Scott County, Iowa. He enlisted 2 November 1864 and mustered in 28 November 1864 with 16<sup>th</sup> Iowa Infantry at Grinnell, Poweshiek County, Iowa. He mustered out 19 July 1865 at Louisville, Jefferson County, Kentucky
