Additional Information

Daniel W Bolles enlisted as a Private with Co E, 51st Illinois Infantry on 27 February 1864 at Middleford, Vermillion County, Illinois for a period of three years. He mustered out 31 March 1864 at Chicago, Illinois.

Mary Smith, Daniel Bolles mother, married Henry Bolles in Carroll County, Indiana, 14 June 1845. Henry Bolles died in 1849. Daniel and his mother are found living in a boarding house in Irvin, Howard County, Illinois in 1850 and appear in the census with the last name of 'Bowls'. By 1860 they have moved to Vermillion County, Illinois where Mary Bolles marries William White.

Daniel enlists in the Civil War from Vermillion County. In 1870 Daniel marries Hester Farnsworth and they continue to reside in Vermillion County. They have one child, Lillian. In 1878 Daniel marries Mary M Hammer and are living in Parke County, Indiana in 1880. They have three children, Thomas, Stella and Fred. By 1892 he has married Mathilda Myrtle Hatfield.

In 1931 Daniel and Myrtle travel to Orange County to visit his daughter Lillian Bolles Short. Daniel dies in Orange County January 1932. After his death his wife Myrtle returns to Indiana. In California in February 1932, Myrtle applies for and receives Daniel Bolles Civil War pension.

Daniel W Bolles was a member of GAR, Altoona Post No 407, Waterman, Indiana
