Enlisted 1 August 1861 at Coulterville, Illinois, mustered in 10 August 1861 in Company F, assigned to recruiting duty 25 October 1862 in Missouri. Commissioned as 1st Lieutenant 12 October 1863. Mustered in Company K 20 October 1863 at Bridgeport, Alabama, wounded slightly in the arm at Missionary Ridge, Tennessee 25 November 1863, assigned to command Company C 1 March 1864. Mustered out 23 May 1864 at Resaca, Georgia, promoted to Captain 12 May 1864, mustered in Company C 24 May 1864, mustered out 24 August 1864.

David's brother Thomas served during the Civil War with Co F, 10th Missouri Volunteer Infantry. He died of typhoid fever 3 months after mustering in.
