Judson A Stevens, a resident of Genoa, Dekalb County, Illinois enlisted as a Private on 11 September 1861. He mustered into Co L, Illinois 8th Cavalry on 18 September 1861 at St. Charles, DuPage County, Illinois. He was promoted to 2nd Lieutenant 28 April 1863 and to 1st Lieutenant on 2 November 1863. He mustered out 18 September 1864.
