Additional Information

Abraham H Stutsman, a resident of Denmark, Lee County, Iowa, enlisted as a Private on 13 July 1861. He was mustered into Co C, Iowa 1st Cavalry on the same day. He was discharged for wounds on 19 January 1864 at Davenport, Scott County, Iowa.

He was wounded on 25 March 1862 in St Clair County, Missouri and at Bayou Meto, Arkansas on 27 August 1863. He received a severe wound to the left arm which had to be amputated.

After the Civil War he was judge of the First Judicial District Court in Iowa. For many years he was the city solicitor of Burlington, Iowa

Member of GAR, Sedgwick Post No 17, Orange County, California

Stutsman had been a resident of Orange County for over 30 years.
