PORTRAYAL OF CHRISTIAN ARMS



The COAT OF ARMS of the Isle of Man Christians with the family motto is as follows:

ARMS: Azure—a chevron humettée between three covered cups. or.

CREST: A unicorn's head erased, argent, armed and gorged with a collar invected, or.

MOTTO: Salus per Christum.

RECOGNITION OF ARMS

Whether portrayed in color (as on page 3 in Volume No. 1 of CHRISTIAN FAMILY CHRONICLES) or in black and white (as on the cover and facing page of this volume), the Christian family coats of arms utilize symbols which make the reproductions easily recognized and understood by viewers acquainted with heraldic pictorial representations.

ARMORIAL REPRESENTATIONS

The tinctures or colors given to escutcheons and their bearings are denoted in engravings and other black and white renditions by various lines or dots, a system invented by an Italian in the early seventeenth century. Using this standardized method, the Christian shield and crest would be rendered thus:

Azure (blue) for the field or ground—represented by lines drawn from the dexter to the sinister side of the shield, parallel to the chief.

Or (gold or yellow) for the charges, which consist of chevron and three covered cups, and for the unicorn's collar, horn, and hooves—expressed by dots.

Argent (silver or white) for the unicorn's head-left quite plain.

RIGHT TO BEAR ARMS

The Christian family arms, like other paternal arms, are hereditary and as such belong only to members of that family. Although all members of the same family rightfully claim the same bearings in their coat of arms, distinguishing signs called "differences" can be employed to denote the degree of consanguinity or the order of birth. Formerly, borders sometimes denoted different branches of a family. At present, heralds in England generally use the following:

Daughters may bear the arms of the father, as the eldest son does after the father's decease; but differences are not added to the females' coats of arms.

The right to bear the arms is strictly governed in nations where authority has been established to regulate the wearing of arms and to preserve a record of the rights of families to the same. In republics like the United States, however, there is no supervision in matters pertaining to heraldry.

--NOTES--

So often, the search for information about a common ancestor is undertaken independently by descendants unaware of the other researchers' endeavors. Such was the case for three descendants of David and Abigail (White) Christian of Lawrence County, Ohio, until their subscriptions to Christian Family Chronicles and subsequent correspondence with the editor brought them together.

Less than six months ago, little more was known beyond their direct lines "to David and Abigail Christian" and about more recent kin. (Each is descended from a different child of the couple.) At that time each submitted a query in the attempt to learn the identity of David's parents. Through the intensive and cooperative efforts of all involved, that problem was solved before the queries ever had a chance to appear. Result: Queries changed to those in this issue, #79-40, #79-41, #79-42.

Coincidentally, when it was discovered through a 1905 newspaper account that David's parents were John and Johanna (Farley) Christian, the editor was able to add several generations to their Farley lineage from Farley Facts and Fancies, a quarterly to which she had subscribed in the attempt to determine the early Farley connections to the Christians of Virginia.



- Chappelear, George Warren. Leake Family and Connecting Lines. Dayton, Virginia.
 ----. Date and nature of Christian family contents not available to
 editor.
- Grabowskii, Bessie Berry. *The DuVal Family of Virginia*. Richmond, Virginia. 1931. Traces descent of some lines from Henry and Martha (Patterson) Christian of Amherst County, Virginia.

The author, father of Charlou Koenig and his siblings, attempts to trace all descendants of all their ancestors—especially strong in line of Thomas Christian of the 1687 Charles City

- 1) Lucy Christian and 2) Sally Ridgway. At the time of his death, William Bradley's wife was Elizabeth (?Christian?). who may have been his second or third wife. Elizabeth died after March 1819. probably in Elbert County, Georgia.
- 79-56 Mr. Ted O. Brooke 79 Wagonwheel Court. N.E., Marietta, Georgia 30067:

Need any information about Drury Christian, who left his will in 1783 in Amherst County, Virginia, naming "beloved companion, Elizabeth Upshaw; brother, John Christian; my four children. John Christian Upshaw, Elizabeth Christian Upshaw, Lucy Christian Upshaw, and Sally Christian Upshaw."

- 1. Elizabeth married Henry Moorman in 1788 in Amherst County, Virginia, using the name "Elizabeth Upshaw." with consent given by "her mother Elizabeth Upshaw."
- Sally Christian married Pleasant Dawson in 1791 in Amherst County, Virginia.
- John Christian married Elizabeth (maiden name unknown). John died about 1813 in Amherst County and his widow Elizabeth married in 1816 John Dillard, who had been the guardian of the orphans of Drury Christian.
- 4. Lucy Christian was apparently dead by about 1810. Note that these children used the name "Christian rather than "Upshaw" with the single exception of the marriage of Elizabeth to Henry Moorman.
- 79-57 Mrs. S. P. Cammack 350 East Rustic Road, Santa Monica, California 90402:

With the possibility of having multiple Christian ancestors (but as yet with no proof of any), I am especially interested in the Christian, Bradley, and Oglesby ties of Virginia and Georgia. Three major connections pose questions:

Was the wife of the William Bradley (born 1740-died 1805) Elizabeth Christian? Was that, in fact, his birth date? Had he been married before? Was he the brother or nephew of the Lucy Bradley who married Robert Christian of the Albemarle County, Virginia, will proved in May 1749?

Exactly what was the relationship of Garrett Oglesby to his wife? Garrett reputedly married "his cousin" Ruth Bradley about 1804 in Elbert County, Georgia. Was her maiden name Bradley, and was she the daughter of Drury and his first wife Lucy (Christian) Bradley?

What was the maiden name of Mary, whose husband Robert Christian (will proved 1791 in Amherst County, Virginia) was the son of Robert and Lucy (Bradley) Christian? Does anyone have a clue to her identity?

PAREN CHRISTIAN'S LEGACY

As Paren Christian was loved in life, he was honored in death. His legacy extended beyond the money and lands distributed to his children—beyond the coveted clock and other keepsakes bequeathed to them. He left heirs who through love of God and love of their fellowman demonstrated belief in the motto emblazoned on the family coat of arms: Salus per Christum.

Christian was not just a name for the children of Paren and Isabel J. (Mitchell) Christian. It symbolized a way of life. Except for their first-born, who lived little more than a year, their offspring married and had children of their own to whom they "showed the way."

Emizella Frances Christian, born 10 June 1855; died 16 September 1856, both in Logan County.

Zerilda Caroline Christian, called Caroline, born 27 January 1857, died 17 August 1917 in Cabell County, West Virginia; married 4 September 1873 in Logan County Oscar Fenton "Fent" Ferrell.

James Jordan Christian, known as Jordan, born 22 August 1859, died 26
November 1941 in Cabell County; married 1) in Wyoming County,
West Virginia 12 December 1883 Alice Virginia "Ally" McClure;
married 2) about 1914 in Ironton, Ohio, Lillie May Smoot, widow
of Charles Reynolds.

Paren Bilton Christian, called Bilton, born 23 March 1862, died 17 January 1928, both in Logan County; married 12 April 1888 in Wyoming County, Rebecca Varina Godfrey.



- Rebecca Ann "Becky" Christian, born 8 July 1868 in Logan County, died 1 February 1946 in Cabell County; married in Logan County 17 July 1884 William Altizer.
- Cora Isabel Christian, born 3 June 1871, killed 3 July 1916 in Cabell County when a runaway horse overturned the carriage in which she was riding; married 30 December 1886 Emory Altizer, brother of William.
- Mary Spicie Emaline Christian, known as Spicie, born 1 October 1874 in Logan County, died 26 June 1969 in Beckley, Raleigh County, West Virginia; married in Logan County 8 April 1896 William Austin Stanley.
- George Thomas Christian, born 6 December 1876 in Logan County, died 10 April 1908 in Longmont, Boulder County, Colorado; married in Kentuck, Jackson County, West Virginia, 1 May 1901 Martha Ann Duff.

Regardless of the means chosen for earning their daily bread, this generation of Christians retained a love for the land and espoused the faith of their fathers. Albert is still remembered thirty years after his death for his revival-meeting appearances. When the needs of his family did not demand attention to farming, he devoted his energy to preaching the Gospel throughout the southern counties of the state. This devout man was not beyond indulging in puns on the family name, however. When asked, "How long have you been a Christian?" his tongue-in-cheek, "Every minute of my life," on more than one occasion brought the quick and ready response, "God bless you, brother."

Once asked his name at a prayer meeting in Beckley, he replied, "Christian!" Where he was born, "Christian!" Where he lived, "Christian!" At times there seemed to be nothing to which Albert could not truthfully answer, "Christian!"

Jordan also grew up in the little town which bears the family name; and he, too, gave overt witness to the Lord. He was always ready when called on for prayer and never hesitated to respond to his minister's teaching with a fervent and audible "Amen."

While maintaining an ever-constant faith, the Christian brothers encountered numerous changes in day-to-day living. Bilton, particularly, entered fields which paralleled the development of the area

-from farming to lumbering to railroading. Not one, though, turned to coal mining. Bilton's wife, Varina, who died on St. Valentine's Day 1967 after celebrating her 100th birthday the previous month, often engaged in reminiscences about the active life led around the turn of the century. Shortly before her death she recalled how lumberjacks worked in the late winter months getting timber cut and snaked to the bank of a stream, ready to float as a raft after spring rains raised the river to "log tide." She related that her husband often joined the raft hands at Christian and piloted them through the rough waters of the Guyan to Peck's Mill. Then he would return to Christian by horseback and, as often as not, pilot a second raft the same day.

The women were not idle at such times. According to Mrs. Christian, "When it commenced raining, we started killing chickens and baking pies—sometimes cooking all night—for we knew the raftsmen were coming and they'd be hungry." In times of calm as well as crisis she and her sisters-in-law were ready to lend a helping hand. Spicie (Christian) Stanley almost matched Varina's longevity, dying at 94 years of age.

The eulogy which appeared in the church bulletin the day following George T. Christian's demise in 1908 reveals his family's characteristic faith and courage. It reads in part:

Taken with a hemorrhage less than two weeks ago, he steadily failed until the end came. His death was triumphant. Those who saw him during the last two or three days will never forget his testimonies and the glory that lit up his countenance.

George had grown to manhood during the years his father served on the Board of Education and had matriculated at Morris Harvey College before going into business.

Paren Christian's sons and daughters married into families which generally shared their educational and religious values. Capt.

Luossa Armour and Rebecca (Lester) Godfrey, Varina's parents, were both teachers. The father had attended Marshall University in the 1840's when it was a two-room school known as Marshall Academy, and

he had graduated from college in Ohio.

Charles Edward and Mary Jane (Fletcher) Duff were strong advocates of education for everyone; and their daughter, Martha Ann, became a school teacher following her studies at Marshall College. Mr. Duff was well-read on Biblical subjects and took great pleasure in discussions with country preachers or circuit riders who came to his home in Jackson County. He had high aspirations for his children, wanting them "to amount to something."

Emma Mitchell's mother and father fostered such hopes for their progeny, too. Micajah Goodwin and Clarinda (White) Mitchell— like their Christian cousins—would have been pleased to see the evergreater contributions later descendants would make to mankind.

TO COLORADO AND BACK

The eighth of November, 1907, arrangements were complete for the "big move." Although the Christians had been happy and prosperous in the heart of Appalachia for upwards of a century, hopes for a more healthful climate prompted some members of the clan to travel over 1,000 miles westward for a fresh start. Like their forebears one-hundred years earlier, two brothers and a sister with children, nieces, nephews, cousins, and widowed mother decided to migrate together.

Believing that a higher, drier climate would prove beneficial, George T. Christian, Sr., sold his general merchandise store at the mouth of Elk Creek and acquired an interest in a similar enterprise in Longmont, Colorado. His wife Martha Ann optimistically joined in preparations for the move. When her husband returned from a preliminary trip West, she was waiting with their four pre-school youngsters.

Rebecca Ann (Christian) Altizer was also ready with some of her brood when the conductor called, "All aboard." A son, Bert, had already left with the furniture on an earlier train; and her husband, William, had stayed behind because of sickness in his family. Three traveled with their enthusiastic mother.

Albert Leander Christian was equally keen about the plans for



living at the foot of the Rockies. He was accompanied by his second wife, Sarah Alma (Perry), and their two children. In addition, three of Albert's five children by his deceased first wife, Emma (Mitchell), made the journey. Choosing to remain behind was the eldest daughter, Emma Pearl, who had just married the previous year. The three teenagers who went along with their father and step-mother never forgot the tantalizing sojourn "out West." Alden and Icy Maud subsequently captivated the imagination of their children with accounts of the train ride and the spectacular beauty of Pike's Peak. Twenty-five years later 40-year-old Thomas Richard would revisit the Colorado towns remembered from his youth.

As with all who made the original trip, Tom found the delights of their stay tempered with sadness. Illness and death struck quickly. On his visit in 1932, Tom would stop at the grave of his Uncle George, who was stricken only a few months after making the hopeful move to the 5,000-foot elevation. Buried beside her father, Gladys Virginia was born the month after his death and died at eight days of age. Little Ruth Altizer, too, was buried nearby.

For the living, frustration over economic conditions was added to the sorrow caused by these personal losses. When a money panic tied up their funds in the bank, the new environment seemed as direful as it had once seemed promising. The changing conditions compelled the new settlers to consider returning to the familiar hills of West Virginia.

Also contemplating such a change were Bilton Christian and his wife, Varina (Godfrey). About the time his sister and brothers established residence in Colorado, Bilton had moved to Oklahoma Territory with his family.

With the encouragement of relatives "back home" and deeming a return East in the best interests of their families, the Christians and their kin once more packed their belongings-having added a prized cow-and returned to the farms they had left behind.

Kentucky, like so many other states on the route of the westward-moving early "settlers," became home to progenitors of several branches of the Christian family tree. My ancestor Thomas Christian, whose roots beyond his Kentucky residence are not known to me, was a Washington County land owner.

Thomas' son John developed a family plantation in Lebanon, Kentucky, but his untimely death in 1833 precipitated changes he could not have foreseen. After the estate settlement in 1837, John's widow Mary Cathern remarried Mr. William McElroy, who had been appointed guardian for the five children. The newlymarried couple decided to move to Missouri and brought the family to the small village of Warren in Marion County.

PART II

By the seventeenth century the Christians had homes and estates in every part of the Isle of Man and on neighboring shores across the Irish Sea. Assuredly, the desire of the venerable Ewan Christian, Deemster of the tenth generation, had been realized-to make the name of the Christians flourish. Christian parents by the thousands had their children's christenings entered into parish registers* in every part of the Isle: Maughold, Kirk German, Bride, Onchan, Ballough, Marown, Andreas, Ramsey, Douglas' Saint Matthews, Lonan, Braddan, Jurby, Kirk Rushen, Malew, Lezayre.

The family name, too, was beginning to appear more frequently on the rolls of institutions of higher learning throughout the British Isles: Dublin, Edinburgh, Cambridge, London, to name only a few. The schools of law, medicine, and theology attracted most of the Christian gentlemen; and as they completed their studies, many returned to the Isle of Man only to attend sessions of the House of Keys or to visit relatives-preferring to settle elsewhere for the greater opportunities afforded. Even the deemsters themselves sometimes found the lure of the "mainland" inviting and abandoned the ancestral seat at Milntown.

Such a shift in base of operations took place with Ewan Christian of the thirteenth generation. Like earlier relatives, he had developed contacts in Ireland and England-having graduated at Trinity College, Dublin, and having entered as Barrister-at-Law at Gray's Inn 4 August 1671. Also, just six years previously his father Edward had transferred ownership of Unerigg Hall in county Cumberland, England, to Ewan, namesake of the great-grandfather who had first acquired this estate overlooking the waters of Solway Firth. Named for the river Ulne or Alne (now called Ellen), Unerigg underwent a name change when a later Christian owner-occupant adopted the appellation "Ewanrigg" in honor of the deemster ancestor who first added Unerigg to his holdings.

It is apparent from contemporary accounts that not all of the name were prosperous or well-known. Even members of the deemsters' families could find

^{*}The parishes conformed to the established Church of England. The Manx had accepted Protestantism without bloodshed and had welcomed their first Protestant bishop in 1555. Reference to Protestant teaching is first found on the Isle of Man in 1580 when John Christian, then appointed Vicar of Maughold, is recorded as the first Protestant minister of the parish. His father was William McCristen, Deemster of the eighth generation.

themselves in distressed circumstances—as was the case with several descendants of Edward and Dorothy (Wilson) Christian. A perusal of journals written by individuals acquainted with the family reveals that at least two of Deemster Ewan Christian's younger brothers did not fare as well as he. While he was still living, Ewan was in a position to help his "poor relations," if necessary. After his death, however, his widowed sisters-in-law had to turn to others for assistance. One of these was his sister Margaret. On 10 July 1729 the following entry appears in the diary of the Reverend John Keble of the Isle of Man:

A most pressing letter to Mrs. Margaret Christian of Ramsey, desiring her to be kind to her sister-in-law, John Christian's widow, and to her other poor relations, particularly to her brother James Christian's children. . . .

To his own children, Ewan Christian of the thirteenth generation of deemsters offered every advantage. He himself had become heir not only to position and wealth but had inherited and developed those traits of character which made him a sought-after barrister, successful farmer and coal operator, devout parishioner, and beloved family man.

The early moves of the family* can be traced through the entries made in the country's parish registers. After their marriage 12 February 1677 in London's St. Gregory by St. Paul, Ewan and Mary (Caine) Christian lived outside London in the country at Epsom, Surrey County, and later in suburban Whitechapel with expeditions to Cumberland. During these and succeeding years the following were born to them, the last ten at Unerigg:

- Ewan Christian, born 23 March 1679, christened 29 May 1679 at St. Mary, Whitechapel, Stepney, London; died 18 May 1680 at Epsom, Surrey.
- Elizabeth Christian, born 10 June 1680, christened 17 June 1680 at St. Mary, Whitechapel: died 8 December 1696 at Whitechapel, Middlesex County.
- Edward Christian, born 8 December 1681; died 20 January 1682 in Dearham, county Cumberland.
- 4. Sarah Christian, born and christened 9 September 1683 at St. Mary, White-chapel; died there in August 1684.
- Dorothy Christian, born 3 July 1685; died 24 August 1685 at Dearham, county Cumberland.
- Mary Christian, born 26 April 1687; married 7 February 1710 John Fletcher of Clea Hall. No issue. He married 2) Isabella Senhouse.
- John Christian, born 14 May 1688 in Dearham, died there 25 September 1745; married 14 May 1717 Bridget Senhouse in Ellenborough, county Cumberland.
- 8. Margaret Christian, born 2 November 1689 in Dearham; married Thomas Crakeplace of Crakeplace Hall. They had issue.
- William Christian, born 3 February 1690 in Dearham, died 2 February 1721; never married.
- Anne Christian, born 8 September 1692 in Dearham, died 12 January 1693 in Dearham.

- 11. Isabel Christian, born 13 December 1693 at Dearham; reputedly died young and probably never married.
- 12. Jane Christian, born 18 February 1695 at Dearham; married 8 June 1719 Wilfred Clarke of Standingstone. They moved to Wigtonshire and had issue.
- 13. Thomas Christian, christened 29 March 1697 at Dearham, died 1770. Appointed Vicar of Crosthwaite, county Cumberland, in 1728. He married three times:
 - 1) Elizabeth Monkhouse on 31 July 1728. Two daughters.
 - 2) Jane Scott about 1735. One son. She died in childbirth.
 - 3) Emma Naylor on 8 October 1740 or 1741. One son.
- 14. Martha Christian, christened 27 August 1698 in Dearham; married Robert Taubman of Cockermouth. One daughter.
- 15. Alice Christian, born 25 May 1702 in Dearham; married her cousin Quayle Curghy/Curphey of the Isle of Man.

Although not the first of his kinsmen to establish residence outside Man, Ewan Christian was apparently the first in the line of Manx judges to do so. His continued concern for the Isle's affairs made him ready to make the trip back and forth between the seaports of Whitehaven and Ramsey, a distance of only thirty-five miles by sea. Along with other legal and religious contributions, he helped through his role as negotiator to obtain what many Manx islanders today look on as their Magna Charta.

His wife and children often accompanied him to Man; and, indeed, every summer of their childhood the youngsters went over with their parents from Cumberland to Man. Because of their active social life there, the five daughters came to be known as the "fair maids of Milntown." Home, however, was Unerigg, which had been enlarged by Ewan Christian and at the time of his occupancy had forty-two bedrooms, "quite fitting" for their large extended family, many servants, and the steady stream of house guests entertained there. These eighteenth-century ladies and gentlemen adopted a style of life which would continue to be enjoyed and flourish until the twentieth century.

Continuing expansion of Unerigg, Ewan's son John Christian added kennels and huntsmen's quarters to the already spacious accommodations. With these additions the country estate was well equipped for the hunt and its attendant balls and other festivities-all considered so essential to the full life of the period's gentry.

Contemporary letters and diaries give a picture of the seemingly constant social whirl of the circles in which the Christians moved. Always there was "much company," dinner parties "at home" or "out," weeks or months "in London," boating and picnicking "at Lake Windermere," "dancing at Unerigg," going to the "races at Carlisle," "riding parties" on one estate or another. Indeed, one diversion after another in one place after another was the order of the day! Trips to the continent were mentioned with the same casual references accorded the frequent rounds between Bath, London, Cumberland, and the Isle of Man-to each its season.

Generation XIV

John Christian, eldest surviving son, followed in the footsteps of his father and became Barrister-at-Law at Gray's Inn in 1706. He also became heir to the Unerigg and Milntown estates. Although residing primarily in county Cumberland, John served as a member of the Keys on the Isle of Man. John and his wife Bridget, "the tall, fair, eldest daughter of Humphrey Senhouse of the adjoining estate of Netherhall," encouraged the education and advancement of their offspring. The two eldest sons, Ewan and John, were barristers; Humphrey, a divine; Edward, a captain in the Royal Navy; Charles, an attorney; and their two daughters who married chose clergymen as spouses.

VIRGINIA

The original federal census for Virginia was destroyed, a particularly unfortunate loss since Virginia was the most populous of the states in 1790. Coincidentally, Virginia was also home to the largest number of Christian families. To compensate somewhat for the missing enumeration, the Bureau of the Census published Heads of Families at the First Census 1790—Records of the State Enumerations. Compiled therein were results of the state censuses from those counties for which the documents were still available; namely, 39 counties with a population of 370,000. Still lacking were 41 counties with 377,000 population. To fill the remaining gap at least partially, Augusta B. Fothergill and John Mark Naugle's book, Virginia Tax Payers 1782-87 Other than Those Published by the United States Census Bureau, appeared in Richmond, Virginia, in 1940. These references and a few miscellaneous records have provided the data appearing below.

Generation XV

Ewan Christian, who had been called to the Bar in 1742, inherited the estates of Unerigg and Milntown on the death of his father three years later. His own death at thirty-four only a few years afterward without issue allowed the family land and mining interests to pass to his brother John. Neither Ewan nor John ever acted in the capacity of deemster on Man, so far as is known.

John Christian, of the same generation as the brother whom he succeeded, was made a Magistrate before he was twenty and became High Sheriff of Cumberland the year before he died. His marriage to Jane Curwen of Workington Hall joined his line to that of another prominent Cumbrian family. The untimely death of both parents left the children under the guardianship of their uncle, Henry Curwen, Member of Parliament.

GENERATIONS OF THE DEEMSTERS

Generation XVI

John Christian (also known as John Christian Curwen) was uniquely a member of both the British House of Commons and the Manx House of Keys. Except for a brief period between 1812 and 1816, he was a member of Parliament from 1786 until his death in 1829. Thus the active public service for which the family was noted continued into the sixteenth generation, due in no small part to this Whig's "magnificent presence and voice, outstanding powers of oratory and unfettered wit . . ." as well as to his "close acquaintance with the conditions of coal-mining and agriculture."

- On 1 March 1790 John Christian assumed the surname and arms of Curwen and henceforth was known as John Christian Curwen. Although his mother was a Curwen, it was through his marriage to an heiress cousin, Isabella Curwen, that he came to acquire the Workington estates along with his new surname.

SUBSTITUTES FOR 1790 "FIRST CENSUS"

DELAWARE

The original 1790 federal census for Delaware was destroyed; however, Leon deValinger, Jr., State Archivist, used tax lists for that or closest year in preparing Reconstructed 1790 Census of Delaware, published originally in 1954 at Dover, Delaware. Editor used this reference in search for Christian residents of the period. No entries were found for property owners with the surname of Christian, Cristen, Christie, Cristy, etc.

NEW JERSEY

The original 1790 federal census for New Jersey was destroyed; however, a substitute for that census is available in *New Jersey in 1793* by James S. Norton, published at Salt Lake City, Utah, in 1973. This source contains an abstract and index to the 1793 State Militia Census (taken of all eligible males between the ages of 18 and 45) as well as lists of ratables for those counties for which the militia records could not be found. Following are abstracts of all pertinent entries:


Generation XVII The John Christian who would return to the Isle of Man and take an active role as deemster was the product of his father's first marriage to Margaret Taubman. John and his descendants would also carry the Christian surname. On the death of his mother, the young boy was raised by his maternal grandparents in southern Man. Educated at Eton, he next studied under the tutelage of a Manx clergyman in Edinburgh and finally at St. John's College, Cambridge. There he was called to the Bar in 1801, four years after his father turned over Milntown to him.

Milntown and Unerigg both underwent change during the tenure of John and Susannah (Allen) Christian. For Unerigg, the change was in name; he was the first to refer to the estate as "Ewanrigg." He and his family lived there happily during the early years following his marriage. On obtaining the office of Deemster—a post then requiring residence on the Isle of Man—John moved with wife and children to Milntown, once again the seat of a Christian deemster after a lapse of a hundred and fifty years. The home was extensively remodeled and still bears the strong imprint of this heir to family name and tradition, for the reconstruction converted Milntown's battlemented, stone mansion into the painted, plastered edifice seen today.

LINES OF DESCENT

Pedigree charts or lineage rosters provide a graphic, convenient means for presenting an individual's ancestry. The format selected for publishing in this section a particular line of descent depends upon such factors as the number of contributors having a common Christian ancestor, the amount of material submitted, and the space limitations of a given issue. If information on the collateral lines is available, it may be published. Usually, however, emphasis will be on the Christian lineage.



IN THE UNITED STATES CENSUS RECORDS

The first United States census, taken in 1790, consisted of an enumeration of the inhabitants of the states of Connecticut, Delaware, Georgia, Kentucky, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, North Carolina, Pennsylvania, Rhode Island, South Carolina, Tennessee, Vermont, and Virginia.

The results of the 1790 federally-conducted survey would be far more valuable to genealogists today if a complete set of the schedules for each state were still extant. Unfortunately, the returns for the states of Delaware, Georgia, Kentucky, New Jersey, Tennessee, and Virginia were lost or destroyed.

In order, therefore, that the abstracts presented here might offer the fullest possible coverage for the Christian family households, other supplemental lists and sources have been utilized. The editor has incorporated records from ten years before and after 1790 for this compilation. Notes immediately below each state's entries contain specific sources and explanations.

In each case, the spelling used for names herein is the same as that used in the source from which the data was obtained. Many variations of both Christey and Christian appear because during the post-Revolutionary period spelling of surnames was not as standardized as later. There was the chance, too, that such entries as Christie and Christy might in fact have been abbreviations for Christian—not particularly unusual at that time. Several seemingly unrelated names also appear since an error may have occurred on the original or in the transcriptions used as sources. Christey, for example, in script would become Chrisley if the scribe simply forgot to cross the "t." No abstracts were made for Crisey, Crissey, and Crissy, a surname which occurred frequently in New England.

Corrections and additions are always welcome, but a special invitation is exextended to subscribers to send more replacements for the period surrounding 1790.





I William Christian now at Kentuckey do make this my last Will and Testament as follows: Having amply & fully given to Mr. Alexander Scott Bullit & my Daughter Priscilla the Share of Estate intended for Her, I have now only to bequeath to my said Daughter Priscilla a pair of Stone Shoe Buckels & two Gold Rings, the whole to cost Ten Guineas.

I will & devise to my wife Anne five hundred Acres of my Bear Grass Land to include the Improvement whereon I now live, and to be laid off by a line runing from the Ozmoor land to Mr. Bullits, parallel with the Dutch Station & Breckinridges line which joins me, to her & her Heirs & Assigns forever. I will & devise to my said Wife Anne, my Negroes. James Kavanaugh James Lumpkins Peter, Lewis, Titus & John & also Dinah her Child Willson & her future Increase, to her & her Heirs & Assigns forever-I will & bequeath to my said Wife Anne whole of my Household & Kitchen furniture, & plantation Utensils, including One Waggon & Geers. I bequeath to her also four work Horses & two riding Horses & all the cattle & Hogs I leave to her & her Assigns-This Devise of the land & Negroes above mentioned the Bequest of Furniture &C is made to my said Wife as a full Compensation for & in lieu of her Dower in my Estate both real & personal. For should she claim Dower, then the devises & bequests in this Will shall cease & be void & she is to stand to & have her dower only.

The remaining part of the Tract I live on I suppose will be about Six hundred & fifty Acres & will be bounded by my Wifes five hundred Acres, by the Oxmoor, Edma Taylor, Fleming & Bullits Lands. This Six hundred Acres be the same more or less I will & devise to my Daughter Sarah Winston Christian to her & her Heirs & Assigns forever.

And whereas I own a large Tract of Land upon Elkhorn, containing by Patent 3,000 Acres but which I expect will measure 4,000 adjoining Flourney & Meredith I will & devise to my daughter Elizabeth One Thousand Acres out of the said Tract to be laid off so as to include a big Spring called formerly Bryan's Spring & which lies near the Road from Bryan's Station to Robert Johnston's, to her & her Heirs & Assigns forever. It is to be laid off to join Merediths Line as well as to include the Spring. All the rest of the said Tract of Elkhorn after laying off the Thousand Acres for my daughter Elizabeth I will & devise to my Executors, or such of them as may act to be sold for the paiment of my debts. I also will & devise to my Executors to be sold for the paiment of my Debts my four hundred Acres of land in Mercer County upon Shawney River purchased from Daniel Trigg, to them & their Assigns forever or to such of them as may act.

I will & devise to my daughters Anne & Dorothea my Tract of land upon Ohio (joining Peachey's land at the Mouth of Kentuckey) containing by Patent One thousand Acres, which Tract be the quantity more or less I will & bequeath to my said two Daughters and to their heirs & Assigns forever.

I will & devise to my son John. Saltsburg & all my adjoining Land with this Condition that the profits arising therefrom shall for the first seven Years be wholly disposed of for the paiment of my Debts if necessary in aid of the lands I have ordered to be sold for that purpose, & in the next place for the maintaining supporting cloathing & educating my Family. That is to say, my single & unmarried Children & my wife while She remains a Widow. The disposal of the said profits to be solely at the disposal of my Wife while She remains a Widow, without Controll or being called to any account therefor at future period. But should she marry she is from thenceforward to be considered as an Alien in my Family & give up all Direction & Power in It & limit herself to the Estate I have given her in lieu of Dower.

To my dear Mother during her natural Life I will & bequeath Tom Body Sarah & Hannah.

Should my Wife or Executors as the Case may be be able [illegible] part of the profits of Saltsburg or monies arising from the Saltsburg Lands I have ordered to be sold after paying my debts & maintaining & support cloathing & educating my Family as above, such overplus is then to be applied to the equal benefit in future of my Children that may be unmarried. Whenever a Daughter marries She is to have her Fortune & to have no more to do with my Estate as She is neither to gain or lose by Misfortunes or Advantages therein.

The whole of my Negroes are to be kept together as a Common Stock until the Marriage or Arrival of Age of a Child, when such Child is to take off Its Share.

Besides the Eight Negroes above Willd to my wife, I will to Her besides Edinburg, & Cloe, to her & her Assigns forever.

I will & devise to my daughter Sarah Winston Christian Charles (got from her Grandmother), little James, Jenny & their Children, Sarah, Adam, Betty, & Jenny & Moses to her & her Assigns forever.

NUMBERING AND ARRANGING SYSTEM FOR GENEALOGICAL RECORDS

In Volume No. I, January 1979, of these Christian Family Chronicles readers the alphabetic and the numeric can be will have noticed on page 18 a set of numbers associated with the descent of Archie H. Christian. Archie Christian is a valued collaborator of mine in the work, The Descendants of Charlou's Ancestors, described in the "On the Bookshelf" section of this issue; and the numbers used in his line of descent and in my work are the "DCA Numbers." It seems worthwhile to explain this system for arranging genealogical records so that it may be used by others in their own work.

Since The Descendants of Charlou's Ancestors studies both the ascending and the descending lines, the numbering and arranging system provides for both these directions—numbering ancestors back to the common ancestor and then numbering collateral lines down to a particular descendant and providing for the orderly arrangement and retrieval of all of them.

Numbering Rules for Descending Lines

The basic single- or double-digit number assignment of each individual is keyed to the birth order in the family ("family" with some modifications as described beyond). If the birth order number for an individual is known, he is assigned that single- or double-digit number. If it is unknown, he is assigned an alphabetic letter at the guessed or arbitrary position; that is, a = 1, b = 2, c = 3, etc.

About the author:

Dr. Louis Koenig identifies himself as "Amateur Genealogist." However, those who have corresponded with him regarding Christian family research can attest to the professional level of his endeavors. For over twenty-five years Dr. Koenig has utilized the system described in the accompanying article for the ease it offers in arranging and retrieving records, identifying relationships, and comparing data. Especially valuable to those engaged in research on a common line, the "DCA Numbering System" might prove beneficial to Christian family researchers tracing their ancestry.

If partial information is available. intermixed. For example, 1, b, c, 4, 5, represents a child known to be the first child, children known to be the fourth and fifth, and second and third children whose order is not known.

Illustrating up to this point: the John Christian, #4 in the Archie Christian descent, is the second child of a fifth child of a third child James Christian and is numbered 352. (Note: This is to be read as "three, five, two," not as "three hundred and fifty-two.")

If the birth order is not known and if the compiler has given up on ever determining the correct order, then the alphabetics called for by the rule may be replaced by numbers assigned arbitrarily. For example, the actual birth-order sequence for the four sons of the immigrant Thomas Christian is not known and probably never will be known; but they are assigned numbers in an arbitrary sequence or by the order listed in a will or the like. The purpose of the alphabetics in place of the numbers is to signify an uncertainty which may later be removed—that is, changed to a number -without too much changing of the other numbers and the arrangement.

Females are designated by an underline. For example: Mary, the fifth child of John Christian (352), would be designated 3525.

When the birth order number comprises two digits, it is distinguished from successive single-digit numbers by extending the underline under both digits, For males the same is accomplished by a tie over the digits. Example: 35212 would be a female 12th child of a male second child, etc.; 3521 2 would be a female second child of a female first child of a male second child, etc. On the other hand, $352\overline{18}$ would be a male eighteenth child of a male second child,

Arrangement of Individual Data Sheets

Recognition of Ancestral Relationships

The system allows not only rational arrangement and retrieval but also guick recognition of relationships and of common ancestry. Illustrating: individuals having the same sequence of digits up to some point have a common ancestor at that point. Thus 35212, Carolina Matilda Christian, would have a common ancestor with 35241-that being 352, John Christian. (Refer to Archie Christian line of descent.) Deeper, the position of the digit after the common ancestor designates the relationship: the first position being siblings; the second position, first cousins; the third, second cousins, etc. Still further, the relation between the following two

second number is the first cousin once removed of the first. That is, the count (minus one) from the common ancestor to equal positions indicates the degree of cousinship, and the count beyond the equal point indicates the degree of removal.

In-Line Cousin Marriages

The complication in this so-far straightforward system comes from in-line cousin marriages, which in Christian genealogy abound, layers of them, even unto the fourth generation. When 212 married 226, the problem is how to number their children. The system is designed to group parents and children closely together in a family pattern. But when mother and father occupy separated loca-

(In The Descendants of Charlou's Ancestors the individual sheets contain notations as to such cousin marriages and also to not-in-line cousin marriages, if known.)

Plural Marriages

Plural marriages further complicate is that the person represented by the the cousin complication. Not-in-line plural marriages simply follow the rule for sequential numbering of children. Using Archie Christian's lineage again as an example: the children of (35) William Christian's second marriage to Susanna Brown do not bear the proper birth order numbers. They should be: 3, 4, 5, etc. representing the sequence of William Christian's children, regardless of the mothers.

If the husband in a plural in-line cousin marriage has prior or subsequent marriages, there is no complication since his children are numbered sequentially by the rule. It is when the wife in such an in-line cousin marriage has children by prior or subsequent marriages that the complication arises. Again, for consis-



LAST WILL AND TESTAMENT OF ISRAEL CHRISTIAN

In the Name of God Amen, I Israel Christian being low in health but of Sound Mind and Memory, do make this my last will and Testament.

I will and bequeath to my beloved wife Elizabeth, four negroes, to wit Isaac, Dorson Bill and Kate, to her and her Heirs forever, I also give and bequeath to my said wife all my stock of horses, Cattle, Sheep, Hogs also all my Clothes, Books, Household & kitchen Furniture of all kinds as well as Plantation Utensils. To her and her heirs forever: I also give and bequeath to my said wife, one-hundred pounds annually during her natural life, to be raised out of the sale of my lands. I direct that all my Lands, already surveyed, and not patterned or what is yet to survey, may be pattened or granted to my son William Christian, in as ample a Manner as they could be made to my self -- while Living.

I direct and impower my said son to sell whatever Part of my lands Patented or unpatented which he may think proper to sell for the purposes of paying the Debts I owe and of raising the annuity of a hundred pounds annually which I have directed to be paid to my wife during life, and to make sufficient conveyances, I direct that my son shall Convay to or settle upon my daughter Rosanna it to be spared at my wifes Death one Thousand Acres of Lands on the north side Kentucky located by Col. Boon for me to be settled upon her independent of her present or any further Husband, and to be wholey her own and at her own Disposal.

I will and direct that my son shall convay to my grandson John Henry Christian one thousand acres of my Notelinn Land at my Wifes Death.

I also direct that my son shall convey to Sarah Winston Christian five hundred acres of the Notelinn Land being the remainder of the survey and also five hundred acres surveyed on Knobb Creek at my Wifes Death.

When my son obtains titles for my Lands enterd upon the Waters of Sandy River or a sufficiency thereof for the purpose, I direct that he may Convey to my Granddaughters Priscilla & Mary, Daughters of my deceased Daughter Elizabeth to my grandChildren Stephen Trigg Fleming Trigg & Polley Trigg each one thousand acres and in Case the said five thousand acres not obtain upon the Waters of Sandy River or should turn out bad in my sons opinion he is at liberty & authorized to give the said five Legatees such a part of about four thousand acres of Land located by Col? Boon for me as my said son may think fit to give them at my Wifes Death in Case he has then saved the said Boons locations or any part of them But my Daughter Rosannas thousand as above stipulated is first to be given up.

And shold there be still Lands left at my Wifes Death besides providing for the purpose & appropriation already mentioned It is to belong equally to my son W Christian & my Daughter Anne the wife of William Fleming and her half to be conveyed to her by my son in such manner as to be her own property & at her own disposal independent of the present or any other husband. And to prevent Disputes in fixing upon her share my son shall chose two men who shall determin which Tracts (if any Lands are left he is to settle upon his said sister.

And for the full ξ complete fulfilling ξ executing this my last will and Testimoney I appoint my wife Elizabeth my Executrix and my son William Christian my Executor or whichever of them may Chose to act. -

The children of the wife in such a case are numbered, by the rule, in the sequence of their birth to her in all marriages . . . but those children from the in-line marriage comprise a gap in her number set and are numbered, by the rule, as children of the in-line father. For example: Emily Christian, 212, marries 1) John Notinline and has two children. Then she marries 2) Mark Christian (1), 226, and has three children. Finally she marries 3) William Notinline and has two children—a total of seven children of Emily, 212. The numbering follows:

2126 children of 212 from W. Notinline

2261 children of Mark Christian 226

2262 and Emily 212 2263

On the individual record sheet for Emily, 212, carrying the information for her second marriage, the children would be listed but with the notation, "children carried under father," just as with nonplural in-line marriages.

This completes the description of the numbering system for the descending line. The numbers actually used in The Descendants of Charlou's Ancestors are called "DCA Numbers," but this does not mean that the system is confined to that work or to Christian genealogy. It is a general system* that readers are welcome to use for their own records in any line.

As indicated at the beginning of this article, numbers may be assigned not only for the descending line (as with the examples given for Archie Christian's

lineage) but in the ascending line as well (see the chart of Charlou Koenig's ancestors immediately following on next page). With this chart for convenient reference, a rudimentary explanation of the ascending line system is given below.

Numbering Rules for Ascending Lines

The numbers at the left are the "DCA Numbers" for Charlou's ancestors. Reading from left to right they show the birth-order numbers of his ancestors in successive generations. Thus his mother was a sixth child, her father a seventh child, and his mother (her grandmother) a first child; therefore, Charlou's great-grandmother is 671.

In-Line Cousin Marriages-Ascending

The handling of in-line cousin marriages in the ascending line is even more complicated than in the descending line. We go back to 671 57, George Asbury Christian, to illustrate how the ascending line is tied to correlative descending lines, as follows.

The 671 57 represents the line of ancestors of Charlou back to George Asbury Christian. If the digits are reversed to 75 1 76, they represent the descent of Charlou (implied following the 6) from George Asbury Christian. In the same way the digits 72153 represent another descendant of George Asbury Christian-actually, as shown by the positions, a third cousin to Charlou's mother, 6. To relate these two in an arrangement system, they are combined with a slash (/) after the common ancestor:

671 5/7/2153
In the arrangement heirarchy the slash (following) serves the same function as the decimal point in the Dewey Decimal Classification. Illustrating, with fewer digits for convenience, the arrangement would be:

- 521 3rd generation ancestor
- 521/1 lst child of preceding
- 3rd child of same 521/3
- 521/31 1st child of 3rd child of same
- 5217 4th generation ancestor
- 5217/2 2nd child of preceding
- 5217/3 3rd child of same

Note that there is a gap where the first child of the fourth generation ancestor would appear because that first child is himself an ancestor and appears in place farther up the line: 5217/1 is equal to 521; that is, the first child of 5217. Note also that as each ancestor is added to the line all of his correlative de-

CHRISTENED 'THOMAS CHRISTIAN' ON ISLE OF MAN

- SEVENTEENTH CENTURY -

Much interest has been expressed in determining the parentage of Thomas Christian, immigrant to Charles City County, Virginia, before 1700. If from the Isle of Man, as has been assumed by numerous descendants, it is likely he and/or his son Thomas had a christening or birth record entered on the parish registers there. The abstracts below list all such entries (designated by a "C" or "B") for individuals named Thomas Christian born on Man between 1600 and 1700 and show the vital data which appears on the Computer File Index.*

MICHAEL CHRISTIAN--with brother William came about 1720 to Northampton County, Virginia, from Ireland; but they were originally from Scotland. 17

PAULUS CHRISTIAN -- on ship "Phoenix" 28 August 1750 from Rotterdam, last from Cowes. 18

PETER CHRISTEIN--on ship "Phoenix" 28 September 1751 from Rotterdam and Portsmouth to Pennsylvania. 18 & 20

That the father of Elijah Christian was the Charles Christian whose will in Goochland County, Virginia, was dated 18 September 1783 and proved (i. e. probated) 16 February 1784 is attested to by the contents of that will and other sources. Whether Elijah's mother was Charles' first wife, Judith Woodson, or his second, Mary Leake, has not yet been determined. Listed in Charles' will and presumed to be his children are the following: Lucy Woodson, Judith Woodson Daniel, Charles, John, Elijah, Turner, William, Walter, George, Elizabeth Humber, Mary Grishem, Judy Lacy, and Morning Christian.

According to Marshall L. McClanahan's early manuscript, William Christian, Immigrant to Virginia, and Some of His Descendants (Elwood Park, Illinois, 1958—National D. A. R. Library Call No. 45999), "Charles Christian (Charles³ Charles² Thomas¹) was b. in Westover Parish, Charles City County ca. 1710. He md. ca. 1730 1) Judith, daughter of Joseph Woodson (Robert² John¹) by his wife Mary Jane Woodson (John²-¹), and by her had all his children. He md. 2) Mary, daughter of Walter and Judith (Mask) Leake. Judith, his first wife, was b. ca. 1712 and came to Goochland with her father 1710/11." Charles Christian is known to have married his second wife before 31 October 1757, when her father Walter Leake mentions his daughter Mary Christian in his Goochland County will.

Certainly some of Charles' children were born of his second marriage to Mary Leake, a fact established by his son Walter's Bible record wherein the following appears, "Walter Christian son of Charles Christian and Mary Christian was born 23 Sept. 1760 . . ." (See "Revolutionary War Pension Applications" in National Genealogical Society Quarterly, Volume 51, p. 193.) It should be noted also that Mrs. Harry W. Archer of Liberty, Texas, whose pedigree appeared in Christian Family Chronicles, Volume No. I, at page 17, gives Mary Leake as Elijah's mother.

Elijah Christian is listed before Turner in the will, in the same position in The Valentine Papers as well as in the William and Mary account of Volume V, whereas McClanahan records him after Turner, to whom he gives the middle name of Hunt (not elsewhere reported). As Turner's birth has been given as 1750 (see Woodsons and Kindred by Henry M. Woodson, Richmond, Virginia, 1915), it would seem reasonable to believe Elijah was older, born about 1749 or perhaps a year or two earlier. Further, and on this point, John H. McIntosh (in The Official History of Elbert County: 1790-1935, Elberton, Georgia, Stephen Heard Chapter D. A. R., 1940, at p. 388 et seq.), citing the Bible record of Ira Christian, 1801-1857, a prominent lawyer of Elberton in his lifetime, named the seven sons of Charles Christian with Elijah immediately before Turner and stated Turner was born in 1750. None of the sources examined gives Elijah's exact year of birth. Of interest, however, is the fact that on the marriage bond 3 January 1778 for Turner Christian and Anna Payne, Turner's father Charles Christian "consents," thereby suggesting Turner was not then 21 years of age. If such proves to be the case, then his birth would have occurred about 1760, ten years later than the sources previously cited indicate; and the date would be more in line with Elijah's birth "about the year 1758" given by L. C. Christian (see source above).

McClanahan (at page 15) reports, "All seven sons of Charles Christian were said to have participated in the Revolutionary War," several as members of the First Rifle Regiment of Amherst County, Virginia. Indeed, their father Charles Christian, a Whig, supported the American forces and is recorded as having furnished supplies and personal services to the Virginia militia. (See D. A. R. Patriot Index, Washington, D. C., 1966, p. 130, where this appears: CHRISTIAN, CHARLES "b. c. 1715 d 1784 m x PS Va."—from proof of membership by a descendant of his daughter, Elizabeth Humber, nee Christian.)

Corroboration for Revolutionary service of Charles and his sons is present in various sources, one of the most comprehensive being Leonora Higginbotham Sweeney's Amherst County, Virginia, in the Revolution—including extracts from the "Lost Order Book," 1773-1784, Lynchburg, Virginia, 1951. A brief resume of the military activities of Elijah and his brothers follows:

- 6. Isaac Christian married Miriam Young, daughter of William and granddaughter of Edward Young, mutineer.
- 7. Mary Christian married before 1835 Arthur Quintal, son of Matthew Quintal, mutineer.
- 8. Margaret Christian married twice: 1) to Matthew McCoy, son of Daniel and grandson of William McCoy, mutineer; and 2) to Mayhew Young, son of William and grandson of Edward Young, mutineer.
- III. Mary Christian, born 20 September 1793 on Pitcairn Island, reputedly at the very hour during which her father was murdered. As far as is known, she never married.

English became one of the native tongues of the children and grandchildren of Fletcher Christian, and the story of his adventures was retold from generation to generation.

Of the thousands of his descendants who today bear the Christian name or through intermarriage that of one of his fellow mutineers, many have journeyed to the ancient homeland for which their ancestor sometimes pined. At Moorland Close they can still enter—as did their kin of old—through the heavy doors of the lofty, arched gateway into the scenes of their family's past.

- I. Thursday October Christian, later called Friday October Christian. + was born and christened in October 1790: died in 1831. He married about 1807 Mary or Suzannah, born about 1770, the Tahitian widow of William McCoy, mutineer. They had at least the following issue:
 - 1. Charles Christian, born 1808, died 1831; married about 1829 his first cousin Maria Christian, daughter of Charles and Sally Christian.
 - 2. Joseph Christian, born about 1810; reputedly never married.
 - 3. Thursday October Christian, born about 1812; married Mary Young, daughter of William and granddaughter of Edward Young, mutineer.
 - 4. Mary Christian, about whom nothing more is known.
 - 5. Polly Christian (probably the nickname of daughter above) married Edward Young, born about 1791, the son of mutineer Edward Young and his Tahitian wife Susan.
 - 6. Peggy Christian married twice: 1) to Daniel McCoy (1814-1831), son of Daniel and grandson of William McCov. mutineer: 2) to her first cousin Fletcher Christian, son of Charles and Sally Christian.
- II. Charles Christian, born 1792 on Pitcairn Island; married about 1811 Sally, a Tahitian, possibly the widow of Matthew Ouintal, mutineer. They had at least the following issue:
 - 1. Fletcher Christian, born 1812, died 1852; married his first cousin Peggy Christian, the widow of Daniel McCoy.
 - 2. Edward Christian, born 1814, died 1831; probably never married.
 - 3. Sarah Christian married about 1829 George Hunn Nobbs.
 - 4. Maria Christian, born 1815, married three times:
 - 1) about 1829 to Charles Christian, her first cousin;
 - 2) about 1832 to John Quintal, son of Matthew and grandson of Matthew Quintal, mutineer;
 - 3) to William Quintal, son of Edward and grandson of Matthew Ouintal. mutineer.
 - 5. Charles Christian married before 1837 Charlotte Quintal, daughter of Arthur and granddaughter of Matthew Quintal, mutineer.

William Christian: According to McClanahan, was a Sergeant of Artillery in Virginia Line; from "Lost Order Book," p. 36, qualifies as Captain; p. 54, in the seige of Yorktown. L. C. Christian declared that William was taken prisoner by the British and starved to death "on a British vessel." Since there is evidence that he survived the Revolutionary War and subsequently raised a family, perhaps he only "practically" starved to death or died in the War of 1812.

John Christian: A private in the First Rifle Regiment. Later a Captain since on p. 113 of Sweeney's work mention is made of Capts. William and John Christian, "brothers."

Charles Christian, Jr.: One of those named as a member of the First Rifle Regiment of Amherst County, Virginia.

Elijah Christian: "Lost Order Book," pp. 32 et seq. & also p. 334, was endorsed by Amherst County Court as an Ensign and on Oct. 5, 1788, he qualified; later as a Second Lieutenant; pp. 37, 442, 151, from an affidavit by an applicant for a pension: James Luttrell of Knox County, Tennessee, said he was drafted into the Amherst militia, marched to North Carolina, and served under Capt. Christian . . . Ensign Elijah Christian in the "Guilford Expedition," and that when the detachment was "in sight of battle," joined Col. Lynch "& pursued the British."

Turner Christian: According to McIntosh, was a Revolutionary soldier; and per McClanahan, is listed on Knight's Roster of Revolutionary Soldiers of Georgia and on Capt. B. F. Johnson's Certified List of Revolutionary Soldiers.

Walter Christian: From affidavits accompanying the pension application of his widow, it can be ascertained that he "served three years in the Virginia line of the Continental establishment."

George Christian: At age 16, is listed on the payroll of Francis Taylor's Virginia Regiment 1 April 1779. Family tradition also places him at the Battle of Kings Mountain 7 October 1780.

In 1775 Charles Christian, Sr., conveyed title to his son Elijah Christian by deed of gift, reciting his love for his son as the consideration thereof. Recorded in Deed Book D, p. 358, of Amherst County, the deed describes the land as a plantation "whereon he now lives," of 400 acres adjoining another plantation owned by the grantor and still another owned by Matt. Whittle from a tract "paternd" by James Christian, John Christian, and William Brown. Witnesses were Abraham Lemaster, David London, Jno. Owenby, Jr., and John Christian, and deed was executed 31 October 1775.

Elijah Christian's name was recorded in the Virginia State Census of Amherst County in 1785, at which time his household consisted of seven "White Souls" (but without slaves). In addition to himself, one was probably his wife Elizabeth Britt; and while not decisive, five of these white souls were doubtless their children. The family moved to Georgia sometime between 1785 and 1790, when on May first Elijah purchased 300 acres of land "on the waters of Kettle Creek" in Wilkes County.

⁺When contact with the outside world was reestablished with the landing of the American ship Topaz in 1808, the Pitcairners learned that the calendar which had been so carefully kept since the day of the mutiny had not been adjusted when the Bounty crossed the international date line in its wanderings. Thus, the first-born son was born on a Friday rather than a Thursday in October and changed his name accordingly.

Among the family members who accompanied Thomas Ewing and Mary Ann (Doughty) Christian on their move from Cocke County, Tennessee, to Atchison County, Missouri, was their still-single son Lewis Calvin Christian, writer of a 1905 letter* containing a detailed account of the trip. Becoming an esteemed citizen of Atchison County, he served as justice of the peace in Clark Township for five years and in Rock Port for ten years. He was assessor for the 1859:1860 term and held the office of county clerk from 1875 to 1877.

The venerable L. C. Christian—called Squire, Judge, and occasionally Colonel—used only his initials on his business stationery. Although he had read for the law and, indeed, advised the poor who couldn't pay for legal aid, his later years were spent primarily in merchandising. Even at age 72 he was "active as any of his boys" and still enjoyed life fully. His keen memory and attention to detail is apparent from the following portion of a letter written to his daughter Allie (Christian) Thomas.

books for guidance, he speculated that Pitcairn's Island might be the answer.

On 15 January 1790, nine months after the mutiny, the company sighted the great rock which signified Pitcairn; and the final chapter in the lives of Fletcher Christian and his fellow mutineers was soon to begin. With its "delicious" climate, thickly wooded forest, plentiful seafood, abundant fruit, and rich soil, Pitcairn Island, although small, offered the promise of a tropical paradise to the nine mutineers and their Polynesian mates—somewhat less than perfection for the six native males accompanying them, men who would in effect be servants and who would have to share three women between themselves.

After dropping anchor and emptying the ship of its cargo and stripping it of all usable appurtenances, but before a definite decision could be made regarding its disposition, one of the mutineers set the ship afire; and H. M. S. *Bounty* was consumed by flames in the waters of Bounty Bay.

Under Christian's direction, the settlers turned to the task of building homes and enjoyed a brief period of relative tranquility before the accidental death of a mutineer's spouse disrupted the delicate balance which had been maintained. When the colonists reluctantly allowed their disconsolate compatriot to take for his wife the mate of one of the native men, the resentment and jealousy of the deprived gave way to plotting death against the Englishmen. When their intrigue was exposed, two ringleaders were summarily killed. Unfortunately for all, the chain of suspicion, fear, and violence was only temporarily quelled; and some months later most of the mutineers were murdered in the fields as they worked. By the end of 1800 only one of the original male population had escaped death.

Before he was killed in the 1793 massacre, Fletcher and Isabella Christian had become parents to two sons and a daughter. Their first-born was also the first child born on Pitcairn Island, and their youngest was born on the day of her father's death. Names of the

—so much so that within three weeks of sailing, Christian could only lament, "I am in hell," and determined to desert ship.

Because so many of the others must also have been "in hell," what started as his desire to desert ship became mutiny. Instead of being a lonely deserter before dawn 28 April 1789, he became the de facto leader of mutineers. Before the day ended, they had seized the ship; cast Bligh and eighteen loyalists adrift to almost certain death" in the ship's launch (albeit with Christian's sextant and nautical tables, a tool chest, compass, and other useful items); and had begun deliberations regarding their own future course of action.

It is significant that at least four of the mutineers—Christian among them—had developed intimate attachments on Tahiti. So it was perhaps inevitable that they would ultimately steer the *Bounty* toward its shores in order that the women who were to be their wives could accompany them.

Remaining on Tahiti was out of the question for Christian and his followers because of the likelihood of capture and eventual court martial. Finding a suitable haven proved more difficult than they had anticipated, though. After two abortive attempts to settle on Tubai and a third return to Tahiti for additional women (and to leave a few mutineers and loyalist crew members for whom there had not been space enough in the launch), the wanderers set sail once again in search of a homeland. Due to the presence of hostile native populations, they barely averted disaster in several attempts to settle on already inhabited islands.

In view of these experiences and the worrisome risk of discovery, Christian decided their goal must be to find a remote, harborless, uninhabited island. After consultation with charts and voyagers'

I will return these clipings; and make some corrections for future use. We left our Home 4 miles north of Newport Tenn Wednesday, March 24¹¹ 1852, and arived at Bro. P. R. C.'s on Saturday June 12¹¹ 1852, the cause of our being on the Road so long was on account of my sickness. I caught the Measles the day we started, but we Traveled about 100 miles ariving at uncle Jack Doughtys, (Brother to Mother) where I lay 35 days. We left uncles and the 2¹² day thereafter we was in the top of the Cumberland Mountains where Bro. Bob was taken down with the Mumps. We had to remain there some time; after leaving there we had no trouble; but was delayed so much that we see that we could not reach our destination in time to Raise a crop, so we took our time crossing the Ohio River at Golconda, thence W. to St. Louis, thence North—crossing the Mo. River at St. Charles.

^{*}Due to Bligh's genius as a navigator, the launch reached safe harbor; and Bligh returned to England with the other survivors to make a full report resulting in a court martial. After the court martial, Fletcher's mother retired to the Isle of Man, where she died 8 January 1819.

We then went N. W. into Calaway Co. and stoped with a Mr. Holt, formerly a Neighbour; and an uncle to a cousin of mine, Nathaniel Christian who was staying with his uncle Holt. We were there about a week, then we went S. W. crossing the Mo. again at Rocheport, and on the south bank we seperated from Bro. Phineas. We went down on the south side of the Mo. River 2 miles to John Walsh'es, a Brother to Bro. Phineas' wife. We then came up to Saline Co. to uncle Isaiah Huff's (he maried Fathers oldest sister), remained there 1 week. We then came up to Lexington in Lafayette Co. then crossed the Mo. River again (the third time) We came up to Agnecy ford in Buchanan Co. where uncle Jas. Christian lived (and a great many other Relatives and Tennessians) remained there a week or two, then on to Bro. P. R. s ariving on Saturday evening, June 12 -- 52. I was not able to walk any on the way; the first time we Bought corn as low as 25 cents per Bushel was in Illinois: We thought that was very cheap, had never heard of such a thing before. St. Louis was a small city then, only 2 streets from the River, most of the Bussiness was then done down on the River; there was not then a Locomotive Engine west of the Mississippi River. There was but one R. Road in Ill. that was from Indianopolis to Chicago, and they had just begun grading on the east side of the River at St. Louis, and R. R. towards Chicago; in coming to this country we did not travel on Sunday a single time . . .

Not all the children and grandchildren of Thomas Ewing and Mary Ann (Doughty) Christian settled in "this country" of Atchison County, Missouri. Some remained behind in Cocke County, Tennessee, while others eventually moved to Texas and other points westward.

Fletcher Christian, who had already been promoted to acting lieutenant and second in command on board ship, was appointed permanent commandant at Point Venus, the island site selected for the nursery garden quickly created under the direction of the botanist and his assistant. Most of the company, like Bligh, continued to bunk on the *Bounty* anchored in the harbor.

Life for all, however, began to undergo radical changes in Tahiti. Several of the men formed alliances with the graceful, native women who were allowed to share their accommodations on land or shipboard. Most, too, adorned themselves with tattoo marks over large portions of their bodies as was the Tahitian custom. Thus it was for the dark-haired, "handsome and cheerful" Christian, for whom life was at its most idyllic. He was living on Point Venus with "his Isabella," nicknamed "Mainmast" for her tall, erect carriage. As events subsequently proved, this sailor who among his peers had had the reputation of being "a great man for the women" was, in fact, ready to settle down with this chieftain's daughter. Called Mauatua or Miamiti in the Polynesian tongue, the beautiful, radiant Tahitian remained devoted to him for life.

During the months necessary for the more than 700 pots of breadfruit plants to reach the stage where they could safely endure the long sea voyage to the West Indies (where they were expected to be the start of plantations providing a nourishing, easy-to-grow, all-year-round food crop for the slave population), Bligh's dicipline of the Bounty crew became increasingly slack and erratic. Insubordination and floggings increased, and Bligh publicly humiliated his men for the slightest infraction or failing previously overlooked—Christian being no exception. There was evidence, too, that some of the men would prefer to remain in Tahiti rather than sail with him again.

Nonetheless, when the plants were loaded and all declared ready for embarkation, everyone was aboard except the senior surgeon who had died during their stopover. Relations between commander and crew rapidly worsened with Christian bearing the brunt of Bligh's wrath

recommended to Bligh by Captain John Taubman.* Although all officer berths had already been taken, Christian was sufficiently anxious to sail with and to learn from this excellent navigator and hydrographer (who had served as sailing master under the celebrated James Cook) that he offered to enter the ship "as a foremaster until there is a vacancy among the officers" provided he be permitted "to mess with the gentlemen." So it was, working as a rating and messing as an officer, that Fletcher Christian was welcomed by Bligh on the Britannia's first voyage to the West Indies. He was promoted to second mate on the second voyage and, by account of the first mate, "treated like a brother" by the captain.

Popular with the ratings and well-liked by the officers, Fletcher had a five-foot-eight-inch figure well suited to "feats of strength and agility." It was not surprising, then, that Bligh would choose the strong, resourceful Mr. Christian as Masters Mate for the Bounty when in 1787 Bligh was appointed to command the armoured brig fitted to transport breadfruit plants from Polynesia to the British West Indian colonies.

From 23 December 1787 when the <code>Bounty†</code> left Spithead, England, until 26 October 1788, when it arrived at Matavai Bay, northern Tahiti, Christian assisted Bligh in handling the routine chores and multiple crises of the voyage. The ship's company endured one ordeal after another: stormy, tumultuous seas; injuries and sickness—all without loss of life, all with a fortitude, determination, and dicipline that allowed them to reach their destination ready to establish island headquarters for the months it would take to obtain and cultivate the breadfruit saplings.

of that time: William Wordsworth and Isaac Wilkinson.

Fletcher was characterized as a lively, mischievous boy who developed into a likeable, engaging young man. Wilkinson subsequently wrote. "I can with truth say a more amiable youth I have never met with." Edward Christian also attested to his younger brother's qualities, writing that he "possesses extraordinary abilities, is an excellent scholar, and everyone acquainted with him from a boy . . . can testify that no young man was ever more ambitious of what is esteemed right and honourable among men, or more anxious to acquire distinction and advancement by his good conduct in his profession." Edward himself advanced from reading law at Cambridge and from a short stint as schoolmaster at Hawkshead Grammar School (with Wordsworth as a pupil) to becoming a fellow at St. John's College, Cambridge, and first occupant of the Denning Chair of Law and a leading counsel in London.

Both Edward and Fletcher have been described as "charming" and as "clever," qualities which would lend themselves to achievement. That there was another side to Fletcher and his siblings can be deduced from the references to their various eccentricities. Edward was "extraordinary in appearance and demeanor"; one of the older brothers, "unstable mentally": and Fletcher, "subject to moods," although any depression was usually short-lived, and he would emerge once again cheerful, alert, and energetic.

Fletcher Christian adapted quickly and well to life on the seas. At twenty-one, when he first signed with Lieutenant William Bligh* on the Britannia, Fletcher was an enthusiastic midshipman recently returned from the Orient on H. M. S. Eurydice. In search of a new assignment to continue his career at sea, Christian had been

2 May 1751 to Anne Dixon, daughter of Jacob and Mary (Fletcher)
Dixon, brought with it the lands and manor of "Moorland Close,"
located in Brigham parish of county Cumberland. It was here that
their children were born and that each child's christening was duly
recorded in the parish register:

- 1. John Christian, christened 27 August 1752, died 1791. He became an attorney who never married.

- 7. Fletcher Christian (the subject of this sketch), christened 25 September 1764, murdered on Pitcairn Island in the South Pacific 20 September 1793. He married Mauatua /Miamiti, whom he renamed Isabella, the daughter of a Tahitian chief.
- 8. Frances Christian, a twin christened 24 August 1766, died 7 September 1766.
- 9. Ann Christian, a twin christened 24 August 1766, died also 7 September 1766.
- 10. Humphrey Christian, christened 23 December 1767, who, as far as is known, died young.

Loss of his father when Fletcher was not yet four years of age undoubtedly affected his personality but is not known to have interfered with his education. He was offered all the advantages accorded the elder sons. His earliest formal training at Brigham School (to which he rode each morning on his pony) prepared him for entry to nearby Cockermouth Grammar School at age nine. There he remained seven years for the well-rounded education expected of a gentleman. Coincidentally, two later poets of note were in attendance there part

Who were the spouses not identified in O'Neal's article? Speculation, clues, answers, proof invited!



MR. FLETCHER CHRISTIAN

Fletcher Christian, whose name has become inextricably tied to that of His Majesty's Ship Bounty, began life in the north country of England. Unlike his attorney father or older brothers who chose professional careers in law and medicine, the adventurous youth at eighteen decided to join the Royal Navy. That choice would lead not only to the travel and adventure he craved but ultimately to the circumstances causing him to lead the mutiny on the Bounty.

"That unfortunate disaster," as Christian came to refer to the mutiny, resulted in his name being both vilified and revered, attacked and defended. The events would be repeatedly dramatized on stage and film, documented and fictionalized in the printed word—in short, become the subject of a romantic saga which has captured the imagination of several generations of readers and audiences.

Fletcher's education, temperament, and family connections were such that the ambitious volunteer could be expected to advance steadily in his chosen field. From the records it is clear that his parents were a conscientious, dutiful couple with the interests of their children at heart. However, only four of the ten children of Charles* and Anne (Dixon) Christian reached adulthood; and their father did not survive to see any arrive at maturity.

Born 12 December 1729, the son of John and Bridget (Senhouse) Christian, Charles Christian died 11 March 1768. His marriage
