### FAMILY ORIGINS

To find the roots of the Mitchell families in Boone County, West Virginia, one must look not only to the British Isles but to the European continent as well. Indeed, the Mitchells with French ancestry settled in the county earlier than did those of Scotish lineage although branches of both groups had homes there before 1850. It was apparently not until the twentieth century that significant numbers of Mitchells unrelated to either of the earlier two lines came into the area.

Establishing homes primarily on Turtle Creek were numerous descendants of Joshua Michel, who arrived from France for military service during the American Revolution and who chose afterwards to remain in Virginia.

Settling on Pond Fork, a more easterly branch of Little Coal River, were some descendants of Archelaus Mitchell, who also contributed to the Revolutionary cause and whose Scotch forebears were among the landed in Colonial America.

Whether originally spelled Michel, Michael, Michiel, Michaux, Mitchel, Mitchell, or with another variation, the surname in West Virginia usually appears as Mitchell—regardless of national origin of the immigrant. Tracing the following genealogies would have been simplified had there been distinctions in spelling. Nonetheless, it has been possible to identify most of the nineteenth century Mitchell residents of Boone County by utilizing all available sources: family traditions, Bible entries, cemetery engravings, articles, manuscripts, correspondence, military papers, and such county records as deeds, vital registers, court minutes, and probate documents.

Special thanks and credit go to several members of the Boone County Genealogical Society who made their notes and files available: Janet Hager, James E. Richardson, and Glenn Roberts, all descendants of Joshua Michel; and Sigfus Olafson, whose expertise and generosity have repeatedly proved of benefit to the author in her genealogical research.

It is hoped that accuracy and completeness have been achieved for the generations presented; if not, corrections and additions are welcomed. No attempt has been made to follow all descendants of Joshua and Archelaus since the emphasis is on those who carried the Mitchell name and, except for the progenitors, on those who lived in Boone County.

## THE FRENCHMAN BECOMES AN AMERICAN

Joshua Michel, born about 1757 near Paris, France, died in Monroe County, West Virginia, at ninety years of age. The transition from French soldier to American citizen followed in due course his decision to stay in the United States after serving with the French forces who came to the aid of the colonists in the Revolutionary War. Minor details of his life and service differ from one account to another but generally agree in major respects.

Left an orphan as a young boy, he was raised by an old couple who assigned him the task of gathering three bundles of sticks for firewood each day. According to reminiscences related to his grandchildren, his mother was killed during a thunder storm along the road to a nearby village, where she had gone early in the evening to do some trading. Found at the foot of an upturned tree shortly after daybreak the following morning, her lifeless form caused his father's frantic despair to give way to a pervasive grief which lasted until death claimed him also a short while later.

At about eighteen years of age Joshua enlisted in the French Army and may have sailed to America on the ship which LaFayette outfitted at Bordeaux in 1777. In all likelihood, though, his landing on America's shores probably did not occur until July 1780, when he is known to have been among the troops under the command of Count Rochambeau. He was still with them in October 1781 at Yorktown, where the British Army under Cornwallis surrendered to the bombardment led by Gen. George Washington and Lt. Gen. Rochambeau.

By the time the Treaty of Peace was finally signed in 1783 and the way cleared for the French soldiers to return to their homeland, Joshua Michel had deserted the French to start a new life for himself as an American. His decision was not without a certain risk if one judges by the veteran's account to his family and retold by his grandson, S. H. Comer, between 1900 and 1910 through the pages of the Monroe Watchman:

Grandfather . . . was travelling up towards the Blue Ridge mountains nearly starved to death. He stopped at a house to get something to eat. The lady put some victuals on the table and while he was eating, she said, "You are a deserter." "No, ma'am, I am just hunting work." "Yes, but you are; I know by those brass buttons on your coat." Then he said, "Give me a knife and I'll cut them off." He gave the buttons to the woman saying, "Don't betray me."

That the bribe was effective is evidenced by subsequent events. Shortly thereafter Joshua Michel married Nancy Ross in Rockingham County, Virginia; and following her death a few years later, he married Elizabeth Stigard 27 December 1788 in Fauquier County, Virginia.

What ultimately prompted the freedom-loving Mitchell (for so his name was spelled by then) to take the Oath of Allegiance at the time he did is not known, but in 1812 he became a naturalized citizen of the United States of America. By then his children had already been born, and some were grown. According to descendants, Joshua's first move to what later became West Virginia was to Pyne's Mountain about 1795. In 1803 he moved to the Flatwoods in Monroe County and settled on a branch called Brier Run, where he had bought a survey of 950 acres of land. There he built a log house, raised his family, and spent the remainder of his days. All his offspring were married in Monroe County.

To the union of Joshua and Nancy (Ross) Mitchell a son and a daughter were born:

- J-I. Thomas Mitchell, a stone mason by trade and veteran of the War of 1812, was born between 1784 and 1788 and died before 1847. He married Margaret "Peggy" Mathews in Monroe County 10 August 1818. Shortly afterwards they settled on the Greenbrier River where the Big Ben Tunnel is now located. Later they moved to what is known as the Flatwoods on a part of his father's original home tract, where he built a large log house which stood for over a century. Eight boys and two girls were born in Monroe County to Thomas and Peggy:
  - J-I-1. Lewis B. Mitchell, born about 1820, married Mary Kountz in 1849. He bought out the other heirs and remained on the family homestead. Four children were born to this union, only one of whom (a son) lived to maturity.
  - J-I-2. George M. Mitchell, born about 1822, married Mary C. Vass in 1847. They had at least one son and two daughters. Although still in Monroe County in 1855, he reputedly "went to California" and died "somewhere out there."

  - J-I-4. Charles Baldwin Mitchell married Lizzie Brown, and they had two sons and two daughters while living in the valley of Peters Mountain.

    Baldwin was killed during the Civil War at Fayetteville, Fayette County, (West) Virginia, in 1861 with his brother Riley at his side when he fell.
  - J-I-5. James "Jim" Mitchell, born 22 February 1828, married 1 January 1878 Caroline V. Riffe, daughter of Joel and Susan (Solmers) Riffe. A teacher, James served in the Confederate forces under Gen. Joseph E. Johnston. He and his wife were living at Rock Camp when he died. They had one son.
  - J-I-6. Henry Mitchell married Ellen Jones and reputedly died as a relatively young man in Braxton County, West Virginia.
  - J-I-7. Alfred or Albert Mitchell, about whom nothing more is known.
  - J-I-8. Thomas Riley Mitchell, known as Riley, was born about 1840 and lived to a great old age. He married 22 December 1868 Nannie Smith, daughter of Jackson and Catherine Smith. Riley and Nannie made their home on the waters of Indian Creek in Monroe County and had five boys and five girls.
  - J-I-9. Angeline Mitchell, born about 1830, married Joshua Harvey about 1848. They moved to the state of Kansas. Before their deaths there

- they had two sons and eight daughters.

  J-I-10. Miriam Jane Mitchell, called Jane, was born

  7 April 1832 and married in Monroe County

  11 September 1856 to Cornelius Bradley, born

  4 November 1834. They had two sons and a
  daughter.
- J-II. Nancy Mitchell, born between 1784 and 1788, married Abraham Cox on 27 November 1817 in Monroe County. Nothing further is known of her or her descendants.

By his second marriage to Elizabeth Stigard, Joshua Mitchell had ten more children, and it is from several\* that many Boone Countians trace their descent:

- J-III. Sarah "Sally" Mitchell, born about 1790, married Charles Cummings in Monroe County in 1808. They were in what later became Boone County in October 1824, when both appear as members of Olive Branch Baptist Church.
- J-IV. Elizabeth A. Mitchell, born about 1792 in Fauquier County, Virginia; married 23 March 1812 Col. John Miller, son of Michael Miller. They and theirs played important roles in the life of Boone County.
- J-V. James Mitchell, born about 1793, possibly in Rock-ingham County, Virginia, was married by Rev. John Chambers in Monroe County 2 May 1815 to Mary "Polly" Miller, daughter of Michael Miller. From their union the Boone County Mitchells of the French progenitor descend. For biographical details and issue, see separate section entitled "Minister—Hither and Yon."
- J-VI. Mary "Polly" Mitchell, born 11 June 1796 near Union, Greenbrier/later Monroe County, died 17 March 1861 in Monroe County; married there 6 January 1814 to Frederick Comer, son of Augustine and Catherine (Cortreen) (Rush) Comer. (See Kith and Kin of Boone County, Volumes I and II, for details about their family.)
- J-VII. Jane Mitchell, born about 1799 in Monroe County, was married there 6 September 1824 to John Comer, also a son of Augustine and Catherine (Cortreen) (Rush) Comer. Some of their descendants established homes in Boone County.
- J-VIII. Katherine "Kate" Mitchell, born about 1800 in Monroe County, died in Boone County; married 25 March 1819 .
  "Fork" John Miller, born in 1801 the son of Daniel,

<sup>\*</sup>Since lineages herein are carried forward only for those retaining the Mitchell surname, it is hoped that the female lines not already covered in previous issues will be published in future articles. The Miller name (derived from the Hessian Müller in this case) was an especially prominent one in the Turtle Creek area, and there were numerous marriages between the Mitchell and Miller families through succeeding generations in Boone County.

- Sr., and Elizabeth "Betsy" (Comer) Miller. "Fork" John joined Olive Branch Church in February 1827 and "Kate" in August 1830 after their move to the vicinity of Turtle Creek. Most of their children married Boone County cousins.
- J-IX. Lucy Mitchell, born about 1802 in Monroe County, was married there 11 December 1824 to John "Jack" Fipps/Phipps. They moved to Logan County, (West) Virginia, and appear in the 1850 United States Census of that county.
- J-X. Susanna Mitchell, whose birth and death dates are not known, married the Reverend James Ellison on 19 January 1822 in Monroe County.
- J-XI. Margaret "Peggy" Mitchell, apparently born in Monroe County, was married there in 1831 to Thomas "Bill" Cox.
- J-XII. Joseph Mitchell, born 11 December 1810, was married three times: 1) in 1830 to Sarah "Sally" Comer, daughter of Frederick and Nancy (Scott) Comer; 2) in 1833 to Elizabeth C. "Betsy" Patterson, daughter of Massey Patterson; and after her death 18 October 1857 he was married 3) on 18 May 1858 to Nancy Harvey, born 20 April 1821, the daughter of Joshua and Sally (Swope) Harvey.

It is believed one daughter was born to Joseph and Sally (Comer) Mitchell:

J-XII-1. Sarah Mitchell, born about 1831, of whom nothing more is known.

From Joseph Mitchell's second marriage to Betsy Patterson, the following nine children were born: J-XII-2. Sarah "Sallie" Mitchell, born about 1835, married Henry Copeland. They had four sons.

- J-XII-3. James Mitchell, born about 1837, moved to the state of Missouri near St. Joseph; married a Miss Dawson, sister of Nannie Dawson who married his brother.
- J-XII-4. Nancy J. Mitchell, born about 1839, married in Monroe County 27 November 1862 Woodrum Mann, born about 1832 in Monroe County. They had no issue.
- J-XII-5. Mary Susan Mitchell, born about 1843, married in Monroe County 26 April 1869
  Anderson Peters Miller, born about 1845, the son of Charles and Mary Miller. They had several children.
- J-XII-6. Clementine Mitchell, born about 1845, of whom there is no further information.
- J-XII-7. Angeline Mitchell, born 8 May 1848, married Andrew L. Halstead 9 November 1865 in Monroe County. They lived for a time in Bluefield but left no children.
- J-XII-8. Martha Mitchell, about whom nothing more is known.

- J-XII-9. Joseph Mitchell, like his brother, moved to a location near St. Joseph, Missouri. He married twice: 1) Nannie Dawson and 2) his first wife's sister, whose given name is not known.
- J-XII-10. Eliza Mitchell, about whom no further information is available.

From the elder Joseph Mitchell's third marriage to Nancy Harvey, three daughters were born:

- J-XII-11. Miranda Mitchell, who married Joshua Canterbury. They had two daughters.
- J-XII-12. Sirena Mitchell, who married Bob Hall.
- J-XII-13. Margaret Mitchell, who died unmarried while still a young woman.

As far as is known, none of Joseph Mitchell's descendants settled in Boone County during the nineteenth century.

All children of Joshua Mitchell are mentioned in his will, dated 6 January 1847 and proved at the May 1847 term of Monroe County Court. Long after death the patriarch was remembered by his heirs as a hard worker who never grew disheartened. He cleared and tended his lands with optimism, for "he had God's word" as guide: By the sweat of the face ye shall eat bread. His religious principles and faith were in the Wesleyan Methodist doctrine, and he believed in keeping the Golden Rule. Although he had no formal learning, he expressed himself well in his adopted tongue and was wont to conduct Bible meetings. Upright, honest, a good citizen and neighbor, he was considered a fine diciplinarian in church and home. That his progeny profited by his example is apparent from their lives.

# MINISTER-HITHER AND YON

The first of Joshua Mitchell's descendants to become an ordained minister was his middle son, James (No. J-V above), born of the second marriage to Elizabeth Stigard. A noted preacher and early "Boone" County resident, James Mitchell's stay in the area was for relatively brief periods—serving as he did churches in many places. Spiritually and genealogically, however, his impact on county life was strong.

Both James and his wife\* Mary "Polly" (Miller) Mitchell ap-

Both James and his wife\* Mary "Polly" (Miller) Mitchell appear on the record as charter members of the Olive Branch Baptist Church when it was constituted on the first Saturday of October 1824, and he was ordained the next year. Church minutes reveal

\*The given name of Rev. James Mitchell's wife has apparently been erroneously listed in several histories: In Henry Clay Ragland's History of Logan County it appears as Elizabeth Miller; in Oren F. Morton's History of Monroe County, West Virginia, it appears as Sarah Miller, as is the case in an anonymous manuscript entitled "The Mitchell Family—Descendants of Joshua Mitchell." In all available documents prepared during her life (marriage, church, and census records), her name is given as Polly Miller, Polly Mitchell, and/or Mary Mitchell; therefore, Polly or Mary is used throughout this article.

that after William A. Wood resigned the pastoral care in late 1830, Olive Branch Church chose "Brother James Mitchell for her pastor," and there he remained about ten years.

Around 1840 the Reverend James Mitchell answered a call from Ohio but soon returned to western Virginia and settled on Buff's Creek, a short distance from Hurricane (which later fell into Putnam County, West Virginia. Through the years he took part in the organization of several churches, among them Forks of Coal in 1834 and Coalsmouth/later St. Albans in 1860. Hurricane Baptist Church, founded in May 1860, chose him as their first moderator.

Responsible for many conversions, Rev. Mitchell was remembered for his persuasive powers in the recollections of Rev. L. E. Peters. "I have often wondered," Peters said years later, "if it was an act of Providence to send the rain and raise the creeks and cause Brother Mitchell to stop at my father's home in order to capture me." Mitchell's last revival meeting at Olive Branch Church was reportedly held in November 1859.

Rev. James and Polly (Miller) Mitchell raised a family of nine children—most of whom married cousins—and the birth dates appear in Bible records still in possession of descendants:

- J-V-1. Elizabeth "Betsy" Mitchell, born 22 January 1816, died 30 December 1860 or 1866; married William Miller, born about 1820, the son of Daniel and Elizabeth (Comer) Miller.
- J-V-2. Joshua Mitchell, born 10 April 1817 in Monroe County, died 22 March 1885 in Boone County; married 15 March 1835 Catherine "Kate" Miller, born about 1818, the daughter of Col. John and Elizabeth (Mitchell) Miller.
- J-V-3. Sarah Mitchell, born 9 April 1819, married 21 March 1837 Rev. James E. Ellison, son of Rev. James and Susanna (Mitchell) Ellison.
- J-V-4. Susannah "Susan" Mitchell, born 17 August 1820, apparently was married in a double wedding ceremony 21 March 1837 to Col. Ezekiel S. Miller, born 21 February 1813, the son of Col. John and Elizabeth (Mitchell) Miller.
- J-V-5. Agnes Mitchell, born 29 March 1822 in Cabell/later Boone County; married Daniel "Forky" Miller, son of Daniel and Elizabeth (Comer) Miller.
- J-V-6. Margaret "Peggy" Mitchell, born 20 February 1824, married in Cabell County 24 May 1842 Peter Billups.
- J-V-7. Michael Mitchell, born 27 October 1825, married in Cabell County 11 September 1847 Elizabeth Garrett. Michael is listed on the 1850 Putnam County census; but since he makes no further appearance in Boone County, his descendants have not been traced.
- J-V-8. Nancy Mitchell, born 19 August 1827, died 9 April 1862; married Jones James Roberts, son of Henry and Oney (May) Roberts.

J-V-9. James M. Mitchell, born 9 April 1829, died about 1907; married 5 December 1855 Mary Louisa Vickers, daughter of Griffin and Virginia (Allen) Vickers.

One historian commented that Bro. James Mitchell must have possessed "preaching blood" or "spirit" for numerous descendants followed in his footsteps. By shortly after the turn of the century there were his son, Rev. Joshua Mitchell; Rev. C. T. Roberts; Rev. J. H. Roberts; Rev. W. J. Roberts; Rev. M. F. Mitchell; Rev. W. W. Nelson, Rev. E. E. Barker; Rev. Clell Miller; and P. A. Mitchell, licentate.

By the early twentieth century other of Rev. James Mitchell's descendants figured prominently among Boone County's professionals: Of those who became doctors of medicine were his son, James D. Mitchell, M. D., and D. F. Pauley, M. D.; at least two became lawyers, F. S. Ellison and C. M. Turley. Several were officials who "held political offices of trust and profit": F. T. Miller and Charles Randolph Mitchell, Circuit Clerks of Boone County; Elmer Nelson, Clerk of the County Court; Rev. W. W. Nelson, County Superintendent of Free Schools; C. M. Turley, Prosecuting Attorney; and St. Clair Miller, Commissioner of Boone County Court.

### RELIGIOUS AND CIVIC LEADER

Rev. Joshua Mitchell (No. J-V-2), the eldest son of Rev. James and Polly (Miller) Mitchell, like his father became a Baptist minister. He joined the Olive Branch Church in September 1844 and was ordained at Mt. Pisgah Church in October 1865. Joshua, named for his grandfather, held the longest pastorate at Olive Branch of any of its pastors prior to publication of the church's history in 1924. At one time he also served as church treasurer. At least the following churches were organized under his labors: Bethel, Left Hand Fork, Bethlehem, and Olive.

His was a social spirit, and it has been said that he came talking and went talking and "everybody was glad to see Uncle Joshua coming." A Justice of the Peace in 1853, he was elected Assessor of Boone County in 1860, but the Civil War prevented his carrying out the duties of the office.

Catherine (Miller) Mitchell shared her husband's faith and was baptized in May 1845. At least eight children were born on Turtle Creek to Rev. Joshua and "Kate":

J-V-2-A. Andrew J. Mitchell, born January 1839, died before 1925; was married in Boone County by John Hager 13 November 1860 to Sally Anne Kessinger, born about 1837, the daughter of Matthias and Cynthia (Cottle) Kessinger. They lived in Ohio for several years before returning to Boone County. Their two sons were born in Ohio:

J-V-2-A-1. Edgar W. Mitchell, born May 1863, married Nan Roberts, daughter of Joseph Roberts. His death occurred 25 January 1903 at hands of lynch mob. Before their separation, the following children are thought to have been born to Edgar and Nan:

J-V-2-A-1-a. Rebecca Mitchell, born 16 September 1882 in Boone County.

J-V-2-A-1-b. William E. Mitchell, born December 1885.

J-V-2-A-1-c. Morton Mitchell, born August 1887.

J-V-2-A-1-d. Millard M. Mitchell, born about 1889 (may be same as child above); married in Boone County 6 March 1937 Violet Ramsey, born 1918 in Lincoln County, the daughter of W. T. and Martha Ramsey.

J-V-2-A-2. Joshua Mitchell, born 21 April 1865 in Jackson County, Ohio; with wife Mary had at least two sons before moving from Boone County:

J-V-2-A-2-a. John Mitchell, born 2 November 1890.

J-V-2-A-2-b. George Mitchell, born 23 December 1892.

J-V-2-B. Sylvester Mitchell, born October 1840, died 1909; married about 1860 Milly Turley, born January 1840 in Kanawha County. There were at least twelve children born to this couple:

J-V-2-B-1. Elverton E. "Vertie" Mitchell, born
August 1862, married 6 December 1905
Mary Etta VanGundy, born about 1884 in
Lincoln County, West Virginia. All
born in Boone County, the following offspring are those of whom there is record:
J-V-2-B-1-a. Samuel S. Mitchell, born

- J-V-2-B-1-e. Clyde Carlton Mitchell, born 24 December 1932 at Low Gap, married at Wharton 24 December 1932 Nina Madeline Cook, born about 1911, the daughter of Ward Cook.
- J-V-2-B-1-f. A son, unnamed, born 25 March 1913 at Powell Creek.
- J-V-2-B-1-g. Ora B. Mitchell, born 22
  May 1914 at Powell Creek,
  married at Wharton 23
  December 1933 Mary Cook,
  born about 1912 in Wyoming County, West Virginia,
  the daughter of Wirt and
  Berlie Cook.
- J-V-2-B-1-h. Agnes Josephine Mitchell, born 30 July 1918 at Greenview, married at Wharton 3 April 1937 Homer Crose, born about 1916 in Rowan County, Kentucky, the son of Willie and Lizzie Crose.
- J-V-2-B-1-i. A daughter, unnamed, born 7 November 1920 at Coal-bloom.
- J-V-2-B-2. Nancy Jane Mitchell, born about 1864 in Boone County. Jane married there on 8 July 1880 Joseph Barker, born about 1861 in Logan County, the son of Benjamin and Adeline (Fry) Barker.
- J-V-2-B-3. Elizabeth A. "Bettie" Mitchell, born 21 June 1866 in Mud Township; married John Kidd, son of Abraham and Adeline
- Kidd, on 15 July 1885 in Boone County.

  J-V-2-B-4. Joshua Mitchell, born in October 1868,
  married 6 April 1899 in Boone County to
  America Miller, born in October 1877,
  the daughter of Oliver and Susan (Miller)
  Miller. At least three daughters were
  born to them:
  - J-V-2-B-4-a. Lula J. Mitchell, born on Turtle Creek 16 February 1900.
  - J-V-2-B-4-b. Martha B. Mitchell, born 29 April 1901 on Turtle Creek; married in Madison 23 April 1926 to Joseph White, born about 1877, the son of Lee White of Logan County.
  - J-V-2-B-4-c. A daughter, unnamed, born 9 November 1902.

J-V-2-B-5. Isaac Mitchell, born April 1871 in
Washington Township, married in Boone
County 1 October 1902 Roxie Coon, born
about 1875 in Boone County. They had
at least the following children:
J-V-2-B-5-a. Opie Dell Mitchell, born
about 1903, married in
Madison 2 April 1935
Rosa Barker, born about
1907, the daughter of

Wirt and Vena Barker.

J-V-2-B-5-b. Ella May Mitchell, born
25 September 1905, married as his second wife
Andrew Jackson Mitchell.
(See J-V-2-C-5.)

J-V-2-B-5-c. Samuel Austin Mitchell, born 24 August 1910. Austin married 11 February 1933 Zella Marie Bell, born about 1913, daughter of Henry and Roxie Bell.

J-V-2-B-6. Martha Mitchell, born 29 December 1873 on Mud River.

J-V-2-B-7. Sarah S. Mitchell, born in Washington District during September 1875. Apparently died young.

J-V-2-B-8. Mary O. Mitchell, born 19 May 1876 in Washington District; married in Boone County 1 November 1892 Cleophas Miller, born about 1868 in Boone County, the son of Caperton and Melissa (Bennett) Miller.

J-V-2-B-9. Sarah Susan Mitchell was born September 1878. Susan married 2 November 1901 as second wife of James M. Miller, born 1866.

J-V-2-B-10. Henrietta Mitchell, born about January 1881, died in an accident 30 March 1883.

Catherine (Miller) Mitchell, who died of dropsy in Boone County 26 August 1882, preceded her husband Joshua in death. He died 22 March 1885 at the home of their doctor son, James, on Indian Grave Branch of Turtle Creek and was buried at the head of Mud River.

#### EARLY PHYSICIAN

James M. Mitchell (No. J-V-9 above), the youngest son of the Reverend James and Mary "Polly" (Miller) Mitchell, was the

first of the line to become a medical doctor and, indeed, one of the first to engage in practice in Boone County.

Still living with his parents in Putnam County in 1850, the 21-year-old James was engaged in farming while pursuing his studies. On 5 December 1855 he married Mary Louisa Vickers, born about 1839 in Kanawha County, the daughter of Griffin and Virginia (Allen) Vickers—and granddaughter of Henry and Phoebe (Rucker) Allen.

Shortly after marriage James Mitchell, M. D., and wife Louisa settled in Boone County, where all their children were born. By 1880, however, they had moved to the Chapmanville District of neighboring Logan County. At least the following children were born to them:

- J-V-9-A. Leonard M. Mitchell, born about 1857, married Mary Frances "Fannie" Smoot 28 November 1878 in Boone County. They later moved from Boone County and probably had more than the children shown below who were born there:

Mitchells and other cousins descended from the French Revolutionary ancestor continued to figure prominently in Boone County affairs during the twentieth century. In fact, their influence has been felt throughout southern West Virginia; and investigation of the records of nearby counties would undoubtedly result in identification of many not mentioned in the foregoing account.

#### THE SCOTCH MITCHELLS

Although descendants of the Revolutionary patriot, Archelaus Mitchell, Sr., spoke proudly of their Scotch heritage, they were equally proud of their long-standing American legacy. Even before independence was declared, Archelaus and his cousins were enthusiastic supporters of the Colonists' cause.

Precisely how he helped his country has been difficult to determine, however, since several of his contemporaries in the same area bore the identical name. But serve he did, if one can rely on family tradition.\*

Archelaus Mitchell's forebears retained business ties with Edinburgh merchants throughout the first half of the eighteenth century. Like so many of his fellow Virginians' dealings, though, his transactions were tied to the land; and is is precisely in the property transfers of Amherst County that even his family affairs can be followed.

Since during his lifetime Archelaus Mitchell, Sr., had provided so generously for his children with gifts of land, slaves, and furniture, the consequences of his dying intestate were not as serious as might otherwise have been the case. His fatherly feelings and the extent of his holdings can be deduced from numerous deeds, portions of which follow:

. . . In consideration of love & tender Affection to my son Bowlin Mitchell I do by these presents give and bequeath unto him and his heirs and assigns forever a negro Man Slave named Pompy [and] a boy about nine years auld named Pompey, also good feather Bed & furniture and Black Walnut Table . . . also for the same Cause and purpose as above mentioned I give and bequeath unto my Daughter Stelley Mitchell a negro woman Slave named Tamny also her Girl Child named Nicey, a good feather Bed & furniture and Black Walnut Desk . . . 15<sup>th</sup> day of July 1796. . . .

Strictly nominal sums (even by that period's standards) were exchanged in some deeds of the senior Mitchell to his sons:

- . . . For the love and affection he bears for his son [Thomas] and the consideration five pounds current money of Virga. . . . 13<sup>th</sup> day of April 1795 . . .
- . . . In consideration of the sum of five Shillings . . . give, grant, bargain, and sell unto the said Archelaus Mitchell Jun. . . . one hundred acres . . . 16<sup>th</sup> day of April 1796 . . .
- . . . in Consideration of the sum of Dollar . . . have bargained & sold unto Thomas Mitchell . . . a Certain Negro boy named Caleb about ten years old . . . ll<sup>th</sup> day of September 1796 . . .

\*Military pension records, muster rolls, pay rolls, warrants, etc. establish the fact that several men by the name of Archelaus Mitchell performed military services in the Revolutionary War or contributed in other significant ways. It has been determined that the above-mentioned Archelaus was not the one who became a sergeant in the Continental Line and who subsequently received a pension. Furthermore, neither Archelaus Mitchell, Sr., (above) nor his son Archelaus, Jr., was one of the three who are known to have received compensation for service in the War of 1812. It is hoped that a definitive source for his service record will become available.

Archelaus Mitchell's name appears on the 1785 tax list of Amherst County, Virginia, as head of family with total of eight "white souls" in the household, one dwelling, and two other buildings. Surviving him at the time of his death there in 1799 were his widow, Hannah,\* and the following offspring:

- A-I. Archelaus Mitchell, Jr., born between 1770 and 1775, married in Campbell County, Virginia, 7 March 1791 Spicey Goodwin. For details of their progeny, see section below entitled "On the Move."
- A-II. John Mitchell, born before 1775; no further information.
- A-III. Patsy Mitchell, born after 1772, married in Amherst County 2 January 1792 John B. Trent. They are known to have moved to Henry County, Virginia, prior to 1820; but no information as to whether they remained there. John B. Trent was son of Henry Trent.
- A-IV. Thomas Mitchell, born after 1774, married in Amherst County 2 January 1792 Eady Trent, daughter of Henry Trent, in a double marriage ceremony with their respective siblings. Descendants not traced.
- A-V. Bowling Mitchell, born between 1776 and 1784, married in Amherst County 30 September 1805 Nancy White, daughter of Arthur White. They were still in Amherst in 1810 but had moved to Botetourt by 1820. It is not known where they eventually settled.
- A-VI. Stella Mitchell, born between 1782 and 1785, married in Amherst County 20 January 1802 William Jones. Nothing is known regarding their migratory pattern.

Much of the Amherst County land to which Archelaus Mitchell, Sr.'s, children became heirs was located on John's Creek on banks of the Fluvanna. It was not too many years following his death, however, that some had sold their property and moved on.

# ON THE MOVE

Archelaus Mitchell, Jr. (No. A-I above), was a man often on the move. Born during the five years preceding the Revolution, he grew to manhood in the formative years of the Republic

\*Following inventory and appraisement of the senior Archelaus Mitchell's estate, the widow Hannah filed for and received the one-third dower of the real and personal estate to which she was entitled as "relict." List of her allotment and other documents filed in Amherst County Court Records reveal pertinent details about the family, but nowhere has Hannah's maiden name yet been found. It has been determined that she was not the Anna Mitchell mentioned as a daughter in the 1808 Botetourt County, Virginia, will of Peter Deyerle; neither was she the Hannah "Nancy" Mitchell, widow, who married John Murrell, Jr., 27 January 1794. Which was the Nancy Mitchell who signed in 1790 with Charles and John Lynch as heirs of Christopher and Edward Lynch?

as the frontiers were expanding. Following marriage in Campbell County, Virginia, 7 March 1791 to Spicey Goodwin, daughter of Micajah and Elizabeth (Burford) Goodwin, the newlyweds established a brief residency in Rockbridge County, Virginia. They then returned to Amherst County, where they resided on John's Creek. Here they remained for awhile even after selling their home and plantation in 1800. Shortly after 1810 they once again moved from Amherst to Rockbridge County and were listed on the 1820 census taken there. As was their wont, they did not remain long, moving soon into neighboring Montgomery County, where several of their children were married.

Yet another move took place before 1830, at which time Archelaus and his son Jordan were living on 300 acres they jointly owned (with their respective wives Spicey and Isabel) at the head of Buffalo Creek in Logan County, "above land of Benjamin W. White" and a corner boundary marked on a large beech with the initials, "J. D. M."

Because of their frequent moves and the destruction during the Civil War of Logan County marriage records, it has been impossible to identify all issue<sup>†</sup> and spouses. Archelaus and Spicey (Goodwin) Mitchell seemingly had twelve children:

- A-I-1. Jordan D. Mitchell, born 7 August 1794 in Rockbridge County, died in 1863 in Logan County; married about 1818 Isabel J. "Ibia" Gore, daughter of Joseph and Martha (Pine) Gore.\* For details on their family, see section below entitled, "Civilian Soldier."
- A-I-2. A daughter born 1796-1800, possibly Polly Mitchell who married in Montgomery County, Virginia, 23 August 1825 Samuel Davis.
- A-I-3. A daughter born 1796-1800, not yet identified.
- A-I-4. A son born 1800-1810, possibly Archelaus Mitchell who married Betsy McKendry during 1819 in Rockbridge County.
- A-I-5. Samuel Mitchell, which one has not yet been ascertained—possibly the one who married Rebecca Niceley 17 April 1824 in Amherst County or the one who married Eliza Ann Bryant 18 December 1829 in Amherst County. Both these Samuel Mitchells had southern West Virginia connections, the one with wife Eliza Ann appearing in Lincoln County, West Virginia, in 1870; the one with wife Rebecca having a son who married in Cabell County, West Virginia.
- A-I-6. A daughter born 1800-1810, not yet identified.
- A-I-7. Another daughter born 1800-1810.
- A-I-8. A third daughter born 1800-1810.

- A-I-9. A daughter born 1810-1815, probably the Spicey Mitchell who, at over 21 years of age at marriage, became the wife of John Myers 5 March 1835 in Montgomery County, Virginia.
- A-I-10. Another daughter born 1810-1815, probably Matilda or Mahala Mitchell who, at over 21 years of age at marriage, became the wife of William Sublet 18 November 1834 in Montgomery County. Jabez Leftwich and Micajah Mitchell were bondsmen.
- A-I-11. Gustavas A. Mitchell, born about 1815 in Montgomery County; married there 1) Agnes Eakins on 15 October 1835; after her death he married in Pulaski County 2) Sarah K. Galbreath on 1 June 1854. By 1857 they were living in Smyth County. Because of the span of years between the oldest and youngest two boys in his 1850 Montgomery County household, it is possible that Gustavas had another marriage between the two given above. He was living alone with the following three boys in 1850:

  A-I-11-A. Caswell C. Mitchell, born about 1836.

  A-I-11-C. Charles Barnett Mitchell, born about 1848.
- A-I-12. Micajah G. Mitchell, born about 1819, probably in Rockbridge County; married about 1841 Frances Elkins, born about 1829, the daughter of Absolom and Mary (Dobbins) Elkins. They moved about 1825 from Montgomery County to Logan County; by 1850 they were in Boone County; and before 1855, back in Logan County. At least eight children were born to them:

John Jackson Mitchell, born 25 November 1842 in Logan County; married in Kanawha County twice: 1) on 20 September 1866 to Eliza Johnson, daughter of David and Cynthia (Hazlett) Johnson; after Eliza's death 30 June 1868, he married 2) Mary Agnes Holcomb, born 13 September 1846, the daughter of Norman and Lucinda (Anderson) Holcomb.

To the first union two children were born: A-I-12-A-1. Emmeline Mitchell, born 5 July 1867.

A-I-12-A-2. John M. Mitchell, born 30 June 1868.

Prior to 1883 the following children had been born to the second union:

A-I-12-A-3. Lorenzo Dow Mitchell, born 12 May 1870.

A-I-12-A-4. James Henry Mitchell, born 20 March 1873.

A-I-12-A-5. William Averill Mitchell, born 2 August 1876.

A-I-12-A-6. Floyd Chapman Mitchell, born 16 July 1879.

A-I-12-A-7. Charles Leonidas Mitchell, born 4 July 1882.

By 1880 John Jackson Mitchell and family were living in Lincoln County.

A-I-12-B. Archelaus M. Mitchell, born about 1844.

A-I-12-C. Mary Anne Mitchell, born about 1847.

A-I-12-D. Andrew W. Mitchell, born about March 1850, apparently in Boone County, where his parents were then living; may have died before 1860.

A-I-12-E. Burwell C. Mitchell, born about 1852 in Boone or Logan County.

A-I-12-F. Emily Jane Mitchell, born 20 February 1855 in Logan County on Huff Creek.

A-I-12-G. Rushd Floyd Mitchell, born about 1858.

A-I-12-H. Sarah Elizabeth Mitchell, 8 December 1860.

Whether Archelaus and Spicey Mitchell moved again after selling in April 1837 part of the Logan County land "owned and occupied by them" or whether they died shortly thereafter is not known. In spite of the many moves they did make, as far as can be determined they never lived "across the ridge." It would be sons and grandsons who would make the moves—however fleeting—to Boone County territory.

#### CIVILIAN SOLDIER

Jordan D. Mitchell, the eldest son of Archelaus and Spicey (Goodwin) Mitchell, accompanied his parents on the moves which ultimately took them to southern West Virginia. Born 17 August 1794 during his family's first brief residency in Rockbridge County, Jordan was nineteen years old when, at the time of their second sojourn, he volunteered at Lexington, Virginia, 1 March 1814 as a private in the armed forces.

Pvt. Mitchell served in the War of 1812 under Captain John McMullen in a company of light infantry with the 8th Regiment of Rockbridge County attached to the 4th Regiment Virginia Militia commanded by Major Charles F. Mercer. His was an enlistment typical of the times—an answer to his country's call to join with other compatriots in bearing arms until the military crisis had passed.

After returning from service, Jordan married about 1818 Isabel J. Gore, born 11 December 1799, apparently the oldest daughter in the large family of Joseph and Martha (Pine) Gore. Their move to the head of Buffalo Creek was between 1820 (when they were counted in the Rockbridge County census with one boy under ten) and 1830 (when they were living in Logan County with their growing youngsters). By contemporary accounts they were "people of honor and high standing." Theirs was a quiet life devoted to tending their lands and family. In June 1850 they added acreage on Rum Creek to that which they already owned.

Jordan and Isabel Mitchell had at least eleven children:

- A-I-1-A. A son, born about 1819; may have been Henry Mitchell or Harrison Mitchell.

Mitchell, born about 1821 in Rockbridge County, Virginia, was married twice: 1) about 1842 to Harriet McGinnis, born about 1821, the daughter of Pyrrhus and Betsy (Barnes) McGinnis; after Harriet's death about 1851 2) on 6 September 1855 in Raleigh County, West Virginia, to Jane Lewis, born about 1830 in Carroll County, Virginia, daughter of Charles and Jane Lewis. A teacher and farmer, James left children by both wives when he died between 1873 and 1880, probably in McDowell County, West Virginia. James and Harriet had three children about whom little is known:
  - A-I-l-B-l. Marietta Mitchell, born about 1844.
  - A-I-1-B-2. Albert Mitchell, born about 1847.
  - A-I-l-B-3. Lewis Mitchell, born about 1849. He is thought to be the one living with wife Jane in McDowell County in 1870.
  - To James and Jane eight children were born:

    A-I-1-B-4. Buena Josephine "Josie" Mitchell,
    born about 1859, died about 1930's
    at Gilbert, in Mingo County, West
    Virginia; married in 1880 John Henderson "Hence" Cook.
  - A-I-1-B-5. Jane Lavett "Lav" Mitchell, born about 1861, married as his second wife James Edward Browning, born 1 April 1860 in Logan County, the son of Oliver and Amanda (White) Browning.
  - A-I-l-B-6. Charles F. Mitchell, born about 1863, did not live to maturity.
  - A-I-1-B-7. John S. Mitchell, born about 1865, died before 1943; married once, possibly in Pittsburg, Alleghany County, Pennsylvania.
  - A-I-1-B-8. Harriet Emaline Mitchell, born 29 April 1868, died 4 August 1943 in Huntington, Cabell County; married 11 December 1885 in Logan County Charles Franklin Vance, son of Charles Harrison and Rebecca Jane (Christian) Vance. They were called Emal and Franklin.
  - A-I-1-B-9. Henry Bascomb Mitchell, born about 1869, in McDowell County, was married there at Welch 1 April 1895 to Fannie Hatfield, born about 1874 in Pike County, Kentucky, the daughter of Johnson and Polly Hatfield.
  - A-I-1-B-10. Elgin Whitley Mitchell, born about 1871 in McDowell County, was married twice:

- 1) in Wyoming County 20 December 1899 to Anna Brooke Blankenship, born about 1871, the orphaned daughter of J. Allen and Sarah Blankenship; after Brooke's death 18 August 1909 of tuberculosis in Logan County, Elgan was married 2) on 28 December 1911 to Lillian B. Barnard, daughter of Damon Leonadus and Julia Ellen (Wood) Barnard. Elgan died of cancer 20 January 1934 in Cabell County. He had two children by his first marriage and six by the second.
- A-I-1-B-11. Marinda Alice Mitchell, born March 1874, married in Wyoming County 17 June 1897 Everett Ross Christian, son of Andrew Patterson and Luvenia (Toler) Christian.
- A-I-1-C. John D. Mitchell, born about 1823, as was his wife, Martha A. "Mattie" Massey, to whom he was married about 1849. They are thought to have had nine children:
  - A-I-1-C-1. James H. H. Mitchell, born about 1851.
  - A-I-1-C-2. Edmond P. Mitchell, born about 1853.
  - A-I-1-C-3. Jordan Jackson Mitchell, born 29 June 1854 in Raleigh County, married in Boone County 11 June 1872 Frances Charlton, born about 1857 in England.
  - A-I-1-C-4. Robert Dickson "Perkins" Mitchell, born 25 December 1855 in Raleigh County.
  - A-I-1-C-5. Florentine S. Mitchell, born about 1858.
  - A-I-1-C-6. Ulysses McDonald Mitchell, born on Buffalo 8 September 1860.
  - A-I-1-C-7. Mary Mitchell, born about 1863.
  - A-I-1-C-8. An unidentified child who did not live to maturity.
  - A-I-1-C-9. Patrick Mitchell, born about 1870.
- A-I-l-D. Mary Ann Mitchell, born about 1825, died before March 1884 in Logan County; married as his first wife Patterson Christian, son of James Pine and Anne (Moore) Christian.
- A-I-1-E. Archelaus P. Mitchell, born about 1825, fathered ten children by his wife Harriet E. before he was murdered in Civil War strife:
  - A-I-1-E-1. Baxter C. Mitchell, born about 1849.
  - A-I-1-E-2. Augustus Crockett Mitchell, called Crockett, was born February 1850 in Logan County and married 13 July 1868 in McDowell County to Margaret Cline, born about 1850, the daughter of John and Mary Cline.

- A-I-1-E-3. Talbert R. Mitchell, born about 1852.
- A-I-1-E-4. Alexander Mitchell, born about 1853.
- A-I-1-E-5. James Radford Mitchell, born 13 January 1855 in Logan County although birth was registered in Raleigh County.
- A-I-1-E-6. Jordan/Gordon Mitchell, born about 1857.
- A-I-1-E-7. Nancy Jane Mitchell, born about 1858.
- A-I-1-E-8. Cornelius Mitchell, born about 1860.
- A-I-1-E-9. John Mitchell, born about 1861.
- A-I-1-E-10. Ann Mitchell, born about 1864.
- A-I-1-F. A son born between 1830 and 1835, who had apparently died before 1850.
- A-I-1-G. A daughter born between 1830 and 1835, who also had either died or married before 1850.
- A-I-1-H. Spicey Elizabeth Victoria Mitchell, born 6 January 1833, died 2 September 1889 in Logan County; married there 29 June 1854 to Curtis Ballard, son of Rhodes D. and Mary (Perry) Ballard.
- A-I-1-I. Isabel J. Mitchell, usually called "Ibbie" by her friends, was born 11 March 1837. To her family she was a loving but "matriarchal type" who "worked harder than her hired help" in performing household tasks. She died 13 June 1915 in Logan County. She was married there 19 February 1854 to Paren C. Christian, son of James Pine and Anne (Moore) Christian.
- A-I-1-J. Micajah Goodwin "Cage" Mitchell, born in September 1840 in Logan County, was married twice before his death about 1922. He married 1) on 7 June 1866 in Boone County Clarinda White, daughter of Micajah Goodwin and Matilda (Workman) White; and 2) on 27 October 1906 in Mingo County Cora Toler, widow of Walter Morgan and daughter of Harrison and Sarah (Blankinship) Toler. For details concerning his children, see section below entitled, "Farmer-Preacher."
- A-I-1-K. Emaline C. Mitchell, born about 1844 in Logan County, married in Pond Fork, Boone County, 23 October 1865 Anthony Jarrell, son of Daniel and Hannah (Workman) Jarrell. See two-part series in Kith and Kin of Boone County, West Virginia, for articles on the Jarrell family.

Just as members of his own generation had scattered far and wide so, too, did Jordan D. Mitchell's children and their families settle in different communities—usually in southern West Virginia, however.

Ill health of the aging couple undoubtedly played a part in the tendency of their youngest to go as teenagers for extended stays with relatives. In her declining years, Isabel made her home with son "Cage" at Bald Knob, where she died of palsy 20 March 1866, three years after her husband Jordan's passing. Both are said to have been buried at the White family cemetery near present-day Wharton.

#### FARMER-PREACHER

Like so many nineteenth century preachers, Micajah Goodwin Mitchell (No. A-I-1-J) combined farming with preaching. When asked to state his occupation, he was as likely to say "farmer" as "preacher," for he considered each a "calling" of the Lord.

He found he had to forego both temporarily when he served in Company H, 36th Regiment of Virginia's Confederate forces during the War Between the States. He returned without injury ready to settle down in the region of his birth.

As had his father-in-law a generation earlier, "Cage" Mitchell apparently followed the old "courtship route" from the head of Buffalo across the ridge and down the road along Jasper Workman Branch of Pond Fork to court a Boone County "gal," his hazel-eyed second cousin "Rindy." After their marriage 7 June 1866, the couple decided to make their home there.

Micajah Goodwin "Cage" Mitchell first married Clarinda
"Rindy" White, born 30 June 1846 at Pond Fork in what was
later Boone County, the daughter of Micajah Goodwin and
Matilda (Workman) White. (See "The White Families of Boone
County" in Kith and Kin of Boone County, West Virginia,
Volume II for the White genealogy.) Following Clarinda's
death 20 October 1899 at Christian in Logan County, Micajah
married secondly in Mingo County 27 October 1906 Cora (Toler)
Morgan, the widow of Walter Morgan and daughter of Harrison
and Sarah (Blankinship) Toler.

By his first marriage to Clarinda, Micajah Mitchell had eleven children, several of whom were born in Logan County after the parents had left Boone to live near Elk Creek kin:

Clement Goodwin Mitchell, born 10 December 1867 A-I-1-J-1. at Pond Fork, died 31 July 1945 at Kissler in Logan County. This Methodist lay minister who contracted work in the mines married 22 July 1896 Dorothy Perry, born October 1872, daughter of Green Lee and Penelope "Nellie" (Vance) They were the parents of nine children: A-I-l-J-l-a. Archie Lee Mitchell, born 30 May 1897 at Elk Creek in Logan County, died 1 October 1925 there; married Lula Morgan. One daughter. Leonard Sherman Mitchell, born A-I-1-J-1-b. 3 November 1898 in Logan County, died at about age 50; married Sadie Toler. No issue.

- A-I-1-J-1-d. Zetta Dale Mitchell, born 4
  October 1902 in Boone County,
  married 29 April 1929 Dewey
  Davis, son of Eff and Virginia
  (Donahue) Queen. Dewey carried
  his step-father's name. No issue.
- A-I-1-J-1-e. Prince Albert Mitchell, born 3
  August 1904, married March 1936
  Bessie Kennedy, born 15 October
  1915, daughter of Floyd and May
  (Walls) Kennedy. Six children.
- A-I-l-J-l-f. Emerick Mitchell, born 4 February 1906 in Logan County, married Alma Endicot. Two children.
- A-I-l-J-l-g. Nevel Howard Mitchell, born ll March 1909 in Logan County, married Margie White. One daughter.
- A-I-1-J-1-h. Haulsley Staton Mitchell, born 16 September 1917 in Logan County, died 5 August 1918.
- A-I-l-J-l-i. Charles Evert "Bill" Mitchell, born 18 August 1918 in Logan County, married Emma Browning, daughter of Sherman and Edna (Blankenship) Browning. Two children.
- A-I-1-J-2. Nevel Sherman Mitchell, born in January 1869 in Boone County, died in Beckley about 1912; married 22 January in Logan County Elizabeth J. "Lizzie" Stanley, born October 1873 in Raleigh County, the daughter of John Anderson and Martha Briscoe (Hollandsworth) Stanley. Lizzie died in 1935 at Beckley in Raleigh County. The first of their seven children was born in Logan County and all the others, in Raleigh County.
- A-I-1-J-3. Emma Lodosky Mitchell, born at Pond Fork in Boone County during May 1870, died about 1896 on Elk in Logan; married as his first wife 22 September 1886 Albert Leander Christian, born also in Boone County on Big Coal River 15 April 1865, the son of Paren C. and Isabel J. (Mitchell) Christian. After Emma's death, Albert married secondly Sarah Alma Perry, daughter of Andrew J. and Mary (Lester) Perry. Albert and Emma had five children.
- A-I-1-J-4. Caroline "Tiney" Mitchell, born about 1872, died June 1906; married 15 September 1905 Luther Ferrell, born 24 March 1885, the son of Oscar

Fenton and Zerilda Caroline (Christian) Ferrell. No issue. Luther later married Mahala Grimmett.

- A-I-1-J-5. Eva Mitchell, born on Little Coal in Boone County 29 July 1873, died on Reedy Creek in Wyoming County 17 May 1963; married there 14 September 1898 Andrew Jackson Walls, son of Wilburn Harman and Tassa (Lester) Walls. Their four children were born in Wyoming County.
- A-I-1-J-6. Jordan Mitchell, born about 1876 in Boone County, died at age nineteen unmarried.
- A-I-1-J-7. Eliza Jane Virginia "Jenny" Mitchell, born in March 1877 in Crook District of Boone County, married in Logan County 17 August 1900 Van Doren Browning, born about 1871, the son of Isaac E. and Mary Ann (White) Browning. Their five children were born in Logan County.
- A-I-1-J-8. George Doliver Mitchell, born at Fields Creek in Kanawha County 29 October 1879, died in Cabell County 16 May 1973; married in Logan County 9 June 1906 Hattie Bradbury, daughter of P. Dexter and Sarah Ann "Yantee" (Spratt) Bradbury. They had six children.
- A-I-1-J-9. Dora Mitchell, born about 1881, died at age seventy-six in Gilbert, Mingo County; married 1) Monroe White, son of Benjamin Harrison and Nancy (Stafford) White, and 2) Yeager Hatfield. Dora had three children by each husband.
- A-I-1-J-10. Martha Mitchell, birth date unknown, died at about fourteen years of age.
- A-I-l-J-ll. Myrtle Mitchell, birth date unknown, died at about three years of age.

Six more children were added to the already large family of Micajah Goodwin Mitchell through his second marriage to Cora (Toler) Morgan. All were born in Logan County:

A-I-1-J-17. John Mitchell, born about 1915, died as an infant.

As he grew older, Micajah Goodwin Mitchell continued to enjoy the admiration of family and friends alike. In his ministry at revivals throughout southern West Virginia, he was noted for being as entertaining as he was instructive, "a remarkable man." With such a captivating personality, it is no surprise that he was called on often to officiate at weddings in the area.

Although never moving much outside a 25-mile radius, Cage Mitchell's homes were located in the several neighboring counties of Logan, Boone, Kanawha, Wyoming, Mingo, and McDowell. It is to even more far-flung counties that one must now look to follow the Mitchells who are still "on the move" around West Virginia and the nation.

#### THE NEW MITCHELLS

Because of the late nineteenth century dispersion of Mitchell families, it has sometimes been difficult to determine if the twentieth century newcomers were, in fact, new lines or actually cousins rejoining the fold—descendants of either Joshua Mitchell or Archelaus Mitchell, colonial ancestors.

The most common birth places of the new arrivals after 1900 were Lincoln, Logan, and Putnam Counties; but there were also Mitchells who migrated to Boone County from West Virginia's Jackson, Fayette, Kanawha, McDowell, Mason, Wyoming, and Raleigh Counties as well as from Virginia's Patrick, Scott, Washington, and Buchanan Counties.

From wherever they have come or for however long they have stayed, the Mitchell contributions to the community have been lasting ones.

### MORE ABOUT THE MITCHELLS OF FRENCH DESCENT

## by Ruth Williams Cornell

The information given here is an addition to the Mitchell lines which was so excellently done by Agnes Branch Pearlman in Kith and Kin, Vol. V, published April 1979. This article will expand the Freeman Dowdy Mitchell line # J-V-2-G, page 108 of Vol. V Kith and Kin.

Freeman was born 12 January 1855 in Boene County. He was the son of Rev. Jeshua Mitchell and Katherine "Kate" (Miller) Mitchell; the grandson of Rev. James and Elizabeth (Miller) Mitchell; the great-grandson of Joshua Mitchell, who came from France, and Elizabeth (Stigard) Mitchell of Menroe County.

Freeman studied "Doctor" books and served as a local decter in Boone County. When the West Virginia Legislature passed the law requiring all doctors to be licensed, Freeman neglected to purchase his for the minimal fee of \$10. or \$15. Freeman was to regret this the rest of his life. During his life he also worked as a merchant, a farmer, and also a coal miner. Politicians used Freeman to help with their campaigns premising that they would help him obtain his medical license. However, they forget him as soon as the elections were over.

Freeman married Agnes Jesophine Griffith on 1 April 1878. She was the daughter of John and Harriet (Lacy) Griffith. The

coremony was performed by the Rev. Joshua Mitchell.

Agnes was also interested in medicine. She served as a midwife in Boone County. She delivered many of her grandchildren. Among these she delivered were: Martha (Snodgrass) Taylor; Josephine (Asbury) McDerment; all of Alice Hodges' children except Emmel; and Carcil and Willard Mitchell.

Freeman died in Kanawha County the fifth of September 1930. Agnes didd the 23 of October 1934 at Hernshaw, Kanawha County after picking a "mess" of greens for her som-in-law, Danny Snodgrass. Agnes was living with Danny and Elsie (Mitchell) Snodgrass at the time of her death. Aunt Elsie told me that Agnes had been se industrious that her children were clothing patched by grandmether Agnes for more than a year after her death which teek place during the depression.




Bias Cometery on Turtle Creek.



Annie and Carrie Mitchell walked with their brother, Horton Mitchell, and Rackel Miller late in the evening of Oct. 2, 1900 to the home of the Rev. Hewever, the friends and relatives discovered where they were staying about the fifth night and gave them the belated serenading.
