To sonin-law Joshua Janock, 10 acres "in lieu of a cow James Pine left for his wife, which cow is long since dead." Rest of estate is left to his wife for life and then to his sons Richard and Thomas, and his daughter Rachel. (not dated) Witness: Joseph Smith Proved June 13, 1683

Thamason Ellison - Whereas I, Thomason Ellison, widow, of Hempsted on Long Island in Queens County having a certain estate left by my huband Richard Ellison dec. for my maintanence during my natural life, after which by my husbands will the said estate is to be divided amongst our three youngest children Richard, Thomas and Rachel. By reason I find myself uncapable to manage the said estate for my own comfort and the best advantage thereof I do therefore see cause and have set out and disposed unto my son-in-law Samuel Pine a certain lot of meadow lying on the south side on a neck coled washburns neck bounded on the west by the meadows of Timothy Holsted. To all Christian people to whom these may come, greeting. Know yea that I, Susannah Atkinson, of the township of Mansfield in the county of Burlington and state of New Jersey, widow, being at this time in reasonable health and of sound and perfect mind and memory, blessed be to God. For the same and all others his mercies do this 4th day of October in the year of our Lord 1794, make constitute and ordain this, my last Will and Testament in wording, in manner and form as followeth, that is, today:

First and principally I recommend my soul to God, who gave it and my body to the earth to be buried in a decent Christian like manner at the descretion of my executor herein after named.

Secondly, as to the worldly estate where with it hath been pleased God to bless me with in this world, I will and devise the same in the following manner: That all my just debts and funeral charges be first paid and discharged.

Thirdly, I give all my wearing apparel unto my daughters that shall be living at the time of my decease to be equally divided amongst them, Elizabeth Ellison excepted, she having been provided for before. And as to the remainder of my personal estate, if any there be, I give in the following manner.

To Lydia English, to the children of John Ellison, dec. their father share to Susannah Ellis. To the children of James Ellison, dec. their fathers share. To Joseph Ellison, to Elizabeth Ellison, to Hannah Beck, and to Ezekial Ellison. That is to say, to have each share and share alike the children of John Ellison and James Ellison to have only two shares amongst my surviving children. And if any of my aforementioned children should be dead at the time of my decease, then the share given to the parent shall be equally divided amongst their surviving children. And if any of the aforesaid legaties do not make legal demand of their in three years after my death it shall be forfeited to them and equally divided between them that do. And likewise, it is of land on which I now live with my will that the \_ of David King be for the sole use and benefit of my daughter Hannah Beck whilst she remains the widow of Asa Beck and live on it . First and principally I give and recommend my soul in the hands of God that gave it and my Body to earth to be buried to the discretion of my Executor herein after named and as to the worldly estate it hath pleased God to bless me with I am willing to give, devise and bequeath to my wife and children in the manner and form as followeth:

I give my son James Ellison five shillings, he being before by me advanced.

I give my son Joseph Ellison five pounds sterling, he being before me advanced.

I give, devise and bequeath to my son John Ellison that part of my plantation laying on Hands Creek that contains all the improvement, excluding the bottom cleared and fenced, I mean all that part of said land that lays on the sun rising or East side of said creek, all which piece or parcel of land I give to him my son John Ellison, his heirs and assigns forever, he being subject to pay one half of the legacies this will contains.

I give Asa Ellison five shillings, he being before by me advanced.

I give, devise and bequeath to my daughter Ann Ellison the upper part of my plantation laying Hands Creek, all that lays above the third fording in the fork of the creek, all of which piece or parcel of land I give to my daughter Ann Hayes her life and then to ascend to her son John Hayes, he not living to the age of 21 to ascend to her next surviving heir to their heirs and assigns forever.

I give Ruth Ellison five shillings.

I give, devise and bequeath to my daughter Marey Paul that part of my plantation laying on Hands Creek that towards the sun setting or West side of the said creek extending from the loc Sine to the upper end of the Hickory Bottom including the Bottom Field, all which peice or parcel of land I give to my daughterMary Paul and her husband, paying one half of the legacies, her life and here to ascend to her son John Paul if he lives to

age of 21 if not to ascend to her next surviving heir, their heirs and assigns forever. I give my wife Ann Ellison what the law allows her and all the rest of my personal estate I ordain to be equally divided among my children.

I also nominate and appoint my true and trusty friend John Ellison and Isaac Paul to be Executor of this my last Will and Testament making nul and void all former Wills and making this and only this to be my last Will and Testament. Inwitness whereof I have hereunto set my hand and seal this 12th day of August in the year of our Lord one thousand seven hundred and eighty eight - 1788.

## ELLISON

"Lawrence Ellîson was an early settler of Long Island, N. Y., he died in Hempstead, Long Island in 1664. He had three sons, Richard, Thomas and John." This John was probably the one listed below, the ancestor of the Ellisons who settled in southern Virginia, Greenbrier and Monroe Counties in 1771.

John Ellison, born@1695, married Susannah( maiden name unknown) @ 1725 Burlington County, New Jersey. He died 1761 in Mansfield Twp., Burlington Co., she died 1795. Their children were:

James Ellison I, 1735-1791, married Anne English Addis, widow of Thomas Addis, daughter of William English. They settled in Greenbrier Co., Va. 1771. He died December 1791 at his farm on Bradshaw Run Monroe Co., Virginia. Their seven children were:

Numerous articles are found in the county histories about the Ellisons and all of the descendants.

Son # 1, James II and son # 4, John, are listed in the DAR Patriot Index, soldiers of the Revolution, conflicting dates are stated. It is possible that the Joseph listed is son # 2.

My research concentrated on son # 3, Asa Ellison Sr., as his line connects to the Neely, Christian, Harper lines of Summers, Fayette and Raleigh Counties. A previous article gives this line of descent. ELLISON

James Ellison, born 1735 New Jersey, son of John and Susanna Ellison, married February 11, 1758 New Jersey, Anne English Addis, a widow, daughter of William English. They moved, with their seven children, four sons and three daughters, from Mansfield, Burlington County, New Jersey to Greenbrier County (W) Virginia @1771.

Numersous articles are scattered throughout the histories of the southern counties of Va., the area now West Virginia, about the descendants of this couple. In this article we will pursue the line of Asa Ellison Sr. and his son, Asa Ellison Jr.

Asa Ellison Sr. born @1760, son of James and Anne Ellison, in Mansfield, Burlington County, New Jersey, moved to the Greenbrier area, later Monroe County, when about eleven years old. He married Elizabeth Kilpaterick December 17, 1782 Greenbrier County and Asa Ellison, Jr, is one of the proven children of this marriage. Records of the death date of the first wife, llizabeth Kilpaterick, have not been found, however, March 19, 1805 a bond was made by Asa, Sr. to marry Elizabeth Pennington. Asa, Sr. married his second wife April2, 1805, in Momroe County, Virginia. The last record for him in Monroe County, Va. is a deed of sale, Sept. 3, 1807 for 62 acres on Fitzpatericks Run near Indian Creek. By 1808 the family had arrived in Whitley County, Kentucky.

Asa Ellison Jr. born @1784 Monroe County Virginia, son of Asa Sr. and his first wife Elizabeth Kilpaterick, took out a bond to marry Mary "Polly" Tuggle, March 19, 1805 Monroe County, Virginia. They were married March 26, 1805. (This is not to be confused with his father, Asa Sr., who took out a marriage bond the same day and married for the second time April 2, 1805.) The marriage bond states "You may give license for my Polly Tuggle and Asa Ellison", signed Thomas McDaniel and Sealy McDaniel. This was probably her mother and step-father. No other record of her parents has been located.

Asa Ellison Jr. and Mary "Polly" Tuggle Ellison lived andraised their family on Little Pipestem Creek in Pipestem, Giles County, Virginia(Mercer County and 1871, Summers County West Virginia).

Asa died in 1846. Mary "Polly", born @1784 in Virginia is listed as a widow in the 1850 Mercer County Census, age 64; daughter Mary A. age 26, insane, born Va.; son William T. age 22, born Virginia. Agter the marriage of son William T, in 1855, she and her afflicted daughter, Mary Ann, lived in his home.

The heirs of Asa sold 150 acres, on Little Pipestem Creek, to William M. Meador, Oct. 10, 1853. Records of the transaction are recorded in Princeton, Mercer, County, W. Va. and signed by Polly Ellison, wife; James Ellison, wife Polly; Lark T. Ellison, wife Nancy; Asa M. Ellison; William T. Ellison: Emeline Ellison Meador, wife of Isaiah Meador.
