My will is that what ever debts I owe to any man be first payd out of my estate, and the residue of my estate I doe dispose of as followeth;

l ly; I give unto my deare and loving wife the one halfe of my whole estate whether in housing lands cattle debts due to me from any or moveables or what ever else is mine; and this to be hers to dispose of as she shall see cause either in her life time or at her death.

2 ly; I give to my eldest sonne Isaack Morrill a double portion of the other halfe of my estate to be payd to him at the age of one and twenty years or day of marriage

3 ly; The rest of the sayd halfe of my estate I give unto my other five children, Abraham, Jacob, Sarah, Moses and Lidda Morrill and to be equally divided betweene them and to be enjoyed by them as they come to the age of one and twenty yeares or at the day of marriage.

The widow Sarah Morrill married Mudgett, 8 Oct. 1665. He was a "shipwright"; he served for Abraham Morrill as a soldier in the Narragansett War, 1675; was a householder" of Salisbury in 1677; freeman 1690.

An authority has said the descendants of the ancient trainer, Abraham Morrill, in every generation have been noted for their enterprise, whether in iron, fish, cloth, nails, coasting vessels, farming or trade.

In Cambridge Abraham Morrill was proprietor of Cambridge and resided on the west side of Brighton Street, near the spot occupied by the old Porter Tavern.

In 1640 he removed to Salisbury where he was an original proprietor. In 1650 he was one of the four richest men in town. 9 He had a grant of land in the first division in Salisbury, Mass. in 1640 and again in 1644 and 1645. His name is signed to a petition of the inhabitants of Salisbury in 1658. His home was on the "Green". On 25 Jan. 1642 sixty acres of land were granted to him and Henrie Saywood to build a Cornmill. No other mill was to built so long as this one ground all the corn the people needed. This mill was situated at what is now called the "Mills" Amesbury. He is believed to have moved from the "Green" and owned and occupied a house on Bailey's Hill, Amesbury, "a most slightly place taking in the sinuous Merrimack and Pipe-Stave Hill to Deer Island, while, at its foot, among the ancient elms, nestle the hamlets of Pointshore." The cellar of his house is still visible.

One of the peculiarities of the Puritan code of laws is shown in the record of Abraham Morrill's having been fined in 1741 for "selling his time to a servant." Possible this servant was a prisoner of war.

At his death he owned four guns. The death of Abraham Morrill, Mr. Morrill says in his history of Amesbury, Mass. "one of the most prominent men in the old town, may with propriety be mentioned here as his descendants have helped to people the town. • he was one of the first to settle the new territory.

Whittier in his poem to Quake Morrison makes the latter say:

"Ensign Morrill and his son,

See the wonders they have done.

Roberts in his History of the Ancient and Honorable Artillery Co. says, "The family of the ancient trainer, Abraham Morrill, through long generations has been noted for its enterprise, whether in iron, fish, cloth, nails, coasting vessels, farming or trade. In the business history of of Salisbury and Amesbury, Massachusetts, the ancient and honorable soldier of the Artillery Co. and his numerous descendants have made a noble record.

Subject; MAJOR CALEB GIBBS - GENEALOGY

Dear Jim;

Your participation at the Massing of the Colors was greatly appreciated. At the request of the National Society, S.A.R. I am writing an article about the January 17th earthquake - to put it in an SAR perspective, I am using the Massing as an example of inter chapter cooperation as the theme. It pleases me to be able to include my friends in the Orange County Chapter.

Your offer to assist me in TRYING to identify the ancestry of Caleb Gibbs is appreciated beyond any expression of thanks.

In the past two years, I have amassed a tremendous amount of information on him. Most of the data is from letters to and from him, his being mentioned in numerous others, as well as the official records. To date I have four (4) 3" binders with hard copy information and ten (10) 3.5" disks. I can reasonably place him day-by-day from April 21st, 1775 until his death on November 6th, 1818. But before April 21st - nothing - a few assumptions, all explained in the attached genealogical information.

I have read literally hundreds of biographical and autobiographical books, and never have encountered one that starts with the subject of the biography being **26** years of age. Attempting to explain way this lack of information discredits the balance of the proposed book. I MUST find his date and place of birth and his parentage.

I believe this lack of information has discouraged other writers from attempting a biography.

In my efforts to find his ancestry, I have made numerous inquiries. The historian of the Newport, Rhode Island Historical Society, I was advised of their efforts to link him to the Gibbs family of Newport, without success. How extensively they tried is a matter of conjecture. He was a resident of Marblehead, Massachusetts when the War broke out (1775), and was selected to serve as Adjutant of the Marblehead Regiment with the rank of Captain. The Historian of the Marblehead Historical Society suggested that many of the residents of Marblehead were involved in smuggling. John Glover, Colonel of the Marblehead Regiment, was one of them. Glover was

also involved with John Hancock, another smuggler,. It is possible that Gibbs was also involved, and since the British blockade of Boston (In response to the famed Tea Party affair), shipments from Europe were unloaded at Newport, transferred to Coastal vessels and sailed up to the neck of Cape Cod (usually Barnstable). The cargo was transported via wagon to Sandwich (the north shore of the Cape) loaded on another Coastal vessel and sailed north to Marblehead. Here it was unloaded and smuggled by wagon into Boston. All of this was necessary because the British Man-o-War cruising the Cape would discover any vessel attempting to round the peninsular or sailing in deep water. It makes good sense that Glover or other smuggling ring types, would have someone working for them that was familiar with Newport.

Since smuggling, although patriotic, was a capitol crime, it follows that concealing ones identity to prevent causing problems for family members at home was commonplace.

To further this line of thinking, after the war, Gibbs, for a time, owned and operated a Chandler's shop in Boston. Obviously, selling equipment and stores to ship owners required a good knowledge of the sea.

The other possible explanation is that Gibbs' parents were loyalists. We have numerous recorded stories of the problems created by Loyalist/Patriot family relationships. A recent find indicates that George Washington's infamous mother was a Tory. That would explain away the problems Washington had with his troublesome mother.

In either case, someone, somewhere, has found the answers and recorded them in a genealogical record. The Mormon Library Salt Lake is probably the best place to search for such a record.

Your assistance in this regard will be most appreciated.

ADDITIONAL INFORMATION

The information on the Children of Caleb and Catherine Hall Gibbs was found in Carlos F. Godfrey's 1906 book"*The Commander-in-Chief's Guard*". Page 171. Godfrey cites his genealogical information coming from Mrs., Caroline E. Blagge of Galveston, Texas. The third child of Caleb and Catherine Gibbs was **Sarah Blagge**.

Mrs. Lucie Kenison of Galveston joined the Daughters of the American Revolution on April 13th, 1964. She was born on December 8th, 1886 and was the wife of Alphonse Kenison. She was a descendant of Caleb Gibbs through his son Alexander Hamilton Gibbs. Her papers add nothing to the genealogical information and she showed Caleb Gibbs baptismal date from Newport, Rhode Island as his birth date. (See attached genealogical chart). The D.A.R. records show her mother, as having been an early member of the D.A.R. (D.A.R. No. 13039).

A Mrs. Carribel Nichols McCaleb, also of Galveston, Texas, (D.A.R. No. 66895), wife of Harper Hunt McCaleb. She was descendant from Caleb Gibbs through his granddaughter Caroline E Blagge. (See the attached pedigree chart.)

All the D.A.R. records have been obtained. Additional, no man has joined the S.A.R. or S/R claiming Caleb Gibbs as a Patriot ancestor. The last member of the Society of the Cincinnati based on Gibb's service was his son Alexander Hamilton Gibbs.

Letters were written to every person in the Galveston area named McCaleb, Nichols, Kenison - most came back as having moved without forwarding addresses, and of those that did response no connection was found.
