#### CHARLES WARREN MERRILL

The Merrill family was founded in America by Nathaniel Merrill, and his brother John, who came from Salisbury, county Wilts, England, in 1634, and settled in Newburyport, Massachusetts. The name is said to have originated in the French-speaking Cantons of Switzerland, several centuries ago. In its original form "Merle", still prevalent in Switzerland, it is said to have signified a blackbird. As a confirmation of this we find that on the arms of one Merrill family, which attained distinction in the early years of their sojourn in England, appears a picture of this bird.

NATHANIEL MERRILE, born in Salisbury, Wiltshire, England, about 1610, came to New England when a young man, and we find him and his brother John settled at Newburyport, the port of entry of Essex county, Massachusetts, in 1634. Nathaniel married there Susanna Willerton, and had a number of children. He died in Newburyport, March 16, 1654, having sons: John, Nathaniel, Abraham, Daniel and Abel. Several of his sons were prominent in the Colonial history of Massachusetts, New Hampshire and Vermont; some of their descendants later migrating to the state of New York.

DANIEL MERRILL, one of the younger sons of Nathaniel and Susanna (Willerton) Merrill, was born at Newburyport, August 20, 1642. He married Sarah Clough, born 1646, died 1706, daughter of John and Jane Clough, of Salisbury, Massachusetts, who had come from England in 1635. John Clough was born in England in 1613, died in Salisbury, Massachusetts, in 1691. Daniel and Sarah (Clough) Merrill continued to live for some years in Newburyport, and there their seven children were born between the years 1674 and 1688. They later removed with their eldest son, John Merrill, to Salisbury, on the Merrimac river, near the line of New Hampshire, where Daniel Merrill died in 1718.

DANIEL MERRILL JR., second son of Daniel and Sarah (Clough) Merrill, born about the year 1676, married Esther Chase, and settled at Salisbury, Massachusetts, named for the place of nativity of his grandfather, Nathaniel Merrill, in Wiltshire. He probably removed later to New Hampshire, late in life, where we find his sons and grandsons residing before the middle of the eighteenth century, but little is known of his history.

JOSEPH MERRILL, son of Daniel and Esther (Chase) Merrill, born about the year 1700, in Salisbury, Essex county, Massachusetts, married Mary Palmer, and settled in Stratham, on the right bank of the Swanscott river, in Rocking-ham county, New Hampshire, about six miles southwest of Portsmouth, on the coast, the town or township in Pennsylvania nomenclature, extending from Exeter down the Swanscott river to the Great Bay.

JAMES MERRILL, son of Joseph and Mary (Palmer) Merrill, was born September 18, 1729. At the dawn of the American Revolution he was living in the town of Stratham, Rockingham county, New Hampshire, and with other members of the Merrill family participated in the first action taken by the inhabitants of the town toward resisting the efforts of the British Ministry to tax the

# First Generation

NATHANIEL<sup>1</sup> MERRILL was one of the earliest settlers of Newbury, Mass., in 1635. He was the ancestor of a mat majority of those who now bear the Merrill name in this country: it is believed, indeed, that less than one percent. of the Merrills in America can trace their redigree to any other emigrant ancestor.

Nathaniel<sup>1</sup> Merrill and his older brother John were born in England. The registers of Wherstead, a parish lying three miles south of Ipswich, in Suffolk County, mgland, contain the following entries:

1599, Aug.16. John Merrell son of Nath! Merrell & Mary his wife was baptised.
1601, May 4. Nathanaell Merrell son of Nath! Merrell & Mary his wife was baptised.

There are reasons for believing that these entries are the record of baptism of John and Nathaniel<sup>4</sup> Merrill of Newbury. These reasons will be given at length in mother place.

Nathaniel<sup>4</sup> Merkill and his brother John settled in Tewbury in the Spring of 1635, having passed a year or to at Ipswich, Mass.,(then called Agawam) with most of the Newbury settlers. In 1638 Nathaniel<sup>4</sup> became one the "proprietors" of Newbury.

It is supposed that Nathaniel' Merrill was married fore leaving England. No record is found of his mariage in America. If the marriage took place here was probably at Ipswich, in the short time before be settlement in Newbury. His wife's name was Susan-Savage, in the "Genealogical Dictionary of New gland" (published in 1861), says that Nathaniel' Mer-Il married Susanna Jordan. In this he was no doubt blowing Coffin's "History of Newbury" (published in 165), and the statement has been frequently copied.

After the death of Nathaniel' Merrill his widow married Stephen Jordan (or Jourdain). Nathaniel<sup>2</sup> Merrill, son of Nathaniel<sup>4</sup> and Susanna Merrill, gave a deed, under date of 16 Aug.1661, to Peter Godfrey of Newbury, in which the phrase occurs, "after the decease of my mother Susanna Jordan," and out of this fact the error regarding the maiden name of Nathaniel's wife grew.

Stephen Jordan came to America in March, 1633/4, in the ship Mary and John, and settled in Ipswich. He removed after 1649 to Newbury. The date of his removal was probably about 1653, in which year he sold land in He died in Newbury 8 Feb. 1669/70. Ipswich. Susanna Jordan died 15 Jan.1672/3, in Newbury, administration on her estate being granted to her son Abel<sup>2</sup> Merrill. Stephen Jordan had two daughters by a prior marriage. They had married, in Ipswich, Robert Cross and John An-It is supposed that no children drows respectively. were born to Stephen and Susanna Jordan, none being mentioned in the settlement of the estate of either.

The conjecture has been advanced, and it has even been stated as a fact, that the wife of Nathaniel<sup>1</sup> Merrill was Susanna Wilterton (or Wolterton.)

John<sup>2</sup> Merrill, one of the older sons of Nathaniel, went to Hartford, Conn., before 1657, while still a minor, and it is said was adopted by Gregory Wilterton. Savage, in his "Genealogical Dictionary," said that Gregory Wilterton "had good estate, large tan works, and no children." Gregory Wilterton made his will 17 July, 1674, and died soon after, leaving legacies to a number of per sons, including relatives in Ipswich, England. Savage adds: "Most of his estate was given to John Merrills, because he had adopted him." The same statement of adoption is repeated in the "Memorial History of Hartford County."

These facts lend plausibility to the theory that Gregory Wilterton was a brother of Susanna Merrill. It was a long journey from Newbury to Hartford; means of communication were meagre, and both communities were in their infancy. It seems unlikely that John<sup>2</sup>, as a very young man, would have made such a journey, separating himself for a lifetime from home and kin, unless to make a home with other kin in the place where he went to live.

John errill, his brother, signed the will as a witness, menand there is no reason to doubt that Nathaniel had mjoyed equal advantages of schooling.

Merrill, in Aroostook County, Maine, received its name from Capt. William<sup>6</sup> Merrill (Levi<sup>5</sup>, Israel<sup>4</sup>, James<sup>3</sup>, Abel<sup>2</sup>) of Portland, who purchased the southeast quarter of Township No. 6, Range 4, 7 June, 1842, for \$1932. The township received the name of Merrill Plantation at its organization in 1876, and was incorporated as a town in 1911. Its population in 1920 was 361. William-George<sup>7</sup> and Edward-Thomas<sup>7</sup> Merrill, sons of Captain Merrill, settled on the land which he purchased, and some of their descendants now live in that vicinity. Lumbering and potato-raising are the chief industries.

Merrill's Corner is a village in Brownfield, Oxford County, Maine. It received its name about 1810 from Nathaniel<sup>6</sup> Merrill (Nathaniel<sup>5</sup>, John<sup>4</sup>,<sup>3</sup>, Nathaniel<sup>2</sup>), a farmer who lived there. # Elmer Klassen, former postmaster general

#### The New York Times

Elmer T. Klassen, 81, a former US postmaster general who rose from messenger to president of American Can Corp., died of congestive heart failure Tuesday at a nursing home in Palm Harbor, Fla.

In 1971, Mr. Klassen became the first postmaster general named not by the president but by the Postal Service's board of governors under new federal legislation.

He became the 60th postmaster general Jan. 1, 1972, serving until 1975 when he retired and moved to Palm Harbor.

From 1969 to 1971, he had been leputy postmaster general.

Mr. Klassen played a major role n shaping the Postal Reorganization Act of 1970, which took the Post Office Department from under the control of a Cabinet-level government officer and made it an independent agency in the executive branch.

He was instrumental in negotiating a contract between the US Postal Service and the representatives of seven postal unions with about 600,000 members in July 1971.

At the time of Mr. Klassen's re-

tirement, the Postal Service was under criticism by members of Congress and others because of financial and organizational problems and higher rates.

Mr. Klassen came in for his share of the criticism, in particular from newspaper columnist Jack Anderson, who took issue over contracts awarded by the Postal Service.

Mr. Klassen was born in Hillsboro, Kan., and raised in California.

He began his career at American Can in 1925 as a messenger in the San Francisco plant.

Forty years later, on April 28, 1965, he became president of the \$1 billion company, which later became Primerica Corp.

Mr. Klassen never attended college. His only formal education beyond high school was advanced management training at Harvard in 1954.

In 1968, at age 59, Mr. Klassen unexpectedly resigned his \$170,000a-year job as president of American Can, saying he was quitting because of "variance with the chairman's approach."


