Dear Mr Blauer

Thank you very much for your enquiry. The enclosed leaflet describes our services but please let us know if there is anything you would like to ask.

The discrepancy in the Bottetourt pedigrees has arisen because there were two John de Bottetourts who married Maud de Greys (the names Matilda and Maud were different forms of the same name): the first was the father of Joyce (wife of Baldwin Freville and Adam Peshale), the second her brother. As is shown by the enclosed copy from *The Complete Peerage*, generally considered to be the most authoritative source, the line descends as follows:

John de Bottetourt d. 1324, married Maud Fitz Thomas

his son Thomas de Bottetourt dvp (died in his father's lifetime) 1322, married Joan de Somery

his son John de Bottetourt (1317/18-1385), married (1) Maud de Grey, daughter of John de Grey, 1st Lord Grey of Rotherfield; married (2) Joyce la Zouche

his son John de Bottetourt dvp 1369, married Maud de Grey, daughter of John de Grey, 2nd Lord Grey of Rotherfield, leaving issue Joyce, wife of Hugh Burnell.

Sisters to this last John de Bottetourt, and daughters to the earlier John (d.1385) were Joyce Freville/Peshale, Alice Kyriel and Catherine Berkeley.

Both the pedigrees you sent are thus in error to some degree. The first (page 90) is largely correct but gives the wrong wife for the last John. The second (page 209) omits the first Maud de Grey but has the second correctly. It is not clear from *The Complete Peerage* whether Maud de Grey or Joyce la Zouche was your Joyce's mother, but Burke's *Extinct Peerages* (copy enclosed) agrees that she and Elizabeth were children of the first marriage; neither does the former source show her sisters Elizabeth, Matilda and Agnes.

We hope this information is of help.

Elizabeth, who m. lst, Sir Robert Ferrers, a younger son of Robert, 2nd Baron Ferrers, of Chartley, and conveyed to him the lordship of Wemme, co. Salop, and the said Robert was summoned to parliament as "Robert Ferrers de Wemme, Chev." in the 49th EDWARD III. Elizabeth Boteler m. 2ndly, Sir John Say, and 3rdly, Sir Thomas Molinton, who styled himself "Baron of Wemme," but was never summoned to parliament. Her ladyship had no issue by her second and third husbands, but by the first she left a son,

BOBERT FERRERS, who inherited the Barony of Boteler, as well as that of Ferrers of Wemme, but was never sum-moned to parliament. His lordship d. in 1410, leaving two daus., co-heiresses, viz.,

BOTELER-BARONS BOTELER, OF WARINGTON.

By Writ of Summons, dated 23 June, 1295.

Lineage.

The first of this family who assumed the surname of BOTELER

ROBERT LE BOTZLER, from filling the office of botelor or butler to Ranulph de Gernons, Earl of Chester, and under that designation he founded an abbey for Cistercian monks in the year 1158. This Robert left a son Robert, but nothing further is known of the family until the time of King John, when

JOHN DE BOTETOURT, governor of St. Briavel's Castle, co-Gloucester, and admiral of the king's fleet in the reigns of EDWARD I. and EDWARD II., was summoned to parliament as a Baron by the latter monarch, from 10 March, 1308, to 13 September, 1324. His lordship m. Matilda, sister and heiress of Otto Fitz Thomas, and dau. of Thomas Fitz Otho, by Beatrix his wife, dau. and co heir of William de Beauchamp, Baron of Bedford, by whom he had issue,

Lord Botetourt, who was one of the eminent military characters for the reign of EDWARD I., took a leading part in the Scottish wars of that monarch, and was entrusted with the government of the strongest castles, the command of the fleet, and other duties of the highest importance. His lordship d. in 1324, and was s. by his grandson,

JOHN DE BOTETOURT, 2nd baron, who had livery of his lands
in the 14th EDWARD III., and in two years afterwards attended

BOTHWELL-LORD HOLYROODHOUSE.

By Letters Patent, dated 20 December, 1607.

Lineage.

JOHN BOTHWELL, of Alhammer, eldest son of Adam Bothwell, bishop of Orkney, was, on his father's resignation, appointed a lord of session, 2 July, 1593, and sworn of the privy council to JAMES VI., whom he accompanied to England in 1603. He was created a peer by the title of Lord of HOLYRUDHOUSE, by was created at Whitehall, 20 December, 1607, to him and the heirs male of his body; which failing, to the heirs male of Adam, bishop of Orkney, his father; which failing, to his heirs and assigns. BOULDE, or BOLDE, BARON OF RATOATH.

By Letters Patent, dated 13 August, 1468.

Lineage.

SIR ROBERT BOULD, OF BOLDE, Knt., was created BARON RATOATH, in the peerage of Ireland, by patent, dated at Drog-heda, 13 August, 1468. His lordship m. twice. By his 2nd wife, Ismay, dau. and heir of Sir John Serjeant, of Castle Knock, near Dublin, and widow of Sir Nicholas Barnewall, of Crickstown, he had no child; but by his 1st wife, whom he had married in England, he had a dau. and heir, KATHARINE, who m. Edmund Barnewall, Esq., of Dunbrow, co. Dublin, and had issue, Robert Barnewall, of Dunbrow, and Elizabeth, m. to Richard Talbot, of the house of Templeogue.

BOURCHIER_BARONS FITZ-WARINE EARLS OF BATH.

Barony, by Writ of Summons, dated 23 June, 1292. Earldom, by Letters Patent, dated 9 July, 1536.

SIR WILLIAM BOURCHIER (3rd son of WILLIAM BOURCHIER, EARL of Ewe, in Normandy, and Anne his wife, dau. and heiress of Thomas, of Woodstock, Duke of Gloucester, youngest son of King Edward III.,) having m. Thomasine, heires of Richard Hanckford, Esq., by Elizabeth his wife, sister and heiress of Fulke Fitz-Warine, 7th and last Baron Fitz-Warine, of that family, who d.s.p., in 1429, was summoned to parliament, jure uxoris, as Baron Fitz-Warine, from 2 January, 1449, to 7 September, 1469. This nobleman, who was one of the foresters in the reign of Edward IV., had license from that monarch to export, duty free, a thousand woollen cloths of his own goods. His lordship appears to have married 2ndly, Catherine, widow of — Stukeley, by whom he had a dau. Elizabeth, to whom her mother bequeaths in her last will, dated in 1466, "a girdle of red tissue." Lord Fitz-Warine d. dated in 1466, "a girdle of red tissue." Lord Fitz-Warine d. about the year 1470, and was s. by his son,
Sir Fulke Bourchier, Knt., 2nd Baron Fitz-Warine, who was

His lordship d. in 1479, and was s. by his son,

JOHN BOURCHIER, 3rd Baron Fitz-Warine, who, in the 6th of HENRY VII., being of full age, had livery of his lands, and was summoned to parliament from 12 August, 1492, to 8 June, 1836. His lordship inherited, likewise, the large estates of his mother, the heiress of the Lords Dynham. This nobleman signed the celebrated letter to Pope CLEMENT VII., in the 22nd HENRY VIII., wherein the subscribing lords apprised his holiness of the frail tenure of his supremacy, should he refuse the pontifical assent to the divorce of the king from Queen Kaths-ning. Lord Fitz-Warine was subsequently advanced, by letters patent, dated 9 July 1536, to the Earldom of Bath. His lordship m. Cecilia, dau. of Giles, Lord D'Aubeney, and sister and heiress of Henry D'Aubeney, Earl of Bridgewater, and had, with other issue,
