Married Josephine or Josefine Obadal in Jersey City, NJ on 24 Nov. 1924.

This information on the marriage is from Josephine's records and is listed on her naturalization records in the 1940's in California. I sent for the marriage record but it was not found in Jersey City in 1924. However, one of Josephine's sisters, Julia Obadal, married Earl Wilson there in 1921.

Son August Walter Berger was born June 23, 1937 in Los Angeles d. Jan. 11, 1989

Alfred and Josephine were in California by 1929.

On the 1930 census Alfred Berger indicated that he had filed a petition for naturalization, but I could not find it in California. I could not find it in NY. Maybe it is NJ.

Enclosed is a check for \$3.00. A certified copy is not necessary unless it would provide additional information.

This is for genealogical purposes. Alfred Berger was my father-in-law. He died in 1952 and I never met him myself. His wife Josephine is also dead, as is their only child, my late husband. We know nothing about my husband's father's family and I would like to have this information for my children.



His SS# was 550-12-1609.


He married my mother-in-law Josephine Obadal in New Jersey in 1924.

I am trying to learn more about my deceased husband's father, Alfred Berger, who came to this country from Austria in the early 20<sup>th</sup> century. Alfred died in 1952 of some kind of degenerative disease of the brain. He was institutionalized for the last five years of his life and was described by neighbors as "a vegetable" when he died at the age of about 63 years old. The state institution where he died no longer has his medical records.

My husband (an only child) developed epilepsy in his mid-forties and died in 1989 of an accident due to an epileptic seizure at the age of 51. We don't know the cause of his epilepsy.

Since we know nothing of Alfred's relatives except that he had a brother and sister (names unknown) we would like to find more information on Alfred's background. According to family papers he was born in 1889 and came to this country about 1909.

I have four children and would like the health information for them, as well as for genealogical purposes on Alfred and his wife.

The marriage date I have listed of Nov. 4, 1924 is from information given by my mother-in-law (Josephine) on her naturalization papers. Jersey City archives could not find their marriage listed. Perhaps it was a different year and/or date. She was naturalized much later in life. Please search a wide range of dates and counties. It must have been between 1911 (when my mother-in-law immigrated) and 1930 (when Josephine and Alfred were married and living in Los Angeles in the 1930 census).

Please send me two copies. I don't need it for official business so I guess that it is a certification rather than a certified copy. A check is enclosed.

I can read some German.

For deaths on which the medical certification is made by the physician in last attendance, Section 10401 of the Health and Safety Code requires that "The physician shall within 15 hours after the death deposit the certificate at the place of death, or deliver it to the attending funeral director at his place of business or at the office of the physician."

For deaths on which the coroner makes the certification, Section 10429 of the Health and Safety Code requires that "The coroner shall within three days after examining the body deliver the death certificate to the attending funeral director."
