Luther disappeared in about 1972. He graduated from Williford, Arkansas High School in about 1946. In 1953 he worked in St. Louis at the ~~Toddler~~ House as a Chef. In 1950? he worked in St. Louis at the Chase Hotel as a Chef.

1948-49 Luther had a girlfriend with a little girl named Harvetta. (Conrad G. Willbanks met and dated the "little" girl when he was older, her real name being Ann High. Her mother had asked "Ann" if Conrad was related Luther Willbanks. That's how Conrad found out "Ann" was Harvetta.

^{Althe}
"Puger" Dickerson lived in Hardy. He may have "done Luther in". Puger's wife (Ida Jane Booth) was Luther's lover(?). Puger's wife remained his wife. Puger was Grampa Amos Willbanks' (Luther's father) friend. This happened approximately the same time as the disappearance of Luther. Luther was an alcoholic. Conrad G. saw him in 1960 in Williford living with his father Amos.

Luther had been living in Texas (on welfare) and was waiting for an eye transplant through the Salvation Army. In 1972 he wrote a letter to his sister Rosa and he was living in Austin, Texas. He had told her he would see her in California and he would get there by going from Salvation Army to Salvation Army to do it.
