John Dow and Amy KING who also reside in Bloomfield twp. When interrogated by court Abraham gave his birth date and place, speaks of the Family Bible. He says he volunteered to serve.

His family consists of wife Nancy, aged 71 years (as of 1824). A Nat. Archives letter says he was allowed pension 14 Apr.1818 and he was then a resident of Huntington co.m Pa. He was also pensioned by state of Pa. In 1820 Alexander was 66 years old and Nancy was 68.

(The Court had to know whether they were married before that date. ) William King says Abdrew kept a record of the age of his children but it was destroyed by accident about 14 years ago. Andrew and Sally had five children, says William. Andrew was a private in the Virginia line and got a pension. In 1842 Sally is 82 years old. In 1833 in Claiborne co., Tenn. came Andrew King and he was 80 years old and "poor". No children living with them, just he and his wife. His parents told him his age. Andrew was living in Henry co., Va. when called into service and since the R.W. has lived in North Carolina, but now lives in Clairborne co., Tenn. He volunteered to serve.

King was b. 5 April 1750 in Hanover co., va. Resided with fa. until of age. Then removed to Botecourt co., va. Lived there short time. In summer of 1774 he vol. and served in Indian war. Ret'd to Botecourt co., ya. Enlisted as private in the Va. troops in Spring 1775 in Capt. Geo. Frazier's co. He was allowed pension on application while a resident of Allegheny co. (formerly Boutecourt co.) Va. He died 18 Mar 1836. The soldier married August 21, 1787 to Rebecca Bess. She was allowed a widow's pension in 1838 while living in Allegheny co.. Va. At that time she was 87. JOHN KING was a son of the soldier and wife, was a resident of Covington, Allegheny co., va. in 1839. No reference to other children, if any.

He enlisted as a volunteer in the state troops in R.I. in 1776 in January at Makxakka letter: "I am clerk of session of lst Presby. church Smithfist?? ok - in Goshen, Orange co., N.Y. and I possess the marriage record kept by the Rev. Nathan Kerr, pastor. Clement King married to Mary Woodward on 28th Dec. 1780 in city of ... (can't read). 

Joshua is widowed and remarries to Julia Ann Johnson whom he marries in Muscatine co., Towa. This also from Pension papers. In 1830 he is living with Rebecca in Rush co., Indiana and is Justice of the Peace. I think Rebecca died here. He purchased land in Hancock co., Ind. in 1836. In 1838 in Muscatine co., Iowa. In the Spring of 1838 they came to Cedar Creek twp., Johnson co., Towa (county history). "He was from Indiana". I find him in Cedar co. Towa in the 1840 census. In 1855 he comes to court about pension and states he is 57 years old. He is in Jackson co., Iowa in 1860 census, with only two children in the home: Stepehn M. King, 19 yrs. and Carolina 16 yr. both b. Iowa. In 1870 census they are in Newton, Jasper co., Iowa and he is 72 yrs old b. Md. I do not know when he died or where. Marriage record to Rebecca is in the Ross co. courthouse in Bk A-B 1798-1825 p.329.

Her birth date is given in her obituary for 30 May 1801, a copy of which I secured in Hancock co., Indiana library. Her marriage is recorded in Ross co., O. courthouse in Bk A-B 1798-1825 p. 296. Her death is from her tombstone which was sent to me. She is buried in Gilboa cemetery by her husband, Arthur Lewis. Her husband was in the War of 1812 - copy of which I have. Arthur Lewis' land is mentioned in the Isaac King land transaction of 25 Nov. 1819 in Ross co., Ohio, "and on the waters of the North fork of Paint Creek being part of Survey No. 804 in the name of Edward Carrington bounded described and as follows Beginning at an elm and White oak and East to Joseph Godfrey running S 24 W 197 poles to a black oak thence with Elijah Holloways North line S 701 E 106 poles to a small white oak thence with ARTHUR LEWIS West line and N 24 E 194 poles to a hickory thence with the line of the Survey N 69 W 106 poles to the beginning." Arthur Lewis died 15 Dec 1863 74 years 7 mo. 25 days. In the census Arthur says he was b. Maryland and so does Elinor King Lewis his wife. But in the obituary it states Elinor was b. Delaware which I doubt.

They are in the 1820 concord twp. p.254 census residing by Isaac King. They are still there in 1830 (the rest have gone on to Indiana). He lived near John King and John Timmons. In 1840 Arthur and Elinor are in Hancock co., Indiana, with 8 children. Obituary says there were 11 children all told. In 1850 they are in Hancock co., Indiana and the children are: Isaac, Martha, George E., James H., HESTER ANN, Wingate K., and Milicent. Milicent was the name of the 2nd wife of Isaac King, sr. In 1860 they are still there with children: Hettia, Milla, Wingate K., Rachel E. and with two of Elinor's sister's children. Her sister Elizabeth P.King Lamb had died and so Isaac Lamb and Jane F. Lamb were living with the Arthur Lewis family. In 1870 they are still in Hancock co., Indiana alone. Elinore is head of the household and is 68. A girl Rachel, the daughter is now 13 and is the only one left at home with her mother. The obituary says Elinore died at the home of her son, John S.Lewis commissioner of the east district. and I found him in the 1870 & 1880 census.

HESTER KING

We have been unable to find anything about this couple. I do find the marriage of a Moses Guthery to Hannah Hasten 10 Jan 1811 by Benj. Daniels, J.P. in Ross co., Ohio. I do not find Hastens in the 1820 census film and Ross co., O. library tells me there are no Hasten names in the 1820 Index. I do find 4 Huston families in 1830 in Pickaway co., O. and think this needs investigating. Have asked for a photostatic copy of the naming of the h eirs from Hancock co., Ind. because I feel the girl who copied may not have transcribed it right. This will cost me another \$6. darn it.

&OHN KING

Leaving until I can sort other John Kings out and discover just about what age group he would be in.

JOSEPH KING

Born ca 1807 in Ohio. Married 10 Oct 1831 in Hancock co., Indiana. Book Cl p.50. I got the obituary from Andrew co., Mo. of the wife but it does not clinch my proof. Too long a story to tell, but if we have the right Joseph King we have his entire history documented.

MARGARET KING

The division of the Estate of Isaac King, sr. states that the name of Margaret's husband is James King (no initial). Lowell Volkel thinks it is his James J. Lewis who lived in Pickaway co., Ohio. It appears to be so because the story in two different county histories give the same story - almost identical. The Vermillion co. history states that Margaret and her husband James J. Lewis, accompanied by her father Isaac King came to Rush co., Indiana in 1830 and in 1832 to Hancock co., Indiana. Where Mr. King remained. The young couple went on to Vermillion co., Indiana in 1837." The county history of Hancock co., Indiana tells of Arthur Lewis, being b. Maryland, going to Ohio at an early age, coming to Rush co., Indiana in 1832 and two months later to Hancock co., Indiana. The story goes that James J. Lewis and siblings were orphaned early and taken by grandmother and an uncle to Pickaway co., Ohio at an early age. No one knows the name of the grandmother nor the uncle. So - I am trying to prove this is our Margaret and James J. Lewis. If same, the children= Isaac S. Lewis, William, Sarah, Nancy, James A., Martha J., John W., Mary Ellen, Joshua, Elizabeth, Meredith (male), Henry B., and Samuel Brenton.

ISAAC KING, jr.

Marriage is in Book Cl p.126 Hancock co., Indiana. By 17 May 1849 both Isaac King and his wife Elizabeth Carr King are deceased and the court appoints guardians for the two girls, Mary J. King and Mahala Ann King. We know that Elizabeth Carr was the sister of Noah Carr because the girls are entitled to part of his property - because he too is recently deceased. The reason that I think this is Isaac King, senior's son is because we find a Mary J. 12 years old b. Indiana living with her grand father and his second wife, Milicent (who was not previously married). And Isaac and Melicent had not been married any 12 years. I wondered for many months who on earth this Mary J. was until I studied the court records and found this. I feel sure this is our Isaac King, jr. Will hope some day to find grave of both Isaac and his wife, Elizabeth. The other girl, Mahala Ann was living with the court appointed guardian, Joseph Anderson in 1850 ... which substantiates the proof because why would she also not be in the Joseph Anderson home unless she was with relatives.

poor Mary Jane, the 12 yr. old, marries at 16 to a Samuel Derry, son of Jeremiah Derry and wife Melinda. The other girl, Mahala Ann marries at 16 yr. to Allen T. Hazlett, son of James and Angeline Taylor. But the sorry story is - well written up with all of the gory details in the Hancock co., Ind. history - is that Samuel Derry's SISTER, Lucinda Derry Kingon and Lucinda's husband, Harrison Kingon got into a street fight over the ownership of a tiny gosling and Lucinda and Harrison stabbed Mary Jane's husband to death. I wonder what happened to Mary Jane and the two children but have not had the time to investigate and probably never shall.

## MARTHA KING

Martha Patty King - as she is called on her marriage record, is in marriage book A B 1798-1825 p.387. They were in the 1820 Ross co., Ohio census in Deerfield twp. p.250. With them was one woman over 45 whom I would guess would be Mathias \* mother since Martha's mother was still giving birth to children in her own household. I cannot find them in 1830 but in 1840 I find the widow(?) Martha as head of the household living next door to Margaret Kester (Martha's son marries into the Kester household), and near Martha's brother, JOshua and Noah King. I have found millions of Dennis families living in Delaware and Maryland and Ross co., and Pickaway co. Which one! The W.P.A. history of Maryland says that the Dennis and Robert King family are old time families in Maryland. Martha and Matthias' son, Isaac K. Dennis marries Mary Kester about 1838-39. Isaac K. Dennis dies 18 June 1880 in Ely, Linn co., Iowa and I have written for obituary. This family is included in the POUND - KESTER families, published. But darn them, no back history on the Dennises or Kings. Have a fine contact with Ruth Colony who is descended from the son Isaac K. Dennis, We are some sort of cousins and she is helping me all she can. Bless her.

#### WINGATE KING

Birth date given to me by my father. Marriage date is in Hancock co., Indiana court house Book C l p.156. This is his first marriage. I shall not give you a long account, but I have pinned him down to where I know when he first cut his toe nails. He married 2nd 29 Aug 1865 to the woman who became my grandmother, Martha Isabel Frazier, of Platte co., Missouri.

#### MARY KING

Marriage is in Book C2 p.l in Hancock co., Indiana. He was born about 1817 in Bavaria. He married after Mary died to a Melinda, and then when she dies (I guess she died) to an America. There are no Wachtels in Ross co., Ohio 1820 or 1830. No, in 1830 there are Jacob and George Wachtel living in Wayne co., O. and I got the county history account of them. I first find them in the 1850 Andrew co., Mo. census., Nodaway twp. Martin, wife Mary and ch. Sarah, Elizabeth, Wingate, Henry and Wm. In 1860 Martin is 44, Mary A. is 38, Sarah A. 17 etc. They stay here in Andrew Co., Mo. through 1880... he with different wives. Mary A. the wife says that she was b. in Ohio.

## ELIZABETH KING

Marriage is in B k Cl p. 161 in Hancock co., Indiana. In 1840 we find this couple in Hancock co., Indiana with 1 male ch. under. 5. I cannot find them in 1850 - just when I want them to get her age and where she is born. She is still alive in Oct 1853 because she is named as an heir and it does not say the descendants of Elizabeth Lamb, but names Elizabeth herself. But 26 Oct 1853 Josiah Lamb married a neighbor Lydia Wolf, the widow. Josiah and Elizabeth Lamb had at least these children= John A., Isaac S., Martha J., and James W. Lamb. John A. married Lydias's dau. Zerilda, and James W. married Eliza J. Welman. Josiah and Lydia had Albert W. and Thomas J. Lamb. Josiah Lamb, Elizabeth's husband, was the son of Stephen and Miriam Lamb of Hancock co., Indiana and originally came from North Carolina. Stephen and Miriam had: Josiah who married our Elizabeth P. King (Josiah born ca 1813); Timothy b. ca 1814 who married a Rebecca; MILICENT LAMB b. ca 1820 who married ISAAC KING, SENIOR (his second wife); Elizabeth Lamb who m.
