Thank you for sending that excellent website. I will be taking trips through it in the 'Way Back Machine' that photographs offer us. How neat is the internet, eh?

In the not so long ago 'Olden Daze' we'd have to trek to special library collections or hisorical societies and spend days of time looking through such treasures.

Do you have your and my Mom's street address for the house(s) they occupied while growing up in the Mission District? I recall that they lived on either 20th or 22nd Street

and Dolores. Was that both before and after 1906? Since Mom was born in 1911 after

Nora had remarried to John Collins I have sketchy information about what Grandma, Pauline and Fran lived before and after the Earthquake and Fire. Was their home burned and did they stay over in Alameda with close family friends for a period after April 1906?

I have been debating whether or not to send you a recent treasure find that I've been perusing nightly much past my bedtime for almost a month now.

I have been trolling the photo catalog of a collection located on line through the Bancroft

Library and have come up with 3 photos of Great/Grandpa Judge in his duty as a policeman.

The title is all very wrong for the following image, which is why it pays to troll one photo at a time rather than rely upon text captions to locate information .



Bernard Joseph Judge was a cabinet maker by trade who built cases and finished wood work in the scandal ridden City Hall that crumbled and burnt in '06. We was put out of work due to the Depression of the mid 1890's and then managed to get into the SF Police Department. He rose to the rank of Captain and eventually succeeded man who took the majority of photographs that are in this collection as Property Clerk at the Hall of Justice.

The caption refers to the scandal of the decade in S.F. and Hollywood when Rosco 'Fatty' Arbuckle was charged with the murder of Miss Virginia Rappe. Here body was found in his hotel while he was on a wild debauch in San Francisco.

The scandal and fall from grace rated right up there with the O.J. Simpson trials as Fatty Arbuckle was a very big film comedy star in during the Silent era of films.

However, none of that has anything to do with this portrait of Dad's Dad.

Quake and Fire going this just adds more perspective.

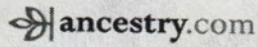

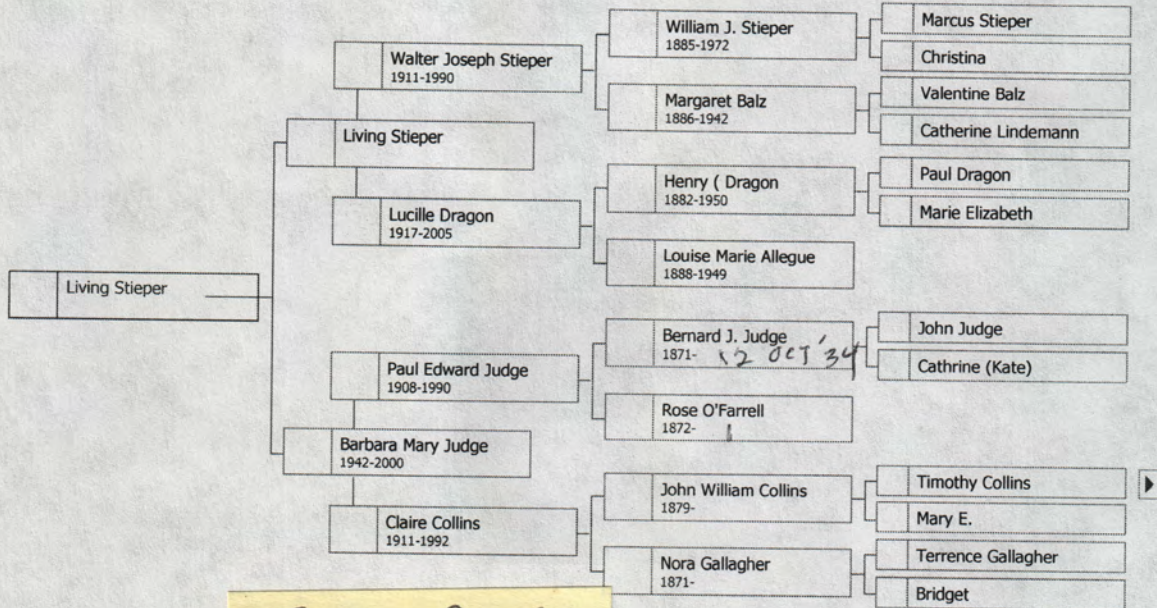

## Chairman Educational Committee

Of course, everyone is eager to see Who's Who in this issue of the NEWS. Here he is: No less a personage than Harry J. Smith, our Educational Chairman. Plump? Well, you can't enjoy California's glorious sunshine, dine on her delicious fruits, nuts, olives and a hundred and one other good things for forty-two years and expect to weigh much less than a couple of hundred pounds.

H. J. is not only a native of California, but has the distinction of being a native of San Francisco. Those of our readers who have completed the M-I (Mathematics) course will readily perceive that it was back in the year 1882 that H. J. announced his arrival as a Native Son. The day was March 8th, the place (then) "South of the Slot" but now—the little incident following will explain. One Sunday afternoon, recently, when H. J., his wife and daughter, with some friends, were motoring through that section of the city, H. J. cried out enthusiastically, "There's where I was born!" His daughter, Florence, a charming young lady of fifteen years, junior student of Girls High, gave her father a look of horror, which plainly conveyed the idea that he should have kept that bit of information under his hat.

H. J. is the fourth son of a family of seven boys and one girl. He graduated from Horace Mann Grammar School at the age of fourteen. His father, having retired after thirty years in the sugar business, had afterwards organized the well known hardware firm of P. A. Smith's Co., 638 Fourth street, and at this time

gave Harry a position in the store. However, as to developing any interest or progressing in the hardware line, sad to say, H. J. proved an entire fizzle, as for one thing, his hobby was mathematics, and for another, he had aspirations of becoming an engineer. So he enrolled with the International Correspondence School for a course in mathematics and in a very short time became very proficient in this study.

At the age of sixteen, he came to the conclusion that he should acquire some practical knowledge as a foundation for his engineering studies, which he contemplated taking later on. With these thoughts in mind, he entered the Joshua Hendy Machine Shop and served four years, completing his trade as machinist. From this time on for six years he continued the study of higher mathematics, to which he added the study of mechanical designing, studying five evenings a week under the leadership of Professor Klink, who was then an instructor at the University of California. At the age of twenty he se-

cured a position as draftsman with Risdon Iron Works, later being promoted to Chief Draftsman.

You would wonder how he ever had any time for pleasure and romance, but it is very evident that this side of his development was not neglected, for at the age of twenty-three, in June 1905, he entered the realms of matrimony. Her name was Mary McNeil, daughter of Stephen McNeil, San Francisco contractor.

In 1910 he accepted a position as Chief Draftsman with the Sierra and San Francisco Power Company, shortly thereafter receiving promotion to the position in charge of Electrical Steam and Hydraulics, where he remained for ten years, or until 1920, at which time this Company was leased by Pacific Gas and Electric Company, and Harry came along and was made Engineer of Construction in the Department of Gas Construction and Operation, which position he fills at the present time.

H. J. was a member of the Educational Committee, in charge of Publicity, during 1923. He was elected a member of the Executive Committee of the P. S. E. A. for the year 1924. Besides being a member of American Society of Mechanical Engineers, Pacific Coast Gas Association, National Electric Light Association, Engineers' Club, and an Associate member of Electrical Engineers, he is "Chief Radio Bug" of the Gas Department.

H. J.'s work in the Association's activities has been characterized by efficient management; given an idea of what is required, he works rapidly to a successful completion. He is an ardent worker for the educational advancement of the P. S. E. A., and his untiring efforts, combined with those of his remarkable staff of assistants, are making notable records for this activity for the year 1924.

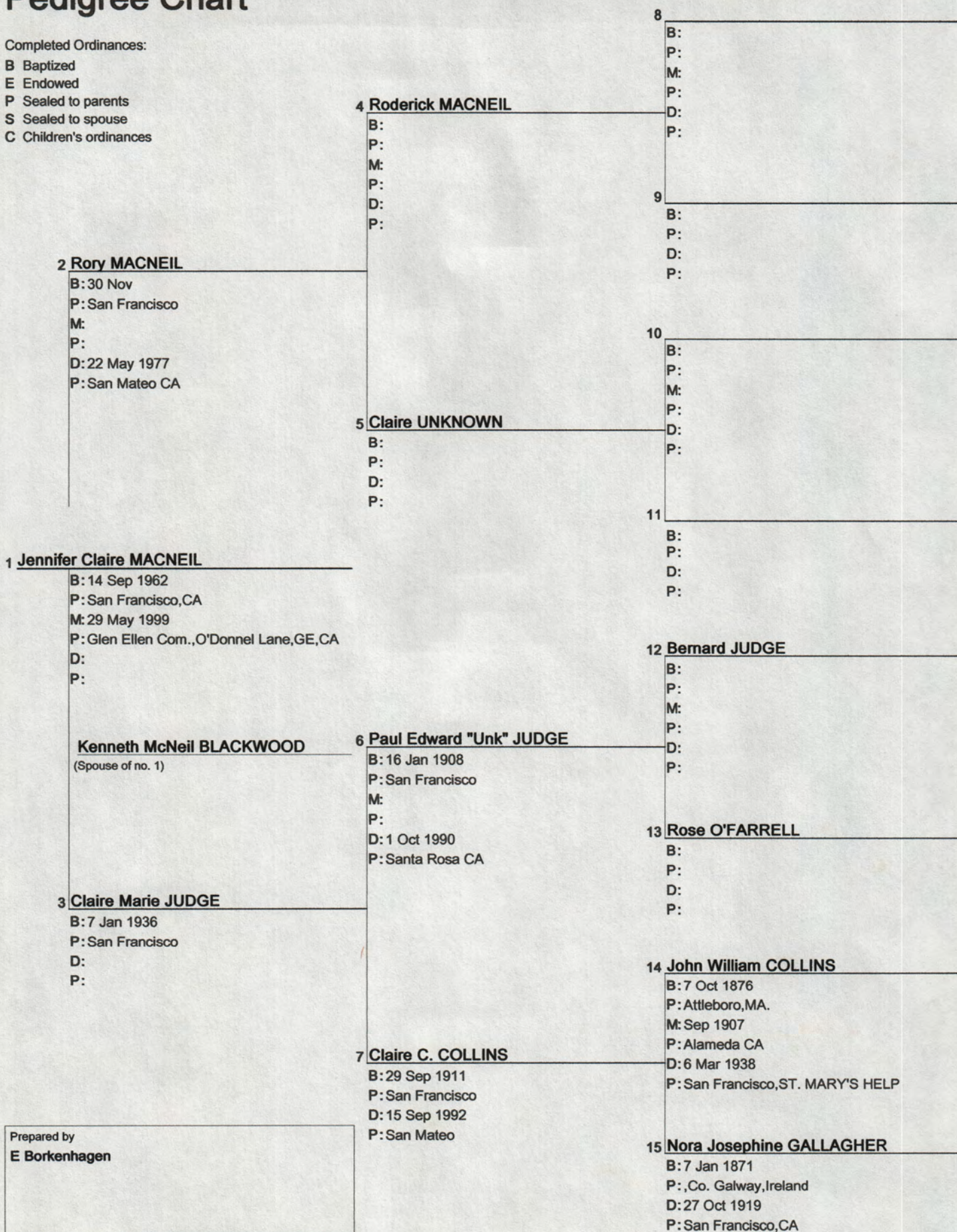

Nora had remarried to John Collins I have sketchy information about what Grandma, Pauline and Fran lived before and after the Earthquake and Fire. Was their home burned and did they stay over in Alameda with close family friends for a period after April 1906?

I have been debating whether or not to send you a recent treasure find that I've been perusing nightly much past my bedtime for almost a month now.

I have been trolling the photo catalog of a collection located on line through the Bancroft Library and have come up with 3 photos of Great/Grandpa Judge in his duty as a policeman.

The title is all very wrong for the following image, which is why it pays to troll one photo at a time rather than rely upon text captions to locate information .



Bernard Joseph Judge was a cabinet maker by trade who built cases and finished wood work in the scandal ridden City Hall that crumbled and burnt in '06. We was put out of work due to the Depression of the mid 1890's and then managed to get into the SF Police Department. He rose to the rank of Captain and eventually succeeded man who took the majority of photographs that are in this collection as Property Clerk at the Hall of Justice.

The caption refers to the scandal of the decade in S.F. and Hollywood when Rosco 'Fatty' Arbuckle was charged with the murder of Miss Virginia Rappe. Here body was found in his hotel while he was on a wild debauch in San Francisco.

The scandal and fall from grace rated right up there with the O.J. Simpson trials as Fatty Arbuckle was a very big film comedy star in during the Silent era of films.

However, none of that has anything to do with this portrait of Dad's Dad.
