CHAPTER XXX.

BIOGRAPHY AND GENEALOGY.

AYER, JOHN, Salisbury, 1640, had Hannah, born 21st December, 1644, removed to Ipswich 1646, Haverhill 1647, there died 31st March, 1657. (See page 73). John, Haverhill, son of the preceding, born in England, married 5th May, 1646, Sarah, daughter of John Williams of the same, and next, after 1659, Susanna, daughter of Mark Symonds, of Ipswich, and removed to Brookfield as one of its first settlers, there killed by the Indians when they destroyed the town, 3d August, 1675. He kept the inn, and his children were (besides Sarah) Samuel, John, Thomas, Joseph, Mark, Nathaniel, and Edward, of whom some lived at Brookfield after its renovation. Another John, perhaps a son, perhaps a nephew of the preceding, was of Ipswich, lately from Haverhill, in 1679, and had a wife Mary. Peter, of Haverhill, 1646, youngest son probably of the first John, married 8th October, 1659, Hannah, daughter of William Allen, was freeman in 1666, a representative in 1683-5-9, and 90, and died at Boston 3d January, 1699, aged about 66. Robert, of Haverhill, brother of the preceding, freeman 1666, married in 1659, Elizabeth, daughter of Henry Palmer, of the same, and had Samuel. Samuel, of Haverhill, son of Robert, freeman, 1683, married Elizabeth, daughter of Simon Tuttle, had Obadiah, (Harvard College, 1710,) John, and James; was selectman and killed by the French and Indians when they surprised the town in August, 1708. Thomas, of Haverhill, 1646, was probably son of John the first, and may have removed to Newbury, there had John, born May 12, 1657, and was freeman 1666.°

BADGER, GEN. JOSEPH, was the eldest child of Joseph Badger, a merchant of Haverhill, where he was born January 11, 1722. His mother, Hannah, was a daughter of Colonel Nathaniel Peaslee, one of the wealthiest and most influential men of this town.

The first person of that name in this vicinity, was *Giles Badger*, who settled in Newbury, Mass., 1643, and died July 17, 1647. His son, *John Badger*, born June 30, 1643, by his first wife, Elizabeth, had John, died in infancy; John, born April.26, 1665; Sarah, and James. Mrs. Badger

John¹ Ayer 1592-1657

John Ayer, son of Thomas and Elizabeth (Rogers) Eyer, was born at Osbourne, St. George, Wiltshire in 1592, and died in Haverhill MA 31 March 1657. [The name is spelled Eyres, Ayre, Ayers, etc.] He married Hannah Evered in England. He departed from Norwich, Norfolk, with his family in 1638, and in 1639 was one of the earliest settlers of Salisbury MA (then called Merrimac). In 1646 he resettled in Ipswich, and then in Haverhill about 1647.

Hannah Evered, daughter of John Evered alias Webb, was born in Marlborough, Wilts, and died in Haverhill 8 Oct. 1688.

Peter Ayer was born in England about 1633, and died in Boston 2 Jan. 1699, while attending general court. He and his brothers John and Obadiah were granted land in the 4th division of Haverhill (later Methuen and Salem NH) in 1659. On Nov. 1 of that year, he married in Haverhill <u>Hannah</u>² <u>Allen</u>. He was made freeman in 1666, and served the militia as cornet of cavalry. He represented Haverhill in the general court from 1680 until his death.

Hannah Allen, daughter of William and Ann (Goodale) Allen, was born in Salisbury MA 17 June 1642, and died in Haverhill 22 Dec. 1729.

officer who had command of the troops besieging Macbeth in Dunsinane Castle ordering his men to march to the attack with branches of oak taken from Birnam Wood, and on that account obtained the name of Aikman, is still an article of faith with some (C. E. Stevens, Stevens genealogy, New York, 1904, p. 87-89) though too silly for belief. Alisaundre Akeman of Lanarkshire who rendered homage in 1298 (Bain, II, p. 204) is believed to be first of the name recorded in Scotland. His seal shows a fox, with paw raised, looking upwards, and S' Alexandr' Acman (ibid., p. 186). The tombs of ten John Aikmans are said to be in Arbroath Abbey, and the surname is also recorded in Orkney in 1575 (Oppressions, p. 4). John Hekman was bailie of Montrose in 1400 (Stodart, 11, p. 404). William Aikman (1682–1731), the portrait painter, sold the family estate in 1707 on leaving Scotland to study in Rome. Akman and Aykman 1505.

AILMER. Emme de Ailmer and Roger de Almere, both of Selkirkshire, rendered homage, 1296. The seal of the latter bears a hunting horn, stringed, and S' Rogeri d' Alnmer. As Roger de Aylemer he accounts in 1304 for the ward of Trequair (*Bain*, π , p. 198, 202, 439, 552). Adam Aylmer was a tenant under the earl of Douglas in the vill of Tybris, 1376 (RHM., π , p. 16), and Elizabeth Aimoir appears in Cambuswallace, 1603 (*Dunblane*).

AIMERLAND. Probably from the Aimerland (1602) of *Perth Retours*, no. 106. Henry Aimerland, servitor of James Wishart of Pittarrow, 1629 (RPC., 2. ser. III, p. 209).

AINSLIE, AINSLEE. Most probably from Annesley in Nottinghamshire, England. William de Haneslej who witnessed a charter by Walter, bishop of Glasgow, between 1208-18 (LCD., p. 236) is probably William de Anslee, canon of Glasgow c. 1220 (RMP., p. 1). In 1221 Magister Thomas de Aneslei was one of a number appointed to settle a dispute between the monks of Kelso and the bishop of Glasgow (REG., p. 101; Kelso, 230), and Sir Aymer de Aynesley was one of the knights appointed to settle the law of the marches in 1249 (APS., 1, p. 413). Two individuals of this name rendered homage in 1296: (1) John le fiz Johan de Anesleye of Roxburghshire, and Johan de Anesleye of Crucfut [? Crawford] of Lanarkshire (Bain, II, p. 199, 212). The seal of the former appended to his homage is broken but shows two geese (?) drinking at a fountain and S' Ioh'is. se. . . Ant (?). Adam de Aynesleye was juror on an inquisition 5 gow, 1432 (REG., p. 335). Cf. EYRE.

held at Roxburgh in 1357 (ibid., m, 1641), and John of Aynesley witnessed a grant of the forest of Eteryk to John Kerre in 1358 (Roxburghe, p. 8). In 1377 Robert II granted to William de Aynysley a charter of the lands of Dolfynston in the sheriffdom of Roxburgh forfeited by John de Aynysley his father (RMS., 1, 592). The lands of Dolphingstoun passed, c. 1500, to the Kers of Cessfurd through marriage of Mark Ker with Marjorie Ainslie, daughter and heiress of John Ainslie. Ralph Aynsle produced a remission for being treasonably associated with Alexander, formerly duke of Rothesay, in 1493 (Trials, 1, p. °17). John Ainslie, the eminent geographer and land surveyor, was a descendant of the old family, and Robert Ainslie (1766-1838) was a friend and correspondent of Robert Burns. The surname was at one time common in and about Jedburgh, but has now disappeared from there. Anenislie 1598, Ainsley 1689, Ainsloe 1677, Anslie 1567, Ansly 1677, Anysle 1493, Aynisle 1464, Aynsle 1464, Enslie 1685, Henesleis (pl.) 1579.

AIR, AYR, AYRE. (1) Robert Air of Hedreslawe was rentaller of the mill of Hedreslawe in 1281 (Bain, 11, 196). Johan Ayr of Aytone, Berwickshire, rendered homage, 1296 (ibid., n, p. 206). Thomas Ayre was provost of Kintore, 1331 (ER., 1, p. 356), Elyas Ayr witnessed a charter by Robert de Lamberton, 1336 (Raine, 230), and in 1401 Richard Ayre made a wadset of part of the lands of Kinnaird to Duthac de Carnegie (Southesk, p. 719). Michael Ayr appears as a witness in Brechin, 1450 (REB., π , 83), and the surname of Air subsisted in the parish of Farnell until 1851, when the last of the name (an unmarried woman) died at an advanced age (Jervise, LL., p. 239). The lands of William Ayr or Air in the lordship of Dunbar are mentioned in 1522 and again in 1535 (Home, p. 32, 35), and the lands of a later William Air in the Merse are mentioned in 1580 (ER., xxr, p. 65). Janet Air in Brechin, 1583, and Patrick Air in Panbryde parish, 1675 (Brechin). John Aire in Coldstream, 1780 (Lauder). Perhaps same as EYRE, q.v. (2) Of local origin from the royal burgh of Ayr. Reginald of Ayr was clerk in Ayr, 1287 (Bain, n, p. 89). Albinus or Aubinus de Are had a charter of "unam obulatam terre que vocatur Cercnokenculrath et Autitigille cum pertinenciis" from Robert 1 between 1315-21 (RMS., 1, 49). Walterus de Are, clericus Glasguensis diocesis, notary public, 1399 (Pollok, 1, p. 138). Dogall de Are witnessed the sale of a tenement in Glasgow, 1430 (LCD., p. 246). Richard Air was bookbinder in Glas-

The Surnames of Scotland

AIRD. Of local origin from a place of the name. It may be from Aird near Hurlford, Ayrshire, or from the hamlet of Aird in the parish of Inch, Wigtownshire, more probably from the former. The Airds of Holl and the Airds of Nether Catrine in Ayrshire were ranked as old families. Nicoll Ard and William Ard, followers of the earl of Cassilis, were respited for murder in 1526 (RSS., I, 3386). George Aird was herd in Melrose 1658 (RRM., I, p. 183), William Aird was heir of William Aird of Holl of Neitherburntschellis, 1687 (*Retours, Ayr*, 647). John Aird, merchant in Dundee, 1696 (*Inquis.*, 7669), may be John Aird, maltman in Dundee, 1697 (*Brechin*).

AIRDS. Local. There are several places named Airds, mainly in the south-west. Mr. James Airds was minister of Torryburn, 1686 (RPC., 3. ser. XII, p. 55).

AIRIE. Local, probably from the two and a half mark land of Arie, 1611 (*Retours, Kirk*cudbright, 104). John Airie in Wakemilne, 1685 (RPC., 3. ser. x, p. 197).

AIRKIE. Robert Airkie, servant to Durie of Grange, 1679 (RPC., 3. ser. vi, p. 286).

AIRLAND. Henrie Airland in Strathhendrie possessed the fermes of the land of Fynmouth, 1606 (*Fordell*, p. 159–160).

AIRNES. Bessie Airnes in Glencouband, 1657 (Dumfries). There is an Arness near Fenwick, Ayrshire.

AIRRES. Robert Airres in Siministoun, 1692 (Peebles CR.).

AIRSTOUNE. Local. Letters against James Airstoune for defrauding the king's customs, 1524 (*Irvine*, p. 35).

AIRTH. A not very common surname derived from the barony of Airth near Larbert, Stirlingshire. About the year 1200 William de Arthe witnessed a grant to the Abbey of Cambuskenneth (Cambus., 81). Richard Derth (i.e. d'Erth) is mentioned as falconer to the king of Scotland in 1212 (Bain, 1, 532), and Bain notes in his preface that Airth was a famed breeding place of falcons. Willelmus de Herth witnesses a charter by Maldouen, third earl of Lennox, c. 1248 (Levenax, 11). Elena, spouse of Bernard de Erth, laid claim to certain lands in the sheriffdom of Dumbarton in 1271 (RMP., p. 191). Hugh de Erthe, bailiff to Sir John Cumyn in 1291, is probably the Hugh de Erthe, knight, who was taken prisoner in Dunbar Castle in 1296 (Bain, 11, 532 and p. 178). Dr. Ayer, senior, on completing his studies in 1805, removed to Newfield, where he began the practice of medicine, and on the seventh of November of the same year married Thirza Mason, of Bethel, New Hampshire.

He continued in the active practice of his profession at Newfield until his death, a period of twenty-nine years.

He traced his descent (being sixth in line) from John Ayer,¹ of Salisbury, a planter first mentioned in 1637, who removed to Haverhill in 1647 where he died ten years later, leaving nine children.

¹The following is a more complete statement of the ancestry :

I. JOHN AYER (or EYER) of Salisbury 1637, planter, removed to Ipswich in 1646, and to Haverhill, 1647, where he died March 31, 1657. He married Hannah — who died Oct. 8, 1688. They left nine children: John, Nathaniel, Hannah, Rebecca, Mary, Obadiah, Robert, Thomas and PETER. The will was probated at the court held at Hampton, Oct. 6, 1657.

II. PETER AYER, (or EYER) Cornet, of Haverhill, youngest child of JOHN AYER, born 1633; married Hannah Allen of Haverhill, Nov. 1, 1659. He was a Freeman in 1666, and a representative in 1683-5-6-9, 1690-5-6 and 8. He died Jan. 2, 1699, leaving nine children: Ruth, Hannah, Abigail, Mary, Martha, SAMUEL, William, Rachel and Ebenezer.

III. SAMUEL AYER, of Haverhill, the Lieutenant, sixth child of PETER, born Sept. 28, 1669, died Jan. 2, 1744. Was rep-

John Ayer is mentioned by Mirick as one of the thirtytwo landholders of Pentucket, now Haverhill, in 1645. The line descended through Peter, the youngest of the children, a representative from Haverhill for several years, who died January 2, 1699, leaving nine children, the sixth of whom was Samuel, born in 1669, died in 1745. In 1700, according to Mirick, "Nearly one-third of the inhabitants of Haverhill were named Ayer. They were a fearless, athletic race of men and were mostly cultivators of the soil." Ebenezer, born in Haverhill in 1705, died in Salem, New Hampshire, in 1762, was the fifth child of Samuel. His son, Joseph, born in Salem, New Hampshire, May 23, 1746, had six children, Dr. James Ayer, senior, being the fourth.

She was daughter of Robert and Susanna (Atwood) Kimball, of Bradford, Mass.; born March 25, 1707, died Sept. 19, 1749, at Salem, N. H. Lieut. Ebenezer Ayer was prominently mentioned in the Town Records of Salem, New Hampshire, after 1736. Of their children I have the names of five: Ebenezer, Timothy, John, JOSEPH, Isaiah. By his second wife, Elizabeth ——, there were four children : William, Elizabeth, Samuel and Phillip. He died at Salem, N. H., March 3, 1762. The widow died there January 2, 1786.

Ayer is spelt, Ayer, Ayre, Aire, Eire, Eyer, Eyre, and each is also found with an s suffixed. (I., Hoyt, 36.)

Alsbee is spelt, Aslebee, Arsleby, Aslebey, and perhaps on account of possible French origin—possibly on account of illegible chirography, as Aslett and Aslet. (V. Ess. Ant., 187.)

Major John Aldrich of Lakeport, N. H., who is upwards of eighty-four years old, has been kind enough to write regarding his personal recollections of the Revolutionary soldier, Solomon Cole. who is described elsewhere in this issue. Major Aldrich writes as follows:

"My recollection of our great-grandfather Solomon Cole is distinct, though more than 70 years have gone by since he passed from this life. My early home was in the town of Franconia, N. H., about three miles from Lisbon, where he resided with his son, Rev. Samuel Cole. When about 7 or 8 years of age my mother took me with her on a visit to her grandfather, where we remained for several hours and he showed me the scar made by a bullet through his wrist. The cicatrix showed very plainly on both sides of his wrist and it must have been a very ugly wound, partially disabling him through life. I think it was his left wrist, but I am not sure.

"I was twelve years old at the time of his death, and saw him occasionally up to that time. He was quite active until he was past ninety. Once he came to my father's house and took dinner with us and walked home on the same day, six miles in all. He was very sociable, and agreeable in his manners, polite and affable, so much so as to be the subject of remark by strangers. As I remember him, he was slightly below the medium size, straight, and I should judge of nervous temperament. His hair and beard

LETTER OF GOV. BELCHER OF MASS., TO COLONEL SHERBURNE.

[Communicated by JEREMIAH COLBURN, Esq., of Boston.]

Gov. Jonathan Belcher, the son of Andrew Belcher, a wealthy merchant of Boston, was born at Cambridge; he graduated at Harvard University in 1699. He afterwards made two voyages to England, being engaged in mercantile pursuits. In 1729, the House of Representatives chose him their agent to transact the business of the colony in London; on the death of Gov. Burnet, in 1730, he was 2ppointed by the crown governor of Massachusetts and New Hampshire — which office he held for eleven years. He lived elegantly in his family, was very hospitable, made great show in his dress and style of living; by the depreciation of the paper money of that time he was curtailed of a large portion of his salary, and was obliged to expend a large sum annually from his private fortune in order to maintain his sumptous style of living.

He was superseded as governor in 1741, but in 1747 he was appointed governor of New Jersey. He died at Elizabethtown, August 31, 1757, aged 76. His remains were interred at Cambridge, Mass.

The Officers of the Government need not trouble themselves about his heat, nor his Protests, he shall know he is not above the Kings Laws, & the Ship shall lie till he comply with them. Having spent some time in tracing the early generations of the two distinct families of Ayres and Ayer, I desire to preserve the result. Savage in his account makes a mistake which escaped my notice until my attention was called to it by Mr. Melvin Lord. Capt. John Ayres of Ipswich and Brookfield was not the son of John Ayer of Haverhill. I have carefully examined the deeds at Salem, and have careful copies of the town records of Ipswich and Haverhill, and these show that the mistake has been made by confounding two persons of the same name. First, I will give the

John,³ son of John² Ayer, died no doubt unm., as on 23 Sept., 1683, his father presented his inventory (*Reg.*, xv, 331, lines 11-18). Zechariah,³ Ayer, another son of John, was alive at Newbury, 24 Oct., 1696.

I now proceed to the family whose name was commonly spelt AYRES. I have already shown (*Reg.*, xv, 56) that there was a Moses Ayres of Dorchester, 1667, whose son came to Boston and left issue. There were also at Ipswich Samuel and John Ayres, living at the same time, but between whom no relation is known to have existed.

SAMUEL AVRES, Sr., of Ipswich (perhaps the apprentice mentioned by Savage), had Samuel,² b. 14 Sept., 1658; John,² b. May, 1661; Joseph,² b. 29 Oct., 1664; Mary,² b. 22 June, 1667; and Susan,² who m. Thomas Wait, 21 Nov., 1677. He d. 17 Feb., 1696-7. And perhaps he had m. a second wife, Mary Johnson of Hampton, 14 Dec., 1681.

Of his three sons, John,² d. no doubt 23 Nov.. 1690, and made his brother Joseph executor (*Reg.*, xv, 331, line 8). He was a cordwainer, and, I think, did not marry.

Samuel² Ayres of Ipswich, m. I suppose, widow Mary Fuller (pub. 23 June, 1721) and had Samuel, b. 17 Feb., 1722–3, d. 5 Dec. following; Lydia, b. 31 July, 1728, d. 10 Aug. following; Samuel, b. 8 Feb., 1729–30, d. 12 March following; Susanna, b. 1 Oct., 1732, d. 12 Nov. following. He d. 21 Oct., 1743, aged 87, and left his property to his brother Joseph's children. The dates and circumstances seem conclusive that this was the son of Samuel, Sr.

Joseph² Ayres of Ipswich, a tailor, m. Margery —, and had Mary, b. 10 Aug., 1694; Sarah, b. 6 May, 1696; Elizabeth, b. 21 Sept., 1699; Deborah, b. 8 April, 1701; Joseph, bapt. 4 Nov., 1705. He d. 4 March, 1730.

If these records be properly placed, it would seem that Samuel Ayres left but one grandson, while John Ayer had fourteen, all but one of whom married. I now turn to Capt. JOHN Ayres of Ipswich and Brookfield. I have shown that Savage was wrong in giving him Sarah Williams for a wife, and I doubt not that Susanna, dau. of Mark Symonds was his only wife. It has been suggested that he was the John Eyre, grocer of Norwich, Eng., aged 40 in 1637, who went to Holland (*Reg.*, XIV, 327), but this seems highly improbable.

I notice in the Historical Collection of the Essex Institute, 1, 95, that William Lamson of Ipswich died, leaving 8 children before 29 March, 1659; and his widow Sarah desired to marry one Thomas Hartshorne of Reading, but her brothers, William Fellows and John Ayres opposed it, 1661. Now as John Ayres m. a Symonds, and we learn of no other daus. of Symonds except those recorded by Savage, it seems probable that this Sarah Lamson was own sister of John Ayres.

We learn from deeds at Salem, that John Ayres lived at Ipswich, 1648, and as a tenant on Mr. John Norton's farm. In Nov., 1672, he seems to have sold out all his rights in the town, including those derived from his father-in-law, Mark Symonds, and he was killed by the Indians, 3 Aug., 1675.

I find on the original inventory presented by his widow, "I have seven sons and one daughter." She died 8 Feb., 1682-3. I suspect that she was related to Samuel Symonds, at least Mrs. Rebecca Symonds, his widow, having the distribution of some charity, gave a portion of in 1682 to Mrs. Ayres. I have already (*Reg.*, xv, 332) shown from deeds the names of these eight children, they were: John; Samuel;² Thomas;² Joseph;² Edward,² b. 12 Feb., 1658; Mark,² b. 14 Dec., 1661; and Nathaniel,² b. 6 July, 1664; Susannah,² the daughter, m. a Day and had a son Robert Day of New Roxbury, 1716.

John² Ayres, I suppose was of Ipswich, and had by wife Mary, a child, b. Sept., 1677; Abigail, b. 14 May, 1680; Ruth, d. 24 Dec., 1685- He seems to have had no issue, and I think died at Boston 12 Aug., 1711, aged 62; but I am not sure that I identify the right man. Samuel² Ayres of Newbury, m. 21 March, 1677, Abigail, dau. of William Fellows, probably his own cousin, by whom he had Mary,³ b. 13 Jan., 1677-8; John,³ b. 16 March, 1678-9; William,³ b. 26 Jan., 1681-2; Ephraim,³ b. 13 Feb., 1686-7; Stephen,³ b. 13 March, 1689; Jabez,³ b. 27 Dec., 1690; Samuel;³ Joseph;³ Ebenezer;³ and Edward.³ These names I add from a deed of 5 Oct., 1717, of the mother and brothers of Stephen to his widow.

[I may here add that Jabez is recorded as the child of Samuel and Sarah Ayres — yet his first wife was Abigail, his widow was Abigail, and in 1701 William Fellows in a deed mentions "my brother-in-law Samuel Ayres who m. with my sister," and I think it more probable that the clerk made an error, than that Samuel had three wives, two of the same name, and married the second so soon after the death of the first. I have given (*Reg.*, xv, 332) the descendants of this Jabez.]

THOMAS² AYRES of Newbury, m. Hannah Errington, 21 March, 1677, Thomas,³ b. 25 Jan., 1678-9; Hannah,³ b. 2 Aug., 1680; Rebecca,³ b. 27 May, 1682; a dau., b. at Ipswich, June, 1686; Abraham,³ b. 18 June, 1688; Sarah, b. 29 Aug., 1690; Mehitable, b. 5 April, 1697. JOSEFH² AYRES of Ipswich, m. Sarah Caldwell 9 June, 1684, and had Sarah,³ b. 5 Aug., 1685; Elizabeth,³ b. 28 Jan., 1687, m. Aaron Kimball, 5 Feb., 1716-7; John,³ b. 26 Feb., 1692-3; William,³ b. 18 Sept., 1696; and Benjamin,³ b. 16 Dec., 1700. I think he m. a second wife, wid. Hannah Dutch, pub. 21 April, 1714. A deed recorded at Worcester, 1741, but dated 14 Jan., 1716, is from Thomas, Mark and Edward Ayres, all of Portsmouth; Nathaniel Ayres, blacksmith, of Boston; Samuel of Ipswich, son of Samuel Ayres, deceased; and Robert Day of New Roxbury, whose mother was Susanna Ayes — to Joseph Ayres of Ipswich, selling all the land at Brookfield, formerly possessed by our honored father John Ayres.

Of MARK² and EDWARD,² I know only that they were of Portsmouth and Kittery. NATHANIEL² of Boston, I identified in a previous note (*Reg.*, xv, 56).

I will notice but one or two of these grandsons of Capt. John Ayres, whose names may be confounded with others. We have seen that John Ayer, Jr., went to Ipswich, after Capt. John Ayres had removed, thus causing one confusion. We now see that Samuel Ayres, Sr., the apprentice no doubt, had sons Samuel and Joseph married at Ipswich, at the same time that Capt. John Ayres's two sons of the same name had families. I hope that I have kept them distinct, and identified them by reference to deeds. A third Samuel³ Ayres, son of Samuel and Abigail (Fellows) and grandson of Capt. John A., m. Eliner Randall of Ipswich 7 June, 1715, and had Martha,⁴ b. 2 March, 1718; John,⁴ b. 22 Nov., 1719, <u>d</u>. 20 Feb., 1720–1; John,⁴ b. 17 Sept., 1721; Elizabeth,⁴ b. 6 Oct., 1723, d. 9 of same month. His wife d. 31 Oct., 1734; and he m. Hannah Gold (pub. 31 Dec., 1737).

JABEZ³ Ayres, m. Rebecca Kimball 8 Dec., 1718, and lived at Rowley whence he removed to Brookfield. A deed dated 2 June, 1721, shows that she was the dau. of Henry Kimball of Haverhill. The records show that HENRY KIMBALL, m. Hannah Marsh 14 Dec., 1677, and had Hannah, b. 7 Oct., 1678; Mary, b. 24 July, 1680; Judith, b. June, 1682; Elizabeth, b. 21 March, 1683-4; Sarah, b. 13 Sept., 1686; Abigail, b. 7 April, 1689; John, b. 27 Sept., 1691; REBECCA, b. 12 Oct., 1694. His wife and son John were killed 15 March, 1698-9. She was the dau. of Onesiphorus Marsh, who mentions in his will his granddaughter Rebecca Kimball; and this explains why she named her child Onesiphorus Ayres.

ONESIPHORUS⁴ Ayres of Brookfield, m. Anna⁵ Goodale, 1759; she was the dau. of Solomon⁴ Goodale, and b. 18 June, 1740. Her father was son of John³ Goodale (b. 10 Aug., 1681) who m. 8 Sept., 1703, Elizabeth, dau. of John Witt, and d. 11 May, 1752. John³ Goodale was son of Zecheriah² and Elizabeth (Beauchamp) Goodale, and grandson of Robert¹ and Katherine Goodale.

SOLOMON⁴ GOODALE, m. ANNA (HINDE) widow of Samuel Walker, 18 May, 1782, of whom more anon.

He married 19 Oct., 1664, Hester or Esther Huggins, probably daughter of John Huggins of Hampton, N. H. She was admitted to Rowley Church, 8 Dec., 1668. He was admitted 29 Mar., 1669. Freeman, 19 May, 1669.

29 Nov., 1674, "Br. Austin acknowledged his fayling that he had gone soe farr in ingageing himself to a remove to a new plantation before he had propounded his desire to the church that he might have their advice and consent, the church saw noe ground to disuade him from his undertaking (seeing he had noe accomodations heer) but wished gods blessing upon him & his" (Ch. He was a surveyor of highways in 1661.

John 3, with the title of 'Corp'I' was tythingman in 1697. He was lieut. of a company at Chebacco in 1683. He was imprisoned and fined £30 for opposing in town meeting the arbitrary measures of Sir Edmund Andros in 1687. His companions were John Appleton, Thomas French, John Wise, Robert Kinsman. and William Goodhue. His will was dated March 13, 1705, and proved May 17, 1709. He left a wife named Judith, and sons John the eldest, William the second, Thomas and Joseph; a daughter Elisabeth, born March 7, 1684, wife of James Giddings. He appoints '' William Giddinge of Jebacco Cordwinder," sole executor; the will was witnessed by Nathaniel Goodhue, Job Giddings and Samuel Giddings.

ANNABLE, John, a tailor, was an inhabitant in 1647. The same name occurs as a contributor to Major Denison's allowance in 1648; and as one of the inhabitants who are entitled to shares in Plum Island, Castle Neck, &c., in 1664. Again in 1697, the name is among those who have horses that go on the common; and in a list of commoners made March 9, 1707-8. Two persons are probably here designated; father and son. John and Mary had children:

In 1706 permission was granted to John and Matthew, with others, to raise a seat in the gallery of the meeting house. Robert was commoner, in 1707.

ANDERSON, John, was a soldier, and died probably in the army, in 1700. Daniel Ringe was appointed administrator on his effects, Nov. 20, of that year. His property was $\pounds 3$, 1, 5, wages received, and a like sum then due.

AYRES, John 1, was an inhabitant of Ipswich, 1648. He had: Edward, born Feb. 12, 1658,

He was admitted a commoner March, 1667, and had privilege of commonage granted Feb. 1667. He removed to Quabog, afterwards Brookfield, about 1672. He had the title of Captain, and was killed by the Indians at Squakeag, now Northfield, in 1675. (*Felt.*) His wife Susanna, rendered an inventory of his estate, amounting to £195, 13, 6, to which she adds, "I have seven sons and one daughter."

He mentions a daughter Mary, and a grandchild Susanna Waite. It is probable that the Samuel who married Abigail Fellows was the son of Samuel 2. He mentions in his will that he "formerly gave to son Joseph, land where his house stands." He died Feb. 7, 1696.

A'TTWOOD, Thomas, was a surveyor of highways in 1673. He died April 10, 1694. By his will dated March 25, 1693-4 after legacies to his wife Elizabeth, his eldest son John, and his son Thomas, directs that the residue of his property be divided equally among his other seven children, being 5 sons and 2 daughters. The inventory of his property amounted to £267, 13, 5d. His widow married John West, Sept. 9, 1697. Elisabeth West, late widow of Thomas Attwood, Sept. 5, 1698, exhibits a list of debts paid as ex'x of Thomas Attwood. She charges "for ye bringing up Elizabeth from her father's decease to this day 4 years and 1-2 till six yr old;" "bringing up Francis for 5 yr old, 4 yr and 1-2;" "bringing up Joseph fr 3 yr old

* This Samuel Ayres was probably not a son of John 1. There was a Samuel Arres, servant, who came to New England with John and Elizabeth Baker, 1637. He was then 14 years of age. when his father died 4 yr & 1-2." She had rights of commonage in 1697.

AVERYE, Avery, Averell, or Averill. William 1, had a house lot on the south side of the river in 1638, near where the meeting house now stands. He was commoner in 1641, subscriber to towards Major Denison's allowance in 1648. He died before May 20, 1653, at which time his widow possessed a house lot near John Woodam's land. His widow, Abigail Averill, died before March 27, 1655, under which date William, probably her son, presents an inventory of her estate. The effects with their appraised value are as follows:

William Averill 2, probably son of William 1, married Hannah Jackson, July 31, 1661, in which year he was surveyor of highways. He sold to John Woodam, Oct. 4, 1658, a six acre lot of land; he possessed a lot of land Aug. 30, 1655, the "corner of which came near the mill dam." He had a son William born May 1, 1662.

ARDWAY, see Ordway.

ARCHER, Henry possessed a houselot and probably a house on the 'highway leading from the High street to Bridge street,' Fcb. 18, 1638. He was a free holder in 1648. May 10, 1649, he together with his wife Elizabeth, who died April 11, 1669, conveys to William Story, "a farm of ninety acres, granted unto him by the Town of Ipswich, beyond Chebacco falls. He was entitled to certain commoners rights in Plum Island, &c., as Mr. Symonds' farmer in 1664. He appears to have had a house and land in town in 1656; he had granted to him "an acre of land as a house lot and privilege of commonage," February, 1667.

ALLIN, Edward, married Sarah Kimball, Nov. 24, 1658. They
