He served as member of the Spencer Committee of Correspondence, 1775, 1778-1780, and was commissioned Justice-of-the-Peace, 18 March 1772. He was also frequently employed as scribe in writing wills, deeds, and other legal instruments.

1. MILES (OR MYLES) NUTT was born about 1598, and he died at Malden, Massachusetts, 2 July 1671, aged 73 years. He was a proprietor at Watertown, 1636, and was admitted freeman of the Colony, 17 May 1637. He removed to Woburn where he was a proprietor in 1645. He married)Sybil (Tuicknett) Bibble, the widow of John Bibble of Boston, and the daughter of John Tuicknell, of Wedmore, co. Somerset, England, and the sister of John Tuicknell, of Wedmore, to whom she gave power of attorney, 26 September 1650, to collect a legacy left her by her father. John Bibble was a licensed innkeeper at Hull, 29 May 1644, who removed to Malden. Miles Nutt and his wife Sybil made a mutual agreement or will, 4 January 1658, by which her daughter Anna (Bibble) Jones, wife of Robert Jones of Hingham, and her children were to inherit certain property. Miles Nutt made his will 1 February 1673/4, which was probated 15 December 1674, in which he bequeaths to his wife Sybil, and to their daughter Sarah, the wife of John Wyman, and her children. Sybil was in Shadwell in Stepney Parish, London, England, 9 October 1640. After the death of Miles Nutt, she married again, John Doolittle, of Rumney Marsh (Chelsea), Massachusetts. The Nutt property in Woburn was given to John Wyman, Jr. first wife

Henry Sweet and wife Mary, with William Andrews and wife Ann and Mary Andrews conveyed to William Spencer "land formerly of John Andrews who died intestate in Newport, R.I., we being heirs." The grantors here were undoubtedly Mary Ridgley Andrew, widow of John¹, her stepson William Andrew with wife Anna Searle and Henry Sweet with wife Mary Andrew, daughter of John¹.

Mary Andrew was certainly Henry Sweet's wife between 1693 and 1713, so she was the mother of Griffin Sweet, born 1709. Some Sweet family genealogists suggest that another Mary could have been Henry's wife before 1693, but there is nothing to indicate he married more than once. Henry Sweet received Mary's inheritance from her brother in the same year distribution was made to the other heirs and Henry was already in possession of part of the land according to the deed. Furthermore, on 4 May 1713 (ibid. 2:146) Henry deeded "for consideration of full satisfaction already in hand [no sum of money mentioned] paid by my son, John Sweet, weaver, one parcel of land, 20 acres, bounded east by highway, north by Charles Andrews, west by William Allin of Prudence Island, southwest by William Andrews." Though the land description is vague, there is some reason to believe this was the 20 ' acres deeded to Henry in 1693 by John² Andrew. If this was Mary Andrew Sweet's inheritance, it would be unusual for her husband to dispose of it to a son not her own, and John⁴ Sweet was the second son, born 24 March 1684.

That Mary Andrew was Henry's wife as late as 17 Jan. 1724/5 (*ibid.* 4:39) is shown by the fact that Henry Sweet with wife Mary [he by "H" mark, she by "X" mark] sold for 120/10 to Charles Hazilton of North Kingstown "the 17th meadow share lying in the Great Meadow in East Greenwich, drawn in the right of John Andrew of Newport" as laid down in the plat of said meadow by John Smith, surveyor, etc.

The date of Henry Sweet's death is unknown and no probate record has been found. From 1713 to 1728 (ibid. 2:144 f., 169; 4:166, 543) Henry deeded land to sons Henry, John, Joseph, Benjamin and William Sweet, to the last named on 31 Oct. 1728, the final land transaction for the father. Mary Andrew Sweet, wife of Henry, is believed to be the "Mary Sweet of East Greenwich, died 2 May 1752, in her 89th year" recorded at West Greenwich (Arnold, Vital Record, West Greenwich 1:97). The entry follows that of the death of her granddaughter, "Hannah Sweet, daughter of Benjamin, died 8 April 1752 in her 18th year," both shown to be in Volume 1, p. 87 of the original records. It is logical to suppose that Benjamin⁴ Sweet, who lived at West Greenwich by this time, recorded the death of his daughter and his mother at the same time. No other Mary Sweet of East Greenwich fits this age at death.

Mary² Andrew was thus born about 1664, the daughter of John¹ Andrew and his first unknown wife, probably their eldest child. She married about 1681 Henry³ Sweet.

THE ENGLISH ORIGIN OF MILES NUTT WHOSE DAUGHTER SARAH MARRIED JOHN WYMAN

BY JOHN B. THRELFALL

In 1955 Mr. John Insley Coddington published an important article (TAG, supra, 31:90-101) on Mrs. Sybil (Tincknell) Doolittle which showed that the second of her three husbands was Miles Nutt, born 1598, died at Malden, Mass., 2 July 1671 aged about 73. Mr. Coddington presented what was then known about Miles Nutt and his only child Sarah, but the origin of Miles Nutt and the name of his first wife were unknown. The following parish register entries seem to apply to the family of Miles Nutt who came with his first wife and one daughter Sarah to New England by 1636 in which year he was a proprietor of Watertown and received a grant in the first distribution. Sarah married on 5 Nov. 1644 John Wyman of Charlestown, had ten children; married a second time, 25 Aug. 1684, Thomas Fuller, and she died 24 May 1688. Since Miles Nutt had only one daughter and no sons, there are no descendants of the name, but the numerous Wyman descendants will be interested to know the background of Miles Nutt.

Although a search was made, nothing can be found in the way of probate records for the Nutt, Jackamin or Branson families, nor were there found any parish records which might have extended this pedigree. Perhaps they are to be found in other parishes.

Barking is about one mile southwest of Needham and Old Newton is about five miles north of Needham. There is another parish named Barking in Essex.

THE HAUTEVILLE ANCESTRY



The late Mr G. Andrews Moriarty in his as yet unpublished The Plantagenet Ancestry devotes folios 71 to 74 to the Hauteville family and their relations the Princes of Capua, and the Dukes of Naples and Spoleto; and folio 74 gives an expanded version of his account of the ancestry of Guy, Duke of Spoleto, Lay Abbot of Mettlach (d. 860), that appeared in NEHGR 107 (1953) 282-4. However, these particular tables rely heavily on W. H. Turton [The Plantagenet Ancestry (1928)]; E. Rübel (Ahnentafel Rübel-Blass (1939)], and E. Winkhaus [Ahnen zu Karl dem Grossen und Widukind (1950-53)]; and as all their accounts of the Lombard and Norman rulers of this period in Italy have been largely superseded by the writings of Augusto Sanfelice di Monteforte [La prima famiglia di Guaimario IV, Principe di Salerno (1936);Richerche storico-critico-genealogiche (1947-62), which are not readily available, here follows an attempt partly based on Sanfelice to revise and amplify Moriarty's pedigrees, and suggest further lines of research, without in any way following up every ancestral line as far as possible as Moriarty does.

According to Moriarty (fo. 71) Tancred d'Hauteville married twice, and by one of his wives, both of unstated origin, was the father of Robert Guiscard, who in turn married twice. By his first wife Alberada, also of uncertain origin, Robert Guiscard was the father of Bohemond of Antioch, whose descendants are well-known [see F. L. Weis, Ancestral Roots of Sixty Colonists (4th ed. 1969), Line 103]; and by his second wife Sikelgaita of Salerno Robert Guiscard is presumed by Moriarty to have had a daughter Matilda, wife of Raymond Berenger II of Barcelona and ancestress of the Counts of Barcelona and Provence, and so of Eleanor of Provence, wife of King Henry III (Weis, op.cit. Line 111).

Now Szabolcs de Vajay has shown in a pamphlet entirely devoted to the subject that the above Matilda was certainly the eldest of the six children of Robert Guiscard by his second wife Sikelgaita [Mahaut de Pouille, comtesse de Barcelone et vicomtesse de Narbonne, dans le contexte social de son temps (1971)]. Matilda married first in 1078 Raymond Berenger II, Count of Barcelona, who was assassinated in 1082 leaving an only child Raymond Berenger III; and secondly in 1085 Aymeri I, Viscount of Narbonne, who died on crusade in 1105 and by whom she had five children including a son Guiscard named after his famous grandfather. Matilda died in 1108.

Sybille, the youngest child of Robert Guiscard by Sikelgaita, married Eble II de Roucy. Turton (*op.cit.* fo. 184) gives Ade, wife of Gaucher II de Châtillon (d. 1148), as Ade de Roucy, a granddaughter of Eble II and Sybille de Roucy; and Elizabeth Woodville, wife of King Edward IV, was certainly descended from Gaucher II and Ade de Châtillon. However, W. M. Newman [*Les seigneurs de Nesle en Picardie* 1 (1971) 190-2] has examined the problem of the identity of

Sybil Tincknell or Tyncknell was baptized at Wedmore, co. Somerset, England, 2 Aug. 1607, and after three marriages and widowhoods she died at Malden, Mass., 23 Sept. 1690, "aged about 82 years" according to her gravestone in Malden Cemetery, though she was really 83. She was the daughter and the elder of two children of John Tincknell or Tyncknell, who was baptized at Wedmore 29 Sept. 1580 (son of an earlier John Tincknell), buried there 3 Nov. 1626, and married there 16 Oct. 1606 to Margery Rodford, baptized there 8 Dec. 1583, daughter of Simon and Joan (Burges) Rodford of Wedmore who were married there 2 May 1583. [Parish Registers of Wedmore, co. Somerset, 3 vols., Wells, 1890.]

Sybil Tincknell married first, at Wedmore, 7 May 1629, John Bibble (also spelled Bibbill and Bible), who is said in the Banks Mss. in the Rare Book Room in the Library of Congress to have come from Lympsham, co. Somerset, which seems very probable as Lympsham is but eight miles from Wedmore. John and Sybil (Tincknell) Bibble had no children baptized in Wedmore, and they may have left Somerset soon after their marriage. They lived for a time in Shadwell, then part of the large parish of Stepney, co. Middlesex, but now a part of London.

John Bibble came to New England by 1637, and a house lot in Boston was granted to him on 4 Oct. 1637. He soon engaged in litigation. At a Court held at Salem on 31 March 1640, the Constables of Salem and Marblehead were ordered to arrest and commit to gaol in Boston William Mead and Thomas Ashley, to answer at the next court in Salem to John Bibble in the matter of debt [Records and Files of the Quarterly Courts of Essex County, Mass., 1:16-7]. Sybil had not accompanied her husband to New England, and on 9 Oct. 1640 she was still in Shadwell. On that date "John Bibble made a letter of Attorney to Sibill Bibble his wife of Shadwell in Stepney parish & John Waterton of the same shippwright to sue James Buckley of Shadwell aforesaid" [Note-Book Kept by Thomas Lechford, Esq., p. 181]. The date of Sybil's arrival in New England is not known, but it was probably not long after 1640.

The Bibbles seem to have lived both at Malden and at Hull, Mass. On 29 May 1644, John Bibble was licensed as an innkeeper at Hull. On 26 Sept. 1650, "John Bibble of Hull in N.E. constituted John Tincknell of Wedmore in Somersetshire his wives brother to aske leavie

ac. a certaine rent due to his wife for lands in wedmore aforesd (being daughtr of John Tincknell late of wedmore aforesd deceased) [Aspinwall Notarial Records, p. 322, orig. p. 289].

John Bibble died (apparently at Hull) between 21 July 1653. the date of his will, and 21 Aug. following, the date of probate in Middlesex Co., Mass. There is a record of the death of a "Thomas" Bibble in 5 mo. 1653 in the Malden Vital Records; doubtless this is a mistake for John Bibble's death. His will, which was printed in full in the New England Hist. & Gen. Register. vol. 9, pp. 306-7, contains the phrase "1 John Bibbill of Malden in New England living now of Hull in New England." From the language of the will, it is evident that John and Sybil (Tincknell) Bibble had only one child living, namely, Ann, wife of Robert Jones.

Sybil (Tincknell) Bibble married second, presumably at Malden, in January 1658/9, Miles Nutt, who was born about 1598 and died at Malden 2 July 1671, aged about 73. She was his second wife. The birthplace of Miles Nutt in England is not known to the present writer, and the surname Nutt, though not common, was found in the 17th century in widely separated parts of England. Miles Nutt came to America by 1636, accompanied by a first wife whose name is unknown and a daughter Sarah. He was a proprietor in Watertown that year, and was made freeman 17 May 1637. He then moved to Woburn, where he was a proprietor in 1645. His daughter Sarah Nutt married at Woburn, 5 Nov. 1644, John Wyman of Charlestown, Mass. At some time after this, Miles Nutt moved to Charlestown, where he was one of the petitioners in favor of the freedom of the church.

At the time of their marriage, Miles and Sybil made the following contract:

"A mutuall Agreement made the 4th day of Januarie 1658 [1658/9] Betweene Miles Nutt and Sibell his Wife Concerning the Settling of his Estate upon his said wife for her future. Imp: it is my Will and reall Intention that my wife Sibell that now is shall have and enjoy hir Life in the house I now live in in Charlestowne after my decease And that she hold and possess it with all things thereunto belonging or in any wise appertaining for terme of her Life moreover it is my will & desire that my aforesaid wife Sibell shall have the one halfe part of my whole Estate as well reall as personall of all and whatsoever I may die possessd of at the time of my death Excepting the house above mentioned which she shall Enjoy only for terme of Life, with all appertaining thereunto. Furthermore it is my Will and desire that if God take first away by death my wife Sibell before me that in such Case my will is that the sd halfe part of my Estate as above mentioned (at the

time of my death and decease) shallbe given and fall unto y^e daughter of my Wife Sibell by name Anna the wife of Robert Jones and unto his Children of hir Bodie. And further it is my desire that if after my decease my wife Sibell survives. and that then shee shall desire to live & dwell in my house and land at Maulden in such case my will & desire is that she shall have libertie to have and Enjoy that house & land conditionally that that the Estate being equally divided shee give a full Allowance for such hir Libertie as Indifferent men shall Judge meete in that case. And further I doe fully a really make over unto my wife Sibell that tenne pounds which I lately received of William Morris the which he is to receive by exchange of his friends in England. I doe hereby make it safe unto her to be at hir dispose After my death and decease. In witnesse of truth I have hereunto sett my hand seal.

In addition, Miles Nutt left a will (in the same file):

"The Last Will and Testament of Miles Nutt made the first day of Februarie in the yeare 1660 [1060/1] being very sensible and in good understanding. I doe firstly Committ my soule unto God who gave it me and my Bodie to be laid in the grave. Next I doe bequeath unto my wife Sibell all and whatsoever I have by deeds under hand and seale of a former date I say I doe hereby fully ratifie and Confirm what is therein Exprest a mentioned And no more. Nextly whatsoever Estate [shall leave or die seased of more and besides what is given by deede to my wife Sibell, I doe bequeath all such Estate unto my daughter Sarah the now wife of John Wyman to have and p'sess whatsoever may Appeare to be mine shee to enjoy it for terme of life and after her decease the said Estate to fall unto hir Children that Are or may be, to bee divided equally betweene them only the eldest son John shall have a double portion. And further my Will is that John Wyman the Elder be Executor unto this my Last Will and Testament and I doe further desire and here nominate my trusted friends Solomon Phipps and Jo'n Catler [sic-probably John Carter was intended] to be my overseers in trust to see this my Will performed. The mark of Miles Nutt Witnesses hereunto: James Cary, Solomon Phipps, Thomas Carter. James Cary & Tho: Carter do attest on oath that the abovesd is a true coppie of Miles Nutts will."

From the language of the foregoing contract and will, we may, perhaps, infer that Miles Nutt was Sybil (Tincknell) Bibble's enthusiastic bridegroom in January 1658/9 but a bit more restrained by 1 Feb. 1660/1. Miles Nutt was a juror in Charlestown in 1660, and Sybil his wife joined the church there on 29 (6) 1660. They evidently moved to Miles Nutt's house in Malden after that year.

After Nutt's death in 1071, Sybil remained a widow three years, then married third, at Malden, 30 Oct. 1674, John Doolittle (or Dowlettell, as he himself wrote the name). Sybil was his second wife.

According to Elijah E. Brownell's edition of Charles E. Banks, <u>Topographical Dictionary of 2885 English Emi</u>-grants to <u>New England</u> (1937), p. 184, John Doclittle and his brother Abraham came from Ribbesford, co. Worcester. The authority given is Banks Mss. The present writer has not been able to find the reference in the original Banks Mss. in the Library of Congress. The Parish Registers of Ribbesford commence in 1574, but have not been searched in connection with this article. Several other New England settlers came from Ribbesford, and "Doelittle" was a Worcestershire name. In An index to Worcestershire Fines, 1649-1714, edited by John Amphlett (1890), the name appears twelve times; six times in connection with the parish of Kidderminster, and once each in connection with Bewaley, Offenham, Shrawley, Rushock, Holt and St. Swithins. Bewdley is an adjoining parish to Ribbesford, and from Bewaley cate the prominent Wakeman family of New Haven.

To New Haven came Abraham Doolittle, John's (probably younger) brother, who was born about 1620 and died at Wallingford, Conn., 11 Aug. 1690, aged about 70. He married first, Joan Allen, who was baptized at Kempston, co. Bedford, 12 Oct. 1617, daughter of James Allen of Rempston, blacksmith, whose will, dated 7 Jan. 1050, names "Abram Dewlittle & my daughter Joane his wife, living now also in New England." [The will of James Allen was given in full in George P. Allen, A History and Genealogical Record of the Alling-Allens of New Haven, Conn. (1899), pp. 9-11, and was later briefly mentioned in George Sherwood, American Colonists in English Records, 1st Series (1932), p. 47; and other records of the Allens in England were given by Donald L. Jacobus in The American Genealogist, vol. 27, pp. (-).] The Parish Registers of Kempston, published in the Bedfordshire Parish Register Series, contain no mention of any Doolittles, and indeed it seems quite possible that Abraham married in New Haven, where Joan's brother Roger Allen (or Alling) had settled. For other details concerning Abraham Doolittle, and his descendants, see William Frederick Doolittle, The Doolittle Family in America, Cleveland, Ohio, 1901-8, and

John and Abraham Doolittle are said to have been in Boston as early as 1640. Abraham removed to New Haven in 1644 and his later career is associated with that colony. But John moved to Lynn about 1643. and later to Rumney Marsh [now Chelsea and Revere, Mass.]. "John Doelittell" was chosen Constable of Rumney Marsh at a general town meeting held 14 (1) 1652/3. On 12 (1) 1654/5, John Doolittle and two others were chosen to run the line between Lynn and Boston and Charlestown and Boston. On 9 March 1662/3, he was chosen surveyor of the highway at Humney Marsh for the ensuing year. He was again chosen Constable for Rumney Marsh on 13 March 1670/1, and in April 1650 he was chosen Tythingman for Rumney Marsh. In 1660 he was made executor of the will of William Bunnell of Pulling Point, and in the same year he was named in the will of the Rev. Edward Holyoke of Lynn, who died at Rumney Marsh 4 May 1660. John Doolittle died at Salem between 22 Sept. 1681 (the date of his will) and 14 Oct. following (the date of probate). The will reads:

"I John Dowlettel living in Rumney Marsh make this my last will and testament. To my loving wife Sybbell the thirds of the rent of my houses and landes, also her houses and land at Malden and Forty pounds and other goods all which is mentioned in perticular in a writing under my hand before marriage to her which Some of those perticular goods I have received but the most part I have not, also my will is that what ever other goods that were hers before I married her. that are in the house, as bees ac. that are not mentioned in the writing Shee should have forever. Also my wife should have that land and marsh which I bought of Thomas Wellman, and after her death [these lands] to be equally divided between Benjamin Jones and the children of Mary Jenkins the wife of Obadiah Jenkins the Grandchildren of my said wife. To my brother Abraham Dowlettell I devise the marsh bought of Mr. Holyoke in Lynn, to be to him for his life and at his death to his son John forever. Also to my brother Abraham I give the marsh bought of Goodman Browne in Lynn, and my part of the house that was Mr Coggans, and my part of the house that was Mr Robinsons, both in Boston, and fifty pounds to bee equally divided among his children as they come of age. Also all my wearing Clothes. To John Dowlettell the son of my brother Abraham fifty pounds. To Joseph Floyd the son of John Floyd the houses and lands that John Paul lives in, when he comes of age, and if he die before the age of twenty-one it is to be equally divided between his brothers and sisters. To Rev. Mr. Wigglesworth Pastor of the Church of Malden 20 shillings in silver yearly as long as he liveth in Malden. To Sarah Floyd daughter of John Floyd one hundred pounds. To John Floyd that two hundred pounds that Ebenezer Stocker is to pay me, twenty pounds a year towards my maintaining one of his sons at the Colledge. To Sarah Floyd wife of John Floyd fifty pounds, and to their children fifty pounds to be equally divided between them as they come of age. Signed 22 Sept. 1681. John Declittle his marke

Witnesses: John Richards his marke Ebenezer Stocker his marke

John Richards and Ebenezer Stocker made oath in Boston 25 Oct. 1681. Dowlettell his Inventory, taken 10: 8:1681-Total £1578:07:0. John Floyd the Executor made oath 14 Oct. 1681" [Suffolk County, Mass., Probate #1196, not printed in W. F. Doolittle, The Doolittle Family in America, the author of which says, pp. 53-4, that John Doolittle was "said to be" brother of Abraham. Had the author seen this will, he would have been able to state the brotherhood positively].

Sybil (Tincknell) (Bibble) (Nutt) Doolittle remained a widow for the third and last time, for almost nine years. Her own will follows:

"I Sybille Doolittle of Malden widow make this my last Will and Testament in manner following. I commit my soul to God who made it and my Bodie to earth whence it came. I give to Obadiah Jenkins and Mary his wife and to their Children all my housing and lands in Malden with all my movables, he the said Obadiah Jenkins paying out of it unto my Grand children Robert, Zechary, Benjamen and Rebeccah Jones five pounds a piece when they come of age, the sons at y^e age of twenty one, the daughter at y^e age of eighteen. Item I give to my Grand child Sarah Browne one pewter platter and to her son Joseph Browne two pewter platters. _tem I give to Hannah Faddick five shillings and to her children John and Mary two pewter platters a piece. And I make my grandson Obadiah Jenkins my Executor of this my Last Will and Testament And I nominate and Desire my loving friend Mr Wigglesworth & Deacon Sprague to be ye overseers of this my last Will to see it performed. In witness whereof I have set my hand this twenty fifth day of December eighty three. her

In presence of Thomas Cheeves, John Wayls. Inventory of the Estate of y^e widdow Sibell Dolitle Deceased taken 23 September 1690: Ebbts due Funeral charges Usigned, Job Lane, Benjamin Sweetsor, The: [illegible].

"May it please this Hono^{ed} Court to understand that I was present at the making of this will of ye widdow Doolittle which Obadiah Jenkins hath to present unto your Honors. And she seemed at that time to understand her self & ye business she was about compotantly [sic]. The will was in my hand for some time and afterwards she desired to have it in her own hand, & had it. How it came torn I know not, but this is certain she hath been pittifully distracted most of ye time since ye will was written. What she hath given to Obadiah Jenkins α his wife by this will they have dearly earned it. since y^{θ} will was made, α it is but a poor recompense in my judgment for ye great care & trouble they have been at with her continually both in her distraction & in her several sicknesses, which I hope the Court will in their wisdom consider of, tho' the will be not according to law, not further to trcuble yor Honors I rest yor Honors most humble

Malden October 7 1690 serv^{nt} & Dayly Orator at y^e Thrown of Grace Michl Wigglesworth

To the Honoured Deputy Governor together with the rest of y^{Θ}

Honcd Court at Cambridge."

[The foregoing documents are in the Probate of Sybil Doolittle, #6361, Middlesex County Court House, Cambridge, Mass.]

The only known child of Sybil (Tincknell) (Bibble) (Nutt) Doolittle, by her first husband, John Bibble, was:

Ann or Anna, b. about 1630; see below.

1. Ann or Anna Bibble, born in England about 1630, died between 7 June 1677 and 22 Sept. 1681. As "An: Bibble" she was one of the women of Malden and Charlestown who signed a petition to the General Court of Massachusetts Bay requesting that Rev. Marmaduke Matthews be permitted to remain as minister at Malden. The date of this petition was 28 Oct. 1651, and Ann must have been of age to sign it (Deloraine Pendre Corey, The <u>History of Malden, Mass., 1899, p. 146</u>). In her father's will, dated 21 July 1653, she was named as wife of Robert Jones and her eldest child John received a bequest of 105. It is presumed, therefore, that her marriage to Robert Jones took place at the end of 1651 or early in 1652.

Her husband was Robert² Jones, eldest son of Robert¹ and Elizabeth (Soane) Jones. He is said to have been born near Reading, co. Berks, England, after 1625, in which year his parents were married [Melvin E. Jones, Jones-Hathaway-Richards-Gooding Genealogy, 1934, p. 3]. Robert¹ Jones was a planter at Hingham, Mass., in 1636, and Robert² probably accompanied his father to America and lived at Hingham till his marriage. At that time, Robert² apparently moved to Hull, then made a further move to Rehoboth, Mass., after the death of his fatherin-law John Bibble. He bought land in Rehoboth from Robert Titus on 23 March 1653/4, and had settled there by mid-September 1654. He took the oath of fidelity at Rehoboth and lived there over fifteen years, but moved to Swansea, Mass., soon after 28 Feb. 1669/70. He is mentioned in Richard LeBaron Bowen, Early Rehoboth (4 vols., Rehoboth, 1945-9), 1:16, 36, 38, 39, 41, 42, 43, 57, 63; and 3:48, 64, 145, 156, 168. Robert Jones, together with his eldest son John and son-in-law Joseph Lewis, fought the Indians in King Philip's War, and all three were killed and scalped by Indians in a skirmish at Swansea on 24 June 1675 [Plymouth Colony Records, 3: 61. and Jones-Hathaway-Richards-Gooding Genealogy, loc. cit.].

In both Savage, Genealogical Dictionary of New England, 2:554-5, and Pope, Pioneers of Massachusetts, p. 262, there is some confusion between the careers of Robert¹ and Robert² Jones. This is cleared up by Melvin E. Jones in his Genealogy. Robertl Jones survived his eldest son by more than sixteen years and died at Hingham 17 Nov. 1691, leaving a will dated 20 Apr. 1638 in which he bequeathed "to my grandchildren which are the children of my son Robert Jones deceased" [History of Hingham, Mass., 1893, vol. 2, p. 387]. "The heirs of Robert Joanes" [meaning the heirs of Robert] and their property in dehoboth are mentioned in a list of the inhabitants of Rehoboth in 1689, printed by Richard LeBaron Bowen in the New England Hist. and Gen. Register, 97:320, 326. Children:

- i. John³ Jones, probably b. at Hull, Wass., in the second half of 1552; received a bequest of 10s. in the will of his maternal granifather, John Bible, dated 21 July 1653; killed and scalped together with his father and brother-in-law by Indians at Swansea, 24 June 1675; unmarried.
- ii. Mary Jones, probably b. at Hull, Mass., soon after 21 July 1653; not mentioned in John Bibble's will of that date.

iii. Sarah Jones, b. at Rehoboth in mid-Sect. 1652; named in the will of her grandmother Sybil, dated 1683; m. at Lvnn 22 Dec. 1680 Joseph Brown of Lvnn, Mass. Child:

 Joseph Brown, b. at Lvnn 12 Apr. 1682; named in the will of his great-granimother Sybil, dated 1683.

iv. Hannah Jones, b. at Rehoboth "latter end of Aug." 1656.

- v. Mercy Jones, b. at Rehoboth "last of April" 1662; d. voung.
- vi. Rebecca Jones, b. at Rehoboth in May 1665; named in the will of her grandmother Sybil in 1683.
- vii. Robert Jones, b. at Rehoboth in "mid-November" 1667; named in the will of his grandmother Sybil in 1683; weaver; sold land in Swansea in 1696.
- viii. Zachariah or Zechary Jones, b. at Rehoboth 28 Feb. 1669/70; named in the will of his grandmother Sybil in 1683; bought 40 acres of land from Samuel Dailey of Providence, for L20, 9 March 1706 (Austin, Gen. Dict. of R. I., p. 62).
- ix. Benjamin Jones, b. at Swansea 8 May 1674; named in the will of his ster-grandfather John Doolittle in 1681 and in that of his grandmother Sybil in 1683. He is said by Melvin E. Jones, in the Jones-Hathaway-Richards-Gooding Genealogy, p. 3, to have Hived at Bristol, R.I., Swansea and Norton, Mass., but no record of him or his family appears in the printed Vital Records of Norton. He m. at Bristol, 18 Sept. 1696, Elizabeth Border. (Arnold, Vital Record of E. I. 6, Fristol, p. 29). The identity of this woman Duzzles the present writer. She does not appear in the account of the Borden family in Austin, Gen. Dict. of E. I., pp. 23-L, or in Hattie Borden Weld, Historical and Denealogical Record of the Descendants of Richard and Joan Borden, 1899.

The descendants of Benjamin3 and Elizabeth (Borden) Jones in the male line are traced by Melvin E. Jones in his <u>Genealczy</u> (ante cit.), but one item of possible error in this fine bock should be noted. Mr. Jones states (p. 3) that Elizabeth Jones, b. at Bristol, R.I., 12 July 1697, eldest of the seven children of Benjamin and Elizabeth (Borden) Jones, "perhaps married by intention dated 4 Nov. 1741 William Coddington." It is the opinion of the present writer that the Elizabeth Jones who married William Coddington was a younger woman, of a different Jones family.

2. Mary Jones, daughter of Robert and Ann (Bibble) Jones, was probably born at Hull, Mass., soon after 21 July 1653, as she was not mentioned in John Bibble's will of that date; died before 1 April 1720, probably at Malden. She married first, at Swansea, 13 June 1671, Joseph² Lewis (Edmund¹). The date of Joseph's birth is not known. He was killed in battle with the Indians at Swansea, 24 June 1674, together with his father-in-law and brother-in-law. A full biography of Joseph Lewis appears in George Harlan Lewis, "Edmund Lewis of Lynn and some of his Descendants," Essex Institute Hist. Coll., 43:71, 78-81, 121-2.

Mary (Jones) Lewis evidently left Swansea soon after her tragic bereavement, and moved to Malden to live with her grandmother Sybil (Tincknell) (Bibble) (Nutt) Doolittle. She married second, at Malden, 11 Jan. 1676/7, Obadiah² Jenkins, son of Joell and Sarah (Gilbert) Jenkins of Braintree and Malden. Obadiah was baptized at Boston 13 Oct. 1650, and died (probably at Malden) shortly before 1 Apr. 1720, on which date letters of administration on his and his wife's estates were granted to his eldest son Joel. Obadiah Jenkins, Mary his wife and their children were mentioned in the will of Obadiah's step-grandfather-in-law John Doolittle, dated 22 Sept. 1681; Obadiah was appointed executor by his grandmother-in-law Sybil in her will, dated 25 Dec. 1683, and he acted as such when the will was probated in 1690. Rev. Michael Wigglesworth of Malden testified that Obadiah and Mary (Jones)(Lewis) Jenkins "dearly earned" what they received in Sybil's will because of the "great care & trouble" they had with the old lady. For further details concerning Obadiah Jenkins and his descendants, see C. Harold Floyd, "Some Descendants of Joel Jenkins of Braintree and Malden, Mass.," New England Hist. and Gen. Register, 06:269-72. See also, H. W. Brainard, H. S. Gilbert and C. A. Torrey, The Gilbert Family (1953), pp. 24, 53. Children by the first marriage:

- Joseph Lewis, b. at Swansea 6 June or 6 Aug. 1:72; moved to Malden with his mother, 1675; d. at Wilmington, Mass., 25 July 1755; m. at Malden (by Rev. Michael Wigglesworth) in 17°0 to Hannah Jones, who d. at Wilmington 6 Nov. 1760. Six colldren.
- ii. Sybil Lewis, b. at Swansea 18 Mar. 1673/L; rovei to Malden with her mother, 1675, to live with the greatgrandmother for whom she was named; d. at Malden 23 Feb. 1757; m. there (by Rev. Michael Wigglesworth) in 1700 to Samuel? Howard, b. there in Feb. 1671/2, son of Samuel? and Susanna (Milkinson) Howard (originally Hayward, for whom see Thomas Bellows Nyman, The Genealogies and Estates of Charlestown, Mass., 1879, 1:490-1). Five children.

Mass., 1 Feb. 1749/50; m. at Malden 31 Dec. 1712 Senjamin² Teel (Teal, Teele), b. at Malden 2 Nov. 1689, d. 31 Dec. 1777, bur. at West Cambridge, Mass., son of William¹ and Marv Teel of Malden. Benjamin² Teel remarried at Medford, 27 Sept. 1750, Margery Elder. By his first wife, Anna Jenkins, he had eight children (Wyman, Charlestown, 2:935).

- vi. Obadiah Jenkins, Jr., b. at Malden 4 Apr. 1690, d. there L Feb. 1762; m. at Medford 5 Jan. 1720/1 Mary Grover, b. at Malien 26 Sept. 1701, d. there 10 Dec. 1757, daughter of Andrew and Mary Grover of Malden. One child.
- vii. Mary Jenkins, b. (sav 1692), d. before 12 Apr. 1768; m. at Malden, 27 Dec. 1710, Zachary or Zachariah3 Howard, who d. at Wilmington, Mass., 10 May 1758, son of Samuel² and Susanna (Wilkinson) Howard, and younger brother of Samuel3 Howard who married Mary's half-sister Sybil Lewis. Three children.
- viii. Lydia Jenkins, b. (say 1697), d. at Mansfield, Conn., 1_ Oct. 1762; m. ca. 1719 Noah4 Ucham, b. at Malden 1 Cot. 1694, i. at Mansfield & Feb. 1766, son of Nathaniel3 (Phineas2, John1) and Sarah (Floyd) Upham of Charlestown and Malden (Wyman, Charlestown, 2:979 and F. H. Upham, The Descendants of John Upham, 1892, p. 13, where Ludia is called, by confusion with her mother, "widow of Joseph Lewis of Swansey"). Noah and Lydia (Jenkins) Upham moved from Malden to Pomfret, Conn., in 1727 and bought 103 acres there from Joseph and Elizabeth Sessions, for 1500. They later moved to Mansfield, Conn. Four children.

5. Hannah (or Ann or Anna) Jones, born at Rehoboth "latter end of August" 1650; died at Swansea, Mass., 18 Jan. 1725/6; married at Swansea, 21 Dec. 1673, John² Paddock, born 1 Apr. 1043 [Mayflower Descendant, 17: 135., died at Swansea in 1/18, son of Robert and Mary Paddock of Plymouth and Duxbury, Mass. When Robertl Padcock was on his death-bed in July 1650, he gave his seven-year-old son John to Thomas Willett, and Robert's wide w Mary confirmed the gift in Nov. 1650 (Pope, Pioneers of Mass., p. 338]. John Paddock doubtless follower the exciting and varied career of his master Thomas Willett [ante, 19:139-140], who was the first English Mayor of New York in 1665, but lived in Swansea, Mass., from 1668 to his death in 1674. In Willett's will, dated 26 Apr. 1671, he bequeathed £10 to his "old servant John Paddock" [John Osborne Austin, Genealogical Dictionary of Rhode Island, 1887, p. 428]. John Paddock appears as an inhabitant of Swansea in lists dated respectively 22 Feb. 1668/9, 18 Nov. 1670 and 7 Feb. 1671/2, and in the two latter he is listed as one of the "Third or Lower Rank of Inhabitants" [Bowen, Early Rehoboth, 1:36, 38, 39]. "John and Anna Paddock of Swansey, planter," sold 7 acres of upland

in Rehoboth for £5 to Obadiah Bowen of Swansea on 24 May 1681 [1bid., 3:164], and on 15 Nov. 1686 John Paddock received Lot 2 on New Meadow Neck in Swansea [ibid., 1:42]. Hannah (Jones) Paddock was named as "Hannah Paddick" in the will of her grandmother Sybil, dated 1683. John Paddock was again named as one of the Third or Lower Rank of inhabitants of Swansea in a list dated 1689 [New England Hist. and Gen. Register, 97: 326]. The family is treated in J. O. Austin, One Hundred and Sixty Allied Families, 1893, p. 187. Children:

- i. John Padlock, b. ca. 1674, named in the will of his great-grandmother Sybil in 1683; m. at Little Compton, R.I., 11 Nov. 1706, Deborah² Hilliard, Haughter of Williaml and Deborah Hilliari of Little Compton (James N. Arnold, Vital Record of Ehode Island, vol. L, Little Compton, p. 29).
- ii. Mary Paddock, b. at Swansea 16 Jan. 1576/7, named in the will of her great-grandmother Sybil in 1683.
- iii. Martha Paidock.
- iv. Deborah Paidock, m. at Little Compton, R.I., 11 Nov. 1706 (evidently in a double ceremony with her trother) to Robert2 Wordman, b. at Little Compton 8 Sept. 1677, d. there between 23 Dec. 175_ (date of will) and 5 Sept. 1757 (date of probate), eldest son of Johnl and Hannah (Timberlake) Woodman (Arnold, Vital Record of Rhode Island, loc. cit.; Austin, Ger. Dict. of R.I., p. 231). Five children.

Francis Bacon Trowbridge, The Hoadley Genealogy (1894), page 20, states that Philo Hoadley, b. 12 Oct. 1703, m. at Naugatuck, Conn., Apr. 1783, Esther Hine, moved to Delaware County, Ohio, and left a family, untraced. In the Blockhouse Cemetery, Berlin Twp., Delaware County, are inscriptions to: Esther wife of Philo Hoadly died Dec. 31, 1823, aged 58; Philo Hoadley died Oct. 24, 1839, aged 76; Harry H., son of Philo & Esther Hoadly died 1823 aged 19; Sarah N., daughter of David & Esther P. Hoadly died Sept. 3, 183- aged 18 mos.6 days; and Helen M. daughter of Thomas and Laura Hoadly, born Feb. 15, 1831, died Feb. 9, 1844.
