Dear Walter:-

We just returned from a trip to the deep south for a month's vacation and found your letter awaiting me.

I am glad you wrote Katherine Kimball and I know she will respond if she is able. I was just in Salt Lake and spent two days there at the library. I wasn't able to see, Katherine, but I did call her on the telephone regarding our mutual problem regarding Luther. At that time she was flat on her back with a disc problem in her back, but was still trying to carry on her work with the Tuttle book at home, as at that time, she was unable to get to the library.

It was kind of you to keep me in mind regarding Luther. The latest developments, regarding him, are I have substantial proof that Luther did not marry Ruth Terry (1750) daughter of William Terry and Eliz. Cleaves. This Ruth Terry married first Aaron Woodruff, second Joseph Corey and still a third husband. Not just one reference, but many. When I talked to Katherine in Salt Lake, she said Prof. Tuttle who wrote the Tuttle and Tuthill's of America, said he had such little information on him, that it was like he had been dropped in the sea. The only information we have on him, that was given to Prof. Tuttle, were the Manti Temple records of the church and the Archive record regarding Ruth Terry certainly was wrong. I do feel that Luther married a Terry, as he named a son Terry and he in turn also named a son Luther Terry. However, I now feel more confident regarding him, as in September I wrote the the Surrogate Court of Suffolk Co. in Riverhead for a possible will. They will search court records' for a fee. When I returned hom they informed me they had found two early Luther's one Luther V Tuthill and the other Luther G. Tuthill and had to have more information. To-day, I sent them the Archive record, giving the name of the children, stating Ruth Terry was not his wife. There were two other Luther's of Long Island before 1800, one was Luther that married Eliz Moore and the other was Luther that married Mehitable Petty, the latter being a nephew of my Azariah.. I hope something constructive can be found as Katherine has worked just as hard as I have on the Terry line and I started in 1962 and to think we both have been looking for the wrong person, makes it discouraging. Her comments were " It is almost impossible to believe.

In regards to Bethia Hortons, I have found reliable information regarding them both, so I feel very confident about them. But, like you, I never heard of a Moses in the Horton line and my source was in the Tuttle book, regarding Azariah. I found the will of Caleb Horton, son of Barnabus and I am sending you a copy in case you don't have it. I am a member of the New Eng. Hist. and Gen. Soc. and as a member they will send you a collection of their library, three at a time. I have requested the Des. of Barnabus Horton of Southold, but it seems every time I request a book, it is already in use and I don't get it.

I have just written Mr. Breck as a possible membership in to the heritage society, the Order of Founders and Patriots of America. It is a man's organization, but I belong to the Daughters of Founders and Patriots and although I belong to 14 heritage organizations, such as the Mayflower Soc., DAR, Magna Charta Dames, Colonial Governors Americans of Royal Descent, Dames of the Court of Honor, etc., I cherish my membership in the Founders and Patriots because so very few are eligible for membership and once your lineage passes their strict requirements it puts a stamp of approval of your lineage. Currently, the California Society is publishing a lineage book of their members which will be placed in libraries in the U.S. The membership requirements are limited because you must be a direct descendant of either your father or mother, no grandmother lines are accepted and sometimes especially on a maternal line, your children can not become a member, for after you are gone, it becomes a grandmother line, this has happened three times in just the last few months for people writing me asking about membership into the society. My husband is Dep. Gov. of the Order and has been made National Membership chairman and although it is invitational, he would be qualified to issue an invitation. Although there are quite a few members in the bay area, all meetings are held in Los Angeles about four times a year, but even though you couldn't attend the meetings, you feel rewarded for establishing your lineage for your family in the most honored of the heritage societies. You must prove to an early founder before 1657 (you can.), you almost must prove a patriot in the revolutionary war also by the name of Wells (this I don't know if you can) Thomas Welles and Hugh Wells has already been established, but the records as late as 1976 reveals William Wells of Southold never has been, you would be the first one. When I join my many societies, I usually do it for a purpose, either to establish a new line or to pay homage to an ancestor. I thought I should mention all of this to you just in case you could be interested. If you are, just let me know and I can give you more information about it.

Just finished a letter to Katherine Kimball. Surely hope that she has the time and inclination to respond.


In going over your 7-7-81 ltr you mention lack of inf on Luther Tutthill. I have two, as follows:

In a communication to me you wished to know the locale of Luthers death and the following information received by a long distance call from Salt Lake City revealed the following:

A microfilm, in the Salt Lake Genealogical Library states the son of Luther Tuthill (Tuttle) whose name was Azariah. said his father, (Luther) was drowned before 1815; making him near the age of 61 years old when he died and the locale was Smithtown, Long Island (the old name) which was later changed to Oldfield South Bay, Long Island. I am sure this information should be very helpful to you.

Luther was listed in the 1810 census, but not in the 1820, which should be quite helpful as to dates.

Past communication from your office states you have found a file on Luther G. Tuthill and also a Luther V. Tuthill, it is requested, information on thse two men be sent to me. I will be happy to pay for the xeroxing, if necessary.

The Genealogical Society, in Salt Lake is placing the Tuttle name on International cumputor and it is not only important to me, but others as well, that the search in regards to Luther, be fruitful. It is our sincere hope you will be able to help us.

What are the dates of Luther G. Tuthill and Luther V. Tuthill?? it would be quite natural for Luther to name a son after himself.

Thank you so much for all your efforts on our behalf.

Dear Mr. Signorelli:-

In a publication, issued by the Suffolk Historical Society, of Riverhead, New York, entitled, Suffolk Wills, Where Are They, the following information was given among other data.-

For estates from 1797 to the present, the researcher must go to the files of the Surrogate Court at the County Center, Riverhead, New York.

From this suggestion, I wrote to your office in the middle of September, 1981, for a possible will of Luther Tuthill or Tuttle. At that time, I included all the information as to dates.

On September 23, 1981, a form letter, from your office, informed me the court records would be searched for the sum of \$15.00. I immediately sent a check for this amount and it has been cashed by the Surrogate Court.

On October, 7th, 1981, a letter from Thelma H. Elsasser, informed she had been able to locate two files, one of Luther G. Tuthill and one on Luther V. Tuttle. Unfortunately, I did not know the initials of the Luther I was seeking, but because I had already indicated the necessary dates and there were so few by that name in Suffolk Co, I felt either one could be the right one. I informed the researcher, Luther Tuthill or Tuttle was listed in the 1810 census, but not in the 1820, also he was drowned before 1815, therefore pinpointing the time of death to approximately four years.

As I had already paid \$15.00, as requested for the search and the researcher did find in your files two by the name and dates wanted, I wrote your chief clerk asking for a xeroxed copy of the two names already found by the researcher, as I felt one had to be the one I was seeking. I also offered to pay for all xeroxing. Was this such an unusual request? I certainly felt entitled to receive information I had already paid for.

I am enclosing a copy of a communication, dated November 27, 1981

which reads:

"Please remit the sum of \$80.00 for two Court Certified searches of the above named decedents for a period of over twenty five years, Please be advised that our fee is \$40.00 for a search for a period of over 25 years. also no personal checks can be accepted unless they are certified:

Could you possibly give me an explanation for such a communication? What was meant by a 25 year search, the material wanted already had been found and prepaid. Certainly no 25 year search could be misconstrued, as your colonial records are only from 1797 and my request was from the period 1810 to before 1815. Also, why should this data which is public information, just by looking in your files have to be "Court Certified." Is this your policy of all requests by mail?

In the interest of others, I feel the policies of your Court should be outlined. The Suffolk County Historical Society, located in Riverhead, New York, suggests to their members they can write the Surrogate Court, dates already mentioned, for wanted information and if your policy is is the same as quoted in the recent communication, they should be aware of it.

Dear Cousin:-

Before I get delayed in Christmas shopping I want to get all the data I have received in regards to Luther off to you. I know you are just as anxious as I am to find the correct answer and I wish I were reporting happier news.

As you know, we were both delighted the Surrogate Court had found not one, but two by the name of Luther and because I did not know initials of our Luther, they are refusing to send me the data that was found concerning these two names. I offered to pay for the zeroxing, but it seems this request infuriated them to a point where they are demanding another \$80.00, to give me the information I already have paid for. I will not submit to this as it amounts to extortion or blackmail and an attitude that is beyond reasonable comprehension. I feel practices like this should be exposed, so I immediately wrote to the Surrogate of the Court asking for the policies of the Court as well as the Suffolk County Historical Society. They certainly should be aware of such practices, not only in advising others, but to try and do something about it. I don't know if the Surrogate is appointed or an elected official, if it is the latter, the ballot box would be a good way.

Since I talked to you on the telephone, I went to the Library and did further research in regards to the Ruth Terry that married Aaron Woodruff and my quest was quite successful. She had a double wedding with her brother Thomas and she was married at the age of 19 in New Jersey and it would seem William was there before this date according to the account regarding Sarah Crane. She had nine children with Aaron, the first being born in 1770 and the last, Samuel, was born April 8, 1792 and died in 1795. I feel this is quite conclusive evidence that the Ruth Terry, daughter of William, couldn't possibly be ours. I know it is hard to accept, but you certainly cant form any other conclusion.

It would seem from the Temple Ordinance Data regarding our Terry Tuttle, this could have been taken from a bible reference as the date was 19 April 1881 when he was baptised. This was over 100 years ago. Would you happen to know who submitted this? My Archive sheet does not reveal this. What is more bonafide than a bible reference and all this valuable information is sitting on a shelf or drawer completely unobtainable for future generations. The church could accomplish so much in the field of genealogy if they would ask their members to xerox the page where all the family information is given and kept and because it is a sacred book, kept and passed down from generation to generation.

Would you know if the Salt Lake Library would have the Stuart T. Terry manuscript? The Suffolk Co. Historical Society sent me a copy and I sent my copy to Elizabeth Coffman, who is also

searching the Terry's, however, she had most of the material I sent her and said it was just a portion of the manuscript. It would seem there are very few copies of this manuscript to review. What I had made no mention of Terry's brother, Azariah, wherein it stated he was the son of Luther and Ruth Terry. This could serve as a bona fide reference, as there were very few that attempted a journal in these very early days. I know of only two others and that was Griffin who was a grandson of Jonathan Terry and Moores Index and of course Salmon records and Southold town records. It could be there were other Ruth Terry's that were unrecorded, Jacobus, whom I admired so much, said he found so much of this. Prof. Tuttle had another reference to Luther other than Reva Anderson and that was Kate Tuthill who sent him this data in the 1920's of Indianapolis Ind. and Benjamin Tuthill, Brooklyn, N.Y. Wouldn't it be wonderful if we knew how to get in touch with them? Last winter I wrote the State of New York asking for a marriage bond from their early archives, there was none. I really don't expect to hear from the Surrogate, rather than make an issue with his chief clerk, I think he will just choose to ignore my letter altogether. Even if Luther had no will, it was the duty of the court to administer his estate, sometimes these old administrations consisted of only a feather bed and some pots and pans. The name Luther, especially on the dates wanted wasn't all that common and the two Luthers that were found could be ours, don't you think so? I am furious with them, but I am helpless to do anything about it except to just what I did, take my case to the head man.

I do hope your back is better. I am so sorry you are having such a time with this. I can well imagine how miserable this can be for you, especially these busy days of the holiday season. The days are going by so fast and I am totally unprepared for Christmas. It was so nice to talk to you on the telephone, it is too bad I don't live closer so we can compare notes. If I hear anything in regards to the deed search I will let you know. I am not too optimistic about this, mainly because I couldn't tell them the exact locale where to search.

Dear Ms. Perry:-

At one time you wrote Suffolk Wills, Where Are They and it was published in the Register. I found this work so informatve, it is used with my reference books. As per your suggestion, I wrote the Surrogate Court for a possible will of Luther Tuthill, and I feel you should be aware of at least one person's experience with the Surrogate Court.

It was felt by Alva Tuttle, who wrote the book Tuttle and Tuthill Lines in America, that Luther married Ruth Terry, daughter of William, son of Thomas, however, after William Terry's will was found, he names his daughter, Ruth Woodruff and further research reveals she was married to Aaron Wooduff and had nine children by him, second Freeman Morris and third Joseph Cory.

Did you know Alva Tuttle is now gone and willed all his material to Katherine Tuttle Kimball of the Mormon Church, and the Genealogical Society has chosen to place the book and it's contents on international computer? This is the first time a family name has been chosen and if it is successful, other family names will follow. Alva Tuttle had started a second book and Mrs. Kimball also has this vast amount of material. Katherine is my second cousin and we both have worked so hard on the Terry line and you were kind enough to help me also way back in 1977 to try and put the various Thomas Terry's in their proper places, now to think of the possibility the line isn't even ours, is hard to accept. Now, when the information will be on computer, it is almost imperative we find Luther's wife. Katherine said, she heard that Stuart T. Terry's manuscript in referring to Luther's son, Azariah, said, "Azariah, son of Luther and Ruth Terry" Maybe if this is true, this could be used as a bonafide reference.

As a direct descendent to Henry Tuthill, one of the founders of Southold, L.I., the Surrogate Court, in the county seat of this area, is certainly disappointing, to say the least, in regards to their attitude in helping others.


PREFACE






Whoever supplied you with information on the Tuttle family actually gave you cards which are more likely to mislead than guide you aright.

Azariah Tuttle married only once, and that was to Ann Mabbitt, Mar. 11 1838. They were sealed as husband and wife for eternity years later, 28 April 1853. It would be a mistake to assume that the sealing date is identical with the marriage date; five of their children were born before 1853.

I have copied from a printed genealogy of this family, and certified by signature that it is a verbatim copy. This will give you the facts you need.

Azariah Tuttle was baptized a member of the L. D. S. Church Dec. 7 1838, by A. Petingale, and was ordained a seventy in 1844. The Seventies Record (1 C, p. 163), gives his birth date as April 20, 1818, New York City, New York, N. Y., the son of Terry Tuttle and Eleanor Mills.





NOTE: The researchers who did the research in Northamptonshire wills described in (77), as copied above for some strange reason to have neglected to study the will of Symon TOOTILL b c 1560 (see above) although did study the will of John WELLS, Symon's father-in-law, which does, as they say, mention his grandsons Thomas, Simon and William TOOTELL". Also Thomas TOOTELL, bro of Symon, had a will which the researcher in (77) seem to have overlooked. Miss Della Gay TUTTLE, 1928, qv, of Salt Lake City, spent many hours the microfilms of these Northamptonshire wills which are available at the Genealogical Society of The Saints in Salt Lake City. These wills, even if in good and clearly legible penmanship (which they are) be difficult enough to read in their archaic Old English with the very variable spelling of not only of many ordinary words which prevailed in those days. Miss Della G. TUTTLE was kind enough to furnish copies of these wills and that of John WELLS and typewritten copies of her carefully developed translid decipherings of these wills and I am greatly indebted to her for this very important information.

I am practically certain that the John TUTTELL who came to Boston, Mass on the PLANTER was a brother first cousin of Richard and William TUTTELL who came with him on the same voyage and I have shown him with a "probably" to indicate a very slight degree of doubt. In my opinion and also that of Miss Della John of the Planter was omitted from the will of his grandfather John WELLS because of the grandfather approval of John's marriage to the widow Joanna (ANTROBUS) LAWRENCE who was four years older than John four LAWRENCE children.

The will of Symon TUTTELL (in his will) or TOOTILL and TOOTELL (In John WELLS will and other documents dated 19 Dec 1627 and names FIVE sons: Richard, John "my second sonne", Thomas (who was deceased when drawn), Simon and William. Also an addition has been squeezed in the will in a finer penmanship, obviously a different scribe at a later date (Abigail was born about two years before Symon's will was proved leaves "to my sunn John, his Daughter Abigaill, five pounds at the age of fiftene yeares").

The will of Thomas TUTTELL or TOOTELL was dated 14 June 1639 (over four years after the Planter had three TUTTELLS to Boston, Mass) and proved in 1640, leaves to "John my eldest sonn". The nature of the and other points in this will indicates that this John, who was bp 4 June 1596 at Holcot, Northampton farmer (John who came on the Planter was a mercer) and strongly implies that he was in England on landing that of his father Thomas in 1640 when Thomas' will was proved in Northamptonshire. Other items in Mass. records and writings also imply that the Planter TUTTELLS were "three brothers" and I am quite that this is correct. Clearly there were two John TUTTELLS, first cousins, and both born c1596.

All the three Planter TUTTLES had, and still have, numerous male lines of descendants in America. His first time is published a very considerable account of most of the male lines from Richard and John. Early generations from Richard is given in Refs (1) and (2). TF is for the most part an account (with serious and minor errors) of descendants of William. All correct data in TF on male lines is contained also with a great deal of additional material.

B In addition to John of the Planter who lived in early Boston, Mass. with wife Mary, there was a John with wife Mary at about the same time in Boston. Dear Prof. Tuttle:-

I returned home from a six week vacation to the northwest and found your letter awaiting me. I do appreciate your reply as I can well appreciate what a busy man you are.

If I may, I would like to convey again how much I appreciate the years of work and the time you spent in compiling the Tuttle history. It was a work that was vitaly needed. I am a member of many patriotic lineage organizations such as DAR, Founders and Patriots, Colonial Dames, Dames of the Court of Honor and Huguenot Society and because there was nothing published later than the colonial period, I had to go into these organizations on my mother's side, namely, the Houghton and Conover lines. Now, I would like to supply supplementals in these organizations on my Tuttle line, because these organizations do publish their data for the libraries. You probably aren't aware of how many people you have helped, many people with Tuttle lines have expressed their appreciation of you, to me. The amount of work you have done is almost unbelievable. It had to take someone for this great undertaking and I am glad it was you. Thank you.

I agree with you, it would be futile to write Mrs. Vail. She has done a wonderful work and if she is still living I hope she is well. My reason for writing her was her reference relative to the military service of Azariah Tuthill. Prior to your book, I was convinced it was Azariah Tuthill born in 1724, that was the Lt. in the 4th Reg.'t of New York and after coming home and reviewing my data that I have I still feel I was right for the following reasons.

In 1962, I wrote the National Archives for the military service of an Azariah Tuthill born in 1724 in Southhold New York and died in 1804. At that time, I had no other information. They sent me 12 photo copies and the information they contained I have condensed and typed for you. It is quite complete accounting for all time between Nov. 21, 1776 to Jan. 1-1782- I also wrote in regards to Luther, but no information was available on him. When they sent this information to me, they said for further information regarding this officer contact the University of New York and I am enclosing a photo copy of their letter to me. Note: From the Calender of Historical Manuscripts Relating To the War of the Revolution- Head of household comprising one male above 50 years. This data could not apply to the Junior Azariah as he was married in 1771 and gone from the household and his issue was only one daughter. I think

the foregoing is very conclusive. Probably Mrs. Vail thought it was the son because of the age factor, however, unlike now, the older men were very active. My two DAR ancestors were both in their fifties and served with their sons, this was also true in my husband's line. This was especially true if they were officers. On page 30, New York in the Revolution- it lists an Azariah Tuthill as a private in the 3rd Regiment, if you will note on the military record sent me there was no mention of any time spent in the 3rd Line Regiment, commanded by Cols. James Clinton and Peter Gansevort- therefore, I feel this must be the service of his son and unless he applied for a pension the National Archives wouldn't have the record. It is unfortunate that Sr. or Junior wasn't put after their name, as it is confusing to every one- In the book Documents Relating to the Colonial History of the State of N.Y. Vol. 15 page 492 it makes no mention of Lt. Tuthill serving in the 3rd Regiment, therefore I feel both father and son served in the war.

I am so glad you are interested in colonial history. I am too, it is the intimate details that make genealogy so interesting. For instance, on microfilm in the Salt Lake Library I read the reason Henry Tuthill left England was because of the custom in England of leaving the estate only to the eldest son and he was the third son. He with 13 other families were the founders of Southhold, the oldest English town in New York. He came there from Hingham Mass. where he first settled, he was a landowner there, but sold it when he went to New York. He was made constable in 1640. It has been noted by me this profession has followed in succeeding generations, down to my own grandfather, Azariah Jr. Henry's wife survived him and married William Wells, Esq.

John and Deliverance Tuthill were large landowners, owning land in Southhold and Brookhaven. He also was constable in 1695. He was one of the commissioners that laid out the Kings highway, a member of the N.Y. colonial legislature in 1693 and the first magistrate. There are a number of books written about the Tutttles of Southhold such as- The Founding Families of Southhold by Jefferson- History of Southhold by Witaker- Tuthill Family meetings, page 31-33- Southhold Town-

It is too bad so little is known of Terry Tuttle, it is probable because he died at such an early age- I visited his wife's grave (Eleanor Mills) when I visited Manti, Utah-

In the book History of San Pete and Emery Co, Utah, it states Azariah Tuttle, son of Terry and Eleanor Mills, born in 1818 was left fatherless when he was nine and had to begin to work early to help support the family. He worked in a printing office and when 15 was bound out to learn the trade of a

Dear Mrs. Bunnell:

Thank you very much for your very kind words about my book. I certainly put about half a lifetime and a great deal of money into it. I am not complaining, however, as it was a most interesting project and I'm quite proud of it.

As to your writing to LTV about your problem, I feel sure that it would do you no good to do so for at least two, and perhaps three reasons. Taking the third reason first, she may not still be living. Her health began to fail considerably in 1964 when she stopped all genealogical work and correspondence for that reason. At that time she requested me not to give her address to any persons who might write to her about genealogical problems. Prior to that time I had referred many persons to her when I, in my data collection activities, found a new person who was, or might have been, a descendant of Henry Tuthill bp 28 June 1812. She had always been very interested before that time and had often urged me always to let her know whenever I made contact with such persons. But her husband had become completely deaf and, after two cataract operations still partially blind, so that she had to watch over and care for him all the time. This was quite a chore as he was still physically able to and wanted to be active and doing things; even still insisted on driving a car a bit, although this meant that she or someone had to be with him all the time. They had lived for about 20 years at the large old Vail farm and estate near Michigan City, Ind., although a tenant caretaker and supervisor had looked after the estate for many years and was still there and able to do it, but Mr. Vail still tried to do a lot, even in 1964. Mrs. Vail said in 1964 to me in a letter that all this was "getting her down seriously and that her own health was failing and she was getting very nervous". So she had decided to stop all genealogical work and correspondence and asked me not to give her address to any more people and not to send her any new data I collected. Fortunately she had given me her enormous collection of data, typing it up on my file cards herself over a ten year period. After that I didn't write to her often, but I still sent her occasional notes or greeting cards. I heard from her then very little, the last time in the summer of 1967. At that time she said that things were getting so bad that they might have to go live with their only child, a married son who then lived in Florida and whom they usually visited in the winter. The son was urging them to do so. In earlier correspondence with me she had said that the son "had no interest whatever in genalogy and that both he and his wife thought that it was a foolish waste of a lot of time". So I'm not at all certain that the son would inform me if his mother died. Also I don't have his address. Of course I sent her a book in December 1968 but it was signed for by the tenant caretaker on their estate, and I presume that he would have done that, even if Mrs. Vail had died, and would have turned the book over to their son.


The second reason is that even if she were still living (if so, she would be 89 on Sept 7) and you wrote to her, I doubt that she would reply to you for I feel sure she would not be able to help you.

The third reason is that she was very careful to search all possible sources in her 50 years of genealogical work, and especially for military service records of all sorts. So if she knew of any service for Luther or Azariah, Sr. I'm sure she would have put it on thier cards which she typed for me. Both Ltv and I looked carefully through the published "New York in the Revolution" for all Tuthill and Tuttle items. Also I searched all early military and other records and sources in Washington, D.C.

This does not certainly mean that Luther had no R^evolutionary service, of course, for it is well know that many men served but all the records have been lost. However, although there are cases where two or more brothers served in the Revolution, it was much more usual for one to serve while the others stayed at home to look after their parents, their own and the serving brother's families, etc. I have read this many times and it makes sense. If one reads a detailed history of The American R^evolution one wonders that so many did serve. They got very poor pay when they got any, and they often had to forage for their food while they served!

I'm sorry to be so negative in all this. I wish I could assist you and wish you luck. If you do find any indication of military service for Luther, I would like to know it, for a possible supplement to the book in a few years.

FOUNDER (Tuttle)

Henry Tuthill left England to come to America to seek his fortune in a new land because it was the custom in England to leave the family estate to the oldest son and he was the third. He came on the ship Planter to Massachusetts in 1630 and was the first constable of Hingham.

In 1640 he left with the 13 original families to settle Long Island New York. With him was his son John (known as Pilgrim John) and the family settled Southold, Suffolk County, New York. Southold is known as the oldest English town in New York. The houses that were built are still standing.

The sur name Tuttle is of most remote antiquity, some historians say there is a connection between King Tuthankem (King Tut) and the name and in the Encyclopedia of Biographies it states it goes to the god Toth on the Lower Nile in Egypt, vestiges of whose worship was believed to have existed in early England.

PATRIOT: (Tuttle)

Lt. Azariah Tuttle was in the Revolutionary War from 1776 to 1781. After the war ended, he further enlisted to the State of New York for the "Defense of the Frontiers." He was in all the major engagements of the war, but the most impressive to me was that he served through the historical ordeal at Valley Forge.

Azariah Tuttle Sr., was one of the original members of the now L.D. S. Church. He was ordained in to the high office of the "Seventies" in 1837. He suffered through the persecution the Mormons had in Missouri and had his fields and house burned by the mobs in Nauvoo. He took an active part fighting the Indians being a member of the Silver Greys and was a member of the city council in Provo, Utah.

Azariah Tuttle Jr., his son was the sheriff of Emery County. He helped break up and capture the notorious Robbers Roost gang, headed by the outlaw Butch Cassidy. He led a posse in a narrow canyon where the bandits were cornered, as he was walking up the middle of the canyon unprotected and a perfect target, he was shot and crippled for life. In 1911 Gov. Spry presented Sheriff Tuttle \$2,500 on behalf of the people of Utah for what he did to break up this notorious gang of outlaws. His activities are told in the book Outlaw Trail also the Wild Bunch.

Mark Tuttle, his son and my father made out the check to honor Sheriff Tuttle when he was State Additor for the state of Utah. He was appointed Deputy State Auditor in 1910 and served in that capacity or as State Auditor for 14 years. He organized the Utah State Association of County Officials and was the founder and first president. Because of his love for efficient government, high ideals and service to his community a coveted award called the "Mark Tuttle Award", was conceived and given to the County Official depicting these ideals each year. A white bible also given to the wife of the winner in memory of my mother, Alta Conover Tuttle. She was the first cousin to a former governor of California, Goodwin Knight. Their grandson, Mark Tuttle and named after my father, has won recognition as the writer and co-producer, of the T.V. comedy series "The Beverly Hill Billies".



Thank you for sending me a copy of your letter to Kathanne Kimball.

It will be some time before I complete my analysis of the Southold Town Records, but I do think the Thomas Terry of Block Island who bought land at Orient was not the son of the first Long Island Terry. I reserve other opinions.

I enclose a chart on which I have very crudely indicated our known relationships through the Youngs, Tuthill and King families. Sorry my William Terry and yours are not the same person but I do think there must be a relationship. There was so much intermarriage on Long Island and so many name similarities that it is extremely difficult to sort them out.

I am also enclosing a copy of a very rough first chart of the Terrys.

I gather the Samuel Terry son of John¹ whom you discuss on the first page of your letter is another Terry to add to the confusion. The Samuel who may have married Ann Lobdell is the son of a John but one who did not come to America. I would appreciate your advice re the total number of immigrant Terrys with whom you have become acquainted.

Your comments re the Terrys and Tuthills are noted, unfortunately all of the descendants of the early settlers of what is now Suffolk County, LI seem to form one big family! It would be great if the whole mess of them could be computerized at one time: Tuthills, Terrys, Wells, Hallocks, Howells (from both Southold and Southampton), Benjamins, Fannings, Reeve(s), Kings, Browns, Smiths, Conklins, Youngs, Hortons, etc. etc. etc.

Good luck with your work; you will be hearing from me.
