The Genealogy Committee and Mrs. Siemiatkoski thank all those who took time to help us improve and expand our coverage of the first four generations of the family of Gov. Thomas Welles and Alice Tomes. In keeping with its commitment to the highest standards of accuracy in genealogical research, the committee presents here the results of these efforts as an extension to the first edition of the first volume of the The Descendants of Gov. Thomas Welles and His Wife Alice Tomes.

#22 The information is all correct as it stands. Further details on the estate of Deacon Thomas Welles were erroneously placed in two paragraphs under #28, Thomas Welles III, his first cousin, who lived in Hartford, not in Fairfield County. This mis-identification was made in the Chester Welles typescript, which was used to check the manuscript of this work in its final stages, and was not caught before publication.

13, 14 Delete the two paragraphs on Hannah Tuttle and insert the following: He married, as her second husband, Mrs. Hannah (Tuttle) Pantry, daughter of Richard Tuttle of Boston. She was born in Ringstead in Northamptonshire and came to New England as a child. She first married John Pantry of Hartford who died in 1653. She died 9 Aug 1683 in Hartford, age 50 according to her headstone in the Ancient Burying Ground (Hale Inscriptions). Hannah Tuttle has been proven by Donald Lines Jacobus (TAG 30:7-9, Jan 1954) to be the daughter of Richard Tuttle of Boston, as noted in Stiles' History of Wethersfield, not the daughter of his brother William Tuttle of New Haven, Jacobus himself admitted to following the Tuttle and Pantry genealogies and six pieces of circumstantial evidence in placing Hannah Tuttle in the New Haven family when he wrote Hale, House and Related Families (1952), which this writer consulted for the first edition of this work.

#32 Add: "Born Sep 1644 in Hartford, CT. He was baptized and owned the covenant (as Jonathan, son of Mr. Thomas Welds, History of the Second Church in Hartford) on 23 Oct 1687. L. B. Barbour in his Families of Early Hartford misread this entry as a son of Jonathan's brother, Thomas Welles III, which is disproven by that man's will and by this church record. Since Jonathan did not marry, when he died one week after joining the church, his estate was distributed to his brothers and sisters and their eventual heirs,

being administered by his brother, Thomas Welles III. Thomas delayed in settling the affairs and was repeatedly asked by his siblings to administer the estate. Hartford Probate Court records for 27 Nov 1695 (Hartford Probate Packets, microfilm reel #614) contain an agreement to divide the estate between John Olcott and Mary his wife (widow of Thomas Welles III), Ichabod Welles, Samuel and Joseph Welles, Mr. James Judson for his wife Rebeckah Welles, and Mrs. Sarah Bidwell (formerly Welles). In that transaction the heirs agreed to exchange twelve acres of Jonathan's land for twelve acres of Joseph's land. The estate was not finally settled until 1706. Manwaring (I:518) lists a "Jacob" among the children. Close reading of the actual paper shows that he probably misread the name "Ichabod" and recorded it twice, once as Ichabod and once as Jacob. A thorough search by James D. Wells of Santa Barbara, CA, has failed to turn up any evidence at all of a Jacob. The same siblings and their heirs are repeated sevaral times during the cattlement of the actors "

Abbott and others have apparently confused the two forms of the same name for Hannah. This reference will be deleted in future editions.

Insert after the part about Naubuc: "His estate was inventoried on 8 Nov 1695 by Joseph Wadsworth and Cyprian Niccols. On 11 Nov 1695 adminstration was granted to John Olcott, who distributed the estate to the Relict, the eldest son, and the youngest son, both of whom were still minors." Barbour in *Families of Early Hartford* gives him a son Jonathan, baptized 23 Oct 1687. The person baptized at the Second Church on that day was not a son of Thomas, but his brother Jonathan, "son of Mr. Thomas Welds", who also owned the covenant that day and died one week later. The Chester Welles manuscripts mixed up the estates of the two cousins Thomas Welles, one living in Hartford and one living in Fairfield.

After Mary Blackleach's birth and before her children insert "After Thomas Welles died, she married, second, John

Olcott, and third, Joseph Wadsworth, the famed preserver of the colonial Charter."

#29 Chester Welles erroneously reported that John Bidwell Jr.
was the grandson of Richard Bidwell, an early settler of
Windsor. Richard Bidwell of Windsor left no known descendants and was not the father of John Bidwell, Sr., an
early settler of Hartford, though they may have been related in some way.

#182 Sarah's family is carried forth into the next generation. On Sarah herself:

v. Sarah. Born 16 Dec 1700 (Hartford Vital Records). Died 11 Aug 1763, age 62, according to her headstone in the Old Cemetary in Portland (Hale Inscriptions: Portland, page 152.); 10 Aug 1763 according to the records of the First Church of Portland. She was christened at the Second Church in Hartford on 8 Jun 1701. Her mother, Ruth Judson Welles, named her daughter Sarah Clark in her will (Charles Manwaring, Digest of Early Connecticut Probate, vol. 3, pages 473-474). She owned the covenant at the Portland Congregational Church on 19 Jun 1743.

She married as his second wife Capt. John Clark, son of Samuel Clark and Mehitable Phippen (Bryant places the wedding in East Hartford; it is also recorded in Middletown) on 13 Jul 1738. According to his own deposition in the Middletown records, he was born 6 May 1711 in Milford (the Milford records have June); he was baptized the same day. He moved to Middletown 1 Mar 1731 (Middletown Vital Records). He married

there on 18 Jul 1734 Sarah Hurlbut, daughter of Ebenezer Hurlbut and Sarah Dickens, born in Middletown on 1 Dec 1710 and died there on 31 May 1737 (Hale Inscriptions, Portland, page 152). He owned the covenant in the Portland Congregational Church on 27 Apr 1735. He was made Captain of the First Company of Middletown in May 1743 (Connecticut Colonial Records, vol. 8, page 545). He died on 5 (Middletown records) or 6 (Portland records) Oct 1763, age 52. His death date is erroneously reported in the Hale Inscriptions as 5 Dec 1768. John and his wives are buried in the Old Cemetary in Portland, which was once a part of Middletown.

John Ellsworth III, son of Capt John Ellsworth II, whose sister Esther Ellsworth married Capt. Samuel Welles (#180) and of Anne Edwards, daughter of Timothy Edwards and sister of Rev. Jonathan Edwards. He was born 24 Aug 1735 O.S. (4 Sep 1735 N.S.) (Windsor Vital Records). He died 14 Feb 1779, age 44, and was buried in the Mortimer Cemetary in Middletown. Both John and Sarah renewed the convenant at the Portland Congregational Church on 18 Jul 1762. He married, second, in Middletown on 23 Jan 1772 Martha Hall, widow of Capt.Richard Hall and daughter of John and Esther Elton, who died 16 Dec 1791, and by whom he had children. After his second marriage, he was dismissed from the Portland Church to the Middletown Congregational Church. His estate (#1296) was pro-

- bated in Middletown in 1780 and was found to be insolvent

Sarah is not listed in the town or church records. Rev. Samuel Orcutt must have had sufficient reason to include her in the genealogy in both the *History of Stratford* and the *Henry Tomlinson Genealogy*. Sarah was born only eight months after her brother, which may be why neither she nor her mother survived.

The Hannah (Smith) Trumbull listed by Stiles was, in fact, the stepmother of John Strong III. The genealogies of the Strong family, by both Henry Dwight and by Eva Garfat in her chapter on John Strong,

Jr. in the 1992 Strong Family History Update, correctly carry forth the identity of John Strong III's wife as Mary Pinney. Capt. Robert Welles II mentioned in his will all his chil-108 #136 dren except Christopher and included "my dear youngest daughter Abigail Elizabeth." She will be included in the numbering in subsequent volumes. This Josiah Welles has been mistakenly identified with #630 #748 as to his death date and his wife's name. This Josiah Welles died 24 Aug 1783, age 62 years, according to both the Wethersfield Vital Records and the Cemetery Records. He is buried in a plot with his brother Capt Hezekiah Welles and his brother's wife Mary Boardman. This Josiah, #630, does not appear to have had a wife. The Anna Stillman erroneously mentioned here as his wife was actually the wife of this Josiah's third cousin, #748. That Josiah Welles died before she remarried in 1756, and was dead when his father's estate was probated in 1776. Christopher apparently died before 1738 when his father's #631 will was written, as he is not mentioned in it.
