

Extracts from Cornelius Youngs' Military Record and Lydia (Warren) Youngs' Pension File as Widow of Cornelius Youngs

The following was extracted from Cornelius Youngs' military records and his widow's pension application file at the National Archives.

Cornelius Youngs Birth

- 1826, East Rutland, New York age 37 (Enlistment paper 17 Feb 1864).
- 1836 East Bloomfield, New York, age 27 (Muster roll 4 Mar 1864).
- 1828, age 37 14 Aug 1865 (Detachment Muster-out Roll).
- 1828, age 37 16 Sep 1865 (Hillsdale Co., Mich. marriage record).
- 3 Jan 1828 from age 45y-6m-22d at death (Certified death record; Hillsdale Co., Mich.).

Lydia Ann Warren Birth

- 1824, age 41 16 Sep 1865 (Hillsdale Co., Mich. marriage record).
- 1819, age 71 24 Jul 1890 (Application for Widow's Pension).

Enlistment, Service, Discharge

- Enlisted 17 Feb 1864 at Allen, Mich. (Enlistment paper 17 Feb 1864, Muster roll 29 Feb 1864).
- Mustered in as Private 18 Feb 1864 at Detroit, Mich. in Co. I, 1st Regt., Mich. Sharpshooters for 3 years (Muster roll 29 Feb 1864).
- Detailed in Pioneer Corps at Annapolis, Md. 23 April 1864 (Company Muster Roll May & Jun 1864).
- Engaged in the Battles of Wilderness, Spottsylvania, North Anna, Coal Harbor, and Petersburg (Company Descriptive Book extract).
- Sick and sent to hospital 1 Jul 1864; returned to Co. 25 Nov 1864 (Company Descriptive Book extract).
- Sick and sent to hospital 114 Mar 1865; returned to Co. 21 Apr 1865; detailed as Company Cook (Company Descriptive Book extract).
- Honorably discharged at Washington, D.C. on or about 28 Jul 1865 (Declaration 24 Jul 1890).
- Mustered out at Detroit, Mich. 14 Aug 1865 (Detachment Muster-out Roll).

Wives

- Lovica Warren, who died about 20 Aug 1863 (William G. Whitney affidavit 15 Jul 1891).
- Lydia Ann Warren, widow of Clark Fox, about the last of Aug 1865 (Application for Widow's Pension).
- Lydia Ann Elizabeth Fox 16 Sep 1865 (Hillsdale Co., Mich. marriage record).

Children

- None mentioned, but mentions 11 Dec 1894 affidavit of Peter Fox and Mary Pierce sent to auditor.

Residences

- Allen, Hillsdale Co., Mich. (Declaration 24 Jul 1890).

Cornelius Youngs Death

- 25 Jul 1872 (Application for Widow's Pension).
- 25 Jul 1873, killed by R.R. cars (Certified death record; Hillsdale Co., Mich.).

Lydia Ann Warren Death

- Lydia dropped from pension roll 8 Jun 1892, because also on roll as mother of Charles Fox, so no termination because of death in file. She d. apparently after 11 Dec 1894, when affidavit of Peter Fox and Mary Pierce was sent to auditor.
