

### Sutton/Warren/Stokes Research Objectives

The following is a statement of the overall objectives of researching the Sutton, Warren, and Stokes families.

- Identify as many of Catherine Sutton's siblings as possible; get birth, marriage, death dates, names of spouses. Get spouse birth and death dates, if possible, and names of parents, if available. Further spouse ancestry of no interest unless otherwise connected to our family.
- Identify as many of Catherine Sutton's nieces and nephews as possible; get birth, marriage, death dates, names of spouses. Get spouse birth and death dates, if possible, and names of parents, if available. Further spouse ancestry of no interest unless otherwise connected to our family. Moderate interest in descendants of nieces and nephews, but not enough to make a project of it.
- Trace the Ancestry of Levi W. Sutton from Concord, Lewis Co., Kentucky ca. 1829 to New Jersey ca. 1807. No clues; dead end.
- Trace the ancestry of Daniel Warren from Canton Twp, Stark Co., Ohio in 1820 to ??? No clues; dead end.
- Trace the ancestry of Matilda Stokes from Canton Twp., Stark Co., Ohio to Delaware. Lemuil Stokes, ae 45+, was in Pike Twp., Stark Co., Ohio in 1820 census and also was in Mispillion Hundred, Kent Co., Delaware in 1790[?]. He may be her father.
- Try to find connections between New York Warrens and Daniel Warren's family, possibly George W. and John H. D. Warren.

The following is a summary as of this date of the research yet to be performed on the family of Levi W. and Catherine (Warren) Sutton and of her parents, Daniel Warren and Matilda Stokes.

#### In Michigan

- Get William W. Campbell military record and pension application. (Ordered 11-28-94)
- Get Cornelius Young military record and pension application. (Ordered 11-28-94)
- Get Jacob Beck Civil War military record and pension application. (Ordered 11-28-94)
- Get Clark Fox Civil War pension application. (Ordered 12-5-94)
- Get Ezeriah J. Parmelee Civil War pension application. (Ordered 12-5-94)
- Get George W. Warren Civil War pension application. (Ordered 12-19-94)
- Get Sarah (Warren) Beck death certificate. (Ordered 12-5-94.) Try to find out where she was living prior to death.
- Try to locate Sarah Warren/William Austin marriage 11 Sep 1843 (where?) in L. Hawkes' notes. This date inconsistent with present Daniel Warren family reconstruction, but better than 2 Oct 1841.
- Try to locate Sarah (Warren) Austin/John Shoop marriage 5 Aug 1848 (where?) in L. Hawkes' notes.
- Try to locate Sarah (Warren) Austin Shoop/Jacob Beck marriage 1 Jan 1852 (where?) in L. Hawkes' notes.
- Look for Lydia (Warren) Fox Young(s) death record (last found Hillsdale, 1880).
- Look for Lydia (Warren) Fox Young(s) remarriage after 1880. May explain lack of death record.
- Look for Matilda Warren's death record after 1870. Age 88 in 1870 census is about 10 years too high if this is Daniel Warren's wife.
- Look for Leonard and/or Grace Warren after 1874. (Haven't checked Hillsdale 1880 census yet.)
- Look for Leonard Warren death record.
- Look for Grace Warren death record. (Will say whether widow or married at death. May give parents and birthdate.)

- Look for Leonard Warren land records, especially "estate of" records.
- Look for Eli Banker before and after 1862 marriage to Catherine Sutton. Have his military record. There is no pension application.
- Look for Banker child buried in Hillsdale; died 7 June 1864 at Detroit. Banker given leave to take child to Hillsdale for burial.
- Look for death or divorce of William Sutton of Quincy Village after 1860. Wife Catherine Sutton could be one who married Eli Banker.
- Look for Ezeriah and Lydia Ann (Sutton) Parmelee after their marriage. Lydia went by the name "Ann."
- Try to find Ida Parmelee, when born, who she married, and when she died.
- Try to resolve George Warren/May Sutton marriage. Either death, divorce, or annulment before 1878 or a George and May living together in 1880. Look for another May Sutton of correct age for marriage record.
- Try to find Clarence Porter/May Sutton marriage ca. 1778.

#### In Ohio

- Get both Jenny Fox death certificates. Certificate received for Jenny who d. 1936; not related. Our Jenny certificate ordered for third time 12-21-94.
- Get Daniel Warren/Matilda Stokes marriage record from Stark Co. (Ordered 12-21-94)
- Get Daniel Warren probate packet from Stark Co. (Ordered on speculation 12-21-94)
- Get Lemuil Stokes probate packet from Stark Co. (Ordered on speculation 12-21-94)
- Check Charles Stokes in 1840, 1850, 1860 censuses. See if he is Matilda's brother; if she is living with him.
- Check Cuyahoga Co. marriage index for Leonard Warren marriage record. Child, Phebe, b. Ohio, ae 3 in 1850. Marriage not on CD.
- Check Cuyahoga County land records for Wm. Austin, Clark Fox, all Warrens 1830-1850.
- Check Stark Co. land records for Warrens and Stokes. Try to find when they arrived and from where; when they left county.
- Check Stark Co. for Bible records, local histories, etc. that may contain information on Warren and Stokes.
- Try to identify unknown son of Daniel and Matilda.
- Check War of 1812 records for Daniel Warren, Charles and Lemuil Stokes.
- Write to First Families of Ohio for Daniel Warren, Matilda Stokes ancestry.

#### In Delaware

- Check Mispillion Hundred, Kent Co. for Lemuil Stokes marriage record.
- Check Kent Co. land records for Stokes. Try to find when they arrived and from where; when they left county.
- Check Kent Co. for Bible records, local histories, etc. that may contain information on Stokes.

#### Revolutionary War

- Check Revolutionary War service records for Lemuil Stokes. Send for military records, pension records if found.
- Write to DAR registrar to see if Letha Simon and/or Marguerite Simth/Smith applied for membership based on their Warren line. If so, get a copy of their applications.
