61. Robert F. Kenyon (Barber, Robert) was born in Onondaga Co. in 1808. He married first Rachel-who died on Oct. 23, 1837, aged 25 yrs., 8 mos. She is buried in the Kenyonville Cemetery. He married secondly Sophia Thomas, born in Pa. 1815, daughter of Samuel and Jane (White) Thomas. Robert F. Kenyon is listed in the 1855 Census taken at Carlton as follows:

An Appreciation

The foregoing article does not pretend to be a complete account of the family of Robert and Ruth (Barber) Kenyon. It is, rather an effort to correct errors contained in the "American Kenyons and their English Connections" by Captain Howard N. Kenyon and to carry the line further for Robert Kenyon of Rhode Island. Mrs. Philip E. Wait and Mrs. Donald A. Wilson have contributed a great deal of time and effort to this search. We have exchanged data for 6 years. I am also indebted to several descendants of the Kenyon line who have contributed Bible and family records. Their names and addresses are filed in the Library of the New York Genealogical & Biographical Society which has the original ms. of this article containing complete references.

THE VREDENBURG FAMILY

The ancestor of the Van Vredenburgs in America arrived in New Amsterdam on the Gilded Beaver in May, 1658 (Cornelius Burnham Harvey, Genealogical History of Hudson and Bergen Counties, New Jersey [N. Y.: The New Jersey Genealogical Publishing Co., 1900], p. 103). His name was Willem Isacsen Van Vredenburg, which shows that his father's name was Isaac. Records in the Geementearchief in the Hague yield further information: on July 16, 1634, banns were published in the Groote Kerk in the Hague for Ysack Willemss. Van Vredenburch, young man, and Cornelia Jans, young woman, both living in the Hague, and they were married in the Groote Kerk on August 6, 1634, by Domine Eleasar Lotius. (City Trouw Boek 742, p. 84, verso and Groote Kerk Boek 32, p. 73).

This Isack Van Vredenburg, on January 1, 1637, had a son baptized in the Kloosterkerk in the Hague (City Trouw Boek 171, p. 39), Willem, named for his paternal grandfather. Of this grandfather nothing is known, but he probably died before 1658, and his wife was very likely the Maria Van Waelenburch, described as "widow of Willem Van Vredenburch" in

the record of a baptism at the Hague on August 14, 1658. (Record Book 323, p. 18, in the Gemeentearchief in the Hague).

There were numerous members of the Van Vredenburg family living in the Hague in the seventeenth century and among them may be mentioned the following: Henrick Hilleger Van Vredenburch, who in 1612 married Anna Noblecoert from Antwerp (Groote Kerk Trouw Boek 32, p. 7); Johannes Van Vredenburg, who married first Weyntje Van Bemmel (Record Book 238, pp. 80, 102, 123, 144 and Record Book 239, pp. 6, 29, 80, 165, both in the Gemeentearchief in the Hague), and second Elizabeth Furier, daughter of the surgeon Charel Furier of Gorichem (Record Book 201, p. 415, in the Gemeentearchief in the Hague); Abraham Van Vredenburg, a lawyer in the Hague, whose daughter Anna married Jacob Gronovius, a distinguished professor at the University of Leiden (Will Book 998, pp. 69 and 71 in the Gemeentearchief in the Hague); Maria Van Vredenburch, who in 1656 married Jacob Vooburch (Groote Kerk Trouw Boek 32, p. 76), and later married Baron Jan Jacob Van Wassenaer van den Bosch (Groote Kerk Trouw Boek 32, p. 162).

1. Willem, son of Isack and Cornelia (Jans) Van Vredenburg and grandson of Willem Van Vredenburg, baptized on January 1, 1637, at the age of twenty-one arrived in New Amsterdam in May, 1658. For some time he was a soldier in the service of the Dutch West India Company, for the name "Willem van Vredenborgh" on March 28, 1660, was on the musterroll of the company "of his Noble Honor, the Director-General," then in Netherlandish service on the Esopus (CDNY, XIII, pp. 153-154). By June 16, 1661, he had apparently returned to civilian status, for he petitioned, as a discharged soldier, for the remission of the price of his passage money to New Netherland, a request which was granted (CDNY, II, p. 225). In a list of the excise of the wine and beer, recorded in the village of Wiltwyck since November 24, 1661, Wilm van Vredenborg is taxed at 16 florins (CDNY, XIII, p. 212).

Further evidence of Willem's presence in Wiltwyck (later Kingston) is afforded by the court records. On October 4, 1662, Willem Vredenburgh sued Jan Janse van Amersfoort for payment of nine schepels of wheat but the defendant did not appear. On November 28, however, the defendant was in court, admitted his debt and was ordered to pay Willem Vredenburgh (Kg DR, pp. 35, 46). This same day Hendrick Jochemsen was plaintiff in a suit against Willem Vredenburgh, but the only entry in the case is "default." (Kg DR., p. 50).

Jacob Boerhans, Collector for the village of Wiltwyck, on March 6, 1663, demanded in court payments of the excise license for the wine and beer which a number of defendants, among them "Willem van Vredenburgh," had taken and disposed of. All defendants admitted the claim and each was ordered to pay within eight days, in accordance with the Collector's Book, under pain of execution. (Kg DR, p. 63).

The last item about Willem in the Wiltwyck Court Records, for a considerable number of years, is found under the date of December 18, 1663, in the case of Echje Gerrets vs. Christiaen Niessen Romp. Gerrets submitted proofs, dated November 20, 1663, signed by Magdalena Dirricks and "Willem van Vredenborg" that her, Echje's, pillow was in the hands of the defendant. Christiaen, however, claimed that the certificate signed by Magdalena Dirricks was false and desired that both certificates be confirmed under oath. He stated furthermore that his wife's words, uttered while she was sick and delirious, could not be received. The Court then ordered the plaintiff to produce both attestants at the next session (Kg DR, p. 110).

Probably about the beginning of 1664 Willem removed to New York City, where, on October 19, 1664, when he was twenty-seven years of age, he married Apollonia Barents Kool, daughter of Barent Jacobsen Kool (MDC, p. 30), a prominent officer of the Dutch West India Company of Amsterdam (Cornelius Burnham Harvey, loc. cit.). Less than two years after his marriage the following incident concerning his wife is recorded: Apollonia and two other Dutch women, Grietie Lammerts and Rebecca Arissen, bought from an Indian some goods which he said he had fished up out of the river. The women must have had qualms about the matter, for they soon made their purchases known and offered to surrender the articles, upon payment of the sum they had spent, in case anyone missed them. Arent Juriaensen claimed the items on the ground that they had been stolen out of his house. Sheriff Anthony Allard brought the three Dutch women before a court held in New York City on April 24, 1666. The court, on hearing both the plaintiff and the defendants, ordered that the goods be restored provisionally to Arent Juraiensen. (RNA V, p. 351).

On May 15, 1671, together with Hendrick Van Dijck and Hans Kiersteede, he witnessed a power of attorney from Jan Hendricksz van Gunst, glazier at New York, to a notary at Amsterdam to collect money from Aeltje Marchal and others (VRBM, p. 795).

Perhaps Willem was plying the trade of tailor. In any event, in the summer of 1672, when numerous inhabitants of New York City made subscriptions in money, materials or work towards the reparation of Fort James, Willem Van Vredenburgh put himself down on the list in the amount of six florins in work, namely "the making of a paire britch." (ECM 2, p. 707).

The site of the first home of Willem and Apollonia is not known, but on February 1, 1673, William Darvall, former mayor of New York City (CNYHS, 1885, p. 41), sold to Willem Isacqse Van Vredenburg a house and lot on the Heere Street or Broadway, having to the north the Lutheran Church and to the south the garden heretofore belonging to the West

India Company. The lot was in breadth four rods seven inches on the east side along the street and seven rods on the west side; in length it measured seven rods, six feet, four inches on the north and south sides. (CNYHS, 1913, pp. 8-9).

As it transpired, however, Willem was not long in possession of his new house. In October, 1673, the Council of New York decided that Fort Willem Hendrick and the city were much encumbered by houses, gardens and orchards that were too close to the walls and bulwarks. One such house was that of Willem Van Vredenburg, who was therefore ordered "to demolish from cellar to garret" his house and lot "lying and being in Broadway" and to remove to the company's garden number 1, lot number 2, valued at 460 florins. For the cost of removal he was awarded by arbitrators 330 florins, wampum value, to be paid him out of an extra duty levied for such purpose. Willem expressed his satisfaction with the arrangement, and in May, 1674, Jacques Cortelyou, the city surveyor, was ordered to set off lot number 2 in the company's garden for "Willem van Fredenburch." (RNA, VII, p. 13; CDNY, II, pp. 630, 634, 635, 716).

On January 17, 1674, he was the plaintiff before the court at New Orange in a suit against Jacob Spanjard, and both parties were in default. (RNA, VII, p. 43). On October 19, 1678, he sold his house and lot in New York City for 1750 guilders, wampum value (E. Reuel Smith, Notes on the Vredenburgh and Burnett Families [N. Y.: The Knickerbocker Press, 1917], p. 2). In Nov., 1676, and July, 1677, he was taxed in N.Y.C. (MCC, I, pp. 34, 54).

Evidently Willem had returned to Wiltwyck (Kingston) from New York City by 1679 for on October 29 reference is made to a lot situated between a barn and "Willem Van Vredenbrock's mill." (Ms. Kingston Court Records, English trans. in the office of the Clerk of Ulster Co., II, p. 263. Henceforth this will be cited as Ms. Kg DR.).

On April 7, 1680, at Kingston Roelf Jansen, Jan Coneel and Willem Vredenburgh signed a document relating to the purchase of a lot. Jansen conveyed forty schepels of wheat to Coneel, which quantity Coneel was to receive from Vredenburgh for the purchase of a lot "which had again been conveyed to Mr. Thomas De Lavall which amount Vredenburgh was to pay to said T. De Lavall next February, 1680/1, without fail (Ms. Kg DR II, p. 278).

Willem Van Vredenburg on November 6, 1680, was entered to pay—or as having paid—six florins "to fine for his chimney" (Ms Kg DR, III, p. 297), while his name, Willem Van Vredenburgh, appears on a list of names copied from two loose pieces of paper, evidently an index of a deacon's account book dating from approximately 1680 (Ms. Kg DR III, p. 377).

On March 6, 1682/3 the Court ordered Willem van Vreedenborg, defendant, to pay one Sleghtenhorst, plaintiff, fifteen guilders and costs (Ms. Kg DR III, p. 213). On April 14, 1683, Nicolaes Anthony sued Willem

Van Vredenburgh for 375 guilders, and the case was settled out of court (Ms. DR III, p. 235). Two days later "Willem Van Vreden Burgh" acknowledged before Secretary William D' La Montagne in Kingston that he owed Jan Joosten 50 schepels of wheat, which were to be paid "next November." To secure this debt Willem Van Vreedenburgh mortgaged his house and lot in Kingston. On April 1, 1686, Jan Joosten Van Rollegom signified that the mortgage was wholly satisfied. (Ms. Kg DR III, pp. 39-40).

On December 1, 1683, the following entry is found:

"Willem Van Vredenburgh Debit

To poor at Kingstowne, as per memorandum p. 3 6 gldr." (Ms. Kg DR III, p. 260).

On January 8, 1683/4, Nicolaes Anthony sued "Willem Van Vredenborg for sixty-three schepels of wheat, which the Court ordered Willem to pay together with costs (Ms Kg DR III, p. 138).

Of great interest is a case heard on March 28, 1684, by the Court at Kingston, with Captain Chambers, J.P., and Mr. Hendricus Beecqman, Justice, present. Mr. Hendrie Pauwlding swore that on March 30, 1681, upon entering the house of William De Meyer, he found present Niclaes De Meyer, Roelof Swartwout and his wife, "Willem Van Vreedenborgh who was working," and Willem De Meyer who was writing . . . The case is of no further import as concerns Willem Van Vredenburg, save that he made a deposition on March 28, 1684, which runs as follows: "The deposition of WM Van Vredenborgh aged fourtie six yaears or there abouts deposeth and saith that on the 30th day of March 1681 your deponent being at the house of Wilhelmus De Meyer . . ." (Ms. Kg DR III, pp. 185-187). As Willem gave his age as being about 46 on March 28, 1684, he would have been born in 1637 or 1638, so there can be no doubt that he was the son of Isaac Van Vredenburg baptized in the Hague January 1, 1637. At a court of oyer and terminer held in Kingston June 6, 1684, Willem Van Vredenbergh is listed as a juror. (Minutes of Court of Oyer and Terminer, 6 June, 1684, p. 2, ms. in Paul Klapper Library of Queens College.)

Willem's property in Kingston is mentioned in deeds dated March 23, 1685, March 25, 1686, April 2, 1696, and June 26, 1699 (Ulster Co. Deeds, Liber AA, pp. 32, 33, 172, 216). As an inhabitant of Ulster County "Willem Van ffredinborch" took the oath of allegiance on September 1, 1689 (DHNY, I, p. 279). At the same time he apparently maintained close relations with New York City, for he and his wife joined the Dutch Church there on July 15, 1688 ('T Ledematen Boeck, p. 22). On May 19, 1696, Willem Van Vredenburgh of Kingston for sixty pounds sold to Huijbert Aartse of Kingston a house and lot to the south of Bridge Street in Kingston (Ulster Co. Deeds, Liber AA, p. 176). The date of Willem's death is not known, but it was after 1703, for in a jury list of Ulster County, dated

February 15, 1703/4, "W^m Vredenburgh" appears twice, obviously both father and son, so William Sr. was still alive in 1704 (ms. labelled "Venire 1704" in the Paul Klapper Library of Queens College).

Willem and Apollonia had at least the following eleven children:

- +2. i. Isaacq² bap. Oct. 4, 1665, in N.Y.C.; sponsors, Pieter Van Couwenhoven and Aeltje Barents (BDC, p. 80). He married at Kingston Nov. 26, 1725, Rachel Bogaard (Rec. 21, p. 165).
- 3. ii. Cornelia² bap. Dec. 14, 1667, in N.Y.C.; sponsors, Paulus Turck and Marritie Jans (BDC, p. 89). Cornelia,² residing in Kingston, N. Y., had banns published on Feb. 23, 1685, for her marriage to Cornelis Martenzen Van Esslestyne, from Albany, then residing in Claverack (Kg M, p. 508). Cornelis was one of the two sons of Martin Esslestyne, who had arrived in America in 1660 from Utrecht, Holland (F. N. Zabriskie, History of the Reformed Protestant Dutch Church of Claverack [Hudson, N. Y.: Stephen B. Miller, 1867], p. 45) and his wife Mayke Cornelise. Cornelis was an elder of the Dutch Church in Claverack in 1727 (F. N. Zabriskie, op. cit., p. 17. See also Capt. Albert Van Deusen, Van Deusen Family [N. Y.: Frank Allaben Genealogical Co., 1912], pp. 676, 677).

They had the following children:

- (a) Bataah* bap. Aug. 7, 1687, in Kingston, with Martinus Cornelissen Van Esslestyne and Apollonia Van Vredenburg as sponsors (Kg B, p. 29). She m. Oct. 9, 1706 at Albany Isaac Vandeusen (Rec. 21, p. 165).
- (b) Tobias,3 bap. Albany, Aug. 3, 1690 (Rec. 21, p. 165).

(c) Willem,* bap. 1691 or 1692 (Rec. 21, p. 165).

- (d) Isack, bap. Jan. 1, 1693, in Kingston, with Jacobus La Meetere and Ariaantje Vredenburg as sponsors (Kg B, p. 46). He m, at Kingston Nov. 26, 1725 Rachel Bogaard (Rec. 21, p. 165).
- (e) Jacobus⁸ bap. Nov. 6, 1698, in Kingston, with Jacob Martense and Geertje la Maeter as sponsors (Kg B, p. 54). He m. May 18, 1724, in Kingston Magdalena Brodhead (Rec. 21, p. 165).
- (f) Johannes,^a bap, May 26, 1701, in Kingston, with Willem Van Vredenburg, Jr. and Cornelia Martinsen as sponsors (Kg B, p. 62). He m. Maria Vredenburgh (Rec. 21, p. 165).

(g) Abraham, bap. Jan. 8, 1704, in Albany, with Abraham and Marrytje Van Aalstein as sponsors (HSYB, 1905, p. 31).

(h) David, bap. Oct. 28, 1705, in Albany, with Levinus and Wilmpje Winnen as sponsors (HSYB, 1905, p. 37). He made his will Jan. 15, 1748, in which he spoke of his mother and left his property to his brothers, Johannes, Willem, Jacob and his sister Bataah. His will was proved Jan. 17, 1749.

Cornelis Van Esselsteyn made his will June 21, 1740, and it was proved Jan. 16, 1749 (PA pp. 46-47).

 iii. Marytje² bap. Nov. 3, 1669, in N.Y.C. (Rec. 9, p. 151). She m. Nov. 3, 1700, Jan Kortregt, born 1674, son of Hendrick Jansen Van Kortregt and Catherine Hansen Weber (Dudley Vattier Courtright, History of the Van Kortryks or Courtrights [Columbus, Ohio: F. J. Heer Printing Co., 1924], p. 15). They had the following children:

 iv. Elisabeth² probably born in N.Y.C. in 1679, m. William Van Varick. Elizabeth, "wife of Wm Van Varick" was a sponsor at a baptism in N.Y.C. on Dec. 27, 1741 (BDC, II, p. 91).

+6. v. Johannes² bap. Oct. 21, 1671 in N.Y.C.; sponsors, Barent Jacobszen and Grietie Fockens (BDC, p. 103). Married Sept. 12, 1696 in New York City, Johanna Monfour de la Montagne.

7. vi. Annetie² bap. Oct. 8, 1673, in N.Y.C.; sponsors, Adriaen Corneliszen and Rebecca Idens (BDC, p. 112). Living in Kingston, she m. Jan. 3, 1697, in Kingston, Hendrick Rosekrans, b. in Kingston, bap. April 28, 1674, son of Harman Hendricks and Magdalena Dircks (Rec. 21, p. 165), residing in Mombaccus (Kg M, p. 513). They had children:

 Ysaak* bap. Aug. 10, 1712, in Kingston; sponsors, Jochem Schoonmaker and Annetjen Horsy (Kg B, p. 99). Annetie² died before Oct. 26, 1721, for on that date Hendrick Rosenkrans, widower of Annatie Vredenburgh, m. at Kingston Antje Dela Val, widow of Garret Van Benschoten (Rec. 21, p. 165 and UCW, p. 66); see Allen Rosenkrans, *The Rosenkrans Family in Europe and America* [Newton, N. J.; N. J. Herald Press, 1900], p. 55).

8. vii. Ariaentie² bap. Dec. 8, 1675, in N.Y.C.; sponsors, Teunis Barentszen and Aeltie Barents (BDC, p. 121).

+9. viii. Willem² bap. Dec. 22, 1677, in N.Y.C.; sponsors, Hendrick Van de Water and Margrietie Ver Meulen (BDC, p. 130). Married Nov. 12, 1699, in Kingston, N. Y., Heyltje Van Etten.

+10. ix. Abraham² bap. Jan. 27, 1682, at Jan Joosten's in the presence of the whole consistory in Kingston; sponsors, Jan Focke and Engeltie Jans (Kg B, p. 15). Married first, Jan. 17, 1706, in New York City, Isabelle Paersil; married second, probably in 1714, Dorathe Coljer.

FRANCOIS MATRAT (MATRATT or MARTRATT) "a carpenter, born in "Olde France" was the emigrant ancestor of the MARTRATT family in this country. In the "Collections of the New York Historical Society, 1891", Page 256, New York Muster Rolls, 1755-1764 is recorded the enlistment data of Francois Matrat. It states that he enlisted on April 26. 1760, in Capt. DeWitt's Company, was 29 years of age, a carpenter born in "Olde France", was 5 feet, 7 inches in heighth, had brown hair and complexion and was of long visage. The Society's printed volume gives his name as FRANCOIS MATHITT but an examination of the original Muster Rolls which are now in the State Library in Albany, N.Y. indicates that the name, somewhat garbled by another name written above it, was spelled, probably phonetically as MATRITT. It is very reasonable to assume that this was meant for Matrat or Matratt. Francois and Annatje had seven children born while living in Rhinebeck. Record of the Dutch Reformed Church, Rinebeck Flats:

Francois Matrat was also a soldier ir the Revolutionary War. In James Robert's "New York in the Revolution as Colony and State", Page 24, he is listed as a private in "The Line", 1st Regiment. Also listed with Francois is his second son Gideon. There is no further record of Gideon. In the files of the "Old Record" Section of the Adjutant General's office in Washington is found the following "Gideon and Francis Matratt enlisted in the State of New York on the first day of April 1776 and served in a company commanded by Capt. David Van Ness, which was part of the Battalion known as the Van Schaick Battalion under the command of Col. Van Schaick. Both appear on the Muster Roll of this Company and Battalion from Feb. 16th 1776 to dec. 17th 1776. No further record is made as to the date of discharge, place of birth, age, parentage, if pension applied for or received, injuries received if any or death". Francois was living in Kinderhook in 1790. In the first "Federal Census" taken in 1790, his name is found but there is no mention of any of his children (by name). Page 66 reads as follows: "Head of family, 1 white and free male, (including head of family) over 16, 1 white and free male under 16, 4 free and white females". He must have died between 1790 and 1800 as his name does not appear in the 1800 census.

PETRUS (or PETER) MATRAT was living in Kinderhook, Col. Co. N.Y. in 1800 according to the Federal Census. He married MELINDA ALLEN, who, according to tradition was closely related to Col. Ethan Allen. PETER and MELINDA had the following children:

The dates and births and baptism (and deaths) from Kinderhook Dutch Reformed Church and Melinda's Bible. Peter Matrat was in Kinderhook as late as 1810 when his name appears in the Federal Census. He probably died between 1810 and 1821. His wife Melinda married the second time (?) Hogan, one child born, James. Melinda's Bible now (1960) in the possession of the compiler of this article was for many years in the possession of Miss Edith A. Mayberry of Sheboygan Wisc. Miss Mayberry now disceased was the last descendant of Melinda and her second husband (?) Hogan.

CORNELIUS MARTRATT

Although it has not been possible to locate the baptismal record of Cornelius Matratt which would indicate his parents to have been Peter Matratt and Melinda Allen, there is abundant evidence that such is the case. The records of the Kinderhook Reformed Church which record the baptisms of the other children of Peter and Melinda coincide with Melinda'a Bible which was in 1948 in the possession of Miss Edith Mayberry then residing in Sheboygan Wis. Miss Mayberry, now deceased was the only living survivor of Melinda and her second husband a man named Hogan.

The fact that Elizabeth the first born child, born Nov. 2,1795 was not baptised until Jan. 10 1802 would seem to indicate that she was not born in Kinderhook or nearby. There being no evidence that Melinda Allen lived in Kinderhook or that neighborhood and her marriage to Peter is not in the Kinderhook Church records it is altogether possible that the marriage took place quite remote from Kinderhook. After Elizabeth's birth it is deduced that Peter and Melinda came to Kinderhook to live some time before Jan. 10 1802 when Elizabeth was baptised.
