Thank you very much for the information that you sent me. Please excuse the delay in answering your letter. I have been on an extended vacation/research trip and am now catching up on the correspondence that accumulated while I was gone. In fact, we came through Seattle and spent a couple of days there with friends. (I'm addicted to Ivar's Salmon House.)

The Porters in Dover were not my family. Mine were all in New York state at that time and were descendants of Robert Porter of Hartford. There were several other Porter lines in Connecticut and Massachusetts.

It is interesting that you mentioned the Foote book. I am also descended from Nathaniel Foote through Dickinson-Jennings-Peters-Rogers-Porter.

Since I wrote that query in December '92, I have identified Catherine Warren's parents as Daniel Warren and Matilda Stokes, who were married in Stark County, Ohio in 1819. I have been unable to trace either of their ancestries farther back, but have identified most, if not all, of Catherine's siblings and several other of their marriages in Dover. Apparently the family moved to Dover about 1840, but I can find no trace of Daniel after 1830, except his (alleged) signature on Levi Sutton and Catherine Warren's marriage application.

I did visit the WRHS again this trip with no luck. Both times that I have been there, the staff librarians have been very cold and unfriendly. I wish that I had gone to Dover instead this trip. The volunteer researchers you mentioned are much more helpful. I had them do some research in Alene Beaumont Duty's papers, and they did a very good job. In fact, they were the ones who looked up the J.P. and told me that Catherine and Levi were married in Dover. I definitely should give them another try now that I know more about the Warrens. It's sure cheaper than travelling there and getting little or no help.

The books that you mentioned about women in the reserve sound familiar, but I have no record of having searched them in my bibliography. I will try to remember to look in them when I go to our library. We have a very large collection and may have them.

Again, thank you for your suggestions. I will try to follow up on them.

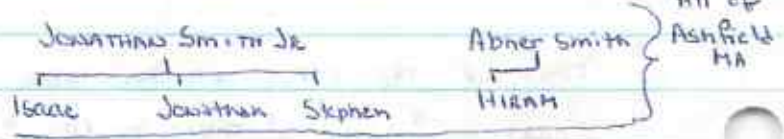

Dear Marilyn:

Please excuse the long delay in answering your letter of June 20th. I returned from my vacation/research trip two weeks ago, but have been swamped with things that had to be taken care of; genealogy had to wait. Today I'm starting to catch up on my genealogical correspondence, and your letter happened to be on the top of the pile, so you get to be first (big deal after all this time, huh?).

Despite a week digging around in Springfield, Brookfield, etc. I came up with nothing new on the Rogers or the Peters. I'm appalled at the quality of the people I found in charge of splendid collections and had no knowledge of what was in them. I had hoped to find people who were knowledgeable about the history of their area and had an interest in it. No such luck. If they were there, I didn't find them. I guess it's back to the LDS microfilms.

You have a point about Hannah being married under her maiden name. I believe that most, but not all, of the widows that I have found remarrying used their last married name. There is also the slim possibility that she was divorced from a Rogers and resumed using her maiden name. I've run into quite a few who did that in later years, also some who resumed a previous married name after the death or divorce of a second husband. Oh boy, does the latter create havoc with research.

It is obvious from Jonathan Foskett's will that his wife either had a child by another man, probably before their marriage. It isn't likely that she had a child by another man after they were married and gave it the other man's surname. The only alternatives are a previous marriage or an illegitimate child. (Captivity Jennings had an illegitimate child by William Barnes about the same time period, and Barnes settled in court a lump sum to Captivity's father for maintenance of the child.) Hannah's child could have been either a son or a daughter. Sons-in-law were usually called sons at that time.

The time frame is right for my Samuel Rogers, Sr. to have been her son. He was born 20 January 1718/9, when Hannah was 20 years old. She didn't marry Foskett until 1724. Samuel Rogers married Captivity Peters 22 June 1742, and that's where the rub comes in.

By 7 December 1756, Samuel and Captivity had six children; four besides Caleb and Moses. Their oldest, Jemima, born 26 May 1743, had married Isaac Wood in 1761 and survived Foskett. Samuel, Jr., born Jan 1754, lived until July 1823. Neither were mentioned in Foskett's will. I don't know if the other four children survived Foskett, but Mary and Lucy were also not mentioned in his will. It seems strange that Caleb and Moses, probably their fourth and sixth children, respectively, would be singled out to be mentioned to the exclusion of the other four. Even if he was only naming grandsons, Samuel, Jr., who probably falls between Caleb and Moses was not mentioned.

While it is apparent that Hannah (first wife or second) had a son or son-in-law named Samuel Rogers, who in turn had sons Caleb and Moses, I don't think that her Samuel Rogers is my Samuel Rogers. I feel that it is just a coincidence that two of each of their children had the same names. Two out of six children being named in the will seem to contradict the hypothesis that the two Samuels were the same man.

The deed from Samuel Rogers to Jonathan, Jr. probably doesn't prove anything except that they lived in the same town. There was no mention of a relationship nor of "love and affection," as is sometimes used when selling to a relative for a low price. It might be of interest if a relationship between them could be established, but by itself it's just an interesting coincidence.

Darn! I hate to sound so negative, but I don't think there is sufficient evidence to tie the two Samuel Rogerses together. I'll keep my options open, but I'm afraid that our supposition won't wash.
