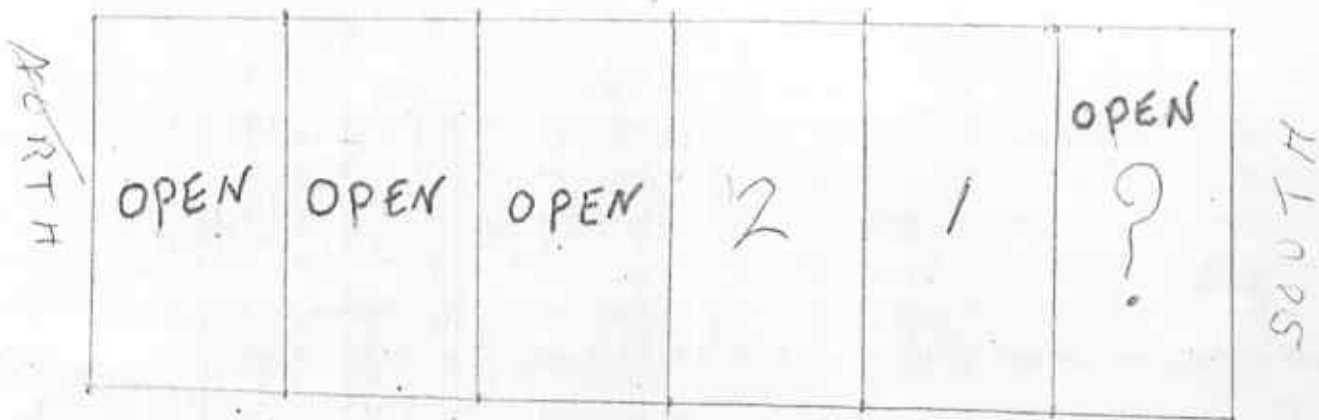
W. Dwight Smith:

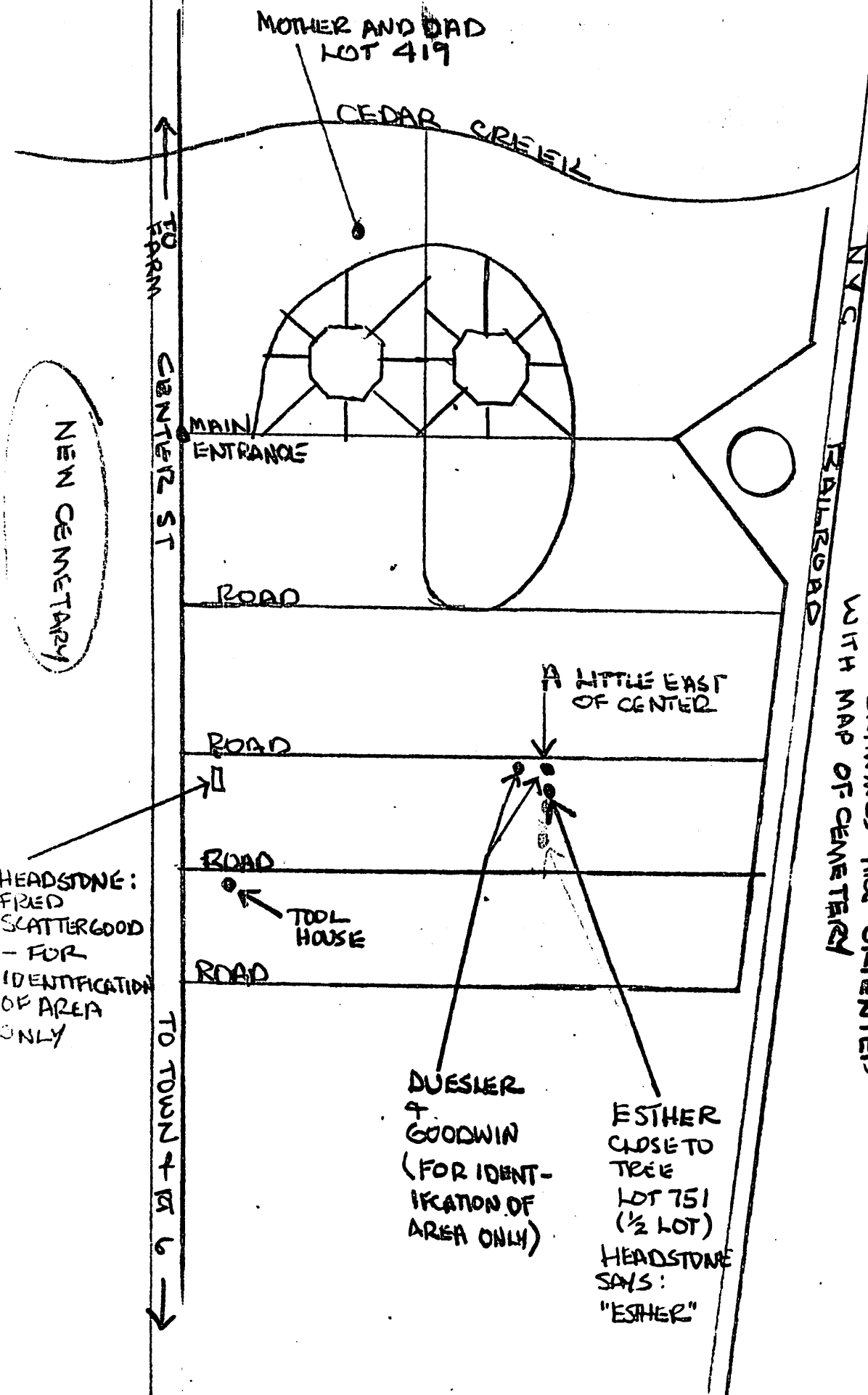
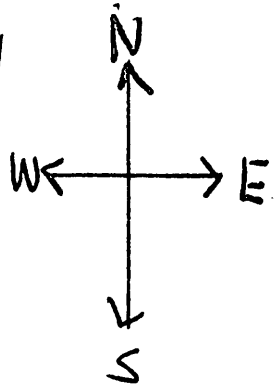
Could the one, on the South, have been reserved for the transfer of the Babie's body (Ester) which was, afterward, found to be impractical?

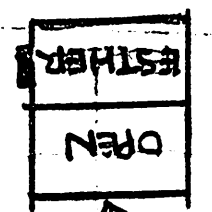
