SEC. 75. WHOEVER SHALL ENGRAVE, OR CAUSE OR PROCURE TO BE ENGRAVED. OR ASSIST IN ENGRAVING, ANY PLATE IN THE LIKENESS OF ANY PLATE DESIGNED FOR THE PRINTING OF A CERTIFICATE OF CITIZENSHIP; OR WHOEVER SHALL SELL ANY SUCH PLATE.
