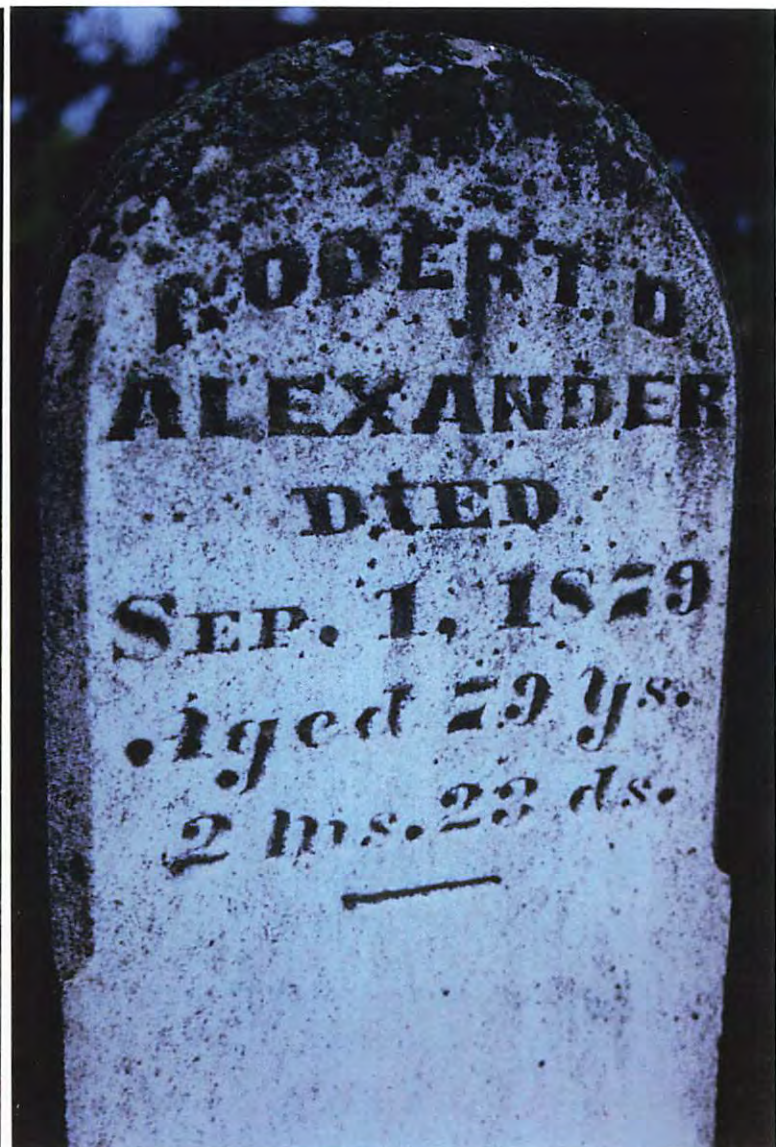

DUNN CEMETERY

From Curtis D. Aiken, Curator Beck Chapel, 535 E. Southern Dr. Bloomington, IN. 47401

In case you receive questions concerning Dunn Cemetery, located adjacent to Beck Chapel in the center of the old area of the Indiana University Campus at Bloomington, here are facts about the cemetery:

Dunn Cemetery was established in 1830 and is still used by Dunn-related families. The last burial was in 1969.

The cemetery is deeded to the three "Brewster" sisters, namely, Ellinor Dunn, Janet Irvin and Nancy Agness Alexander, their children, their grandchildren, their great-grandchildren, and who they may intermarry forever. Thus the cemetery belongs to the heirs forever.

These "Brewster" sisters came up through the Cumberland Gap with George Washington and volunteered and served in the Revolutionary War beside their husbands.

I am one of the heirs and also Administrator/Curator of Beck Chapel, which is unique in itself. The cemetery and chapel are near the Indiana Memorial Union Building. I invite readers who enjoy history and genealogy to visit. Most of the tombstones are still readable, and I see that they are kept erect and repaired. I also conduct free tours of the area.
