


In the name of God Amen I Marmaduke Scott being weak and sickly but of sound mind and memory thanks be to Almighty God for the same do this third day of October one thousand eight hundred and thirteen make this my last Will and Testament in manner and form following:

Item I give and xxxx devise to my son Harvey Scott all my land and Plantation called the body land to him his heirs and assigns forever. I also give and bequeath to my said Harvey Scott my negro boy named Wilson to him and heirs forever.

Item I leave all that part of my land and Plantation where I now live on that side of the mill rode where my house stand only excepting the dead woods lying on the main road to my loving wife Mary Scott during her natural life but not for her to have liberty of cutting and selling any of the timber now standing on the said land. I also leave the labour of my negro man Sorney and my negro woman Lovey and the girl Nemus to my loving wife during her natural life.

Item I give and bequeath to her my loving wife one yoke of oxen, one horse, three cows and calves one sow and pigs and as many other dry hogs as shall make up twenty head.

Item I also give my wife my riding chair also the labour of my negro man Ned for and during her widowhood to support the children. I also give to my wife all the provisions of every kind that is now layed in for the family use and also seventy five barrels of the corn that is now standing in the field one half of the wheat that will be sowed the ensuing year. My will is that my Executor rent out my mill property and receive the rent and keep the repairs in good order and the expense of so doing charge to my estate. My will is that what money I now have in the house be kept and reserved to pay what I may owe and discharge what may recovered against me on account of my being security for loans if any should be recovered against me and also what money is due me. Item I give and devise all of the rest of my estate that I have not given away both real and personal to my seven children to wit Olley, Miriam, Nancy, Ammon, Anna, Susannah, George Washington and the child that my wife is pregnant with to be divided as equally as can be but my will is that the land shall not be land of in less parts than fifty acres and if the land should not hold out to make fifty acres each that he or she that should get no land shall have as much of the other property as shall be sufficient to amount to the value of the land lossing provided neverthe-less my will and desire is that my valuable household property such as beds, desks, tables, chests, chairs and beaufat be not sold during the
