

(Lynn VR); named in father's will.

iii. ANNA (or NANCY), b. in 1781; d. 7 Feb 1854 age 73 of consumption; m. (int.) 29 Sept 1799, JOSEPH⁶ HAWKES (a Quaker), son of John⁵ & Jerusha (Merriam) Hawkes. Joseph was b. at Lynn, 8 May 1773 and d. there, 11 Aug 1828. - 9. NATHAN⁴ ATWELL (Nathan,³ John,² John¹) was born at Lynn, 16 Oct 1744 and died there 10 Oct 1804. He was married at Lynn, 24 Nov 1768, by Rev. John Treadwell, MARY STONE "resident of Lynn" (Lynn VR; Essex Antiquarian, 190). Nathan Attwell was a cordwiner at Lynn, MA.

Nathan⁴ Atwell was a Sergeant, Capt. Rufus Mansfield's Co (4th) which marched on the alarm of 19 April 1775; service 2 days (Sanderson, 192-3). On 24 May 1784, Nathan Attwill, with brothers William Attwill of Lynn and John Attwill of Hollis New Hamshire, for 40 pounds paid by Zachariah Attwill of Lynn (cordwainer), sold to Zachariah a dwelling house in Lynn near the old meeting house, land which their mother Anna Attwill died seized of. Signing also were wives Lydia, Mary & Bridgit

Nathan Atwill's will, dated 15 May 1804 and proved 10 Oct 1804.

"I, Nathan Atwell of Lynn, cordwainer, make this my Last Will & Testament. I commend my soul to God through the extensive merits of Christ, etc... and direct my Executor to pay all debts." I give to my 2 daughters Elizabeth Richardson and Anna Hawkes \$10 each, which, with what they have already received will be their full share in my estate; to my two grandchildren Thomas Farrington and Anna Farrington one dollar each; to my beloved wife Mary Atwell the use & improvement of all the residue & remainder of my estate, both real and personal for & during the term of her natural life with liberty to dispose of any part of the same if necessary for her comfortable support & maintenance. I order and direct that all my said estate which shall remain after the decease of my said wife should be equally divided between my three children: James, Nathan & Charles & their heirs. I apoint my said son James Attwill sole Executor. In whitness whereof I have set my hand and seal this 15th day of May 1804. Witnesses: James Garner, Ezekiel Moulton, Jr. and Samuel Burrill. On 10 October 1804, the estate of Nathan Attwell, late of Lynn, cordwainer, deceased, was presented for probate by James Attwill, Executor & witnesses, who made oath that they saw the testate sign, etc.

Inventory of the Estate of Nathan Atwell, late of Lynn

Dwelling house, barn, shop and 4 acres of land, \$1300.00. The Clove (Cove?) near Thomas Newhalls, \$125; 1 1/3 acres of upland & fresh meadow at Pan Swamp \$40; 3 1/2 acres at Penny Bridge, \$60; Total Real Estate: \$1,515. Personal estate included: 2 pine tables, 6 chairs, 7 pewter plates, 2 platters (\$5), a pair of andirons, shovel & tongs & a trammel, a flat Iron & tin iron (\$4.75), 4 silver teaspons, basket of knives & forks, a pair of bellows, a lantern & a wheel, \$2.80. In the East Room, bed, bedstead & bedding, a desk, a large round table, a small table, a looking glass & a great chair, 6 common chairs, a Bible, blassware & crockery (\$5.20). In the East Chamber, a bed & bedding, a bureau, 3 sheets, a chest, 4 chairs, a gun, & wearing apparel (\$23.75). In the West Chamber, one bed & bedding, one "ditto" (\$18). In the Kitchen, 2 iron pots, 2 kettles, a tea kettle, 2 pails, a tin paid, a great wheel, a 50-cent bond & 3 bushels of barley, a beatle & wedges, 2 wooden measures, 15 bushels of corn in the Garret (\$16.10); In the Cellar, 20 bushels potatles, 300 "ewt?) of Pork, a tub, 4 casks & 2 kegs (\$26.50). The Shop contains 2 seats & tools, a grindstone & 1 small iron crow (\$4.00); The Barn, one cow, 1 heffer, 2 cords of hay & fodder, a fork & a shovel (\$46.20). Total inventory: \$1,717.20. Inventory presented by James Atwell, Executor. The Committee included James Garner, Sarah Breed & Ephraim Breed. Signed at Salem, 4 January 1805.

- 8. Sergt. JOHN⁴ ATWELL (Nathan,³ John,² John¹) was born about 1737 and died at Groton (Grafton co) New Hampshire, 31 Jan 1820 (or 1821) (the DAR "Patriot List" says 1831, but the pension application of 2nd wife lists his death as 1821). He m. first, at Worcester, Mass., 13 Nov 1760, BRIDGET CUMMINGS, b. at Groton, 16 Sept 1739; d. at Hollis, NH, 17 June 1794. She was the dau. of Deacon William and Lucy (Colburn) Cummings. Her tombstone in the Congregational Church Cemetery at Hollis, NH reads "Erected in memory of Bridget Atwill, wife of Mr. John Atwill who deceased June 17th in the 55th year of her life. Now let your hearts begin to melt, when this record you see. This is the debt which I have paid, and you must follow me." On a stone with the Holden family, his date of death is shown as 31 Jan 1821. John Atwell was a sergeant in Reuben Dow Company in the Rev. War. Enlisted 19 Apr 1775 for Lexington and Cambridge. He was in the Garrison at Portmouth, NH for 3 months in 1776. He served in Rhode Island in 1778 for 22 days in Capt. Emerson's Company. He settled on Long Pond north of the center of Hollis, NH, said to be the 8th settler there. He was the Sexton of the Meeting House (Hollis Congregational Church). He is shown on the Hollis Tax List 1 Jan 1775 "on the West Side."

On 26 May 1784, William Atwell and Nathan Atwell (both of Lynn) and John Atwell of Hollis, New Hampshire, for 40 pounds, sold to Zachariah Atwell of Lynn a dwelling house in Lynn near the Old Meeting House (Essex Deeds, 162:23).

Mansfield (again). Acknowledged 3 April 1795; Recorded 19 May 1797; (Essex Deeds, 162:156). On 8 August 1795, Samuel Mansfield (gentleman), Henry Mansfield (cordwiner), Ephraim Smith (housewright, with Lois his wife), and Thomas Hicks Atwill with Joanna wife, Thomas & Mary Mansfield, seamstreses all of Lynn, for 18 pounds paid by Ebenezer Mansfield of Lynn, cordwainer; gave all right & title to a piece of tillage in Lynn on Mansfield's Lane, bounded S & SE on Joseph Mansfield's land, N on Col. John Mansfield's Land, NW on part of a field acquitted to Samuel & Henry Mansfield, being part of the Real Estate of Ebenezer Mansfield, late of Lynn, deceased. "We, togther with Mary, wife of said Samuel relinquished her right of dower. Signed 24 Nov 1789 before William Whittemore, Benjamin Alley, Jr. William Farrington Jr. and Thomas Farrington. Signed Samuel Mansfield, Jr. & a seal, Henry Mansfield, Lois Smith (by mark), Joanna Attwill (by mark), Ephraim Smith, Mary Mansfield & Mary Mansfield (again). Signed 3 apr 1795; recorded 8 Aug 1795; Recorded 8 Aug 1795 (Essex Deeds, 160:64). 10. William Burroughs, b. 7 Aug 1799; d. 22 Aug 1800. 11. Lynn as "Lydia Tarbox" wife of William, 29 Jan 1828, age 78 y (Old Burying Ground) or age 74 (Bible Record of Mrs. William Waite, cited in LVR). Lydia married at Lynn, 23 Sept 1779, WILLIAM⁴ TARBOX, who was bpt. at Gloucester, Mass., 13 Mar 1742/3, son of Joseph³ and Susannah (Stevens) Tarbox. Zachariah; m. 16 July 1778, by Rev. John Treadwell, ELIZABETH BREED, b. 7 June 1758; d. 2 July 1827. She was a daugher of Amos and Ruth (Newhall) Breed (See Breed family). On 8 January 1782, Lydia Breed of Lynn widow of Jabez Breed Tertius, late of Lynn, deceased, granted to Zachariah Atwell (cordwainer of Lynn) for 90 pounds 1/2 a dwelling house & land adjoining. viz: the W end of the house that was formerly Isaiah Newhall's late of Lynn, deceased, & 1/2 the cellar under the E end & 1/2 the garden adjoining said W side, bounded S by the road from Boston to Marblehead, W & E by widow Mary Newhall's thirds; also 2/3 of the barn near said house from the N part of same barn (except said Mary Newhall's right thereof, with the S half & 1/2 of the cow yard adjoining the S end of the barn. Signed 8 January 1782 by Lydia Breed (& a seal); consented to by Daniel Newhall & James Basset. Witnesses: Herny Oliver & Richard Pratt, Jr.: Acknowledged 15 March 1782; recorded 21 Dec 1786 (Essex Deeds, 146:189). Zachariah & Elizabeth (Breed) Atwell lived in a dwelling house with barn & 10 poles of land in Lynn, near the meeting-house, the land bounded in every part by the town common. This land was deeded to Zachariah 24 May 1784 and he lived there until he was appointed keeper of the almshouse at the corner of Fayette & Chestnut Streets. This he kept for a number of years until the almshouse on Tower Hill was opened and he continued as keeper there. Zachariah Attwil was a private in Capt. Rufus Mansfield's 4th co., which marched on the alarm of April 19, 1775; also in Capt. Joseph Hiller's co., 11 July 1777, 2 months, 6 days, & on an alarm at Rhode Island; roll dated Camp at Providence; remained in camp under Lieut. John Watts (Howard Kendall Sanderson, Lynn in the Revolution, 194). On 5 March 1785, Zachariah & Elizabeth (Breed) Atwill, Aaron Breed & Benjamin Newhall Breed (cordwainers all of Lynn), for \$50 paid by Richard Pratt, Jr. of Lynn (cordwainer) granted to said Richard Pratt & his heirs all right & interest in the real estate whereof Jabez Breed, our grandfather (late of Lynn, yeoman) died seized of, being in common & undivided, 1/2 a dwelling house & piece of land adjoinng.... in Lynn. Signed 5 March 1785 by Zachariah & Elizabeth Atwill, Aaron & Sarah Breed, Benjamin Newhall Breed; Witnesses: 22 Oct 1787, Theophilus Hallowell & Benjamin Newhall (Essex Deeds, 162:71). After the war, T. H. Atwell taught music & travelled thrugh VT & NY. On 19 May 1797, Thomas Hicks Attwell's wife granted to Samuel Mansfield, Jr. (gentleman) of Lynn, Henry Mansfield (cordwainer) & Ephraim Smith (Housewright) with Lois his wife, all of Lynn, for 53 pounds paid them by Joanna Atwell, wife of Thomas Hicks Atwell of Lynn (cordwainer) & Mary Mansfield of Lynn (seamstresses) granted & guitclaimed all rights to a dwelling house from the center of the front door through the center of the chimney to the backsides of the kitchen with privilege of entering the front door, etc.. provided said Joanna be at 1/2 the expense of repairing the same ... beginning at the corner of Ralph Merry's land ... They relinquished their right of dower. Signed: Samuel with Mary his wife and Ebenezer with Rebecca his wife, 13 December 1793. Signed Samuel Mansfield, Henry Mansfield, Ebenezer Mansfield, Lois Smith, Ephraim Smith, Mary Mansfield, Rebecca Mansfield & Mary

William Atwell was buried on the south side of the old Western Burial ground where his grave is inscribed: "Mark the perfect man, and behold the upright, for the end of that man is peace" (Sanderson, 193). He m. at Boston, 22 Apr 1753, LYDIA DAGGETT HICKS, who was born at Boston, 31 Oct 1732 and died there, 8 Jan 1812. In Lynn Vital Records, it states: "The wife of William Atwell died 8 Jan 1812, at the poorhouse. (Note: Her son Zachariah was keeper of the poorhouse (see below). She was the daughter of Zachariah and Lydia (Daggett or Doggett) Hicks ("Joseph Sanger Attwill, 1900-1977," typescript by Ludovine Hamilton at Lynn Historical Society)

"William Attwell was a private in Capt. Daniel Galeucia's company, Colonel Benjamin Ruggles Woodbridge's regiment, and in Capt. Eleazer Lindsey's company of the same regiment; enlisted in the latter company May 20, 1775, service two months and thirteen days; also in Captain Brown and Devereux's company, Colonel Jacob Gerrish's regiment of guards, at Cambridge, enlisted February 3, 1778, service five months, three days; on muster-roll for January 1778, dated Camp at Winter Hill. -- Mass. Archives." (Sanderson, 193).

On 26 May 1784, William Atwell cordwainer, Nathan Atwell (cordwainer, both of Lynn ... and John Atwell of Hollis in the county of Hillsborough in the state of New Hampshire (housewright) for 40 pounds paid by Zachariah Atwell of Lynn (cordwainer) sold to said Zachariah a dwelling house in Lynn near the Old Meeting House with 10 poles of land adjoining. Signed 26 May 1784 by William Atwell (mark & seal) John Atwell (mark & seal) & Nathan Atwell. Witnesses: John Flagg, Joseph Barry, Joel Newhall, Nehemiah Greene. Acknowledged 24 May 1784; Recorded 7 Nov 1796 (Essex Deeds, 162:23)

5. NATHAN³ ATWELL (John,² John¹) was born at Lynn about 1707 and died after 24 May 1784 (last recorded deed, see below). He married at Lynn, 27 November 1729, ANNA RAMSDELL, daughter of Jonathan and Anna (Chadwell) Ramsdell. She was born at Lynn, 27 February 1708/9 and died there, 3 April 1755 (Lynn VR).

At a Lynn Town Meeting on 3 March 1734/5, Nathan Atwell, Henry Silsbe, Nathaniel Ingalls & Samuel Hart were chosen hogreaves (Records of the Town of Lyn, 1742-1759).

On 3 March 1739, Nathan Atwell (husbandman of Lynn) sold to Samuel Breed Jr. (husbandman) and Joseph Coats (house carpenter) both of Lynn, for 70 pounds in hand paid, a dwelling house and barn and 10 poles of land in Lynn near the meetinghouse and lately enjoyed by Edward Howard, the land bounded on every part by Town common, the aforesaid granted premises with tenancy & privileges unto them & their respective heirs forever. Nathan Atwell stated he was the true sole proper and lawful owner. Nathan Atwell & Anna his wife (who surrendered her thirds) set their hands and seals; Nathan by seal and Anna by mark & seal. Witnesses were David Dummer & William Barton (Essex Deeds, 79:182).

On 26 May 1784, William Atwell and Nathan Atwell, both of Lynn (cordwainers) and John Atwell of Hollis in the county of Hillsborough in the state of New Hampshire, housewright, for 40 pounds granted to said Zachariah Atwell & his heirs, a dwelling house in Lynn near the Old Meeting House with 10 poles of land adjoining. Signed by William Atwell, John Atwell and Nathan Atwell. Witnesses: John Flagg, Joel Newhall, Joseph Barry and Nehemiah Green; Acknolwedged 24 May 1784; Recorded 5 (or 7) November 1796 (Essex Deeds, 162:23).

On 18 January 1742/3, the town of Lynn sold to Nathan Atwell, 6 poles of land at the east end of his house ("Records of the Town of Lynn").

"There is a tradition in the family that in the days when the king needed more fighting men, and was obliged to resort to impressment to increase his army, Nathan Attwill, the grandfather of Zachariah, was washing his hands in the brook which ran past his house on the Common, where the press-gang came along. In the fight which followed, his arm was broken, but he was told that, being a strong man, they had rather have him with one good arm than many another man having two. He was taken away subsequently, and never returned" (Howard Kendall Sanderson, Lynn in the Revolution, 1:194).

6. RICHARD³ ATWELL (Richard, ² John¹)) was born at Lynn about 1704 and died at Attleboro, Mass, 26 January 1767. When Richard Atwell was still in his 20s, he took up residence in Attleboro, Mass. (B. F. Atwell). He married (1) at Attleboro, 28 October 1727, SARAH BALKOM (or BOLKUM), who was born there, 3 February 1703 and died there, of complications of childbirth, 17 November 1739. She was the daughter of Alexander and Sarah (Woodcock) Balkom. Richard Atwell married (2) at Providence, Rhode Island, 9 April 1741, MARY LAWRENCE, who died 18 January 1755. Richard married (3) 30 December 1756, widow SARAH NICHOLS of Rehoboth.

"Shortly after the birth of his son, Richard Atwell went to sea and disappeared. Neither he nor any of the ship's crew were ever heard from again (B. F. Atwell, 35).

On 9 July 1716. Moses Felt of Lynn (husbandman) granted to John Atwell of Lynn (husbandman) for 7 pounds, 10 shillings, 1/2 of a lot in Lynn laid out to Lieut. John Breed on Lynn town commons & since purchased by Moses Felt; the 4th lot in the 2nd range of the 1st division, called the "600 acres" between lots laid out to Benjamin Allen's successors on one side & the lot laid out to Robert Rand & son Robert lying on the other side and containing 4 acres 22 poles. Signed by Moses Felt (with mark & seal). Witnesses: John Breed & Mary Burrill (Essex Deeds, 49:117). On 16 October 1723, John Atwell (husbandman) of Lynn, sold for 50 pounds currant money to John Parrish of Lynn (brickmaker) for 50 pounds currant money well and truly paid by John Parrish, 2 parcels of land in Lynn in the "600 acres," bounded W & N with John Breed, etc. Signed by John Atwell (by mark & seal) and Margaret Atwell (by mark & seal). Witnesses: Joseph Coats & Thomas Cheever; Recorded: 22 May 1727 (Essex Deeds, 47:255).

On 12 November 1723, **John Atwell** (husbandman) of Lynn sold **to David Potter** of Lynn, for 50 pounds lawful money, 2 parcels of land in Lynn, 1 containing about 5 acres, 60 poles and was part of a piece of land Atwell had improved, **near the dwelling house of Moses Felt**, and was bounded W by the country road, S by Mr. Brintnall's, E by said Brintnall & partly on Joseph Farr's & N on John Parrish's land, by a white Oak tree & N on the country road... the other is 1/2 of a lot laid out to Samuel Parker, the 1st lot obtained by Samuel Walton by sale dating 22 May 1724. John Atwell appeared at Middlesex County & acknowledged. Witnesses: Thomas Cheever (& Margaret his wife) and John Parrish (by mark) (Essex Deeds, 48:217). On 29 April 1729, **John Atwell of Lynn and wife Margaret Atwell** conveyed to John Brintnall of Boston, 10 acres of **land in North Yarmouth, Maine and 1/10th of the right of the heirs of John Maine, said Atwell being grandson of said John Maine** (North Yarmouth Maine Deeds, Book 13:92).

On 18 April 1734, final approval was given by the House of Representatives in Boston, to the 104 settlers of North Yarmouth, Maine. The list of those settlers included **George Felt, Moses Felt, John Atwell and John Maine.**

"In 1735, John Atwell went to that part of West Dunstable, known as the "Niccitisset Wilderness," which later became Hollis, New Hampshire. There he purchased land of the original proprietors of Dunstable. He cleared a small area and built a cabin, thus becoming the eighth settler of Hollis (Early Settlers of West Dunstable, Monson and Hollis, N.H., Worcester, page 187). His homestead was at the head of Long Pond, since renamed Silver Lake. (On 1 August 1947, the author with the aid of an elderly Hollis resident, located the site of John's cabin. The foundation stones were intact and easily discernable, although overgrown. There is evidence that John spent only part of the time in Hollis, returning to Lynn periodically. In the spring of 1751, John sold his homestead to Phineas Hardy of Bradford, Massachusetts. There is no record of the deaths of John and Margaret or the location of their graves" (Benjamin F. Atwell, "A Partial History of Ye Atwell Race, 1876-1898," a manuscript at Lynn Historical Society, page 35).

1. JOHN¹ ATWELL, ancestor of the Lynn Atwells, was born perhaps about 1650, as his first known son was born about 1672. But according to some sources (see above), he came from Devonshire in England and settled in the Casco Bay area of Maine between 1630 and 1640 with John Maine. This would put his birth a lot earlier, but there is nothing found to substantiate it. He died, probably at Lynn, after 1685 (the last official record found). He married ELIZABETH MAINE, daughter of John and Elizabeth Maine.

On 15 August, 1685, Richard Bray (husbandman), inhabitant of Casco in New England, for 11 pounds, granted to John Atwell (fisherman), inhabitant of Casco in New England, 60 acres of land in Casco Bay in Maine, being on the westermost side of a river there, formerly called Ryalls River at Westgostuggo, joining upon Thomas Maynes.



- 2. JOHN² ATWELL (John¹) was born probably at Wescustogo (Cumberland Co.) Maine, about 1672. He married at Topsfield in the Massachusetts Bay Colony, 13 (or 19) June 1693, MARGARET MAXE (Topsfield VR). Margaret Maxe's birth date or place is not known. The Topsfield Vital Records list several Maxes, but not Margaret.

The published *Town Records of Lynn*, which start in 1690, show that **John Atwell** served the town of Lynn as "Haward" from 1710 to 1713. Serving with him were Timothy & Allen Breed, Samuel Stocker, Jr., Joseph Edmunds, Jr., Crispas Richards, Benjamin Collins Jr. Benjamin Bigsbee, John Bates & Henry Libby (2:61-71). He served on a grand jury on 14 Oct 1723 (ibid., 3:51).

In a writ dated 30 September 1695, "John Atwell junior of Lynn was sued by a Mrs. Mary Daffern and Mrs. Martha Padishall (widows and heiresses of Richard Woody, late of Boston, deceased) in an action of trespass upon the case, and according to writ, the plaintiffs being called 3 times, made default and were nonsuited. The judgment was that the plaintiffs pay unto the defendant costs" (Alonzo Lewis and James R. Newhall, *History of Lynn...* [1865], 297).

Deeds recorded at Essex County:

On 9 October 1714, **John Hawkins of Lynn** (weaver) & Abigail his wife (who renounced dower rights) granted **to John Atwell of Lynn** (husbandman), for 16 pounds, **2 lots of land in Lynn** in the "600 acres" so-called (i.e., land now in Lynnfield), one lot laid out to Robert Rand (the 5th lot, 2nd range, 1st division); the other laid out to Richard Johnson, both lots containing **8 acres**, the lot laid out to John Breed on one side & the lot laid out to Joseph Breed on the other side, with the liberty of passing over said lot & rights of herbage belonging to the town of Reading, if there be any. Signed by John Hawkins (and a seal) &

The ATWELL FAMILY

By Marcia W. Lindberg and Richard A. Atwell

There were two or perhaps three Atwell families in early New England. The Genealogical Dictionary of Maine and New Hampshire by Sybil Noyes, Charles Thornton Libby and Walter Goodwin Davis, lists the *1. Benjamin, known only for selling 95 ducks at the Trelawny plantation in 1639/40. Presumably his widow Dorothy married (2) Richard Martin. She was the mother of Benjamin Atwell and Lydia Atwell, who married Robert Corben, to whom in 1673 she deeded her estate for life support. 2. Benjamin married in 1668, Alice Lewis, daughter of George Lewis. Benjamin was killed by the Indians on 11 August 1676. His children (besides one who died young) were Joseph, born 1671, at age 14 chose William Scriven of Kittery his guardian. Mr. Scriven claimed for him the entire estates of his father, grandfather Martin and uncle Corben. * 3. John, North Yarmouth, according to tradition written by Amos Atwell, came from England with John Mains, whose daughter he married. He is mentioned at Lynn in 1650, but came with Mains to North Yarmouth, where "Atwell's Creek" is on the south side of Royal's River below the cemetery... In King Philip's War he fled to York, where he built and fenced at Cape Neck. From York in 1690, he fled to Lynn, where two John Atwell's were living in 1695, and his son John (with wife Margaret) was living in 1727. He raised a family in North Yarmouth of four children (not including Andrew baptized at Charlestown, January 20 1692). John's son John removed from Lynn to Killingly, Conn. He m. in Wenham, Mass. (intentions 11 Sept 1703), his cousin Lydia Felt, dau. of Moses and Hannah (Mains). They were parents of Richard of Attleboro. John Atwell's other children were Joseph and Sarah who married Joseph Townsend of Malden." 4. Philip lived in Kittery and vicinity over 20 years; was employed in the fisheries. He married the widow of John Andrews by 1672 but soon had a falling out and on 26 March 1673, had taken his chest out into the bushes. He was questioned in 1695 for absence from meeting. (Note: Apparent errors appear in the above account. 1. There is no record found that John 1 Atwell was in Lynn in 1650. 2. It was probably John³ rather than John² who removed to Killingly, Conn. 3. It was Richard Atwell (not John) who married at Wenham, Lydia Felt.

ATWELL Connections to the MAINE, FELT, LARRABEE & DAGGETT Families

There is a strong connection between the families of John Atwell, the Larrabees and the Felts, as well as the Maine family. William Larrabee settled at Malden, Mass., where he married, Nov 1655, Elizabeth Felt, daughter of George & Elizabeth Felt. "George Felt was the most prominent of the early settlers of North Yarmouth, Maine. When troubles with the Indians began, William Larrabee returned to Malden, where he was made a freeman 22 March 1699/1700. William's cousin, Stephen Larrabee (ancestor of all the Larrabees of Maine & Mass. Bay Colony), was born about 1630 and died at North Yarmouth. He married a wife whose last name was Main or Mains, "probably a daughter of John Mains." When Stephen's family left North Yarmouth during the Indian hostilities, they went to Lynn. Some returned later to North Yarmouth, but others remained in the Lynn area. John Atwell's granddaughter, Priscilla Townsend married John Larrabee and Richard² Atwell (John¹) married Lydia Felt. In Confession of Faith and Covenant of the First Church in North Yarmouth (p. 48), a list of 103 proprietors includes John Atwell, Stephen Larrabee (plus 7 other Larrabees), John Maine's assignes, Richard Bray's assignes and Thomas Dogett (or Daggett), all names connected with John Atwell and his family. In Ancient North Yarmouth and Yarmouth, Maine by William Hutchinson Rowe [1737; repr. 1980], pages 38 & 40, it states: "All [settlers] were given *10-acre lots of land extending from Falmouth line to the land of the tide on Royal's river. The place of building and settling should be at Main's Point ... follwing the general line of the present street were the farms of 4 Larrabees ... Across the inlet, since called Atwell's Creek, up the river from the Larrabees, lived John and Margaret Atwell*
