The State vs. Fredrick Cole Indictment for Seditious Words

The Jurors in Behalf of the State of New Jersey for the Body of the County of Morris upon their Oath presents, that Fredrick Cole late of the Township of Pequannock in the County of Yeoman being a permicious and disaffected Man, and a person of troubled Mind, and seditious Disposition of Conversation, and contriving, practising and falsely. maliciously, advisedly and seditiously intending to terrify, disunite and discourage the good Subjects of this State. and to dispose them to favor the Pretensions of the Enemy, and to alienate their affections from the present Government established under the authority of the People, he the said Fredrick Cole on the Twentieth Day of January in the Year of our Lord One Thousand Seven hundred & Seventy Eight at Pequannock in the County of afsd. and within the Jurisdiction of this Court, having discourse then and there with a certain Moses Thilburne then being a Subject of this State. concerning the said King of Great Britain, and the present War which he hath waged and carried on against the State, and the United States of North America, and concerning the Power. Authority and Jurisdiction claimed and attempted to be exercised by the said King in and over this State, and the United States afsd. in the Presence and hearing of the said Moses Thilburne and diverse other Subjects & Persons of this State then and there being present did falsely, maliciously, unlawfully and seditiously, say, assert, affirm, pronounce, and with a loud Voice declare, these false, malicious, seditious, and opprobrious English Words following, that is to say "The King of Great Britain is my King" (meaning that the said King of Great Britain, then and still being at open War and Enmity with this State and the said United States, is the King of the said Fredrick Cole, to whom the said Fredrick owes & bears true Faith and allegiance, and that I (again meaning the said Fredrick Cole) "have fought for him" (meaning that he the said Fredrick Cole has fought for the said King of Great Britain) "and would fight for him and no body else" (meaning that he the said Fredrick Cole would fight for & defend the sd. King of Great Britain so as afsd. at open War and Enmity with this State and the sd. United States, against this State of the sd. United States) to the evil Example of all others in the like case offending against the Form of the Act of the Council of Assembly in such Case made & Provided, against the Peace of this State, the Government and Dignity of the same.

6. SAMUEL COLE, JR., son of Captain Samuel and Anna (Rider) Cole, was born in Wantage, Sussex County, New Jersey, 3 July 1787. He married there in 1812 Mary Elston, daughter of William and Elizabeth (Walling) Elston, born in Wantage 27 November 1792.

In 1815 he made an exploratory trip on horseback to Ohio, and was so impressed with the land that he came back for his family, and the following year they moved to the Buckeye state, settling in Washington township. Here he built a log cabin. Later an addition was built, and in it, during the winter of 1821, Samuel conducted the first school held in the area. In 1824 the family moved to Greenville township, Darke County, and settled on the southeast quarter of section 19.

Samuel died in Greenville township 1 February 1866, 35 years after his wife's deather, on 10 August 1831. He is buried in the Sharpeye Cenetery.

5. CAPTAIN SAMUEL COLE, son of David and Eleonora (Westfael) Cole, was born in Minisink, Orange County, New York, 5 November 1751, and was baptized 18 November in the Machackemeck Duth Revormed Church. He married (1st) Janey Davis, daughter of Jan and Willentje (Lineden) Davis, who died after the birth of their third child. He married (2nd) Anna Rider, born 25 October 1760.

At the time of the Revolution Samuel lived in Goshen Precinct, as did his brothers Jacob and Benjamin. This precinct encompassed the town of Minisink. During the war her served in Colonel William Allison's Goshen Regiment, and in February 1778 was commissioned 1st Lieutenant in his brother Captain Jacob Cole's Company. The following June he was made Captain in the same Regiment.

It was shortly after this that he lost his first wife, and with three

young children on his hands, he soon married again.

Indian depredations under Brant were spreading terror through this part of the county at the time, which undoubtedly explains the family's move to Wantage. New Jersey, in Sussex County, in the northwest corner of the state. It was only a few miles, but it was out of the path of destruction.

After the war Samuel settled on his farm where he raised his large family of eleven children. In 1819 he sold out and joined his son Samuel, Jr., who had preceded him to Ohio. He died there, in Greenville Township, Darke County, on 8 January 1828, and is buried in the Sharpeye Cemetery.

4. DAVID COLE, son of William and Catryntjen (Du Bois) Cole, was born probably in Marbletown, Ulster County, New York, shortly before he was baptized in the Dutch Church at Kingston on 6 January 1712. He married in 1737 or 1738 Eleonora Westfael, daughter of Jacob and Margriet (de Duytser) Westfael (also spelled Westvaal, Westfall, etc. Duytser became Dutcher), born 22 October 1721, and baptized at Kingston. Her father was the son of Johannes Westfael and Marritje Kool, daughter of Jacob Barentzen Kool, son of the immigrant Barent Jacobzen Kool.

David accompanied his parents and family to Minisink, Orange County, and was undoubtedly married there. He and "Alleonora", along with her father, became members of the Low Dutch Reformed Church at Machackemeck, upon confession of faith, 20 September 1745. Their children had been baptized in that church from the first, in 1738.

David must have lived just over the New Jersey state line, for his will, dated 9 October 1756, gives his residence as "Macachkemeek", Sussex County (New Jersey), and he is called a wheelwright. He died at a fairly early age, for the will was proved 2 April 1761.

 WILLEM LEENDERTS KOOL (alias William Cool, William Cole), son of Leendert and Marretje (Cornelis) Kool, was baptized in New York City, although he was probably born in Marbletown, Ulster County, New York.
 He married about 1710 Catryntjen Du Bois, daughter of David and Cornelis (Vernoey) Du Bois, baptized in Kingston 25 May, 1699.

William was one of the first settlers of Minisink, Orange County, New York, on the New Jersey borner, and attended the Low Dutch Reformed Church at Deerpark (then called Machackemeck), where he was a reverend elder. He is referred to as a surveyor, and at one time lived on the New Jersey side of the state line.

The date of the family's settlement in Minisink is not indicated, but through 1721 the children were baptized in Kingston, then daughter Catrina was baptized in Rochester, Ulster County, sixteen miles southwest of Kingston, as perhaps were the next two children. The two youngest daughters were baptized in Minisink.

Located about one mile south of Aledo, Parker Co. TX on Farm Rd #5, just west of the Clear Fork of the Trinity River bridge. Cemetery is in grove of trees, first gate on right. In 1988 the Parker County Abandoned Cemetery Committee completely cleared the brush and briars and reset and repaired the old stones.

The one acre plot was deeded to Parker Co. by John Pope Cole, 24 Apr 1883. The is located on the John B Hibbert survey, and assigned to John P. Cole who purchased the certificate in Dallas

Co. TX in Oct 1853, patented in Jan. 1858. The earliest tombstone inscription is for William A. Cole (s/o John Pope Cole). The land was sold by Cole heirs in 1893 to J.N. Markham.

Lois asked if the Charles in 1486/1511 could be their Benjamin C. Yes it could be. That Charles had a brother George and as you pointed out, an uncle Benjamin. You should follow this family on census records, if possible. Often a child is called different names on different census'. I had one ancestor called Daniel in 1850 and William in 1860. You also may want to find Benjamin C. on the 1870 census and see if any of these Coles are in the area with him.

Wayne Co. MI is surrounded by Macomb, Monroe and Washtenaw and all of them, as well as Oakland Co. was formed from Wayne, So you really should check those out before following the family of young Charles. If this is a father and grown sons, as they appear, they were in MI by 1835 when 15 year old Nancy (family 1483/1508 was born. Your on the right track, just hang in there and keep reading census records.

#### MY BRANCH OF THE COLE FAMILY

Stephen Cole of England and Mattie Hunter of Wales came to America in the 1670s, on the same ship. They la ter married and lived in Philadelphia, Pa. It is said that Stephen had been an apprentice in the manufacture of alcoholic beverages in the "old country", and pursued his trade in America.

Stephen and Mattie Cole became the parents of 12 children. The youngest of the 12 was John, who was only ten when his father died at the age of 60. John's mother apprenticed him to a hatter in Philadelphia, but after nine years, John had saved enough money that he paid \$60 for his release.

John married Jane Bound and moved to Richmond County, North Carolina and settled where Rockingham is now located. Here they reared ll children, nine boys and two girls. Three of the sons, Stephen, James and William, were in the Continental Army under George Washington, Stephen being a Captain. The other children were Samuel, Jesse, Mark, John, Peter, and Reuben. The girls were Mattie who married Stephen Wall, and Nanny who married Israel Sneed.

Jesse and Mark first settled in Kentucky, the better to educate their children. Mark died and Jesse reared his children as his own. It was here that the father of Frank and Jesse James met Zerelda Cole, in college, marrying her, and that is where Jesse James got his name. Also, the sister of Zerelda married a Mr. Younger, and that is where the name of Cole Younger began, both being named for their grandfather.

John and Reuben were in the mercantile business in Rockingham, N.C., for some time, then John settled near Dardanelle in 1820 and Reuben settled in Jones County, Ga. John was a doctor and moved to Washington County, Ark. some time in the 1830s, as he was postmaster at Sylvia, later Cincinnati. Before the war the family moved to Texas, where I have corresponded with a granddaughter.

Captain Stephen Cole emigrated to Missouri, and in 1820, Nov. 16, Cole County was named for him. It is supposed that Peter also settled in Missouri, as three members of the family finally located there.

Reuben was only five years of age when the Revolutionary War was over. After going to Jones County, Ga., he met and married Celia Wadsworth, daughter of an Englishman, James Wadsworth. She was born Feb. 10, 1792, and died at Cane Hill, Ark., Jan. 25, 1877.

The children of Reuben and Celia were: James Monroe Cole, 1814-1872; John N. B. Cole, 1817-1876; Nancy Sneed Cole, 1822-1902; Martha Hunter Cole, 1825-1909 and her twin sister, Lydia Wadsworth Cole, 1825-1909; William Troupe Cole, 1828-1899; Samuel Cole, 1831-1924; and Jesse Cole 1833-1911.

Samuel Cole, after the death of his father Reuben, moved with his mother Celia to Cane Hill, Ark., exact time not known, but Samuel had several children in Cane Hill College in 1876-78. Their names were: Hunter, James, Lulu, Nettie, Samuel, John and William. Samuel's wife was Mary Elizabeth Woods. I understand that there is a descendant of Samuel living near Cincinnati, but have been unable to locate him. Samuel, Celia and a Dr. John Cole are all buried at Cane Hill.

Samuel Cole, my great-grandfather, moved, with twelve other families, to six miles north of Elkhorn Tavern in 1832. All the families but five settled in Barry County, Mo., so they could be in a State. The five Cavness families settled in Arkansas Territory, inBenton County, on Pea Ridge. Samuel's children were Samuel, Hiram who lived at Darcanelle during the war, John, James, and Newton Cannon.

Samuel lived here until 1837. His wife having died, he returned to Tennessee. He came back through Benton County in 1839 with the Cherokees and lived with them four years before returning to Tennessee where he died during the war.

My grandfather, Newton Cannon Cole, was born in Tennessee in 1818 and died in Benton County, Ark. in 1893. He married Candace Brashears, who was born in Kentucky in 1820 and died at Long, Okla. in 1913, being 93 years of age. Their children were: William, Joseph, Nancy Jane, Jasper, Mary, James, John C., and Robert A.

Nancy Jane, born in 1853, died in 1927, married my father, Martin Luther Seamster, born in Schuyler County, Mo., June 17, 1844 and died in Benton County, Ark., Feb. 16, 1936. Their children were: John W., Walter A., Marion, Cetta Candace (Crouse), Robert A., Roy, Bert, Lee, Alvin, and Jesse. Only Roy, Jesse and myself are still living.

There were 13 families came from Tennessee in 1832 -- 5 Cavness, two Brashears, Alex and Robert; Dr. Morgan, Warren Potts, A.J.(Jack) Dye, the Cole family, two Banks families (I believe Stephen and Houston).

My mother was 8 years old when the battle of Pea Ridge was fought and gave me some valuable history; also my grandmother gave me much history and started me hoarding antiques, as she gave me a linen cap made in Kentucky in 1820 and the old clothes basket from Tennessee.

Donna Potts, a descendant of Warren Potts; gave me the door facings, hewed with a foot adz, with the pegs intact, that were made by my grandfather in 1832.

One of my mother's uncles, James, was a deputy under Judge Parker, while another brother was a consort of Belle Starr in the Indian Territory.

The five Cavness families were Matthew (Old Matt), Edmond and his wife, Rebecca; Henry and his wife Nancy; Jeremiah and his wife Kisiah; and Matthew Jr. and his wife Rebecca.

The Seamster name is well-known in northwest Arkansas, but I will leave their activities to future historians. However, if I were writing the Seamster family history now, it would be much longer, as I have it back to 1690.
