side of Boston, no New England town can show such a roll of distinguished mames as have illustrated her annals, unless Cambridge be an exception.

Nazing, a rural village in Essex County, England, the home of many of the fathers of Roxbury, around which clustered the affections and remembrances of their youth, comprises the northwest corner of Waltham Half-hundred. It is on the river Lee, and is twenty miles east from London. Its gablefronted cottages, with low, thatched roofs and overhanging eaves, show that this quiet little village has undergone slight changes during the past three hundred years. The manor was given by Harold II to Waltham Abbey.

Its old parish church may be regarded as the parent of the First Church of Roxbury. It is situated on the side of a hill overlooking parts of Hertfordshire and Middlesex, bounded on the west by the river Lee, and on the east and south by Waltham Abbey and Epping. Its parish records contain the familiar names of Eliot, Ruggles, Curtis, Heath, Payson, Peacock, Graves, and others, who, between the years 1631 and 1640, left their beloved homes and, for conscience' sake, braved the dangers of a long ocean voyage in the frail vessels of that period that they might aid in establishing a Christian commonwealth in the wilderness. The accompanying view

of the church represents the building as it appeared when the emigrant fathers worshipped within its old gray walls two centuries and a half ago.

Under the lead of Pynchon, the first-comers to Roxbury settled chiefly in the easterly part of the town, next to Boston. From the town street, now called Roxbury Street, they gradually extended themselves in various directions towards the neighboring towns, notwithstanding the enactment of 1635, designed as a protection against the Indians, that no person should live beyond half a mile from the meeting-house. Jamaica Plain and West Roxbury were settled later. The first mention of the town occurs in the records of the third Court of Assistants, held Sept. 28, 1630, as one of the plantations on which a part of the general tax of £50 was levied, and that day has therefore been fixed upon as the official date of its settlement. Roxbury was the sixth town incorporated in Massachusetts.

In the year 1631 the ship "Lyon," William Pierce, master, left the shores of England with the first batch of Nazing pilgrims on board. Eliot, the apostle, was there, with William Curtis and Sarah, his wife, Eliot's sister and their children, in company with the wife of Governor Winthrop. They were ten weeks on the water. In the summer of 1632 she once more left the Thames for Boston, having among her passengers William Heath, with his wife and children, and several other Nazing worthies. Isaac, his elder brother, did not quit Nazing until 1685. Early in 1688, John Graves, with his wife and five children, left their home for the shores of New Eugland, and in 1635 they were followed by a large number of Nazing Christians who came over in the "Hopewell," Others came later, but emigration from Old to New England ceased about 1640, when the popular cause there began to look hopeful.

The first year was one of great toil and privation. Fuel was scarce, and the cold intense. Few settlers arrived in the

last century. Back of it runs Stony Brook, lined with huge willows. This old house was bought in 1742 by Jeremiah Williams, blacksmith, brother of Col. Joseph and the father of Major Edward Payson Williams. An old mansion, once the residence of Mr. John Amory, now a public house, and styled the "Amory Hotel," is on our left as we approach "Gamblin's End," while on our right a new brick brewers seems sadly out of place in this sylvan retreat. Somewhere in this immediate vicinity was the house and fourteen rols of ground belonging to John May, or Mayes, as it was then written, the ancestor of the well-known family of that name, The book of "Houses and Lands" describes it as "a triangle abutting on R. Gamblin east, the highway northwest, and Thomas Bell's orchard southwest." May, who had been master of a vessel called the "James," sailing as early as 1635 between London and New England, came to Roxbury in 1640, and died on April 23, 1670.

The fine old mansion near the corner of Amory and Boylston Streets, now the residence of Gen. W. Raymond Lee, was




GEN. W. BAYMOND LEE'S BESIDENCE.

built in 1766 on the land given by Thomas Bell in 1672 to the Roxbury Free School, of which he was the most liberal benefactor. Near it stood, until its demolition in 1765, Mr. Bell's homestead, afterwards that of Capt. Ebenezer Gore, the sound portion of the old materials being made use of in the new structure. The homestead eame about 1810 into the possession of Thomas Amory, "Loudon Tom," whose daughter Mr. Lee married. At the bend of the road is a large English elm, and on the grounds in front of the house are many fine specimens of clins, English and American, so disposed as to add greatly to the picture-sque effect produced by the low, irregular outlines of the residence itself. The old portion of the house is central, the wings are modern additions.

Mr. Bell bequeathed all his real estate in Roxbury in trust for "the maintenance of a schoolmaster and free schoole for the teaching and instructing of poore men's children in the town." This gift, a very large one for the time, with its accumulations, renders the school one of the most richly endowed in the country. His lands extended from Stony River, taking in this homestend, across School Street and the turnpike up to Walnut Avenue. The beautiful, smooth field of eighteen acres at the right of Washington Street, on the brow of the hill, on the corner of School Street as you come north, and the great orehard opposite, are embraced in this portion of the princely bequest of Thomas Bell, a merchant, who resided here from 1635 until his return in 1654 to England, where he died in 1672. The apostle Eliot's influence was no doubt exerted to procure this gift for the school, whose establishment he had done so much to promote; and we also find Mr. Bell further sustaining that good man's endeavors by becoming one of the corporators in England of the Society for the Propagation of the Gospel in New England. The memory of Thomas Bell should be fondly cherished by the people of Roxbury.

A short distance west of the Bell homestead stands the old Curtis house. In 1639 William Curtis built on the margin of Stony Brook a substantial dwelling, supposed to be the one now standing. It is in excellent preservation, and is inhabited by the widow and children of the fifth Isane Curtis who has occupied it, and who was the seventh in descent from William, the emigrant. The instances of the continuous occupation of the homestead by the same family for a period of two hundred and forty years, are very rare in New England. The neighborhood was originally a forest, abounding in wild animals, and a pair of autiers can now be seen in the old house, taken from a buck that was shot from within it, probably while drinking from the brook. In 1659 twenty

shillings was paid by the town to Philip Curtis, for killing a wolf here. "William Curtis's homestead of ten acres was bounded south on Stony River, north on Robert Pepper, west on John Ruggles and John Totman, and east on George Brand," says the ancient Transcript of Lands.

The house — a good specimen of the second period of New England architecture — stands on Lamartine Street, near the Boylston station of the Boston and Providence Railroad, over which a hundred trains run by it daily, and is probably one of the oldest inhabited dwellings in the United States. Near it, shaded by the magnificent elm seen in the picture, is the spring that doubtless determined the locality of the dwelling. Tradition says this tree was transplanted a hundred years ago, by one of the family, from a meadow in "Rocky Swamp," a tract lying between Washington Street and Forest Hills Street, then owned by the Curtises. With care it will probably last another century. A large, healthy, fruit-bearing currant-bush grows from a knot-hole on its eastern side.

The timbers of the Curtis house are of unseasoned white oak, doubtless cut from the farm. The nails were all wrought, there being then no machines for cutting them. The building is of two stories, with eight rooms, a garret above, and a small square entry on the lower floor, separating two of the main rooms. It has a pitched roof, sloping down at the rear to within a few feet of the ground, and in the centre stands the enormous square chimney. The windows are small. Originally the glass was diamond-shaped, and set in leaden sashes, but about the beginning of this century these gave place to the small panes of glass they now have, and the lead was converted into spoons. Square blocks of oak, about ten inches across, serve as cellar stairs, and show unnistakable signs of wear from the tread of the generations that have passed over them. Much of the old furniture, handed down for generations, yet remains. Perhaps the apostle Ellot sat at that quaint old table, Winthrop or Thomas Dudley in that antique chair. A company of Rhode Island soldiers were quartered here during the siege of Boston.

William Curtis, a native of the parish of Nazing, was married there to Sarah, daughter of Bennett Eliot and the sister of the apostle, in 1618. They came over with other Roxbury settlers in the "Lion," in 1632, bringing four children. Another passenger was Ann Mountfort, the affanced of Eliet, to whom she was married a mouth after her arrival. There can be little doubt that the influence of his brother-in-law, Curtis, was potent in drawing Eliot from Boston, where he was so carnestly "labored with" to include him to remain.

NAZING.

Hist. of Essex, p. 228, says: "Nazing is, in Domesday book, written 'Nessingham, Nessinga, Nessinges'—may probably be derived from the Saxon word nase, or nose, a projection, and ing, a meadow, as part of the parish stands on a hill."

Situated only 17 miles from London, Nazing comprises the northwest corner of Waltham half hundred. Besides the interest it has for us as the home of our fathers, there is a peculiar feature about this little village and its surroundings, which is strictly characteristic of the many rustic homesteads and picturesque spots for which Old England is so noted. One might imagine from the great number of gabled fronted cottages, with low thatched roofs and overhanging caves, that abound in Nazing upland especially, and the distance it lies from any line of rail, that it had undergone but little change during the past three hundred years.

The old parish church is situated on the side of a hill overlooking parts of Herfordshire and Middlesex; bounded on the west by the river Lea, and on the east and south by Waltham Abbey and Epping. We can easily imagine the emigrant fathers worshipping within its old gray walls.

It consists of chancel, nave and north aisle, with a square embattled tower containing five bills. The body and aisle are divided into four pointed arches rising on circular clustered columns; behind the first column, which is hollow, is a small door, leading by a narrow winding stair to an aperture in front of the chancel, sufficiently large to exhibit a person nearly at full length to the congregation. This was no doubt the entrance to the rood loft; but whether this was originally intended as a place of penance, is not certainly known. It is evident, however, that at no remote period, it was used for purposes of general thanksgiving, as on a wooden tablet beneath the aperture is inscribed the exvi. Psalm: "I will Pay my Vows unto the Lord in the sight of all his People."

This church was appropriated by King Harold to his newly founded church in Waltham, and was first supplied by the canons of Waltham, or by persons appointed by them. The vicarage occurs among the small benefices in the taxation of Nicholas IV., in 1291, and was valued at 30s. The Abbots and convent of Waltham remained patrons of the vicarage till the dissolution of the abbey temp. Hen. VIII.

The interior of the church has undergone a slight change. The old oak seats, which were carved at the ends with a variety of grotesque characters, were, in recent years, cleared out with the exception of about five of the best of them, which have since been refixed at the east end of the side aisle. These seats date back to the time of James the First.

The parish registers of Nazing, which yield many an important item in connection with the emigrant fathers, commence in the year 1559. The first register book is headed with the following text of scripture: "O Lord increase our faith." (N. E. Reg.)

to John Curtis my yongest soon xx markes of lawfull english mony to be payd allso to him at his adge of xxi^{ti} yeares. Itm geve to my daughter Mary the sum of forty shillings of lawfull english mony to be payd unto her whn two moneths next after my deceases. Ite my will & mynde is that all these legasies heere before geven shalbe payd out of my moveable goodes whout the house as Corne cattells grain or any such like thing whatsoever & I will that the overplus of the sayd moveables (these legasies above said being discharged) be equally devyded betweene Agnes my wife & Thomas Curtis my eldest son excepting out of my sayd bequest two of my best lambes won I geve to my daughter Maryes two children.

Concerning my howsehould stuff I do whollie geve the same to Agnes my wife & I make & ordeyn my said wife and Thomas Curtis my son my Executors to see my will truly fullfilled my debts payd & funeralls discharged. And I desire my good freend goodman Bannister & my brother Geordg Curtis to be oversears of this my laste will & Testmt.

*The above testator, William Curtis, was buried in the churchyard of the parish of Nazing, Essex, England, as per the record in the register of burials of that parish viz: "Burials, William Curtis 17 May 1585.



(The chart, hereinafter, will give the children and grandchildren of the above testator, William Curtis, in formal order with their records. We will also give the will of Thomas Curtis, eldest son of the above testator, William Curtis. This Thomas Curtis was the father of the William Curtis baptized at Nazing Nov. 12, 1592, who emigrated to Roxbury, Massachusetts in the ship "Lion" from London June 22, 1632, with his family. Thus, this William Curtis was the nephew of John Curtis the younger son of the above testator, William Curtis, who died in 1585. We now quote the records in the parish register of the church of Nazing, Essex, England, relating to this John Curtis, his wife, and their three children:

"Baptisms. John Curtis baptized Sept. 15, 1577". His marriage is recorded in the marriage register of the same church viz: "Marriages: John Curtyce and Elizabeth Hutchins April 19, 1610". Their three children are recorded in the register of baptism of the same church viz: "Baptisms John Curtis Feb. 26, 1614".* "William Curtis, June 21, 1618". "Thomas Curtis, March 12, 1619 (-20)".

Itm I give unto my Paughter Martha one fether bede. Item I give unto my Daughter Mary one other ficather bede. Item I give unto my Daughter Elizabeth the cubboard in the old parlor. Item I give my table in the old parlor to my Sonne and all that was my first wyves and my Lynnen to be equally devided amongst my iij Daughters. Item I give unto Mary my wyfe my house and lande with all apptinances for mij yeares after my decease uppon Condicon that at the ends of six years shee doe pays or cause to bee payde unto every of my sayd daughters fortie pounds in mann' and forme followings vizt., I will that shee doe paye unto Martha my Daughter forty pounds with in the Compasse of the seaventh and eight years after my decease. Item I give unto Mary my Daughter forty pounds to bee payd unto her in the ixth and xth years nexts after my decease. Item I give to Elizabeth my Daughter forty pounds to bee payd unto her in the xith and xijth years after my decease. Item my Will and meanning is that if my wife doe not pay the three porcons before menconed accordinge to this my Will that when my three Daughters shall have my howse and land for the last six years to rayse them ther sayd porcons. Item I do give unto my somme my howse and land after the ende of mij yeres upon condicon that he doo paye unto my wife yearely viij pounds durings her naturall life and if he refuse to pay the sayd eight pounds that then shee shall have halfe my house and land. Item all the rest of my goods moveable and unmoveable what seever ungiven and bequeathe I give unto my wife whome I make my sole Executrize of this my will. In witness whereof I have setto my hand the day and years above written in the presence of us.

WILL OF WILLIAM CURTIS.

Know all men by these presents, that I, willyam Curtis, in the county of Suffolk in Newengland, for and in considerashion of mine own and my wife's eage and weaknesse, and our unability by resen thereoff to manage that small estate in our hand, so as to attane a Livellyhood thereby; and our incapability to live without some abill person to bee a staffe and guyde, to ous in our eage, and all my children through the goodness of God, being disposed into families of their one excepting my youngest sson, Isaack; they not being in so good canacity, haveing habytashons and effeacts of their one, to manig; to be help fful unto me; for and in considerashion of fatherly affection and other good resens, moveing me hereunto, have and by these presents doo ffully and absolutelly, give, grante, make over, and assine and confurme, unto my beloved sone. Isaac Curtis of the same place, now living with me, my hole esteate, now in my hands, that is to say, my dwelling hous, barn, and outhousings and all my lands, orchards and yards, catill and moveabill goods, of what sort soever, the severall parssells of land, as it now lyeth in Roxbury, tene acars of it lyeth in Roxbury, by Stoony River, as it now lyeth, be the same more or less, with the aforesayd housings, orchards and yards, and these abutting upon Stoony river Easter, and upon the land of Isaac

Curtis, lately of John Curtis, North, and upon the land of John Crafts and Robert Seaver, West, and upon the land of Isaac Curtis, lately the land of Willyam Hopkins, and the hyway leding frome gamblins end south; and two acors of salt marsh, be it more or less in the *eyeland in Roxbury, as it now lyeth and there abutting upon the river. South, upon the land of Robert Seaver. West, upon the heirs of John Ruggles. And five acors of woodland, more or less, nere to the town grate lots in Roxbury, and there abutting upon the town grate lots. and the land of John Mayo and Willyam hopkins west, and upon the land of willyam hopkins, south, and upon Abraham how, east. And mor, eayght acors of land in the woods in the middle divishion in Roxbury, being part of three and twenty lot as it now lyeth, be the same mor or less, and there abutting land of John Baker, east. North, upon the land of willyam lion, west upon the land of, between the middle divishion and the last, South, and together with this my present deed, doe give to my sayd sson Isaack, the present and full posseshion of this estate, to wit, my sayd hous, barn, and out housings, all the above sayd several parcels of lande with all that is upon them, and the appurtenensses and priveleges, belonging to them, together with all my catill and moveable goods, of what sort soever, and I, the sayd Willyam Curtis, will and shall forever, hereafter warant my deed of gift, in all the several parcels of it, unto my sayd soon Isaack Curtis, his hayres, executors, administrators, or assygns, and all persons whatsover claiming any right or title hereunto, by, from, or under me, upon these considirations following:-First, that the sayd Isaack Curtis. shall always, and at all times provide for me, his sayd father, Willyam Curtis, and his sayd mother, Sary Curtis, during the term of our naturall liffe, or the longest liver of ous both; of things necessary for our comfortabill living in this world, of comfortabill housing, lodging, food, clothing and firing, all other things necessary or needful, in health or sickness; and in case he the sayd Isaack, doe at any tiem fail herein, so that there be full cass of complaint, that Williyam Curtis or Sary, his wife, notwithstanding this deed, shall have full power, to will, tak possesshion and sell or otherwise dispose off, any part of this esteat, for their necessary relief, provided before any alienashion or disposal, the sayd Willyam Curtis, or Sary his wife, shall inform the rest of their children, and together with them, by the advice of friends, chosen by the sayd Willyam Curtis, and Sary, his wife. Secondly, that the sayd Isaac Curtis, his hayers, assygns, executors or administrators, shall pay or cass to be payd unto my beloved sonne, John Curtis and to my beloved sonne-in-law Isaac Newall, the full and just sum of forty shillings in some merchantable goods, to each of them, their hayers, assygnes, or executors within three months after the desese of sayd Willyam Curtis and Sary his wife; and this however found above expressed, together with what the have already reseaved is their porshion; and for the rest of my children, tha have already reseaved their porshions. And I, the above sayd Willyam Curtis, do resarve unto myselfe and to my wife, Sary Curtis, during the tiem of our natural liffe, halfe the fruit the orchard doth produce for our one comfort and use, to dispose off, as the sayd Willyam Curtis

and Sary his wife shall see fit. In witness fixed wheroff, I, the sayd Willyam Curtis, hath sett to my hand and fixed my seall, this leventh day of Februari, 1669. Willyam Curtis. Receaved, sealed and delivered in the presence of us,

Peleg Heath, Samuel Crafts. WILL. CURIS acknowledged this Instrument as his Will, May 15th, 1672. Enos Tyng.

[William Curtis and Sarah his wife were here March 4th, 1632, at which date he was made freeman. He probably came from London, bringing four children, and settled in Roxbury, near the station of the Providence Railroad at Boylston Street. He is supposed to be the first of the name who came to New England, except, it may be, his eldest son, William, who, it is stated, came in 1631, perhaps with John Eliot, in the "Lion," and died young. The fifth Isaac Curtis came into possession of the family estate by will from his father, nearly in the same manner as his ancestor William bequeathed it to his youngest son, Isaac, who gave it to his son Isaac, and so down to the present time; the present possessor being of the sixth generation and the fifth Isaac, and the only male heir in the lineal descent now living.

The late Charles P. Curtis was of the opinion that his ancestor William came from Stratford upon Avon, as tradition says a nephew, who came over with him, settled in Connecticut, with other families from his native place, forming a colony and naming the town Strat-

ford after their native place.

A BOND FROM PHILIP TO ISAAC CURTIS.

This testifies that I, filip Curtis, dou own and acknowledge that when my father, Willyam Curtis, did give unto me an assymment of his meadow, near Stony River, in the meadow lots, near to land of John Curtis, joyning unto myn own land and meadow, baring date. on the 25th day of January, one thousand six hundred sixty and nine; he did reserve unto himself, the sayd willyam Curtis, my Father, and to Sarah Curtis, my Mother, during the tym of their natural life, or the longest liver of them both, the whole use of the sayd meadow for moving the first crop on it in the year, constantly, in considerashion, wherof I, the above sayd, filip Curtis, doe fully and absolutely covenant and grant to and with my loving brother, Isaac Curtis, that he, the sayd Isaac Curtis, shal constantly yer by yer, have liberty to mow and make and have a suffishent cart way through my land, with out molestashion too carry away such hay as the sayd meadow dus yeld, for the use of my father, william Curtis, and my mother Sarah Curtis, during the term of their natural life, or the longest lives of them both; also I dou covenant and engag unto and with my sayd brother, Isaac Curtis, that whatsoever charge I, the said filip Curtis, shall mak to the meadow for the use of feeding the rowen or after pasture, after mowing it, shall be done at myn own expense, and py sayd brother shall bar no mor charg of fencing than belongeth to him as lying in common, under the above performance of this fathers

researved interest in his premises, I doe, bind myself, my heyres, executors and assigns during the whol tym of my fathers and mothers natural life. In witness wharoff I have hereunto set my hand and seal in the presence of

Peleg Heath, Samuel Crafts. Dated this twenty-fifth day of January, one thousand six hundred sixty and nine. filip Curtis.

[Hubbard, in his History of the Indian Wars, states, that Capt. Henchman's company marched out of Boston Nov. 1, 1675, to rescue some youths who had been captured at Marlborough by the savages and carried off. On the fourth day's march the Indian plantations were reached, an attack was made, and the youths were rescued. The Indians finally retreated, but Lieut. Philip Curtis, the giver of the above bond, and several of the company, were killed. This engagement took place about ten miles beyond where the town of Mendon is situated.

In the Massachusetts Archives, vol. 69, page 106, date 13:12:76, may be found a petition of Obedience Curtis, of Roxbury, whose husband was killed by the Indians, when under Capt. Henchman. She was the widow of Philip Curtis.

THE FAMILY OF HENRY CURTIS OF SUDBURY, MASS.

 Henry Curts came to New England in 1635, aged 27 years, in the Elizabeth and Ann, and settled at Watertown, Mass., where he was a proprietor in 1636, later removing to Sudbury, Mass., where he was a proprietor in 1639. In deeds he is styled "wheelwright."

He married, probably in Watertown, about 1640, Mary, daughter of Nicholas Guy of Upton Gray, co. Southampton, England, who had come to New England in 1638, in the *Confidence*, and settled at Watertown.

The will of Joan Parker of St. Saviour's, Southwark, co. Surrey, England, dated 24 Aug., 1674, proved the following year, gives to her "brother Henry Curtis of Sandbury in New England," and to his wife, and his three sons, Ephraim, John, and Joseph, 20 shillings each. (Register, vol. xxxii, page 337.)

In Dec., 1668, in a lawsuit concerning property stolen from Henry¹ Curtis, there are depositions of his sons, Ephraim aged 26, John aged 24, and Joseph aged 21, and of Richard Wills aged 20, servant of Ephraim.

(Middlesex Co. Court files.)

Henry Curtis died in Sudbury, 8 May, 1678; and his widow, Mary, died there, 3 Dec., 1682; administration of their estates being given to the son Joseph.² (Middlesex Co. Probate, Nos. 3724, 3731.)

He was also a trader, and had a house at Quansigannag (Worcester)." (Soldiers in King Philip's War, pages 104-105.)

hnathan Fine was born in Alabama put down his first tiny footprints a her soil. Two years after his birth ais family moved back to Tennessee where they had resided before settling in Alabama. For twelve more years he was to put down-more tracks in the beautiful hills of that state. His family moved to Arkansas when he was 14 years old, and it was that state's Boston Mountains with their deep, rich valley ands that were to next bear evidence of Jonathan's traversings, He met and married there, around the year 1836, Rachel Mankins, the daughter of Peter lankins, Senior and Rachel (Bracken) ewis Mankins. Washington Co., Ark., clow Fayetteville, was his home for bout 21 years. He spent 1 years in exas and the remaining 19 of his 61 ears in Crawford Co., Ark., northeast Van Buren at Fine Springs,

The Jonathan Fine family on leaving exus planned to return to Washington punty. They drove their eattle and rses back into Arkansas and enroute camped one night at a big, beautiful ring. They liked the looks of the cely hills and big spring so well that by decided against going any further orth and settled right there. Turning wir cattle loose in the Dyer Bottom cane break some 8 to 10 miles below the spring. That was sometime between 1857 and 1859, at which time none of their surviving 10 children were married, Peter Fine, eldest living son, was to visit kinsmen in Washington Co. and there find and marry Ruthy Cosby, youngest daughter of Wiley and Mary Cosby, of Virginia North Carolina, Alabama and to Arkansas in 1810).

Jonathan Fine is buried at the New Berry emetery, two miles south of the Fine Springs Community named for him. His wife, Rachel (Mankins) Fine, born 26 Jan. 1819, died 24 Feb. 1897 at the lage of 78, rests beside him. Their graves both have grey sandstone, coffin shaped markers that rise above the graves and run the full length and breadth of them. They are simular in shape, size and height to the old fashion hand made coffin. In 1965 a 92 year old granddaughter (daughter of Millie (Fine) James) was still living and residing in Van Buren. Ark, She told

me at that time it was her father, William James, and another man who cut those coffin shaped stones that were placed on her maturnal grandparent's graves. They are cut like some that were cut in the early days of Washington County by a Nathan Tharp. Many of Jonathan and Rachel's 11 children who lived to maturity, their wives, and

many of their 70 grandchildren, greatgrandchildren and 2nd gr.-gr.children are not far from their place of rest. Also sleeping there are my two small babies who were great-great-great-grandchildren of Jonathan and Rachel two times, for my husband is also a descendant of this couple, we being 3rd consins. An enlarged picture of Jonathan and Rachel hangs in my dining room today. (Editor's Note - see photo elsewhere on this page) The gate leg walnut dining table that Brancken Lewis made for his sister Rachel to start keeping house with is still in good shape, still beautiful old and useful, as is the little walnut desk which he also made for his sisters home around 1836 when she married Jonathan. In my bunkhouse is a hand woven coverlet, dyed with native wool, cut, washed, carded and spun into thread by Rachel for her eldest son (my great-grandfather) to start his married life in 1860. I have with it the blanket he carried the four long years that he served the C.S. A.

during the Civil War. I have a tintype of Jonathan, Rachel and all nine of their children who were living in 1865, which was taken when four of the sons had just returned from the war.

I discovered that my sister had the Curtis Family Bible during my first year of research (1963) and started putting records together of the past that coincided with those I had of the present. My mother and aunt spoke of "Grandma Curtis" whom they remembered. They got rather put out with me because of my constant questioning, so went to see Bernice (Brown) Sherman in Centerville, Leon Co., Tex. whom they had so often told me was a cousin, but they did not know just how they were related. Bernice was a descendant of Alfred A. Curtis, son of Capt. Curtis & Nancy Lucy and I found that she had a copy of Alfred's Family Bible, giving some of the same records, but much in addition. It was there I found that "Grandma Curtis" was my gg grandmother, Elizabeth Margaret (Pegues) Boggs, widow of Dr. James Coleman Boggs, who had died in 1854 at the age of 44. She had married Capt. Curtis in 1862, two years after the death of Nancy. She died in 1896 and mother had known her as a child. I was thoroughly puzzled at the relationship this caused in the family, as Capt. Curtis was my 3rd great grandfather and his granddaughter, Sarah Ann Eliza Traweek, had married the son of Elizabeth Margaret, thereby becoming her step-granddaughter as well as her daughter-

As I began tracing the children of Thomas R. & Nancy Curtis, I found I had cousins that I never heard of and began exchanging records on Lucy, Traweek, Pegues, Chinski, Evans, James, Weaver, Carson and other related families. Jas. Coleman & Elizabeth Margaret Boggs had three children, Dr. Alvah DeVotie, Harriet Cornelia (who m. Isaac Chinski) & Alice Stella (who m. Joseph Alexander Evans). I had the records of "Botie" and as I sought records on the Pegues, I found a cousin, Virginia Pegues Lidwin (now deceased) who lived in Crystal City, Tex. She was descended from Charles Cotes worth Pinckney Pegues, brother of Elizabeth Margaret. Through the Curtis Bible records, I found the name of Grandma Sally's mother and father & the marriage record in Ala. Death records of yellow fever was confirmed by my cousin, "Peck" Williams in Lubbock, who exchanged records with me on the Traweek line. Through a friend in Leon Co., Billie Douthitt, who worked with me on the book of Cemeteries, found a family Bible record of Nancy Ritter Curtis & Edward Travis Pistole. Records of Amanda & Nanny who married Carson brothers, were furthered from family Bible records of the Carson family from Richard R. Royall in Houston. The children of Elizabeth Malinda & Ignatius were not only in the Bible, but also in the guardianship papers of Capt. Curtis. Records of the Boggs given in the Bible were completed through questioning at the Boggs Family Reunion where I gave a talk each year of the records I had found. Many records were available of Jas. C.'s brother, Lilburn Wycliffe Boggs, 5th Gov. of Mo. who married Panthea Grant Boone, granddaughter of Daniel Boone. The diaries of the trip from Mo. to Napa, Calif. were fascinating. A biography of the Boggs family in The Lone Star State that was left by Botie to Vivian Earl Boggs, who had left it to his son, V. E., also furthered records. Bibles provide much information that cannot be found elsewhere. This is the only place one can find the children who died young and are not mentioned in wills or other records. Virginia Pegues Lidwin's family record of the family of Samuel Butler Pegues & Juliet King, which was embroidered on an old Sampler by the daughter, Maria Ann and is the only known complete record of the births of the children of this family.

When I wrote the Oglethorpe County Clerk she informed me that there were no Scroggins Wills on file in that county, but she did find the marriage record of Humphry Scroggins to Lydia Rafferty in 1804. Don't know why this man was not listed as a head of household in the 1820 census of Georgia. He could not have been the Humphrey Scroggins who was in Greenville Co., S. C. in 1790 because of the age differences, but might have been this mans son. The Humphrey of S. C. was a Rev. War soldier and has descendants who are members of the D.A.R. He married Sarah or Sallie Kirby, daughter of David and Elizibeth (?) Kirby. This Miss Kirby was born 1767. and she had a brother named Soloman.

Smith Scroggin of Baldwin in 1820 is probably the same Smith Scogins who married a woman with the maiden surname of Sales sometimes prior to 1819. This information Scoggin is filed in Baldwin Co. Ga. Will book 1806-1819. A girl by the name of Pamelia Scoggin married John Allun/ in Baldwin Co.

the territory. No Zebulon on any stone, other Curtises, not mine. After photographing some general views we left, dampened and disappointed.

The next day after a business meeting, a luncheon was served. This inn is noted for its cuisine if not for its comfort. A gentleman on my right, Robert Curtiss of Torrington empathized with my disappointment, and declared he might be able to help me. He knew the name of the cemetery's historian, a former Girl Scout leader, whose troop's project 25 years ago had been to record and number each gravestone.

Before his letter came, a letter from Gail Kruppa arrived with Xeroxed copies of Curtis births, marriages and deaths derived from vital records at the City Hall. The municipal historian, Ernest Ceder, resident of elderly housing, searched for all the Curtis records for the years 1741-1849. Of course, I sent a donation and hearty thanks.

Then Bob Curtiss' letter of October 31 brought the name of Miss Sylvia Wadhams. Another thank you and check.

In December, Sylvia and her sister, Hazel, made two trips to the cemetery, the first to check the condition of the stone, which was found to be tipped, covered with lichens and partially sunk into the ground. On the second trip, they took soft brushes to remove most

of the lichens, and warm water to try and straighten the stone. They took some photos which didn't turn out well because the film was the wrong kind.

Later, I received an excellent color photograph of the stone which reads: "In memory of Capt. Zebulon Curtis who departed this life May 5, 1798 in the 88th year- - - the rest is underground.

In the 1930s, a man named Hale was concerned that early records of Connecticut's churches and cemeteries would be lost. At his suggestion, all such records are now in the state library in Hartford. So great a reward for so little effort on my part!




Serendipity! CE ONLY

That's what it was, no long patient searching, just pure luck that I found the grave site of my fourth great-grandfather, Zebulon Curtis.

At the last minute in October, 1998, I decided to attend the Curtis/Curtiss Society Annual Meeting in Woodbury, Connecticut. Luck again-I reserved the last available room at the Curtis House (no relation) where the meeting was to be held.

Traveling by car in Autumn is a pleasure. There is less traffic; and the scenery on the Pennsylvania Turnpike offered rocky steep hillsides with dark green evergreens alternating with orange, brilliant red and yellow deciduous trees.

My husband and I arrived on Friday and checked in. room was on the second floor. up a creaky staircase (after all, this is Connecticut's oldest inn). Turn to the left, down a step and turn to the right. Our room was large with reproduction "colonial" furniture, including a high four-The bathroom was poster. adequate with nice touches of lotion and special soap.

The sight of our electrical power source was a bit unsettling; an


electric wire was laid on one windowsill and out to a larger wire lying on the roof of a porch below!

A curious coincidence: on one wall of the inn lobby was a large framed deed of a Milwaukee property.

Before leaving home, I had noted that Woodbury was a short distance from Torrington, where Zebulon was supposed to be buried. After stowing our gear (my husband had been in the Navy), we set out for Torrington on a gray misty afternoon. Upon arrival, we found the local historical society in the basement of an old house-museum. Curator, Gail Kruppa, kindly gave us a map of the town and directions for finding the possibly correct cemetery called First Ecclesiastical Cemetery.

We almost missed it. There was no obvious entrance, just a simple black on white wood sign. After backing into a slight space that might be called a driveway, we split up to cover

This query addressed primarily to readers of the Hartford "Times" for reasons that will become apparent below, but to other papers in various localities in this country concerned with these records, is designed to arouse not only the interest but also the copperation of people who are personally interested because no funds are available to finance any research and also because it is extremely probable that much of the needed data is not of public record but is very likely to be in private hands where it may be forever lost unless now produced. If non-professional searchers can prove family relationship to these records given below, it is quite possible that information may be secured from sources not unually open to casual query.

The great migrations of the Mormons brought many allied families together and records received by me from the files at Salt Lake City lead me to set down here as brief an outline as possible so that people located in the east where other records may exist that would fill the gaps in the present data may cooperate. The readers of the Times have long known that I have followed the hobby of untangling the many Curtis lineages and that I am not constructing any genealogy to sell and that I am one of the Stratford, Conn. Curtises and so not related to any of the Curtises of these Utah records, therefore having cleared away this underbrush, I set down here the brief outline and request help from Curtis descendants as well as the descendants from surnames of

allied lines given.

Joseph Smith, the Mormon leader had a Curtis ancestry and it would seem probable that his oldest Curtis relatives in Hebron, Conn., Peru, Mass., the Hudson River Valley, and Western New York and Southern Mich. knew about it for some of them followed him westward. His line anyone can find very complete in any library but briefly it runs as follows: Joseph Smith, b. Sharon, Vt. in 1865, m. in 1827 at S. Bainbridge, Chenango Co., N.Y. Emma, dau. of Isaac and Elizabeth(Lewis) Hale she b. 1804 at Harmony, Susquehanna Co., Pa. and d. at Nauvoo, Ill. in 1879. He was son of Joseph and Lucy(Mack) Smith, a son of Asahel and Mary(Duty) Smith, a son of Samuel Jr. and Priscilla(Gould)Smith, a son of Samuel Sr. and Rebecca(Curtis)Smith. This was Rebecca(3) Curtis, dau. of John (2) and Mary(Looke)Curtis and granddaughter of Zaccheus(1) and Joannatt () Curtis of Salem, Mass. The best printed record of Zaccheus (1) Curtis lineage is in Walter G. Davis's "Ancestry of Lieut. Amos Towne", Southworth

Press, Portland, Me. This book was published in 1927.

Rebecca Curtis's first cousin James(3) Curtis, son of Zaccheus(2) and Mary (Blake)Curtis, married Eleanor, dau. of Francis Jafford of Yarmouth. James Curtis was b. Dec. 12, 1681; his marriage date is missing but it was doubtless very close to 1700 and his children were probably born in Maine and one of them now appears to be that Francis(4) Gurtis, b. about 1790/1 who married at Plymton, Mass. Mayl2, 1720 Sarah, dau. of Joshua and his 2nd wife Susanna(Garner)Ransom, and had two children recorded at Plympton? Plympton; William (5) Curtis b. July 9, 1721 and Susanna(5) Curtis b. June 5, 1723. There are indications that this Francis(4) Curtis ## died there Apr. 24, 1717 ae. 67, so b. about 1650. There are several strong indications that this Francis Curtis who m. Hannah, dau of John Smith Dec. 21, 1671 was a son of Zaccheus(1) Curtis of Salem. The births of all the children of Zaccheus(1) except his dau. Mary are not on record and their names and births years have been secured from items in the Essez Quarterly Courts and elsewhere and it is quite likely that Francis, b. 1650-53 is missing and that the birth years of the others are not accurate. Essex Quarterly Courts Vol. 6, p.64 and 215 indicate roughly that Zaccheus' son John was b. 1649, and his son Zachariah b. 1651. Vol. 8, pl 17 shows that the latter was upon charges of improper relations with Elizabeth, widow of Obadiah Bridges in 1680 in F Ipswich, and after she married Joseph Parker in Oct. Zachariah appears in the Swansea area



now Bristol, R.I. where Solomon(2) Curtis son of Deodatus(1) of Braintree had just settled and in 1690 Zachariah sails away against the French in Samuel Gallup's expedition. (N.E.H.&G. Reg., Vol 9 p354) Perhaps the presence of his brother Francis in Plymouth may have induced Zachariah to leave northern Mass. Again Francis, son of Francis and Hannah (Smith) Curtis m. in 1700 Hannah Bosworth and named his last child b. 1730 Zaccheus Curtis who m. (int.) Aug. 21. 1742 Lydia Thomas. Again, the last child on record of John, son of Francis & Hannah (Smith) Curtis, by his wife Charity was Sarah b. May 10, 1711, and Marblehead has a record that on Nov. 26, 1712 Charity Curtis married John Bassett. There is no Charity Curtis on any vital record extant except the wife of this John, and it would seem likely that John died in 1711 and his widow went to Northern Mass. where perhaps relatives of Joh lived. Lastly, the Dudley, Mass. vital records have a Francis Curtis whose wife was Bethia and whose first child Ruth was of John and Charity() Curtis, therefore it seems highly plausible that this Francis Curtis is the first born of John and Charity ()Curtis b. in 1696 and his brother John b. 1702 was also in Dudley where he married (int.) on Dec. 21, 1734 Sarah Robinson. In an article on the ancestry of Sir Henry Solomon Welcome which I put in the Boston Transcript recently I surmised that this John married in Kingston Apr. 29, 1731 Meroy Delano and I now wish to state that this supposition appears to be untenable. Dudley, Mass. also has the vital records of John(4) Curtis son of Thomas(3) & Phebe(Gould)Curtis(Hohn(2)Zaccheus(1)Curtis) who m. Jan. 16, 1732/5 Hepsibah Hale. This John(4) Curtis is own nephew of Rebecca(3) Curtis, ancestor of Joseph Smith the Mormon leader, and I think that the presence in Dudley of Francis and John, grandsons of Francis and Hannah (Smith) Curtis, and John, grandson of John(2) and Mary(Loocke)Curtis is indicative of the truth of the supposition that the great grandfather of all three was Zaccheus(1)Curtis of Salem, Mass. Reading, #Gloucester. Dudley, Mass. is very close to Woodstock, Conn. and Francis's farm was on the boundary line, so sgy descendants of Edward, his grandson, who m. in Peru, Mass. Esther, dau of Samuel Tyler and removed to New Woodstock, N.Y. eight miles from me. His father, Edward, ran away from his wife Lucy Chamberlain, and took up with a woman by the given name of Thankful, and lived at Monson, Mass. where he had a son Francis and a dau. Thankful. This Francis was b. Dec. 9, 1775 and, strange to say, removed to Woodstock, Vermont, where he m. 1st Lydia Hudson and had a dau. Pamela who m. a Wilcox and removed to New York State and Francis m. 2nd Sarah Emerson b. Apr 7, 1811 who m. Otis Wood, and Edward b. Oct. 30, 1814 who died single. I place this record here because ######### a record of guardianship at Monson, Mass. confirms it and because it conforms with a tradition known to present members of this family, and because it puts one more Francis Curtis

as a probable member of the Zaccheus line.
To return to Francis(4) Curtis probably son of James(3) and Eleanor(Jafford)Curtis. It would appear that Eleanor named her first child Francis after her father Francis Jafford. Vol. XI, p 68 of York Deeds states that on Dec. 1, 1719 Eleanor, dau of Francis Jafford and wife of James Curtis, and her sister Elizabeth, dau of Francis Jafford and wife of John Perkins sold to Thomas Cummings of Topsfield all their right to land on Casco Bay, N. Yarmouth and Falmouth. So it would appear that young### Francis Curtis's birth and rearing in such a locality led him to become a mariner, for Vol 15, p 18 of the Boston Commissioners Reports has an item dated Jan. 12, 1736 stating that Francis Curtis, master of the Brig "Sarah"(named after his wife Sarah Ransom, no doubt) swears that he sailed from Phila., Pa. on Dec. 8, 1735 and small pox was raging there but that his men are all well, and his cargo mostly transferred from another ship. His cargo accepted but his men who never had small

pox to be segregated outside the harbor. This is the last record I have seen of Francis(4)Curtis. A possible gap of one generation seems to exist between this record and the birth of Francis(5) or (6) Curtis in 1743, according to D.A.R. data, 1746 according to family record. Whether he was son of William(5) Curtis b. 1731 is not known yet, but I would appreciate any clues from land records in or near Ashford, Conn. for there this Francis Curtis married on Nov. 17, 1768 Elizabeth(called "Betty") Robbins, and beside this records is Ransom Curtis married on Dec. 8, 1768 Ellica Whiton.* That they were brothers and children or grandchildren of Francis and Sarah(Ransom) Curtis seems extremely likely. If a dead could be found near Ashford telling where these two men came from, we might secure the generation missing. I have received a record of Brancis and Elizabeth's family from living descendants and from Salt Lake City and I append here a compilation Brom both sources supplemented by vital records of Peru, Mass. and probate records of Benesee Co. Francis Curtis d. Aug. 27, 1836 ae. 83 at Warsaw, Wyoming Co., N.Y. His children were: 1. Oliver who married Betsey Webster, no further record. 2. Comfort, b. 1775 who m. April 2, 1793 Priscilla Whitney according to the Peru, Mass. vital records, but private data says Priscilla Fisk. Comfort had land deals with Thomas Fisk and I am inclined to suspect that his wife married 2nd a Mr. Fisk as Comfort died June 4, 1831 and she, b. in 1774, died Oct. 8, 1845. Their son Comfort Jr. b. Apr. 16, 1797 m. and his sons David and DeWitt removed to Flint, Mich. Their day. Sally b. Apr. a, 1799 m. Peter Goodrich and removed to Chautauqua Co. Their son Lyman m. Priscilla _____ no further record. notice I have the wife of Comfort Jr. and she was Bertha Knapp. The data from Utah states Comfort Sr. had a dau. Betsey; this is proved wrong by his probate record. Comfort and Priscilla had a son Ransom B. Aug. 20. :803. no further record, except that he was alive when his father died in 1831; and Confort's (Sr) will mentions no son Lyman given above but I am inclined to suspect that his youngest son, Spencer L. whom he does mention, was named Spencer Lyman. Comfort Sr's. next child was Levi b. Aug. 15, 1804 and died May 23, 1867 ae 61 cemetery record but descendants have death July 22, 1848. He married at Middlebury, N.Y. Mar. 16, 1826 Climena Priscilla Roberts b. June 14, 1804 at 1833 m. Mar. 15, 1865 John W. Hill of Warsaw, N.Y. I notice I have the death of Lyman who d. Mar. 17, 1831 ae, 0-1-3. Emi'y b. Aug. 16, 1835 m. Oct. 22, 1856 Oscar Nash of Perry, N.Y. and she d. Oct. 5, 1901; Henry b. Sept. 23, 1839 m. his cousin Ellen(Curtis)Catlin, dau. of Levi's bros., but record does not state which one. I notice a cemetery record of Oliver Curtis d. June 27, 1831 as 47; their son Sylvester S. d. July 1, 1836 as 9; and their dau. Saloma d. date missing. Of Comfort Sr.'s son Spencer L. I have no record. Of Comfort's day. Caroline her father's probate records shows that she m. Tunis Cronkhite and that her sister Polly (Mary) was single in 1831 but she m. Joseph C. Leike.
No. 3 Calvin Curtis was b. July 25, 1778 and m 1st at Peru, Mass. Nov.9, 1802 Jemima Thompson(int.) I have no record of children by her. He m. 2nd at Peru May 11, 1806 Polly Clapp and the cemetery at Warsaw has her son Emera d. Aug. 8, 1811 ae i. and her son Almeron d. Sept. 20, 1814 ae2; and her dau. Harriet d. Aug. 21, 1811 ae. 10 mos. He m. 3rd Nancy Hibbard by whom he had 4 ch. Samanth who d. Jan. 14, 1830 ae 14; Martha M. no record; Daniel Storrs b. Sept. 5, 1829 who m. Jan. 10, 1850 Amanda H. dau of Clark Eldridge of Canandaigua, N.Y. and had Calvin who d. ae. 3; Frank R. b. Jan. 3, 1857 who m.

Sarah Boyce of Wyoming Village and Lottie B. b. July 3, 1858 who m. Andrew B. Morris of Middlebury; Calvin's 4th child by Nancy was Roger H. Curtis who d. in 1869 no further record. The Salt Lake City data has another child of Calvin named Elvira P. Curtis who m. Alvah Bates. Whose child was she, Jemima Thompson's or Polly Clapps?

No. 4 Amasa Curtis. His birth date I do not have, but his will is dated Nov. 5, 1834. He m. Sept. 16, 1794 at Peru, Mass. Eunice, dau. of Edmund & Abigail(Wood)Richmond, she b. June 12, 1772 at Taunton, Mass. and d. May 9, 1849. They had children: Linus b. Nov. 1, 1795, Betsey b. Sept. 18, 1797 who m. Mr. Webster, Edmund who was b. Mar. 4, 1800 and m. Mary Pierce, Eunice b. Oct. 19, 1802 who m. Isaac Andrus, Francis Waterman, b. May 7m 1805 who m. Sylvia Cronkhite she b. in 6tsego Co. Nov. 18, 1806 and they had a son Albro Curtis b. Oct. 17, 1839 in Wyaming Co., NY who removed to Ionia Co. Mich and d. Aug. 3, 1861; Lydia who m. Nathaniel Frank, and Laura of whom no record. The last two daus. not in Peru, Mass. V.R.

Private records add a ninth child: Hannah who m. Rev. Edward Davis.

The reader will recall that Joseph Smith found the Mormon Bible near Palmyra, N.Y. I wonder if these Curtises from Peru, Mass. were aware of their relationship to him because more of his Curtis relatives came to the same locality. James (4) son of James (3) and Eleanor (Jafford) Curtis born probably in Maine, m. (int) Oct. 1, 1731 Sarah Bushwell and the descendants of three, at least, of their sons settled in this locality. Their son Daniel(5) Curtis b. 1735 m. Mary Goodale and removed to New Salem, Mass. and their son Daniel (6) b. 1764 m. Keziah Smith and settled in old Genesee Co. where he dl in 1838 and here their son Ebenezer(7) d. in 1816, and their son Daniel(7) d. in 1813. Their dau Keziah(7) m. Reuben Rice and had Nancy Rice who m. Enos Reynolds Ganson, another dau. Saloma(7) Curtis m. Seth Johnson. (see Oad Northwest Quarterly Vol. 12, p 83-84). I have a record of a Daniel Curtis who served in the War of 1812 and who was born in 1794 and who d. Dec. 13, 1865 at Wethersfield, N.YY. and who m. there Dec. 27, 1818 Elizabeth W. Charles; He was a private in Capt. Love's Co. of N.Y. militia. On one of the papers as a witness, relationship, not given, was Oliver P. Curtis. At one time he lived in Java, Wyoming Co., N Y. Has anyone any data? Daniel(5) had a brother Asa(6) Curtis b. 1744 who m. 1st Lois _____ and removed to New Salem, Mass. and had by Lois a son Asa(6) Curtis b. 1774. Asa(5) Curtis m. 2nd Elizabeth Day in 1777 and had Robert(6) b. 1780 and Lois(6) b. 1781. Asa (5) m.3d the widow Hannah Chase in 1786. Now at Gainesville, Genesee Co., N.Y. there died on Oct. 2, 1826 Asa Curtis leaving his son Asa Jr. and two children under 21. Lois and James. If this is Asa(6) possibly the Robert Curtis b. 1780-90 of the 1830 census of Palmyra, Wayne Co., is his half-brother. We need to find a living descendant of this Asa Curtis branch of the family. Daniel(5) and Asa(5) had a brother Moses(5) Curtis b. 1747 at Boxford who m. 1771 Mary b. July 20, 1746, dau. of Jeremiah(4) & Rebecca(Hawkins)Meacham. (N.Y. B&G Rev., Vol 65, p. 108). Moses d. 1815 and Mary in 1818 near Conneautville, Erie Co., Pa. Their son Jacob(6)Curtis who m 1st Lycy Atwater and 2nd Sophronia Lee, the Salt Lake City records say died Nov. 18, 1839 at Warsaw. N.W. On Nov. 16, 1938 the Boston Transcript in No. 3033 Part 2 Erie, Pa. Records, signed A.S.B.E. gave "Feb. 2, 1820 Mr. Jacob Curtis m. Miss Sophronia Lee by Rev. John Way, all of McKean Co., Pa." So we need help from some interested person in McKean Co., Pa. to supply more about Jacob(6). His brothers Jeremiah(6) and Nahum(6) who joined the Mormons went first to Pontiac. Mich. 'Jeremiah(6) m. 1st Aurelia Meacham and 2nd Ruth Stratton and Nahum(6) m. Millicent Waite. Jeremiah(6) died in Texas Sept. 27, 1845 and his

descendants went to the San Bernadino, Cal. valley in the 1860's. Nahum(6) d. in 1839 at Nauvoo, Ill. and his descendants went to Utah. The most important child of Moses(6) Curtis is omitted from the records at Salt Lake City and he is Elisha(6)Curtis b. 1776 who m. Resign Clark and removed to from Manchester, Vt. to Lorraine township, Jefferson Co., N.Y. before 1810 and there his famous son Dr. Harvey(7)Curtis was born who became President of Knox College at Galesburg, Ill. See N.E.H.&.G. Register Vo. 49. p 205 and Vol. 4 p 510 of Curry's History of Chicago. Elisha(7)Curtis removed from Jefferson Co., N.Y. first to Greigsville, formerly Kishaway, Allegany Co., N.Y. then to Flint, Mich. There is no doubt in my mind that the Nathaniel Curtis of Early Jefferson Co. was a relative of Elisha Curtis. This Nathaniel m. 1st _____ and had Plina and Lucy and he m. 2nd Chloe, dau of Sylvester and Rebecca(Rice) Finney and widow of _____ Chase and also removed to Flint, Mich. By Chloe he had Serepta Curtis b. Feb. 9. 1820 who m. Rev. Jonathan Copeland(see Copeland Genealogy); Martha; Chloe, Crandall; and Caroline, all Curtis. Besides the fact that Elisha, Nathaniel and Comfort Curtis Jr. all three removed to Flint, Mich. the given name Crandall which Nathaniel gave to his son is a still stronger link to tie these Curtises together as will appear in the next Curtis of the Zaccheus line to be considered now.

Jeseph Smith's ancestor, Rebecca(3) Curtis had a cousin Joseph(3) Curtis, brother of James (3) Curtis who m. Francis Jafford's dau. July 4, 1715 Patience Rockett or Rockwood of Wrentham. They removed to Norton, Mass. where their first child. Joseph(4) Curtis was born in 1716. They then removed to Hebron, Conn. They had a son Benjamin(4) Curtis who m. in 1745/6 to whom I do not their mother, died there in1723 and Joseph (3) seems to have m. a Susanna Chubb, their mother, died there inited and Joseph () seems to have m. a Susaina of the cossibly a widow but there is no record in my possession of any children by her and Mr. Davis's book does not mention her, but he says that Joseph (3) Curtis did marry July 6, 1728 Hannah Cooper of Oxford and had four children: John (4) Curtis b. Dec. 7, 1739; Thomas (4) Curtis b. Mar. 22, 1732; Mary (4) Curtis b. Oct. 2, 1734; and Patience (4) Curtis b. Jan. 5, 1736/7. In Book 9, p 145 of land records at Taunton, Mass., is a record that states that Benja= min Force and wife Elizabeth of Dorchester, tailor, for a valuable consideration paid by Joseph Curtis of the town of Boxford, Easex Co. sells a house and 67 acres and another pacre and various rights to common land in Norton, Dated Mar. 4, 1713. Witnesses: Samuel Ray, Joseph Chaplin and James Curtis. Also in Book 10 p. 148 Benjamin Bate and wife Mary of Dorchester, mason, sells Joseph Curtis of Norton 10 acres in Taunton Purchase on May 26, 1713. Book 9 p. 651 states that Joseph Curtis and wife Patience of Norton sell to Joshua Kent of Swansea 67 acres also 40 acres and 2 acre on Nov. 22, 1715. Why and when Joseph(3) Curtis removed to Hebron, Conn. is not known definitely but his step-mother Abigail, dau. of Robert Stiles and widow(in 1712) of Zaccheus(2) Curtis removed to Canterbury, Conn. and there married 2nd in 1723 Jonathan Hyde. (N.F.H.&.G. Reg. Vol 66, p 261). The 1790 Census at Stephentown, Rensslelaer Co., N.Y. has a James Curtis 1-3-2; a Joel Curtis 1-1-3; and his only son Joel Curtis 1-0-2; and Thomas Curtis 3-2-1; and his son Thomas Curtis. Jr. 1-1-2. These Curtises seem to be from Hebron, Conn. and connected with the children of Joseph(3) Curtis and their descendants also settled in Western New York and in Utah. Joel Curtis Jr. was in Capt. Isaac Bogart's Co. in Rev. War He said he was born in Hebron, Conn. May 4, 1764 and was a son of Joel Curtis. He m. Polly Andrews and resided in Colesville, Broome Co., NY and later in Greene, Chenango Co., N.Y. where he died March 29, 1847. (It was

very near here that Joseph Smith, the Mormon leader, was married. Joel Curtis Sr. died in Stephentown, N.Y. in 1810 andleft a widow Thankful and a dau. Thankful Bailey, a dau. Lydia Bailey, a dau. Rachel Griffin, and a dau Polly wife of Joel Winston, and a grandson Rensselaer Bailey. Witnesses to will: Claudius, Sally and Hosea Moffat, and the appraisers of his estate were Adin Swan and Benjamin Gardner. This Joel Curtis Sr. sold landin 1793 in Stephentown, to Thomas Gardner and witnesses were Hosea Moffat, George Gardner and Joel Curtis Jr. This Joel Curtis Sr. must have been born 1735-40 and is probably son of one of the sons of Joseph(3) Curtis of Hebron, probably by the first wife. There is a possibility that this Joel Curtis is Joel (4) son of Samuel(3) and Mary () Curtis(Caleb(2)Richard(1)Curtis emigrant to Salem, Mass. and Southold, L.I.) This Samuel(3)Curtis settled in Hebron, Conn. about 1703. His son Joel(4) was born there June 16, 1719. If we had the age at death of Joel Sr. who d. 1810 at Stephentewn, ithe matter could be settled. If he was the son of Samuel(3) then he was no relation to Thomas Sr. and Jr. of Stephentown in spite of the connection withthe Gardner family in land deals with Joel Curtis. Mr. Carl Curtis of Pasadena, Cal. who collected much data on the lineage of Richard Curtis of Salem, has given as a child of Richard(3) of Hebron, Conn. brother of Samuel(3) one John(4) Curtis b. Dec. 6, 1727. This birth date is suspiciously near Mr. Davis's birth date of John(4) son of Joseph(3) of the Zaccheus lineage, which Mr. Davis gives as Dec. 7. 1729. This man was in the Lexington Alarm and Seige of Boston 10th Co. Capt. Parsons, 4th Regt. Col Minman. Someone should check the Rev. War. data on him to

secure data on his parentage. Thomas Curtis Sr. enlisted in the Rev. War at exactly the same time and in the same Company. Capt. Isaac Bogart's...that Joel Curtis Jr. did, and at Stephentown. He said he was born in Westerly, R.I. in 1761. He does not give his wife's name. Record from Salt Lake City reveal that he was the first child of Thomas Curtis of Stonington, Conn. who m. in 1760 in Westerly, R.I. Bridgett Cramdall. I hope some one can find the records of Curtises at Stonington for it would seem likely that this Thomas is in reality that Thomas b. 1732 in Hebron, Conn son of Joseph (30 and Hannah (Cooper) Curtis. Of course he could be a son of Joseph(4) Curtis b. 1716 were it not for the fact that Mr. Davis's book says this Joseph didn't marry until 1743/6. He did name a son Joseph Curtis who was born in 1869 and he married Alsa ######(b. 1773)first child of 那世典有益品学出州也是并在出版 Justus and Alsa(Gardner)Brockway. Also Gardner was the dau. of Benjamin Gardner who appraised Joel Curtis's estate in 1810. Also Brockway's sister Lucy(b.1779) m. 1st Pardon Curtis who died in the summer of 1802 and she m. 2nd Stephen A. Mains. This Jeseph Curtis died in Montrose, Towa and he had by Alsa Brockway: 1. Joseph Jr.: Uriah b. May 5, 1805 who m. Ohebe day of Fielding and Anna(Dall)Martin from Virginia and Uriah joined the Mormons and his children were: Elsa Ann. Erastus b. 1828, Levi, Elisa Jane, Mary. Uriah Martin and Emeline. Joseph and Alsa's next child was Gardner Curtis who m. Maria Dunn and had Eli and Joseph Henry. Joseph and Alsa had three daus. Diadema, Polly and one with a name wondrous to behold--Lorumhinnia, at least that is what I have tried to make of it. Thomas Curtis Jr. b. July 19, 1788 was in the 1812 War. He m. at Stephentown Feb. 9, 1810 Judy Crandall she b. July 21, 1791, and he d. at Busti, Chautauqua Co., N.Y. May 22, 1868. He had a son David Henry Cuntis b. in 1819. To his 1812 war papers is attached an affidavit made Oct. 10, 1879 by Stephen L. Curtis and Constant Nash of Cherry Creek, Chautauqua Co., N.Y. that they were not present but knewof Thomas's marriage to Judy Crandall. Judy d. abt. 1880. The census of 1850 at Stocke ton, Chautauqua Co. shows clustered about Thomas and Judy Samuel and wife, Silvia, Crandall and wife, Charlotte, Chauncey and wife, Alice, Orrin and wife Sally, John E. and wife Polly Ann. and Jeremiah and wife Susan, probably all related. The Stephen L. Curtis of Cherry Creek and his brother Isaac

Curtis were born in Stephentown, sons of James (b. 1774) and Anna () Curtis and removed to Cherry Creek in 1834, Their brother James Curtis Jr. was in Leon, Chattaraugus Co. very close to Cherry Creek. This James Curtis married Joanna Palmer and had Erastus, Lorenzee /William and Helen. There was also a son of James and Anna Curtis named Jeremiah who had a son Orrin. (notice the Jeremiah and Orrin in the census of 1850 at Stockton above given). Steohen L. Curtis had a son John H. Curtis whose son Edgar W. Curtis, an attorney, resides at Cherry Creek. Isaac died in 1851 and two sons and three daus. were in Wisconsin in 1861. These descendants of James of Stephentown (b. 1774) appear to be of the same lineage as Thomas of Stephentown.

In another James Curtis of Machias, Chattaraugus Co., N.Y. we may have a descendant of that Ransom Curtis who m. in 1868 Ellice Whiton in Ashford, Ct. and may have been brother of Francis who m. Betty Robbins in same place the same year. This James Cuttis died in Machias in 1863 ae. 84 so born 1779/80. He came from Willington, Conn. to Marcellus, N.Y., them to Machias. His wife was Mary, dau of Zebediah and Priscilla (Morris) Marcy. (see N.E.H.&.G. Register Vol 29, p 306) and this Zebediah Marcy was born in Woodstock, Conn. This confirms the supposition that the Willington, Conn. Curtises came from the same area that other branches of the lineage of Zaccheus Curtis settled. Mary died in Machiad in 1878. James and Mary had four children: Zebediah Custis who m. Lovice Hall and d. 1840. Nancy Maude Curtis who m. Erastus Mayo and d. 1849 and had seven children. William T. Curtis who m. 1st Charlotte Williams and 2nd her sister, Angeline Williams. Origin D. Curtis b. June 27. 1818 who m. Lucy Mayo and had eight children among whom were Mary, Julia, Dorlantha, Jonathan Vantine, whose wife was Adaline, Henry, Edwin & George. Origin Curtis, called Orra, removed to Edna, Polk Co., Minn. His brother William T. resided in East Aurora, N.Y. where he d. Aug. 20, 1888 leaving his brother Orra, and a nephew Rufus Mayo of Polk Co., Minn. and a nephew William Mayo of Springville, Erie Co., N.Y. and James Mayo his brother of the same place, and a niece Minerva Mayo and her sister Cornelia Mayo of Springville, and their sister Louise Cox of Springville, and William T. also left a niece Adele Horton of Bay City, Mich. These Mayos may be related to the famous physicians of the Rochester, Minn. clinic, I do not know how.

A record of another Comfort Curtis seems to be connected with Willing-There was a cabinet maker in Hoosick Falls named Comfort Curtis who m. Rachel, dau of Phineas and Rebecca(Mosher)Chase. Phineas came from Quality Hill. Dutchess Co., N.Y. (See N.E.H.&G. Register Vol. 87, p336). Comfort died in Cambridge, Washington Co., N.Y. in 1817. In this same locality near White Creek came the family of Ephraim Curtis b. 1742 who m. Rachel Bishop and had these children in Panton, Vt.: Frederick(whose day. Sarah md Daniel Belden, he b. 1793 and lived in Brockport, N.Y.)John Bishop (b. 1772 who m. Charity Woodworth), James Martial, Martha, Zenas Alanson, Joseph Seymour, Elizabeth D., Timothy Bradford, Rachel, Chas. Clinton. Descendants say this Ephraim was b. in Litchfield Co., Conn. and was son of Matthew(4) Curtis(Josiah(3)William(2)Widow Elizabeth(1)Curtis of Strarford, Conn.) Matthew's children are of record and there is hardly room for this Ephraim. Records at Littleton, N.H. show an Ephraim Curtis connected with a Josiah Kilbourne and we know that Ephraim(2)Custis son of Zaccheus(1) married Elizabeth, dau. of George and Elizabeth ()Kilbourne. What became of their son Ephraim(3) after he married Lydia Farley of Woburn Jan. 13, 1742 Mr. Davis doesn't state but here is an Ephraim b. 1742 whose family lived next to Curtises of the Zaccheus lineage. Comfort Curtis Sr. had sons born in this order: Comfort Jr., Stephen b. June 14, 1777, David, Solomon; and daus. Rachel wife of Timothy Mosher, Sally, wifeof Alexander Whitney, Olive wife of David Doane, and Anna wife of Alexander Annis. We have a record of Stephen only which I put in the Boston Transcript not long ago. He lived in Springfield, Otsego Co., N.Y. and his sons settled in southern Mich. after a short sojourn in Cayuga Co., N.Y. Stephen m. two Sawin sisters who came from Willington, Conn. (See Slafter Memorial p.11) Their aunt Anna Sawin b. 1756 m. Davis

son of Edy Hatch of Tolland, Conn. The N.E.H.&.G. Register Vol 59 p 21 has a Rev. Sol. William Curtis of Tolland Co., Conn. served as a private against Burgoyne in 1777 under Capt. Thomas Lawson of Union, Conn. Col. Cook's Regt. Data on this man is needed because Willington, Conn. has a record of a William Curtis b. 1774 d. there 1860 m. Mary Holt and hadchildren: Sanford, William, Horace, Sarah H., Alford, Wilson W., Harvey, Oliver H. and Selden. Oliver H. m. Emily Hills and resided in Amherst, Mass. and had sons Frank O. of Amherst and Samule H. of Hartford, Conn. Selden resided in Hew London, Conn. Willington also had births of three children of a Joseph and Rhoda(Curtis and they named their first child Ransom Curtis b. 1792 who m. Mary Venn who died in 1836 in Painesville, Ohio where his father resided with his 2nd wife Joanna whom he probably married in Canada. His first wife, Rhoda, was dismissed from the Willington church to the church at Cambridge, Washington Co., N.Y. in 1803 where Comfort Curtis resided. This Comfort Sr. and his son Comfort Jr. also went to Canada and resided near Coburgh, Ont. Joseph and Rhoda's 2nd child Joseph b. 1795 m. Lovina and had Emily and Emeline, twins b. in 1832 and named after their father's sisters b. in 1817, also twins; and a son Joseph, and a dau. Laura. Joseph and Rhoda's next child Herace b. 1797 m. Harriet Turner on Oct. 13, 1823 in Albany. N.Y. He d. Nov. 1, 1839 in Mentor, Ohio near Painesville. He was drafted for the 1812 War at Schuyler, N.Y. His son Zerah H. m. 1849 Betsey Ann Sweet, hes dau. Mary m. 1850 Alonzo Grover; his dau. Harriet m. 1856 Philip Dodge; his dau. Amanda Malvina m. 1857 Chas. Cady. Joseph and Joanna's son Orlando b. 1812 propably in Lee, Oneida Co., N.Y. m. Martha and had Emeline and Louisa. Joseph and Joanna had a son Ira b. 1822 who m. Lavina dau. of Nathan Phillips Goodell and his wife Hannah Mead Griswold, and they resided in Lodi, Ill. where Ira's brother Erastus b. 1836, last child of Joseph Curtis lived, and Erastus's son Byron lived in Loda now(1940). Joseph Curtis, the father was b. Dec. 7, 1771 and d. Dec. 3, 1852 at Painesville, O. It would seem likely from the migrations that this Joseph was related to Comfort Curtis. Comfort Jr. married a widow of Barnebas McCowan who was born Wilson and whose mother was a dau. of Everadus and Anneke Jans Bogardus and they lived in Canada, and at Butler, NY and in Onondaga Co. NY. near Spafford in the 1830 census close to James and Mary (Marcy) Curtis who came from Willington, Conn. as described above. What became of Comfort Jr's. brothers David and Solomon I do not know unless the Chency Genealogy in its reference on p 80 to Lucy(6) Chency b. May 7, 1761 dau. of Daniel(5) and Zerviah(Paine) Chency of Pomfret, Conn. until close of Rev. War then of Pittstown, Rensselaer Co.(near Hoosick Falls)then of Ellery, Chautauqua Co. married one of them. She m 1st a Mr. Cummings and had David. Benjamin and Polly Cummings and them she m. 2nd a Mr. Curtis and resided near Coburgh, Ont. Can. and had Comfort, John. Thomas, and Hiram all Curtis(spelled Cutrice in this book, but I attach no significance to this spelling) Lucy's sister Rebecca b. Killingly, Conn. Aug. 14, 1775 m. Nahum Aldrich and died at Busti, Chautauqua Co., NY where Thomas Curtis from Stephentown and Westerly, R.I. lived. As we do not have his wife's name in his Rev. War record, perhaps this is he. It is possible, as a marriage in 1779 would permit a child David Cummings in 1780, Benjamin Cummings in 1783, Polly Cummings in 1784 MMd there is room for Comfort and John Curtice before the known birth date of Thomas Jr. July 19, 1788, who m. Judy Crandall. I suspect therefore that Comfort Curtice Sr. is another son of Thomas and Bridget(Crandall) Curtis of Westerly, R.I., however the records at Ottawa show Comfort Sr. and Jr. praying for land in 1792 but the name of Thomas Curtis does not appear. Nevertheless the above Cheney record cannot be of Comfort Jr. as he was b. about 1775 and was the first child of Comfort Sr. Solomon, son of Comfort Sr. may be that Solomon Curtis on p 188 of the Bill Genealogy who m. Persis Bill of Hebron, Conn. and resided in Milford, Stsego Co. in 1806 but removed to Swanton, Franklin Co., Va. after 1812 where he must have died soon, as Persis, his widow, b. in 1777, m 2nd Isaac Edson and had three more children and died in 1822. If this is that Solomon he was living near has brother Stephen in Stsego Co. His children by Persis Bill were Van Rensselaer Curtis, Solomon Curtis Jr. and Isaac Curtis. The surrogate's office of Genesee Co. has a record of a David Curtis of the town of Castile(south part of Wyoming Co.) who was killed May 6, 1830 by being thrown from his wagon while on a visit to Bethany leaving a window Polly who states she had lived with him over 14 years, and 4 children: Antoinette, wife of Norman G. Hurd, LeRoy Curtis, Van Rensselaer Curtis and Polly Curtis. Who

The fact that Francis(4) and Sarah(Ransom)Curtis's first child was William and that there was a family of Curtises in Willington, Conn. which included a William and a Joseph who named his first child Ransom would lead one to think that perhaps the parents of these Curtises may have been Ransom and Ellice(Whiton)Curtis who were married in 1768 in Ashford, Conn. in the same place and year that Francis Curtis m. Betty Robbins. The Root Genealogy p 164 speaks of a Selden Curtis of Marlboro, Conn. who m. Maria, dau of Jonah and Sally(Root)Root she b. 1802. Marlboro has 4 children of a Joseph Curtis: Frances b. 1798, Eliza b. 1800 and Charles Cotesworth Pinckney Curtis b. 1802. Perhaps a Selden was their brothef at any rate this Joseph Curtis may be of the same family as the other record of Deoldatus(4) and Elizabeth(Selden) Curtis shows no son William or Joseph and neither givenname occurs in the lineage of Deodatus(1) Curtis of Braintree, Mass. There may have been another Selden Curtis alliance in Tolland Co., Conn. We sadly need some good angel in Conn. to help us clear up this obscure line of Zaccheus(1)Curtis.
