Marriage Record Book of Frank Pendleton DeBolt, Ph.D.

Transcribed by Barbara Savalick

The following records were handwritten in a small record book by Frank P. DeBOLT, a Presbyterian minister. The 154-page book includes a record of the DeBolt family; a record of marriages he performed from 1914–1934; a loose, half-sheet of personalized stationery with part of a marriage ceremony typed on the back; and a loose sheet with a photo of the Presbyterian Theological Seminary in Louisville, Ky.

The marriages included herein span the state of Missouri and Crawford County, Kansas. Missouri counties mentioned include Sullivan, Stoddard, Jasper, Nodaway, Perry, Mississippi, Pemiscot, New Madrid, Scott, St. Francois, and Cape Girardeau.

These records were transcribed exactly as written; however, surnames have been capitalized on first appearance. Only one marriage was recorded on each page, and they are, for the most part, in chronological order beginning with 1914. As he added entries through the years, Dr. DeBolt recorded the marriages on the odd numbered pages. Twenty years later, when he reached the end of the book, he continued back at the beginning of the book, using the even numbered pages. This is why two marriages from 1934 are interspersed with 1914 marriages at the beginning of this transcription.

As of the publication of this article, the book has been donated to the Missouri Historical Society.

"What token do you give in pledge that you will faithfully preform [sic] these vows?"

(He shall present the ring, holding it in his hand)

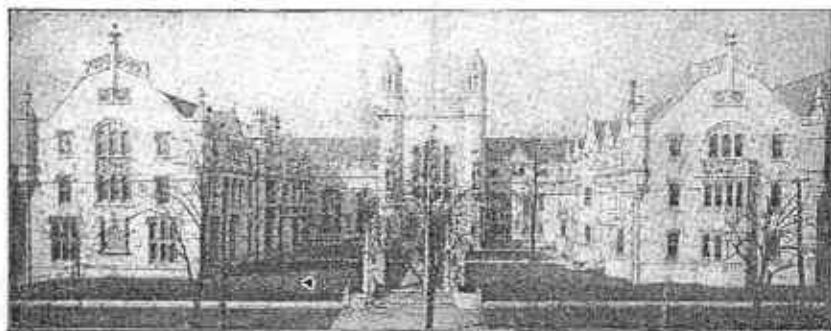
"Do you receive this ring in pledge of the same on your part?"

(She shall take the ring and pass it to the Minister—)

"The ring is the emblem of love. It was so used in a Parable of our Lords; and has ever since been retained in human family as the symbol of affection. May this ring henceforth [sic] be the chase and changeless symbol of your ever-more pure and changeless love."

(The Minister then passes the ring to him, & he places it on the 3rd finger of her left hand.

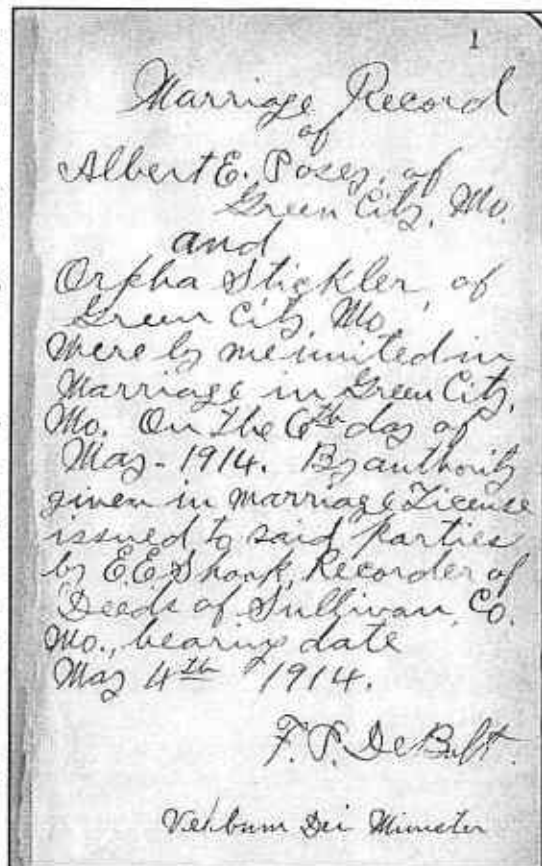
