

Portraits of a Family The Denisons of Stonington, Connecticut

After spending hours viewing the works of the masters at the National Gallery of Art in Washington, DC, on a blustery October day, my brother and I found ourselves in the basement looking into the faces of eighteenth century relatives Capt. Elisha and Elizabeth (Noyes) Denison of Stonington, Connecticut. This discovery led me on a quest to find out more about this family whose ancestry reads like a who's who list of colonial New England.

Capt. Elisha was a great grandson of George Denison and his wife Mercy Gorham, who was a granddaughter of John Howland of the *Mayflower*.¹ Since much has been written about the Gorhams this article will focus on the Denisons. George Denison, who married Mercy Gorham, was the son of Capt. George Denison and his wife Ann Borodell who was known affectionately as "Lady Ann."² Capt. George and Lady Ann were some of the earliest inhabitants of Stonington, Connecticut, settling there in 1654 shortly after George returned from service in Cromwell's army during the English Civil War. He became one of the most prominent men in Stonington and was second in command of the Connecticut Army in King Philip's War, under Maj. Robert Treat³ and was continually elected to the Connecticut General Court in Hartford where he died in 1694. His son's marriage to Mercy Gorham, also the daughter of a militia Captain in King Philip's War, brought the earliest *Mayflower* line that I could find into Stonington.

In researching the ancestry of Capt. Elisha Denison, his wife and his relatives, I discovered several interesting facts. First, Capt. Elisha and his wife Elizabeth were first cousins. Capt. Elisha's mother Rebecca (Noyes) Denison and Elizabeth's father James Noves were both children of Capt. Thomas and Elizabeth (Sanford) Noyes, grandchildren of Gov. Peleg Sanford of R.I., and great grandchildren of Gov. John Sanford of R.I. and the noted Gov. William Coddington one of the founders of Rhode Island. Gov. John Sanford's wife was Bridget Hutchinson, daughter of the famed religious dissenters William and Anne (Marbury) Hutchinson who were banished from Massachusetts Bay. Bridget was named for her maternal grandmother Bridget, who was the sister of Sir Erasmus Dryden and the great Aunt of the poet John Dryden. The author Thomas W. Bicknell wrote of Gov. Peleg Sanford that, "he was well born and well married,"5 a quote that could be applied to the Denisons as well. To make matters more interesting, although not a Mayflower descendant, Elizabeth (Noyes) Denison was also a descendant of Capt. George Denison through her mother Grace (Billings) Noyes.⁶ Secondly, as near as can be ascertained from researching the probate records of the 74 grandchildren of Capt. John Gorham and Desire Howland the eight Denison grandchildren and their spouses were perhaps the wealthiest. Seven of these children left probate records that show an





amazing degree of wealth totaling over 25,862 pounds, which included not just land and buildings but such items as furniture, silver, and 1 lb. of gold.⁷

It is from this background that the subjects of the Denison portraits entered into the period after the Revolution when portrait painting flourished in Connecticut. After years of stalled business activity, the end of the Revolution brought prosperity and by the 1790s new wealth flowed into the young country. This wealth expanded the middle class and enriched the upper class who in turn patronized a growing number of trained and untrained portrait painters. The Denisons were obviously caught up in this trend as not only do the portraits of Capt. Elisha and Elizabeth survive, but so do those of their four children and three other relatives of the Denisons; Ephriam Williams and his wife Hepsibeth (Phelps) Williams whose mother was Hannah Denison,8 and Thomas Noyes who was the brother of Elizabeth (Noyes) Denison. These portraits give us a first hand glance at how a prosperous family of Mayflower descent would have appeared circa 1790. Although the identity of the artist, also known as the "Denison Limner," has been debated for many years they are generally attributed to Joseph Steward a Dartmouth educated minister who turned museum owner and painter due to his poor health, and who lived from 1753 to 1822.9 However, "it has been suggested that the painter of the Denison group might be Capt. Elisha Denison himself, since the portrait of his son shows the boy holding a card which prominently displays his father's name."9

In any case these portraits are important because the artist was not only able to capture the Denisons' physical appearance but some of their surroundings and personality traits as well. In an age when painters were more intent on making their subjects look good than capturing their true likenesses, these portraits seem amazingly frank and intimate. Capt. Elisha and his wife clearly have different noses, eyes and facial expressions. What similarities there are between the two can easily be explained by the fact that they were genetically closer than first cousins and therefore must have shared some family characteristics. Mary Black and Jean Lipman in their book, American Folk Painting state, "The characters of Capt. Elisha Denison and his wife, Elizabeth Noyes Denison, are as sharply etched as the details of their prosperous lives that fill the backgrounds. Their four children, ... are beautifully costumed and set in an attractive array of Connecticut interiors and exteriors that almost provide an inventory of Denison holdings." 10

Capt. Elisha Denison was painted at his writing desk in front of an open window through which can be seen a yard which slopes down to a stone fence and what appears to be the ocean. This probably represents his home in Stonington. His elegant wife was also painted seated at a desk in front of an open window hung with a rich, fringed drapery. She appears to be looking directly at the observer with an almost stern expression which probably reveals a strong personality, perhaps a trait inherited from her great great great grandmother, Anne (Marbury) Hutchinson. Through her window an elaborate bridge can be seen

crossing a small river with sloping lawns and houses along it. "This background was probably chosen to give the sitter aristocratic status by evoking an eighteenth century European estate." It is also romantic to think that the almost unnoticeable gentleman and lady walking arm and arm together in the backgrounds of both portraits may be the Capt. and his lady out for a stroll without the children! The *Denison Genealogy* and *The History of Stonington* suggest that Elisha may have earned his title through involvement in the Revolutionary War by commanding a Cornet of Horses for the eighth regiment in 1775, and collecting money for the families of officers and soldiers of the Continental army. His name also appears quite frequently in the land records of Stonington, which suggests that he may have made some of his fortune in land deals. 12

The Denisons, eldest daughter Elizabeth was painted seated in a Chippendale chair, identical to the one in her parents and sisters portraits, in front of a dressing table. Her hair is decorated with a plumed headdress and with flowers that were most likely made of linen, the creation of which was described in at least one late eighteenth century record.¹³ Although the portrait that is now believed to be Matilda, the Denisons' second child, was originally identified as Phebe, the Denisons' youngest child, genealogical records and the apparent age of the sitters indicated that it may be Matilda. However, the question remains, as the family that inherited the painting now thought to be of Phebe are descendants of Matilda. Perhaps in this case looks are deceiving. Matilda is seated and wearing an immense plumed hat. Most interestingly she was painted with her pets, a bird and a squirrel who seems preoccupied with eating a nut. However, on closer examination it can be seen that it is a long eared squirrel which was native to Europe, not America. "It is likely that this animal was copied from an eighteenth century emblem book. One such volume describes the meaning of such a symbol: "A Squirrel taking the Meat out of a Chestnut, Not without Trouble. An Emblem that Nothing that's worth having can be obtained without Trouble and Difficulty."14 Perhaps Matilda needed to be reminded of the virtues of patience.

Capt. Elisha's namesake and only son would have been about thirteen when he was painted. He is standing in what appears to be a masonry archway through which can be seen rolling green hills and part of a house. He is dressed hand-somely in a long coat and ruffled shirt. Perhaps the most interesting and unusual part of this painting is that Elisha Jr.'s right hand is extended toward the viewer and in it he holds a card for all to see which reads simply, "Capt Elisha Denison, Stonington" which helped solve the problem of identification so common in old portraits. It also suggests the importance that some day he would be the next "Capt. Elisha" and head of the family. Sadly, Elisha Jr. died at the age of 24 and his portrait descended in the family of his sister Matilda. The final Denison portrait is probably that of Phebe. Phebe's portrait is also the simplest of the six. She was painted standing in front of what appears to be pastureland in a silk dress adorned with a large bow on the side and in her right hand she holds

a branch from a rose bush which probably represents the bloom of youth.¹⁵

Although Elisha Jr. died without descendants all three of his sisters married and between them had 29 children of which only three died young. So Capt. Elisha and Elizabeth Denison who lived to 1841 and 1831 respectively, and who had only four children of their own, lived long enough to be the proud grandparents of 27 children. This suggests that there are hundreds of people eligible for *Mayflower* membership through these families.

Together these six portraits present to us six citizens of a newly independent nation that they and their *Mayflower* ancestors fought for and struggled to create. The Denisons are representative of our colonial ancestors who by the time these portraits were painted in the 1790s had been settled here for 170 years. These people laid the foundation for all the freedoms that we enjoy today and I think that they would be pleased to now be greeting visitors to the United States, from all over the world, from their spot on the wall at the National Gallery of Art.

So often those of us researching our *Mayflower* ancestry spend so many hours compiling the information necessary to prove our ancestry that our ancestors become just another name on the family tree, a figment of our imagination. Putting faces to our ancestors allows us to realize that the people we are researching were once just as alive as we are today. I would encourage anyone interested in making this connection to contact the local and state historical societies in the areas where their ancestors lived to see what collections they have that are not necessarily genealogical. Some societies like the Connecticut Historical Society have large collections of paintings and other items donated by various people. Even smaller societies like the Stonington Historical Society have virtual treasure troves of portraits of early residents and notables. Also, museums with large collections of American portraiture usually have catalogs available which describe their holdings.

1. Capt. Elisha Denison (John, Edward, Mercy Gorham, Desire Howland, John) was baptized Nov. 3, 1751 in Stonington, CT., the son of Capt. John and Rebecca (Noyes) Denison¹⁶, a merchant in Stonington and an officer in the French and Indian War. Capt. Elisha married his first cousin Elizabeth Noyes in Stonington on Apr. 26, 1772. She was born Nov. 4, 1750, the daughter of James and Grace (Billings) Noyes. Capt. Elisha probably died in 1841 at Stonington the year his will was recorded, and his wife Elizabeth died on May 13, 1831.¹⁷

George's bro. Gen Danl Denison wrote in 1672 My two brothers, Edward and George had all the Estate of my father left between them, being both marryed long before my father's death; my brother George buried his first Wife in the year 1643, went into England was a souldier ther above a year, was at the Battle of York, or Marston Moor, where he did good service, was afterward taken Prisoner but got free and having married a second Wife he returned to England the year before our Mother died, and not long afterward removed himself to New Ldon near whereunto (viz) at Stonington he now liveth, having 3 sons John, William, and George, 4 or 5 daughters...3 of Daughters are Farryed to Stanton, Palmer and Cheese brook (sic) all living at present in the same town.

The tradition tht George served bn Cromwell's army is thus verified. The story is also told that he was wounded and was nursed at the home of John Borodell, a cordwainner (leather merchant) of Cork, by his dau Ann whom he married for his second wife. He served as Deputy to the Conn Gen Court from New London Sept 1653, May 1654, Oct 1683, May, July and Oct 1684, May and Oct 1685, May 1686, May 1687, Sept 1689, May Sept and Oct 1693, and May 1694. When 1st mentioned in Conn Col Reeds he is called "Captain", based upon his service and commission in England. He served on the War Comm for New London in 1653 when war threatened with Dutch. Although 56 he served as Capt in King Philip's War 1676 in command of New London County troops and second in command of the Conn Army under Maj Robert Treat. He was apptd Provost Marshal May 1677. He was Capt. of volunteer troops against the enemy Sept 1689. Children 1st marriage: b Roxbury:

William came to America on the Lion with his wife and 3 youngest sons; dettled in Roxbury, Mass 1631. John Eliot, Pastor of the First Church of Roxbury and Apostle to the Indians was a tutor of George, his youngst son. Eliot had arrived on the same ship. William was a merchant and must have been a man of means and good education. He was deacon in the First Church of Roxbury, and had a large influence in the Colony. One record states his wife did not unite with the church until some years later. William Denison built a house in Roxbury, Mass; was still standing in 1882. William d. Jan 25 1653; wife d Feb 3 1645; both buried in Old Eliot St. Cemetery at Rox wary. Their children:
