Wilson W. Edmondson, son of William Edmondson, born 1812 in Washington County, Kentucky, married first Pamelia Marshall in 1830, and second to Mary Felder/Murry in 1838 at Marion County, Kentucky. He resided in Marion County until his death in 1862. Children were: Wilson, Elizabeth who married a Mr. Bland, Cynthia, Alice married first to Tullington Ragsdale and second Patrick Daugherty, Joseph, John, Foster born in 1853, and Caroline. All removed to Illinois after the Civil War. Need information on the family in Kentucky and connection to family in Virginia. Sister of Wilson W. Edmondson was Sarah A. born about 1810, married to Green B. Fleece in 1826, and she died about 1842. William Edmondson of Washington County, Kentucky inherited an estate from General Edward Stevens of Culpeper County, VA. I believe William is possibly the son of Joseph Edmondson who died in Washington County, KY with an estate in 1811. Joseph was the son of Mr. Edmondson and Patty Stevens. Patty Stevens was the sister of Gen. Edward Stevens.

Diane is the daughter of Kathryn Helen Dorothy Edmondson and they resided at Harris County, Texas. Her grandfather was Foster Herman Edmondson. Gr grandfather Foster Roy Edmondson, and gr gr grandfather Wilson Edmondson and wife #2 Mary Murry/Felder who resided at Marion County Kentucky and then Adams County, Illinois.



James Edmundson, inducted in North Carolina, private first class, served in the 399<sup>th</sup> Port Battalion, died on April 25, 1943 in North Africa, and buried there.

William T. Edmundson, inducted from Iowa, Aviation radioman third class, United States Navy, died December 13, 1942 at Honolulu, Hawaii, missing in action.

I wanted to share the genealogical information I found using military, medical and pension Civil War Records for three Edmondsons. They were brothers and their parents were John Edmondson and Nancy Farley.

Charles S. Edmondson, served as a private in Company K, 30th Iowa Infantry Regiment. He was 31 years old at his enlistment (16 August 1862) and born in White County Illinois. He died 9 April 1863 of disease at Millikins Bend, Louisiana. He had married Sarah E. Conger 5 August 1858 in Richmond, Washington Co., Iowa. She was age 24 (18 May 1863) when she applied for the pension. Their children were identified as Mary E. Edmondson born 26 June 1859, Emily M. Edmondson born 11 June 1861, and Nancy E. Edmondson born 17 July 1863.

Isaac S. Edmondson, served as a private in Company K, 30th Iowa Infantry Regiment. He was born 16 September 1837 in White county, Illinois. He died 3 July 1908 in Kalona, Washington County, Iowa. He married Rebecca A. Adams 3 November 1859. She died 25 October 1910. They had two children living 6 July 1898. One born 1861 and one born 1866.

William W. Edmondson, served as a private in Company H, 7th Iowa Infantry Regiment. He was 21 years old at his enlistment 15 July 1861 and was born in Lee (?), Iowa. He was killed at the battle of Corinth, Mississippi 3 October 1863.

There is an elder brother, John W. Edmondson, that may have served during the War as well, but I have been unable to locate any information in military records about him. He was reported to be in California by 1870 and never returned to Iowa.

Hope this helps another researcher. If you know anything about John, I would appreciate an e-mail. I would dearly love to know more about his life in California.

Dear Orvan, Paul Brown recently shared with me the list of EFA members descended from David Turk Edmiston which you had sent him. I was, and am, appalled at what I read.

- 1. The records of David call him Edmiston quite consistently; his descendants used other spellings, but so did many descendants of the other 18th century Edmistons, including my own people.
- 2. 28 May 1751 is not the death date for David, but the date on which his executors posted bond.
- 3. Isabella MAY have been a Buchanan, but Buchanan is only a guess, and based on nothing in the way of evidence -- nothing whatsoever, except later ties with Buchanans by OTHER Edmiston families.. In no way should the name of Buchanan be stated as a fact. Actually, there is an extreme dearth of contacts between the David Turk family and the many Buchanans of old Augusta Co.
- 4. I don't know why you put Rachel first for the children of David, but I know of no evidence for it. However, that's a very minor thing.
- 5. There is no John named John Turk, and "Turk" should never be stated as a middle name, either for John or for David, for that matter.
- 6. I am very doubtful about the 1711 birth date for John and will look up the EFAB cited when I have time. I am even more doubtful about Dublin, since at that time, Protestants would have been about as welcome there as they are now. Also, is Dublin in County Cork?
- 7. John cannot be the eldest son: James inherited the land, and must be the eldest because the law of primogeniture was still in effect at that time. James' land was NOT in the Borden Grant, but somewhat south of same. In actual fact, we have next to nothing in data on David's son John. He probably is the John who turns up in SC in the 1760's, holding land near Moses and David II's widow Jane. I thought I had convinced you that John of Augusta (d. 1771) in no way could be the son of David Turk. He's too old, for one thing; he and his family have nothing to do with the David family, as far as the records go; he apparently was closely related to his next door neighbor, Robert Edmiston, probably his brother; he named his eldest son William, and per the Scotch-Irish naming pattern, that means John's father was a William (Robert also named his eldest son William,

buttressing the idea that Robert and John were brothers). What does it take to convince you that you have Augusta John in the wrong place??

8. Adding Matthew to the list of children is an error of major proportions. Not only is there no evidence whatsoever of such a relationship, the family tradition for Matthew is that his

father was a James, and that is supported, for what it's worth, by the fact that his eldest son is named James. The Matthew family may have lived not too far from David, and may even have attended the same church, but there is no evidence AT ALL that they did anything together.

- 9. I do not know why you list TWO sons named David. One is more than enough. The death record implies 1765 for the date, and NC for the place. Both questionable.
- 10. There is no Moses Edmiston/Edmondson with a middle name Thompson. I don't know who started that, but the records are clear, and at the time he lived, middle names were rare anyway. The son of David Turk seems to have left the area c.1763, and there is no mention of a Moses in the records until 1778, when the Moses who d. 1806 turns up in Washington Co. VA. However, there is a Moses in SC by 1764 or so, who is more probably the son of David Turk. What became of him is not clear, but there are references there to a Moses AFTER 1778. However, it is, at least, possible that Moses of SC came back to VA in 1778. BUT THERE IS ZERO EVIDENCE TO SUPPORT THAT THEORY.
- 11. Finally, to identify David's son William with Capt. William is such a staggering leap of fantasy that I don't know what to say about it. We do not know the parentage of Capt. William, but I'd drop dead of surprise if he turned out to be David's son. And Capt. William is NOT the same as William of Rockbridge -- unless the Captain's ghost came back from King's Mountain to die in Rockbridge Co. three years later. Actually, William of Rockbridge could be the son of David Turk maybe; so could the William (if that was his name) who is the progenitor of the Blount Co. TN Edmondsons. There is also a William who turns up in SC at the same time as David II's widow Jane, and a John Edmiston. In short, your account of the family of David Turk is grievously in error in a number of places, and you should not be propagating those errors by sending them out.
- 12. You sent Paul the names of 20 people who allegedly were descendants of David Turk. Actually, only TWO are clearly descended from David -- Paul himself, and Mrs. Long. 9 of the 20 have an outside, very outside, chance of being descended from David Turk because they are descended from Moses of Washington Co. (see #10 supra). 8 of the 20 in no way are descended from David, since their descent is stated as through John Turk, by whom they mean John of Augusta. As stated above, NO WAY is John of Augusta the son of David Some of the 8 actually are not descended even from John of Augusta, since they are using the line claimed by Linda Strahan, which actually takes them back to William of Rockbridge, not to Col. William and his father John. If by some chance William of Rockbridge turns out to be the son of David Turk, then they are in the right place-but you will never convince them of it.

Redmond S. Cole and S. Cameron Edmiston both refer to this David as David "Turk" Edmiston, without giving any reasons for it. There is a Turk family early in Augusta Co., and in the Beverly Manor area, but no records show any connection to this David. No middle initial, much less a middle name, appears in any of the records for David.

The first discovered mention of David is:

\*D-1-4: Rachel Edmiston \*D-1-5: Moses Edmiston \*D-1-6: David Edmiston II

Orange Co. VA, OB III, 208. 24 July 1740. Before Justices Robert Slaughter, James Pollard, Henry Field, Samuel Ball, Morgan Morgan and John Lewis, David Edmiston appeared and made oath that he imported himself, Isabell, James<sup>1</sup>, John, William, Rachel, David & Moses Edmiston, and Jessie Golesby [Gillespie?] and James Daley of Ireland to Philadelphia and from there to this colony.

Although it is not entirely clear, the implication is that David himself came from Ireland to Philadelphia, and no evidence has been found in PA records of his being there earlier, or even of his stopping off there, if he did. Descendants of David II refer to him as an immigrant.

As for the other Edmistons with him, there is clear evidence proving that Isabella was his wife and James his eldest son. The others are presumed to be additional children, and insofar as data on them has turned up, they are of the right generation to fit here. However, there is no proof that they were David's children. Probably most of them, perhaps all, were children in 1740.

David, at the same time that he proved his importation, received land, presumably at a special rate for importing the others. The land's location is shown on J.R. Hildebrand's map of the Beverly Manor Tract (1954), not far from the site of Tinkling Spring Church, of which David was a founder in 1740. His land was about 9 1/2 miles from the church. Paul Edmondson Brown writes: "Members living near his home would meet in one of the homes. Later a branch building was built either on or adjoining Davi'd home. Later this branch became a separate church known as Hermitage Presbyterian Church."

14 Aug. 1741, David was one of those to sign the commission establishing the Tinkling Spring

10 Dec. 1745. William Right appointed Constable in place of David Edmondson in Samuel Hay's Company<sup>4</sup>

19 Feb. 1745/6. Claim of David Edmondson, with David's oath "the men mentioned in his list were pressed by him and served the time mentioned." This is further described:

In 1742 a party of northern Indians on their way south failed to procure a pass from the authorities of Virginia. They came into Borden's Settlement where they were entertained for a day by Capt. John McDowell. They were given whiskey. Moving down South Branch of North River they disturbed the whites by foraging, shotting horses, etc. On complaint of the people Capt. McDowell was directed to call out his company and conduct the Indians beyond the settlements. They were taken to John Peter Salling's, then the most southern habitation. Some of the whites were on horse and all passed a lame Indian behind except one, who shot at him. This brought a fight in which Capt. McDowell and seven of his men were killed. The Indians lost seventeen.

The men who claimed losses by the Indians were Richard Woods, John Mathews, Henry Kirkham, William Henderson, David Edmondson, Benj. Borden and Magdalen, admx. of John McDowell, Francis McCown, John Buchanan and others patrolling, Joseph Lapsley, Mary Doughert, Andrew Myrtin, Isaac Anderson, Joseph Coulton, John Walker, Dominick Berrall, John Wilson and others patrolling, James Walker, Thomas Black and others patrolling--all pressed into service by David Edmondson.

There are scattered further references to David in Chalkley:

20 Feb. 1745/6. Moses Thomson, late of Augusta Co., to James Edmiston, £ 13.17, current money of Virginia, 100 acres patented 20 Aug. 1745 to Moses, east side of South River, Shanandoe, on the Red Banks. Wits: David Edmiston. Rec. 15 Apr. 1746 by Edmiston and others. (III, 254)

13 May 1746. William Wright apptd. constable in place of David Edmiston (I, 18)

3 Sept. 1747 (Augusta Co. Vestry Book). David Edmondson and Thomas Stevenson appointed processioners from Alex Blair's to Capt. Samuel Hay's. (II, 433)

7 March 1747/8. Stevenson and David Edmiston processioned. Also 12 March. (II, 435)

1747. Reference in deed to David's land (III, 265).

17 Aug. 1748. David Edmiston apptd. overseer of road from Tinkling Spring to Stuart and Christian's Road (I, 36).

19 Oct. 1748. A church to be built near David Edmondson's. (I, 37)

DB 11, 421, 23 Sept. 1749. William Beverly to Samuel McCune, 176 acres, line of David Edmondson.

DB 11, 774, 24 May 1750. Deed to Moses Whiteside mentions corner to David Edmiston.

Therefore, from 1740 until his death, David presumably lived on his 350 acres near Tinklin Spring Church. He may have started to get other land, since apparently another tract was surveyed for him, but without title given to him before his death:

21 Aug. 1754. My notes say that there is a reference in a deed to a corner of David Edmiston dee'd. Another note says that the deed in question is one from Beverly to James Edmiston, 200 acres on Elk Run in Beverly Manor, corner to tract surveyed for David Edmiston dee'd. (III, 326)

1765. A reference to a tract of 200 acres formerly known as Elk Run Corner, tract surveyed for David Edmiston (III, 426). No further reference has been found to this land, either for David or James.

David apparently died in the early months of 1751:

28 May 1751. Bond of Isabella and James Edmondson, as executors of David Edmondson. Secs: Wm. McFeeters, Wm. Henderson (III, 21).

27 Aug. 1751. Appraisement of David Edmiston's estate by William Finley, William Jonston, Samuel McCune (III, 22)

There is some curious phraseology: if Isabella and James were executors of David's estate, then there should be a will, but no will is on record. One correspondent said that it could be found in a book of Virginia records preserved in England, but the major book I've seen does not mention the will. James seems to have inherited the land, which he would have done as eldest son of an intestate, the English law of primogeniture apparently being still in force then.

By this time, James was established on land further south in the County, and so the widow and the other children presumably moved there to live with him, with David's original acreage sold off soon after his death:

DB IV, 459 (Ch. III, 306), 20 Aug. 1752. James Edmiston, son and heir and admr. of the estate of David Edmiston, and Isabella Edmiston, relict & heir & admx., to Hugh McClure, 350 acres in Beverly Manor deeded by Beverly to David Edmiston, 24 July 1740.

Ch. I, 67. 23 May 1755. Agnes Edmondson released dower in the 350 acres deeded by her husband to Hugh McCleeve [sic in Chalkley].

There is not even a hint as to what Isabella's maiden name might have been, nor is there any record of her death. There are rumors, perhaps based on good tradition, that she was Isabella Buchanan. The marriage with David most certainly came before the family's arrival in Augusta Co., and in all probability occurred in Ireland, although importation proceedings can be misleading--David might have been in the Colonies for some time before 1740. Another possibility might be that Isabella was a Robinson, since David's grandson John, s/o David II, married a Robinson said to be a cousin. However, that relationship might be through John's mother, Jane Miller.

David's son James must have been of age when his father died, probably born c. 1724 as will be seen. The other children, or most of them, were probably not of age when David died, but no records of guardianship for them have been found. Perhaps when James took all the land, the others inherited nothing and therefore had no need of guardians.

It should be emphasized that no evidence has been found of any contacts between David and the other Edmiston families in the county--Matthew somewhat to the north, or Robert and John to the south. This may be interpreted as meaning that David's relationship to the others was sufficiently distant that they did not think of each other as real relatives.

David seems to use the "Edmiston" spelling, but his son James moved to "Edmondson", and the family remaining in Rockbridge Co. later use "Edmundson."

The James who sold his father David's land had a wife Agnes, which with the other records below, shows him definitely to be this James. James seems to have moved farther south in Augusta Co. even during this father's lifetime, and after David's death, it is assumed that the widow Isabella and her children, most of them under age, lived with James.

James first got land from Moses Thompson, no doubt a relation of Agnes Thompson. This probably also is about the time that James married Agnes Thompson; perhaps the land followed the wedding, so that the newlyweds would have a place of their own.

20 Feb. 1745/6, Moses Thompson, late of Augusta Co., to James Edmiston, £ 13.17 current money of Virginia, 100 acres, patented 20 Aug. 1745 to Moses, east side of south river, Shanandoe, on the Red Banks. Wits: David Edmiston. Rec. 15 Apr. 1746, by Edmiston.

That Agnes was a Thompson is shown by:

It is not known who the Jean Edmundson witnessing this will would be: not James' daughter, who ought to be Jean Tedford. It is possible that this could be a granddaughter, d/o David, old enough to witness and not yet married.

The will record then proves the existence of only two children: David and Jean. This seems a surprisingly small number for such a long marriage, and there probably were others. Note that David has 3 tithables reported in 1778, i.e., 3 men over 16 in his household. James and David would be two of these, but who is the third? Other children may have died young or at any rate before their parents; however, it is still possible that there were other children not mentioned in the wills.

George Edmondson was in Company K of the 55th Virginia Infantry. He enlisted March 31, 1862 at Fort Lowry for 3 years of war. He was appointed a Sergeant on May 1, 1862 and was wounded in action on June 26 of the same year. He was in the Wayside Hospital again on October 27, 1862. On March 12, 1864 he was wounded a third time. Paroled at Richmond, VA on April 29, 1865. He was listed as eligible fo

# Francis Edmondson of Clayton, Indiana and his Descendants

Francis was born on July 26, 1802 at Sinking Creek, Greene County, Tennessee, and died on November 19, 1885 at Clayton.

Four of our EFAB members: Robert Francis Edmondson and Mary Jean Edmonson Mitchell of Clayton, Indiana, James Williams Edmondson of Indianapolis, and Larry E. Edmonson of Pittsford, NY, are descendants of Francis Edmondson.

The family historian for many years was Clarence Virgil Edmondson. Clarence or C.V as he was called, was born in 1884, and died in 1977. CV enjoyed the EFAB for many years, however, I don't know if he ever straightened out his early roots. According to the history written by C.V, which his daughter, and also Robert F sent me several years ago, he had not. Recent generations have been added to the family tree by Robert F and his brother Richard M. Clarence was the uncle of Robert and Richard, great uncle of James W. Mary Jane and Larry go back one more generation to a common ancestor, Benjamin Grayson Edmondson.

Now however incorrect C. V. was in his early history explorations, we owe him much for his records of the Francis Edmondson family and their contacts with cousins. Grandson of C.V., David Lee Edmondson probably still lives in Clayton, Indiana. Daughter Esther sent me material in 1994, and she was 84 at that time. Robert Francis Edmondson, an EFAB member lives at 1719 West County Road S. in Clayton, Indiana, 46118-9067. Robert is a gr gr grandson of Francis Edmondson and a nephew of C.V.

The Francis Edmondson family has resided in the area of Clayton, Indiana since December of 1829. Francis and his brother Solomon went to Indiana and settled in the same area, Sections 27 and 28, 3 miles northeast of the village of Mooresville, the properties being about 1/2 mile apart, and filed for them on December 17 and 18, 1829. Francis later moved to Liberty Township in Hendricks County, filing for land of the following description: Section 10, Township 14.N, Range 1 West, in Liberty Township, Hendricks County, dated November 23, 1831. Francis had to race through the night to reach the land office at Crawford to file before another settler. Probably some of the reasons that the family stayed nearby was that Francis had only one son, and the close proximity to Indianapolis, so there was opportunity for future generations. As you remember, Samuel and Solomon, father and grandfather of Francis, moved to the Beaver Creek area northwest of Knoxville in 1808, having lived earlier in northeastern Tennessee near Rheatown, and the farms on Sinking Creek. Recent data says that Samuel and Solomon each had 200 acres on Sinking Creek in 1798.

Benjamin Grayson Edmondson was the only son of Francis Edmondson and Jane Grayson. Francis and Jane also had two daughters. Benjamin and his sister Elizabeth Jane married into the Little family. Benjamin received his mother's family name as the middle name. So Francis was one of the 3 Edmondsons who married the daughters of John "Big Ben" Grayson son of Benjamin Grayson. This John Grayson the one being located at Beaver Creek in the Yarnell Cemetery. Francis married Jane Grayson on February 3, 1828 at Knoxville. His uncle John had married Jane's older sister on September 19, 1809 at Knoxville, and his brother John married Jane's sister Sarah on August 13, 1816. Jane's sister Hannah married Thomas Yarnell on March 4, 1824.

Francis' uncle John inherited part of Solomon's property on Beaver Creek. How did John transfer the property or sell it prior to leaving for Indiana? Did he transfer it to his fatherin-law John "Big Ben" Grayson who then gave it to his daughter Hannah Grayson Yarnell?

You may note in the first paragraph that there are two spellings of the Edmondson name, single and double Ds. This is true of many of the Edmondson families of SW Indiana. Two of the sons of Benjamin went by Edmondson, and the other 4 went by Edmonson, and this is true to this day in succeeding generations. Larry E. Edmonson is a descendant of Benjamin's son Samuel, and Mary Jean a granddaughter of son Thomas Benjamin. Evidently, the family tried to change the name to Edmonson, but several of the branches resisted and continued with the Edmondson spelling. Now that I am thinking about this, I wonder about the fact that all of the descendants of Samuel Edmondson that went to the South, Alabama and Arkansas stayed with the double D spelling. While in the North, the single D spelling became more prevalent. Could this have been a Civil War reaction? But also it appears that even in Solomon's will, filed in 1817 that the spelling appears both ways. Solomon Edmondson, who married Susannah... last name still not known was the progenitor of the Edmondsons/Edmonsons of southwest, Indiana, with the exception of a few Edmundsons who also settled nearby.

In early correspondence with Mary Jean, she told about her arguments with C.V. about the family history. C. V. was insistent that the line went like this: his father Robert Alexander, grandfather Benjamin Grayson, great grandfather



visit her and ask her the same questions I asked uncle Dale. You will receive the answers alot faster too.

Uncle Dale said that John T A (he called him uncle Johnny as my mother also calls him) used to be a school teacher. He moved to IL and purchased land for 75 cents and acre. He had the land cleared and raised broom straw.

Uncle Dale and my grandfather Floyd went to IL during the court issue about the heirs. Uncle Dale had to take the stand 2

times to say that he knew John T A. Uncle Dale and my grandfather also went to the sale of the land. He said that the Amish people purchased the land.

Uncle Dale said that William Edmonson would travel down the Eel River to the White, then to the Wabash to the Ohio, then to the Mississippi River to New Orleans to sell staves. He would than take a steamboat from New Orleans to Louisville. At Louisville he would walk back to Clay City.

Editor: For the past two years, Clarence Austin Edmonson has been scanning Rita Alexander Abair's collection, and her mother Villa Belle Edmonson Alexander's collections of pictures. The pictures Columbus Lafayette belonged Edmonson, son of Peter Allan Edmonson. Columbus died on December 24, 1928 at the age of 74 at his home in Oklahoma. Here we need to speak about Columbus Lafayette Edmonsons. This Columbus is the nephew of Columbus Lafayette Edmonson, died November 7, 1922, at the age of 87, of Terre Haute, Indiana, the son of William and Delilah Holt Edmonson. Now lets confuse this a little more. Samuel Austin Edmondson, the eldest son of William and Delilah, brother of Peter A. and Columbus L., also had a son Columbus Lafayette Edmonson, married Lucinda Davis and died on March 3, 1922 in Clay City, Indiana. Samuel Jr. Edmondson, brother of William, also had a grandson named Columbus Lafayette Edmondson, son of Jonathan Edmondson. This family we have lost contact with and could have ended up in Alabama or Arkansas. Our family Edmondson/Edmonsons is the only one that possesses this combination of C. L. Edmonsons. My gr. gr. grandfather Columbus Lafayette Edmonson was known by the nickname of "Lum".

Now I was just recently in Kansas on a business trip. So I had a chance to do some research at the Lyndon, KS courthouse and poke around countryalde. I picked up some recent maps of the land and now can compare it to the older township maps that were purchased on the first visit. I also day into the land transfer books, and you can see from the entries that when Peter Allen says that times were tough you find him taking out loans on the property. His brother William Strange Edmonson purchased this land in Kansas first and sold it to Peter. I hadn't known that prior to getting the records. I also discovered on this visit that my digital camera takes outstanding pictures of the courthouse It saves a lot of time and provides a permanent record that is authentic. I imagine that the original property documents are stored someplace with signatures. This is a next goal to get photographs of original handwritten records. The court records handwritten notes in the land record books by the county clerk.

My grandmother Pearl McConnell Edmonson worked for Columbus L. Edmonson, state senator of Midlothian County, Oklahoma where she met my grandfather Jesse. So she saved some of his legislative issue books that bore his signature on the cover.

Now looking at this 1996 property map you will notice Highway 75 that goes north out of Lyndon to Topeka, KS and the hatched area is the Dragoon Creek to the left and the western edge of the man-made lake Pomona. You can also see the section number 6 which is almost split in two by Hwy. 75. An older highway and bridge is just to the right of 75 and that almost splits section 6 down the middle. Section 6 is bounded on the top or north side by 205<sup>th</sup> street. 209<sup>th</sup> street divides the section from north to south. Peter Allan Edmonson owned the southwest and northwest quarters. He purchased the southwest first from his brother William Strange Edmonson on February 21, 1878. W. S. purchased it on April 27, 1877 from the widow Rebecca Stritts. It was first patented by the US on October 5, 1872. Peter purchased the NW section of 6 after his daughter Rosetta married George B. Carter and the property was in both of their names. G.B. Carter later transferred his share to C.L. Edmonson, and C.L. later transferred it back to his father. If you look at the same property as shown in the EFAB #114, page 43, you can see it matches perfectly. The property now has houses on the southeast part of the southwest quarter, and an airport on the northwest part of section 6.

On April 27, 1877, William S. Edmonson purchases the SW quarter of section 6. Sells it to Peter, his brother, on February 21, 1878. Peter also purchased the northwest quarter along with George B. Carter, his son-in-law on November 4, 1880, two years after Rosetta and George were married. On February 10, 1883, after the death of Peter's wife, son, and daughter, times are hard, and he takes out a loan from the Crippenton and Lawrence Co. He takes out a second loan on January 10, 1885. On November 21, 1883, George Carter and wife Rosetta sell their share of the property to Columbus Lafayette Edmonson. C.L. had married Immanda Spurgeon in December of 1881. Columbus takes out two mortgages with the Crippenton and Lawrence Company. You can see from these documents that C.L. transfers the property back to Peter prior to Peter trading property with H. C. Cates on February 10, 1887.

Now one of the interesting things in this research was to pull out the deed for the property for which they traded for. I was able to get the land records for that property also and to visit the owner who has had it since 1957. It appears that two of the sheds are original on the property, but the old farm house was taken down shortly after the current owner moved in. It is a nice piece of property just east of Lyndon about I mile, good farm land with a sizeable creek running through the middle. Supposedly it also had a railroad right of way through it, but I don't know if there was ever a track through the property?

The pictures of the deed book were taken with a 2 megapixel Fuji camera at a low resolution. If I had known that they were going to turn out quite good, I would have used a higher resolution.
