The following is from the family Bible belonging to James A. Adams. The front of the Bible has a publishing date of 1867. Please note that Susan Alice Adams Gault is also known as Alice S or Alice Susan. She was married to a gentleman named Gault before her marriage to J. Otis Ferro in 1888.

# Edgar Dea Fenno

(Born 1833-Died 10 Oct. 1896)

Begat Otis Austin Fenno (Born 20 May 1856, Bedford, Iowa) (Died 24 December, 1942, Entiat, Wash.)

> Begat Edna Beatrice Fenno Henderson (22 July, 1889—29 Sept., 1969) Eric Fenno (7 May, 1897—4 March, 1949) Jessica Ruth Fenno Rawhouser (3 June, 1900—25 Jan. 1974) Bernice Elizabeth Fenno Garton (23 April, 1903—8 Feb., 1975)

In this year of 1975 the last of the second generation of those with the Fenno name and directly descended from Edgar Dea Fenno was laid to grave, and we of the third generation who temporarily remain, pause, gaze into the stern countenance of our common ancestor and wonder — Edgar Dea-the person: lost, no anecdotes, quotes; what remains is a familiar partial prodgeny and a small detail of sometimes controversial bureaucratic data and hazy reminiscence. The following is a summary of information contributed by various people.

In Book "A" of Marriages In Taylor County, Iowa, we find Edgar Dea Fenno married Celinda Randall 12 June, 1853. the 1856 State Census showed that Edgar Dea and Celinda had been residents of Iowa for six years. The 1860 Census show this family living in the town of Bedford, Taylor County, Iowa, with Edgar Dea's occupation listed as a farmer, with real estate valued at \$300, and personal property valued at \$50. Canada is listed as his birthplace, and New York as Celinda's birthplace. Three children are listed: Otis, Bell, and Horace. Charlie was born later.

Edgar Dea's Civil War military service began when he enlisted in the local militia in Aug. 1861 and served as a musician in 4 Reg't. Iowa Vol. Inf. Also as a 2nd Lt. in Co. E. 4 Mo. S.M. Cav., enrolled 24 Feb. 1862, discharged 12 Aug. 1862. The Military service Records at the National Archives in Washington, D.C. show him as enlisting 18 July, 1863 in Co. B, 9th Cav. of Iowa, as a 1st. Sgt. In "History of Taylor County, Iowa" by Lyman Evans, he writes that the 9th Cav, was guartered at Camp Roberts, Camp Kinsman, Camp Jackson, Mo. and Benton Barracks. Brigadier-General J.W. Davidson was in command when the regiment was employed from 14 April, 1864, in skirmishing with and capturing bands of guerillas. May 15th, of that year, the regiment began to embark for Duvall's Bluff, Ark., where it encamped a short distance from White River. It engaged in no battles there, the time was largely spent in foraging and picket or guard duty. The regiment was finally mustered out at Little Rock, Ark., Company B on 23 March, 1866. During the 9th Cav. service, it marched over two thousand miles, moved by steamboat and rail seventeen hundred miles, and the aggregate marches of various detachments approach eight thousand miles more. It lost not a single man killed and only fifteen were wounded. The loss by death from sickness, including two deaths by drowning, was one hundred and sixty-six. His service records describe Edgar as 5ft 51/2 inches tall, light complexion, blue eyes, and light colored hair.

Rebecca Carolina Rogers states on her claim for a Widow's pension that she married Edgar Dea Fenno 15 Nov. 1865, in Fayettville, Ark., both having been previously married. Prior to this date, Edgar's first wife Celinda had died, and the children had been sent to Mississippi to live. Children born to this second marriage were Ada, Robert, Volleigh Dea, Ina, and George.

After the civil war Edgar and his new wife settled in area of Siloan Springs, Ark. and raised all of his accumulating family.

The next 24 years are mostly a blank with Edgar at one time reported to be practicing law in Siloan Springs. In 1890, at the age of 57, Edgar applied for a Civil War invalid pension claiming that he was entirely unable to earn a support by reason of a stiff left ankle which limited his walking to one half mile without resting, and a totally deaf left ear. An affidavit accompanying the application states that Edgar had been unable to perform manual labor for at least eleven years. His declining years were evidently frugal, and when he died in 1896 his wife Rebecca made a declaration for a veterans widow's pension.

Great grandfather Edgar Dea Fenno, an ordinary fellow of God and Country, and the necessary link to a very exceptional third generation of Fenno blood. were John and Jane (Howe) Gustin. He was a brother to the above named Benajah, and both were sons of above named Jeremiah and Bethany (Fuller) Gustin. Now if I could find a will that would verify that my greatgrandmother was indeed another daughter of John's....After two days of searching all types of probate records (the book, <u>GUSTINE COMPENDIUM</u>, gave me his date and place of death), and finding all sorts of estate inventory and sale records, but no will or document which mentioned her name, I was about ready to give up, except for one fact: Her husband, my great-grandfather James Mills, was listed as a buyer of some of the estate items, and his name was found on a guardian bond for another Gustin's child. But this was still not enough to prove his wife's relationship to John Gustin. Finally, I decided to check some land records, and <u>THERE IT WAS!!!</u> Seven years after his death:

This Indenture made the twenty fifth day of January in the year of our Lord one thousand eight hundred and thirty six between James Mills and Bethany his wife late Bethany Gustin one of the heirs and legal representatives of John Gustin dec<sup>d</sup> of the county of Warren and state of Ohio......(etc).....

and further in the document, another unknown element was revealed:

...in the partition of the real estate of John Gustin dec<sup>d</sup> subject to the dower right of Jane Stites late Jane Gustin, widow of the said John Gustin deceased....

Thus we learn also that John's widow remarried, possible explaining why we have not been able to locate her death certificate: we had been inquiring under a different surname.

Relative to the possible Mayflower connection, I have yet to obtain the positive proof though many factors point to that fact. Bethany Fuller married Jeremiah Gustin in Sussex Co., New Jersey, according to the <u>GUSTINE COMPENDIUM</u>. (His parents are both buried at that location). According to several sources I have found on the descendants of the Mayflower passengers, I have found:

Passengers Edward and Ann Fuller had a son, Capt. Mathew Fuller Capt. Mather Fuller had, among his children, a son <u>Samuel</u> <u>Samuel</u>, who married Mary \_\_\_\_\_, also had a son named <u>Samuel</u>. <u>Samuel</u> married Elizabeth Thatcher, and had a sonnamed <u>Elkanah</u>. <u>Elkanah</u> married (2nd) Naomi \_\_\_\_, and had a daughter named BETHANY FULLER.

While I have not found any evidence to substantiate that <u>this</u> Bethany Fuller is the same Bethany Fuller that married Jeremiah Gustin, other than the fact that both Bethanys were born approximate same date and both lived in the same county (Sussex, N.J.) as did the Gustin family, and that this is where Jeremiah Gustin married his Bethany Fuller, BUT IN ADDITION, JEREMIAH AND BETHANY NAMED TWO OF THEIR CHILDREN ELKANAH AND NAOMI (Bethany Fuller's parents' names).....So the search continues (and obviously, I would appreciate hearing from anyone who has researched this line of the Mayflower Fullers).

To my original point: The above mentioned published genealogy <u>DID</u> give me about ten additional generations, <u>AFTER</u> I proved my connection to that family, but I could have easily put it aside as not my line.
