My letter to you of 30 March, last brought an amazingly rapid response which has been transcribed and copies of this information are being forwarded to yourself, Mr Bennett and to a Mrs Adam French, who it is believed may be interested in the HOUSTON connections.

Also in filing the iriginals of the enclosed copies, it was found that a Mrs William Ross Brown just might be interested in thr BROYLES connection. Some of her catalogued material has a Jemima BROYLES who married a Joseph Brown in 1781 in Tennessee (son of Joseph and Mary PORTER BROWN) ancestors of the four time Governor of Georgia (Joseph Emerson BROWN). This may be of the same lineage as the Adam BROYLES of Culpeper County, Virginia ancestry - to Washington County, Virginia at the close of the RW. Joseph and Mar Jemima Broyles Brown were the parents of Mackey Brown, who was the father of Joseph Emerson BROWN.

It is realized that none of this may be of interest to you, but the information is supplied in an attempt to point up the ease with which such a method of filing can be of assistance to others, when properly catalogued.

3 Cadets Drowned in a Pond The Cleveland Star 14 May 1902

While Bathing In A Mill Pond Near Yorkville, C. Harry Stevens, E. M. Nichols and J. F. Lindsay Were Drowned

Charlotte Observer.

Yorkville, S. C. – May 3 – Cadets Harry Stevens, E. M. Nichols and J. Frank Lindsay of the King's Mountain Military Academy, were drowned this afternoon about 3 o'clock. The tragedy occurred while the boys were bathing in Black's pond, two miles west of Yorkville.

Immediately upon hearing the news the Observer correspondent hurried to the scene and found Drs. Walker, White, McDowell and Barrow, assisted by dozens of anxious citizens, trying to resuscitate the unfortunate young men. From eye-witnesses the details of the tragedy were gathered as follows: There were 19 cadets in the bathing party and only a few of them were able to swim.

The pond is a shallow sheet with a deep channel in the centre. Stevens, who was a strong, vigorous young fellow, ventured to wade across, heedless of warnings. He stepped beyond his depth and began to flounder. Nichols and Lindsay, neither of whom could swim, plunged to his rescue and all went down together, Mr. Fred Black, the miller, and Cadet Marsh Marrow of Gastonia, both good swimmers, went to the aid of the three drowning boys and became entangled in the death trap to such an extent that they barely escaped with their lives. Although much exhausted, they continued their efforts until they recovered the bodies of Stevens and Nichols by diving. This was after the bodies had been down about 20 minutes. The body of Lindsay could not be found until the pond had been partially drained. It was at least an hour after the boys had gone to the bottom before the doctors arrived and all four reached the top within a few minutes of each other. In the meantime, however, acting by directions of his mother, who had a previous experience, Mr. Fred Black had already succeeded in getting the drowned men pretty well relieved of water. The doctors devoted their efforts to restoring respiration and worked two hours without success. One of the doctors thought he detected a slight heart action, but was not certain.

Dr. Walker opened a vain in Stevens arm and got a flow of blood, but it was black and showed no sign of oxygen.

Cadet Lindsay was the eldest son of Capt. J. R. Lindsay of Yorkville, Cadet Nichols was the only son of Mr. T. J. Nichols, a prominent farmer who lives near the place, and Cadet Stevens was a brother of Mr. John T. Stevens, a leading merchant of Kershaw . S. C.

I, W. A. Hamrick, of aforesaid County and State, being of sound mind but considering the uncertainty of my earthly existence, do make and declare this my last will and testament:

First. My Executor, hereinafter named, shall give my body a decent burial, suitable to the wishes of my friends and relatives, and pay all funeral expenses, together with all my just debts, out of the first moneys which may come into his hands belonging to my estate.

Second. My will and desire is that my Executor, as aforesaid, shall sell all of my property, real, personal and mixed, within a reasonable time after my death, at public or private sale as may appear to be the best interest of my estate, and I hereby delegate to my said Executor the right to execute, a deed or deeds in fee simple to the purchaser or purchasers of the real estate. It is my desire further that my heir-at-law at the same time make sale of the 29¼-acre tract of land which I purchased from J. C. Byers and wife on Feb 10th, 1877, (See record of Deeds of Cleveland County Book "M", page 368) and which was deeded to "Martha M. Hamrick, wife of W. A Hamrick, and the heirs-at-law of W. A. Hamrick", and that the funds derived from such sale be placed in the hands of my said Executor to be distributed by him, in connection with other funds received from sale of property hereinabove set forth, among my heirs-at-law as hereinafter set forth.

Third. I hereby give and bequeath to my daughter Hettie Hardin, wife of J. A. Hardin, Three Hundred (\$300.00) Dollars in addition to the sum of One Hundred (\$100) Dollars which I have heretofore advanced to her. Should my heirs-at-law fail to refuse to sell the 29¼-acre tract and place the funds in the hands of my Executor for distribution as set forth in paragraph two above, then my said Executor shall appoint three discreet men, who are not related by blood or marriage to any of the parties in interest, who shall value said tract of land and designate the value of the distributive share of said Hettie Hardin therein. My said Executor shall then pay her from other funds in his hands a sufficient sum to supplement the value of her interest in said tract, making her total share equal Three Hundred (\$300) Dollars.

Forth. I give and bequeath to my daughter Mary Bell, wife of John Bell, One (\$1.00) Dollar.

Fifth. I give and devise to my daughters Bertie Hendrick wife of Pink Hendrick, and Maggie Hamrick (single) Fifty (\$50) Dollars each to make them equal with my daughters Hetherly Richardson and Eve Dover and my son James F. Hamrick to whom I have heretofore advanced Fifty (\$50) Dollars each.

Sixth. 

Truman and Stephen Guthrie each recieved a share in the Ohio Co. lands from their father, Joseph Guthrie, of Washington, Conn. They journeyed most of the way to Pittsburgh on foot and by river to Marietta, where they arrived July 3, 1788.

Truman cleared about half an acre near Mound Cemetery (probably the one in Marietta), enclosing it with a brush fence; he sowed about a peck of wheat he had brought from Pa. - said to have been the first sown in Ohio. During the following year they went back to Conn.

In 1791, they returned to Newbury, (Ash Co., Ohio), Stephen with his wife and infant dau., Laura, in company with Eleazer Curtis and family. Later Truman married Elizabeth, dau.of Col. Isreal Stone, of Belpre, taking his wife home in a canoe.

In 1795, when Belpre Twp. was organized, Stephen Guthrie was appointed Justice of the peace, by the governor.

NOTE: Stephen Gutherie was an early land owner in this area on the Muskingum-Morgan Co. line and was involved in the manufactur-ing of salt. -- SYL

'A DAY IN THE JP COURT'

John Sidle an early settler in Muskingum County, Ohio had a saw and grist moll in operation on Licking Creek, in 1815. Mr. Sidle died Dec. 11,1847 and is buried in the Bethleham Cemetery. His will was proven Dec. 30,1847 in Muskingum County. Amoung the estate papers in file #2604 for John Sidle we found the following?

Samuel Harris
Warrant 37c
Branscript 312

June 23rd 1846. This day came John Sidle and made oath that Samuel Har Harris called him a Dammed old rascal and said that everybody said he was a dammed old rascal, and is he was not an old man he would thresh

him, and caught him by the collar and pushed him back and rubbed his fist under his nose and called him a dammed liar, took his affidavit thereof. Thereupon issued a warrant and delivered the same to E. Brown, Const.

The warrant on the above has never been returned

I do hereby certify the above to be a correct copy of the proceedings had by and befor me in the above case.
