Sarah Mann and others her posterity Pltfs. vs John Sutton Deft. In Chancery. This day came the parties by their attorney and the Deft. moved that the suit should be dismissed for that the Pltf. had in open Court disclaimed the same by the record of the proceeding in Dec. Court 1766, but the Court having at the time of the disclaiming continued the suit upon a supposition that the same was not voluntary—and the Pltf. being since ordered into the possession of Anthony Thornton quet sheriff, the sd. Thornton now declares on oath that the Pltf. was brought to his house by a messenger of the Defts. and this presence declared she

did know she was intitled to freedom nor did she desire it but on the next day after the messenger was gone she declared that the reason of her disclaiming the suit was through fear she having been threatened though not by the Deft. that if she prosecuted the suit before the Determination that her children would be removed to the Indians where she would never hear of them again and further upon coming to Court formerly to claim her freedom she was severely whipped by the Deft. on her return home and the said Thornton declared she had never since seemed anxious about the prosecution of the suit and the Complt. appearing now in Court expressed her desire to have the trial proceed whereupon the Court on hearing the argument of council on both sides did order and direct that the suit should be dismissed and thereupon came a jury to wit. Richard Buckner, foreman &c. were impannelled and sworn well and truly to try the issue formerly directed and now joined between the parties, vizt: Whether the complt. is entitled to freedom in consideration whereof it is decreed and ordered that the Complt. go free from the service of the Deft. and that the said verdict together with the Deposition taken and returned in this suit be recorded to perpetuate the testimony for the benefit of the Complts. Issue. On the motion of the Deft. an appeal is granted him giving bond in the Clerks Office according to Law. July 1768. Ibid, p. 198.

"Whereas before my intermarriage with Rachel Courtney my present wife it was by a writing bearing date 19th May 1767, mutually agreed between us that in case we should live together 5 years & she would relinquish her right of Dower to all my lands in case she should be the longest liver that then & in such case I oblige myself to lend her a negro boy named Richmond & one other negro the choice of all my slaves which she was to have during her life & at her death both the said slaves to return to my estate I likewise agreed that in case I should dye within the time aforesd that the said Rachel should be entitled to all the money I might receive for the rents of her land & what other estate she brought me which writing I hereby confirm on my part proved the said Rachel abides by the same on her part according to her contract which she hath since faithfully promised to abide by. To son John Mann all land that my son Robert Mann lives on & my quarter lands adjoining to it and a negro fellow named Charles and negro girl named Nan and my quarter still. To son Augustine Mann part of the land I bought of Mr. Dunbarr where he now lives upon down to my Spring branch & up the branch to my spring and from thence to a red oak by the road, & so up the road to the land I purchased of Thomas Miner his corner by the road all that parcell of land I bought of sd. Miner. To son Robert Mann the land & plantation whereon I now live and all the land I bought of Mr. Dunbar below my Spring branch and a negro girl named Alice. To daughter Ann Lewis, a negro girl named Hannah. To daughter Mary Lovell, [Sowell ?] a negro girl named Winney. To daughter Sarah Townley, a negro man named Ben. To son Robert Man, my still where I now live. Residue of money, outstanding debts and Estate of what kind soever not already disposed of shall

be equally divided between my six children, Robert Mann, John Mann, Augustine Mann, Ann Lewis, Mary Sowell, & Sarah Townley only Ann Lewis sixth part I lend to her during her life & then to be divided between her children that she shall have alive by Richard Lewis. To three sons Robert, John & Augustine all my wearing apparell to be equally divided between them. At death of wife Rachel Mann whatever part return of her dower in estate shall be equally divided between my six children Robert, John, Augustine, Ann Lewis, Mary Sowell & Sarah Townley. William Gibson and a tract of land by me lately purchased from Samuel Broocke and situate in the same Parish and Co. and the negro slaves Lucy, Hearry, Peter and Cloe and the future increase of Lucy and the children which Cloe now hath & her and their future increase, three feather beds and furniture, one Desk, one oval table one small bay mare and one cow & Calf & their increase which things are now in possession of my daughter lately Banks except some of the said slaves by loan from me but it is my will that my son Joseph Mann & his heirs shall hold the said tract of land & slaves & chattles in trust and permit daughter Caty Banks to have the profits of the sd. lands and the use of the said chattles and slaves and their future increase during her natural life & no longer as it is expressly my intention that she shall have no greater estate therein than for her life and my son Joseph and his heirs do hold the said property and permit my sd. daughter to have the

benefit thereof in such manner that the said property and the profits thereof may be to the Separate use of my said daughter and may not in any way be liable to the control or management of her husband Wm. Banks or be in any manner support to or liable for any debt or contract heretofore or hereafter contracted or made by the sd. William Banks & after the death of my daughter Caty Banks my son Joseph or his heirs do convey to such children or child of the sd. Caty Banks which she may have living at the time of her death the whole estate given to him in trust in manner aforesd to be equally divided between them . . . . but in case my sd. daughter Caty Banks shall die without leaving any heirs living at the time of her death I direct that the sd. estate shall go to my son Joseph and my daughters Peggy & Susannah Mann & Sarah Sewell or the survivors and their heirs and in case my daughter Caty Banks shall die and leave a child or children and any such child or children may die before the age of 21 years the portion of such child or children so dying shall go to the survivor or survivors and their heirs and in case all of such children shall die before they are 21 years of age or if she shall leave but one child at the time of her death and such child shall die before it arrives at age the estate hereby intended for my daughter Caty Banks & her children shall go to my son Joseph and my daughters Peggy & Susannah Mann and Sarah Sewell or the survivors. To wife Sarah Mann my whole estate real & personal during her natural life or widowhood including the lands & slaves devised to my son Joseph as aforesd for the benefit of my daughter Caty Banks and her children, as aforesd. which devise shall not take effect during the life or widowhood of my sd. wife unless she shall consent to it. but it is not my intention to devise to my sd. wife any money of which I may die Possessed or any debts. I direct that any debts which may be due to me at the time of my death and of which money and debts I direct that any debts that I may owe at the time of my death shall be paid and the residue of such money and debts to be equally divided between my son Joseph and my daughters Peggy and Susannah Mann and Sarah Sewell the wife of William Sewell them and their heirs; and in case my said wife may chuse it she may deliver

up in her life time to my children any part of the estate herein devised to her agreeably to the estate hereafter given to them. After the death of sd. wife or determination of her widowhood, I devise to my son Joseph Mann tract of land whereon I now live situate partly in Essex & partly in King & Queen Cos., to daughters Peggy & Susannah Mann & Sarah Sewell tract of land called Woodyard and one tract called Birds both in Co. of King & Queen to hold as tenants in common and not as joint tenants. I devise to each of my daughters Peggy and Susannah Mann one feather bed & furniture of the value of 12 pounds each and their choice of a chest or trunk to each of them as my other children have each received such advancement. All the residue of my estate of what nature or kind soever I devise to my son Joseph and my daughters Peggy & Susannah Mann & Sarah Sewell and their heirs, to hold as tenants in common and not as joint tenants. Daughters Peggy & Susannah shall have the privilege to live in the house and on the plantation whereon I now live and be supported out of the estate so long as they remain unmarried. In case either of children Joseph, Peggy, Susannah or Sarah shall depart this life without leaving living issue, that such part of estate as is devised to him or her shall go to and rest in survivor of them, and in case one or more shall die whereby their portion shall go to survivor or survivors such survivor shall be entitled to the whole estate. The still and appurtenances and necessary things used in distilling with the still fixed in the still house on the plantation whereon I now live shall go with the plantation as herein devised and clock fixed up in dwelling house shall be considered as part of personal estate and go with the residue of estate.
