Samuel Rose, born ca 1821 (census) or ca 1819-1820 (C.W. file), Berkeley County, Virginia [now West Virginia] (C.W. pension file). However, it will be noted that he married in 1832, and thus, something does not fit. The marriage date is attested in the Civil War pension file, but is surely an error as he would be only about 11-12 at this time. Both his census records and his Civil War file indicate this approximate birth. However, the 1860 census shows him as age 47, and this would seem more likely correct as that would make him born ca 1813. No explanation for the variances.

He died 28 September 1863, St. James Hospital, New Orleans, Louisiana while in service (<u>Ibid</u>.), buried #249 Cypress Grove #2, New Orleans, parish of Orleans, Louisiana (<u>Ibid</u>.), married 12 February 1832, Cincinnati, Hamilton County, Ohio (<u>Ibid</u>.).

He married 12 February 1832, Cincinnati, Hamilton County, Ohio (C.W. file), Mary Ann Bloomer (Ibid.; her name is shown as Mary Blumin on marriage record of son Alfred Henry Rose), born ca 1821 (census), Kentucky (census), died 28 January 1894, Batavia, [Jefferson County], Iowa (husband's C.W. pension file), parentage unknown. Her obituary was published in the Fairfield Tribune of 31 January 1894:

BATAVIA: January 30—The mother of A. H. Rose died at his home on Sunday morning. Rev. John Brown preached her funeral on monday afternoon. Her remains were conveyed by way of Ft. Madison road to Mt. Sterling, Iowa, where her husband years ago was laid to rest in that cemetery. [Mt. Sterling is in Van Buren County, Iowa.]

Mary Ann was a niece of Martha Woodington according to her husband's Civil War C.W. pension file. [The death certificate of Martha Woodington, Cincinnati, Ohio shows that Martha died 5 September 1860, her father's name left blank, her mother marked as "Bloomer." Her obituary published 6 September 1860: DIED: After a long and painful illness, which she bore with Christian fortitude, Mrs. Martha Woodington, aged 68 years. Her funeral will take place on Friday afternoon, at 1 1/2 o'clock, at the Pearl street Chapel. Friends of the family are requested to attend without further notice.]

He served in the Civil War, Co. D 22 Iowa Infantry, and died while in service. The records of Iowa, 22nd Infantry (in a published roster, p. 643) shows Samuel Rose age 43, residence Albia, nativity Virginia, enlisted July 26, 1862, mustered August 26, 1862, died of disease September 28, 1863, New Orleans, Louisiana.

After his death his widow applied for a pension. From that file (National Archives):

Affidavit: Samuel Rose, Capt. N. B. Humphrey?, Co. D - Reg. of -Vols., state of Iowa, born in Berkeley, Va., aged 43, 5' 9 1/4", fair compl., grey eyes, light hair, a blacksmith, joined at Albia, Iowa 9 Sept. 1862 for three years. Dated: 13 Nov. 1863.

Form: Samuel Rose, Co. D 22 Iowa Inf., Private.

Muster roll: Sept. and Oct. 1863, died Sept. 28 1863 at St. James Hospital, New Orleans. On side says Siege of Vicksburg, Siege of Jackson.

Record of Death and Interment: S. Rose No. 589, number and locality of Grave No. 249, Cypress Grove No. 2, No. 4766 (latter is hospital number of decd), Private Co. D 22 Iowa Vols., residence before enlistment, Berkley Co., Virginia, died Diarrhea Chronic, aged 43 years, died Sept. 28, buried same, 1863.

Company Descriptive Book: age 43, 5' 9 1/4", fair compl., grey eyes, light hair, born Berkeley, Va., occupation blacksmith, enlisted Aug. 1, 186- at Albia, Iowa by R. M. Wilson for three years, died Sept. 28, 1863 at N Orleans, La., Battle engaged in: Port Gibson May 1st, Champion Hills May 16, Black River Bridge May 17th, Assault on Vicksburg May 22, 1863.

Form: Mary A. Rose, widow of Samuel who was pensioner has been dropped because of death at Batavia, Iowa Jan. 28, 1894, reported by P.M. at Mt. Sterling, Iowa.

Affidavit: Van Buren Co., Iowa 25 June 1867, Malinda Blacklige and Jennie Lee, were present when Charles Rose, Alfred Rose and Malissa Rose, children of Mary A. Rose and Samuel Rose were born and that Charles Rose was born in the county of Lee, state of Iowa on 25 Dec. 1852, Alfred Rose on 3 Oct. 1855 in Lee Co., Iowa and Malissa Rose was born 29 July 1858 at Mt. Sterling, Co. of Van Buren, Iowa. Signed: Jennie Lee, Malinda (her x mark) Blacklige. Wit .: Isaac B. Thatcher, Thomas Thatcher.

Affidavit: Van Buren Co., Iowa, 26 June 1867, she is identical Mary A. Rose who was widow of Samuel Rose decd, filed declaration No. 51743, state Charles Rose was born Dec. 25, 1852 in Lee Co., Iowa, attending physician was Dr. Craig whose whereabouts are unknown, and Alfred Rose b. 3 Oct. 1855, Lee Co., Iowa, no physician present, and Malissa Rose b. 29 July 1858 at Mt. Sterling, Iowa, in presence of Dr. Frederick who has since [—?] and hiswhereabouts unknown. Signed: Mary (her x mark) Rose.

Affidavit: Monroe Co., Iowa, 21 Feb. 1865, Mary Ann Rose, widow of Samuel Rose, Priv. Co. D 22 Reg. Iowa Vol. Inf., married him 12 Feb.1832 at Cincinnati, Ohio by one Glenn, a J.P., informed that Glenn died with cholera in 1832 and there was only six persons present at marriage with whom I was acquainted and do not know where any of the persons now reside although I have written to Cincinnati and made inquiry for them and have made inquiry of my friends; there is no record of my marriage in said City of Cincinnati, and there is not any church record of the baptism of any of my children as none have been baptized, can only produce evidence of those who knew my husband and I to live together as husband and wife. Signed: Mary A. (her x mark) Rose.

Affidavit: Monroe Co., Iowa, 22 June 1864, Mary Ann Rose, states I am widow of Samuel Rose decd, Priv. Co. D commanded by Capt. R. M. Wilson in 22 Reg. Iowa Vol. Inf., I married him 12 Feb. 1832, City of Cincinnati, marriage solemnized at house of Martha Woodington who was an Aunt of mine. I further state that at the time of my marriage nor afterward did said Glenn give me or my husband any certificate of our said marriage and that the following named persons were present: Martha and Matilda Woodington, George Woodington, Joe St. John, Mr. Tilot and Mr. Evans, these were the only persons I was acquainted with but there were several others present at my marriage; I have had no correspondence with any of these who were present for about 16 years, I believe the Woodington who were present died with the cholera in the year 1849 when that disease prevailed in Cincinnati. Signed: Mary Ann (her x mark) Rose. Wit.: John K. Duncan.

Affidavit: Monroe County, Iowa, 7 Jan. 1864, Francis Kendall, resident of Albia in Monroe County, aged 66, I became acquainted with Samuel Rose and Mary Ann Rose his wife some time about the year 1852 and knew them about three or four years during which time they resided in the City of Keokuk, Iowa, lived together as husband and wife, I knew them to have several children while they lived in Keokuk, knew nothing more until they removed to Town of Albia in Monroe County, Iowa. In the fall of 1860 said Samuel & Mary Ann moved into the town of Albia aforesaid and they have since resided in said town and they have some four children that are quite young think they are under 16. In fall of 1862 Samuel Rose enlisted etc. Signed: Francis Kendall.

Affidavit: 4 Jan. 1864, John Henderson, resident of Town of Albia, Monroe County, well acquainted with Samuel Rose and his wife Mary Ann Rose for fifteen years, first knew them when they resided in Keokuk, I knew them again about four years ago in the year 1860 in a little town in Van Buren County, Towa called Dog Town, they had several children, in the latter part of 1860 moved to the Town of Albia in Monroe County, I believe the children are under 16, to wit, Jane aged

about 14, Charles about 12, Alfred about 9 and Malissa about 5, etc. Signed: John Henderson.

Hamilton County, Ohio, Probate Clerk states he has made thorough search of marriage records from Jan. 1 1831 to Jan. 1 1835 and find no record of the marriage of a Samuel Rose to Mary Ann Bloomer said to have been solemnized in this county Feb. 12, 1832.

Affidavit: Monroe Co., Iowa, 4 Jan. 1864, Mary Ann Rose, resident of Town of Albia in said county, she is widow of Samuel Rose etc., declares she was married to Samuel Rose 12 Feb. 1832, he died at New Orleans in Saint James Hospital of disease 28 Sept. 1863, she has not remarried, has made diligent search for marriage record, children under 16: Jane aged 14, Charles aged 12, Alfred aged 9 and Malissa aged 5. Signed by her x mark.

Affidavit: Van Buren Co., Iowa, 5 Sept. 1866, Mary A. Rose, resident of Mt. Sterling in Van Buren Co., Iowa, widow, etc., children under 16: Charles Rose b. 25 Dec. 1852, Alfred Rose b. 3 Oct. 1855 and Melissa Rose b. July 29, 1858; has no family record. Charles was b. Jackson ——?, Lee Co., Iowa; Alfred b. Jackson twp., Lee Co., Iowa and Melissa b. Mt. Sterling at her present residence (Mt. Sterling, Van Buren Co.). Signed by x mark. John Madden and Thomas Madden, residents of Van Buren Co., are well acquainted, etc.

Affidavit: Monroe Co., Iowa, 7 July 1865, John Henderson, resident of Albia, Monroe Co., Iowa, knew Samuel and Mary Ann Rose, knew they lived together as husband and wife, etc., after Samuel and Mary Ann had resided about 7 years in said Lee Co. they moved up to a little Town called Dog Town in Van Buren Co.; about 1860 or 1861 moved up to the Town of Albia; he was a blacksmith in Lee Co. when I first knew him about year 1850 or 1851. I am not related by blood or marriage.

Affidavit: Monroe Co., Iowa, 24 Mar. 1865, Simeon Wicoff, knew them, etc. Also affidavit from Monroe Co., 6 July 1864, of Francis Kendall, resident of Town of Albia, knew them, etc. Another affidavit 7 Mar. 1865, Van Buren Co., Iowa, of James A. Alcorn, well acquainted, etc.

From the deed records of the county of Van Buren, state of Iowa:

Deed Bk 15 pp. 88-89, for \$50, Mary A. Rose to H. E. Bradford, real estate beginning at middle of the county road from the Missouri line to Solomon Richardson's, line of Mark C. Thatcher, H. E. Bradford, lying in Sec 7 Twp 67 Range 9 West. Dated: 30 April 1879. Signed: Mary A. (her x mark) Rose. Wit.: Sarah A. Felker? Rec.: 17 May 1879.

Malinda Rose, daughter of Samuel Rose, born ca 1837-1838, Ohio, died June 1911 (obit., 6 June 1911, Ottumwa Courier issue of 6 June 1911), at Gilbert's Rest, So. Market St., Ottumwa, Iowa, (Civil War file of brother George Arthur Rose); (Cemetery records indicate she died at "Gilbert Chop House."

She married 21 January 1858, Van Buren County, Iowa VR, Enoch Blackledge (Mar. Bk C p. 109). They were married at the house of Samuel Blackledge by Lewis Janney?, Minister. According to Civil War pension file of her brother, Malinda left her husband and later lived with a "colored" man named [George?] Hatter, and then with a colored man named — Crutchfield. Whether there was a formal separation or not is not known, but she is buried under the name of Mrs. Malinda Rose.

From Roster and Record of Iowa Soldiers in Miscellaneous Organizations of the Mexican War, Indian Campaigns, War of the Rebellion and the Spanish-American and Phillipine Wars, Vol. VI Misc., (Des Moine, 1911):

p. 233: Co. B, Enoch Blackledge, res. Mount Sterling, native of Ohio, enl. Oct. 11, 1862, muster out Oct. 23, 1862 p. 234: Co. B, David Simmons, res. Vernon, native of Ohio, enl. Oct. 11, 1862, muster out Oct. 25, 1862. However, no pension for Civil War is listed under the name of Enoch Blacklege. It is possible that the David Simmons listed is his brother-in-law.

Her obituary was published in the Ottumwa Courier of 6 June 1911:

The funeral services over the remains of Mrs. Malinda Rose, who passed away at the Ottumwa hospital Saturday afternoon, will be held tomorrow morning at 9 o'clock from the Daggett undertaking parlors. Interment will be made in the Ottumwa cemetery.

Her death certificate shows:

Wapello Co., Iowa., Center twp., Ottumwa, MALINDA ROSE, Ottumwa Hospital, female, white, birth (blank), age 67, widowed, b. Ky., father: don't know; mother: don't know; birthplace of father and mother: don't know; occupation "worked around Restaurant," informant: Mrs. Southerland, Fort Madison, Ia., burial Owwumwa, Ia., undertaker: F. Daggett, Ottumwa, died of general debility.

A letter received from the Ottumwa Public library to the present compiler dated 11 January 1993 states that she was buried in the County Lot of the Ottumwa Cemetery. They also state that in the information at the cemetery they said it was unknown who her parents were but that she was born in Kentucky and that she was 67 at time of death. Her place of residence was listed as the Gilbert Chop House.

George Arthur Rose, son of Samuel Rose, born ca 1845, Hamilton County, Ohio (C.W. file), died 31 October 1903.

It is said in affidavits in the Civil War pension file that he married first to a woman named Katie. However, there is no supporting evidence. It is noted that his marriage in Kentucky (see later) indicates that it is a second marriage, and thus seems to discount that there were three marriages.

He married, evidently 1st as above discussed, 19 May 1872, Sullivan County, Missouri VR (see also Civil War pension file), married by P. M. Blythe, M.G., Sarah M. Baker, born 12 March 1861, Putnam County, Missouri (Civil War file), married 2nd, 8 September 1900, Owen County, Kentucky VR, Mary E. Jones, widow of Fountain F. Jones. The marriage application shows A. G. Rose, residence Owenton, Ky., age 48, 2nd marriage, blacksmith, born Fleming County, Kentucky (sic), father born Virginia, mother born Covington, Kentucky, bride Mary E. Jones, residence Owenton, Kentucky, age 46, 2nd marriage. It was signed by A. G. Rose and witnessed by Jno. W. Turner, D.C. The certificate shows solemnized at the residence of the bride in Owen County, and witnessed by Eugene Salin? and Mrs. Jesse C. Caldwell, sol. by Jesse C. Caldwell. The last two wives both made application for pension, Sarah made affidavit 11 May 1917 and states there was no divorce. After the death of Arthur Rose, Mary married Winnford Jackson.

Sarah M. Baker, the first wife of George Arthur Rose, married 21 July 1880, George W. Murray who died 10 September 1897. She married 3rd, 18 November 1908, Henry C. Rutherford (Civil War pension file of Arthur Rose).

The military file of Arthur Rose states he was born in Hamilton, Ohio, age 18, enlisted July 26, 1862, etc. He served at the battles of Port Gibson, siege of Vicksburg, Miss., siege of Jackson, Winchester, Fishers Hill, Va. etc.

There are files for Arthur Rose concerning his Civil War Union pension under the names of Arthur Rose, and George A. Rose. These are lengthy files because there were two widows claiming under his service.

Jacket: ARTHUR ROSE, alias George A. Rose, widow Mary E., contest widow Sarah M. Co. D 22 Iowa Inf. Invalid f/1890, a/757403, Ky. widow f/1904, a/807957, Ky. Contest widow f/1917, a/1103439, Mo.

Affidavit: Johnson Co., Mo., 11 May 1917, Sarah M. Rose, born Mar. 12, 1861 at Putnam Co., Mo., widow of George Arthur Rose, who enlisted in Iowa under the name of George Arthur Rose as Priv., Co. C 22nd Iowa Inf., that she married May 19, 1872 under the name of Sarah M. Baker at Sullivan Co., Mo., that she had not been previously married; that he had not been previously married, that he died Oct. 31, 1903, that she was not divorced from him. Former claim 049564. Signed: Sarah M. Rose, Leeton, Johnson Co., Mo. Wit.: O. E. Ledland, Leeton, Mo., and J. G. Callison Jr., of same.

Affidavit: Johnson Co., Mo., Sarah M. Rose of Leeton, Mo. appoints Frederick A. Fanning of Washington D.C. power of attorney 27 May 1917.

Certified Marriage: 19 May 1872, Arthur Rose and Sarah M. Baker in county of Sullivan, state of Mo., 7 Aug. 1872. Signed: P. M. Blythe, M. G. Filed: Aug. 7, 1872.

Jacket: Born Hamilton, Ohio, age 18, occupation not stated, blue eyes, brown hair, dark complexion, 5' 5", name found only as Arthur Rose. Dated: Apr. 19?, 1898.

Affidavit: Camp near Ste. Genevieve, Mo., Arthur Rose born in Hamilton Co., Chio, aged 18, no occupation listed, volunteered 8 Mar. 1863 for three years. Signed: Arthur (his x mark) Rose. Blue eyes, light hair, dark complexion, 5' 5". [This is the enlistment form.]

Affidavit: In Case of Sarah M. Murray, No. 649465, 28 Jan. 1915, Linn Co., Iowa, C. G. Lanam, I am 42, po Central City, Iowa, farmer, I am not related to claimant, Arthur Rose who is said to have formerly been married to claimant was my uncle, I do not know of any brother or sister of Arthur Rose who is living but Elizabeth or Isabelle Watson of Atchison, Kansas and I just had a letter from her, I do not know of Arthur Rose having any other name, my mother who is dead told of Arthur Rose being in the army and that he deserted and was captured and was to have been shot but was not, I do not know which company or regiment, I do not know where the family was raised and do not know the given name of my? grandfather Rose, but he was in the army. My father is Jacob Lanam and lives in Mt. Sterling, Iowa and that is the only placeI know of the Rose family living. I do not know anything as to who or where he married, etc. I had a couple letters from this claimant but I have not got them now, she said something about being married to Arthur Rose and that she was at our house when I was small and that my mother had told her not to live with him, but did not say why had so advised her. Claimant said she wanted to locate Arthur Rose if she could. Later I saw in the paper that an Arthur Rose was arrested for putting shoddy goods in clothing he was working for the government and I sent her that but I did not know whether he was my uncle or not, that man was in Philadelphia or some other place the name of which I do not recall and he had a contract to furnish clothing to the Government. Signed: C. G. Lanam.

In Case of Sarah M. Murray, 3 Feb. 1915, Jacob Lanam, aged 65, po Mt. Sterling, Iowa, farm work, my first wife was Jennie Rose and a sister of Arthur Rose, formerly the husband of this claimant, my first acquaintenance with my wife Jennie's family was about 1867, the father I never knew as he was killed in the army, the mother Mary Rose lived in this town, the children were Arthur, Charles, Albert, Louisa, who was called "Sissie," Malinda and Jennie. There were two other girls, Mattie Kelley and Belle Watson that I did not know. Charles died and is buried out here and so is Malissa. "She & not Louisa was called "Sissie." I heard Albert was dead. I got the information about a year ago from a man by name of Parker whose sister Jennie was married to Albert Rose. Parker lived at Mendota, Mo. or some place out west on this rail road line. Louisa died and never married. Malinda married a man by name of Blackledge at Keosangua, Iowa and they parted and she went to Ottumwa, Iowa and I have not heard of her for 30 years. Blackledge is also dead. My wife Jennie is dead. When I first knew the Rose family Arthur was here living with his mother, he first married in Ill. to a girl he called "Katie." That was shortly after I met him. I only saw her once. I reckon they remained here a month or six weeks and then they went away but where I do not know. I was then married to Jennie Rose but we were living at Ottumwa, Iowa. Arthur Rose did not go to Ottumwa while I was there but after I left there in 1872 he went there and staid near a year. I next saw Arthur Rose at Bloomfield, Iowa perhaps two or three years after he and Katie were here. I was living at Bloomfield and it was after I left Ottumwa in 1872. He said he was going back to where his wife was but did not say where. I did not see him again until 1885 when he came here and remained with his mother two or three months. He and I had had trouble and we barely spoke. I have not seen him since and never heard from him only two years ago I heard through somebody here in town that he was dead, somebody said he saw it in the paper but could not find the paper but think it was said he had died some place in Mo. His folks said he was married twice, I think they said he married a girl by the name of Lizzie or some such name but I am not sure of the name. [Here he is asked if he was Sarah.] Yes, I believe it was since you mention that name. It is about 40 or 41 years ago that I heard of his having the second wife. It was said that he and Katie parted and the old lady Rose said Katie and Arthur were divorced. I never knew Arthur Rose as George Arthur Rose. I never knew Arthur Rose to work as a blacksmith but heard it said he did. I do not know whether he was in the army. He and I had trouble about 1867 shortly after I married his sister and we did not associate much. Signed: 3 Feb. 1915, Jake Lanam.

[There are papers in the file showing that the Commissioner of Pension attempted to locate a divorce record at Van Buren Co., Iowa, Henry Co., Iowa, Monroe Co., Iowa with no success.]

Letter: Des Moines, Iowa Mar. 4, 1915 to Commissioner of Pensions by Special Examiner. He states he personally examined records at Ottumwa, Wapello County for a marriage or divorce and found none. Says Malinda who lived in Ottumwa is reported by the postmaster to be dead. I have been holding up the case in an endeavor to locate Alfred Rose but am unable to do so. The postmaster at Mendota, Mo. said he was at Great Bend, Kans. a year ago but the postmaster there reports he is not known there. The Mendota, Mo. postmaster states that Charley Rose, son of Alfred is a street car motorman in Kansas City, Mo. (?) [the question

mark in the record] and may know where his father is. Mrs. Laura Hollingshead is a niece of Arthur Rose who is said tohave been old enough to know about the first marriage of Arthur Rose, her address as furnished is 2200 Dexter St., Denver, Colo. I recommend that the papers in Case No. 807,959, Mary E. Rose, as widow of Arthur Rose alias George A. Rose, be drawn and considered with this case. It is possible that the testimony will show whether Rose was married prior to his marriage with this claimant, etc.

Letter: Des Moines, Iowa Feb. 8, 1915 to Postmaster of Ottumwa, Iowa by Special Examiner, seekingMalinda Rose married a man by name of Blackledge at or near Mt.Sterling, Van Buren County and separated and is said to have gone to Ottumwa and to have lived as wife of a colored man by name of Hatter, also to have lived as the wife of a colored man by name of Crutchfield, she is white, if now living is probably 65 and possibly older, she is said to have been living in Ottumwa some two to four years ago, request that you have the matter called to the attention of your carriers, etc.

Letter: Ottumwa, Iowa Feb. 12, 1915 to Special Agent J. J. Horrigan, Des Moines, Iowa, Malinda Rose, find she died at the Gilbert Rest. on South Market St. about three years ago. She has a daughter by the name of Mrs. Ed. Southerland living in Ft. Madison, Iowa or Mt. Pleasant, Iowa.

Letter: Cincinnati, Ohio Sept. 15, 1915, from Dept. of Interior, Bureau of pensions, On Sept. 9 I visited Owenton, Ky., searched court and marriage records and canvassed the town for information, learned from marriage record that A. G. Rose, residing in Owenton, Ky. age 48, blacksmith, born in Fleming Co., Ky., whose father was b. in Va., and whose mother was b. in Covington, Ky., and Mary E. Jones, residing in Owenton, Ky., were married Sept. 8, 1900, and the marriage was second for each. No other entry for Arthur Rose or George Rose, or a man with initial A. or G. appears as far back as 1880, but the description of the groom in the above does not read like George A. alias Arthur Rose. I made acopy (by imitating) of the signature [included]. Several residents of Owenton remember he was resident for but a brief period, that scon after going to that town he married the "Widow Jones," that within a few more weeks he left her and the community since which time none of them has known anything concerning him. One of the men was at the marriage, he has known of Mrs. Jones since, and knows that now she is the wife of Winford Jackson, see report #5. I did not find an individual who knew Rose before he went to Owenton in 1900. There is a family of Roses in Hesler (Owen County) some of whom are blacksmiths, I conversed with the oldest, who is nearly 50 years old, and he stated to me that he has not known of this Arthur or George Rose, and he did not know the A. G. Rose who married the Widow Jones, etc. Signed: N.? -? Avis, Special Examiner. [There is a handwritten note here "Newspaper April 2, 1911, Alburnett, Ia. Arthur's arest."

Declaration: Powell Co., Ky., 22 Apr. 1895, Arthur Rose, aged 51, enrolled as Priv. 26 July 1862 Co. D 22d Reg. Iowa Vols., Capt. Wilson, discharged at Savannah, Ga. 25 July 1865, is 5' 9", dark compl., dark hair, blue eyes, gives disability. Appoints R. C. Kimbrell of Clay City, Ky. power of attorney. His po is Clay City. Signed: Arthur Rose. Wit.: J. M. Kinnon, Joe Williams.

Affidavit of Adjutant General of Iowa, 2 Feb. 1915, in case of Sarah M. Murray, states he has examined rolls, roords show "Arthur Rose, age 18 years, Residence, Albia, Iowa, Nativity Ohio, enlisted July 26-1862 in Co. D 22 Iowa Inf" etc., rolls do not show any other person by name of Arthur Rose during Civil War.

Letter: Bureau of Pensions, Kansas City, Mo., Dec. 10, 1914 to Postmaster of Atchison, Kans., wish to interview Mrs. Isabell Watson, address in 1911 was 1201 North 4th St., asks for information on whereabouts.

Letter: Bureau of Pensions, Des Moines, Iowa Feb. 8, 1915, Special Examiner, to Mrs. Roland, Milton, Iowa, Martha Rose who lived at Mt. Sterling many years ago had a daughter whose name is probably Laura Hollingshead and a son who is said to have been called Jack, if you knew Martha Rose it was probably as Mrs. Martha Simmons, I am told you likely have the present name and address of Laura Hollingshead and possibly Jack, etc. At bottom: Mrs. Laura Hollingshead, 2200 Dexter St., Denver, Colo.

Kansas City, Mo. Mar. 23, 1915, Commissioner of Pensions, return papers in claim of Sarah M. Murray, widow of George W. Murray, K 5th Priv. En. Mo. Mil., claimants po Lecton?, Johnson Co., Mo., she has resumed marital relations, [difficult to read], mentions Charles T. Rose deposition but he is a young man only 24 years of age, states his father and mother separated when he was 12 and that his father Alfred Rose died about eight years ago, thought his mother Mrs. Jennie V. Roberts might throw some light on the question, etc.

Bureau of Pensions, Des Moines, Iowa Feb. 9, 1915, Special Examiner to Postmaster, Mendota, Mo., several years ago there lived at Mendota a man by name of Downey Parker who was weighmaster at the coal mine, his daughter Jennie Parker married Alfred Rose whom I desire to locate, if Downey is still living please inquire to him of the po of Alfred Rose or his widow if he is dead, etc. Reply at bottom: I have seen Downey Parker and he states that about a year ago Alfred was living in Great Bend, Kans. Understand Alfred has a son by name of Charley living in Knasas City, employment there as a motorman on the street railway.

Examiner's Notes: Shows George W. Murray m. Sarah M. Baker (Rose) July 21, 1880, and lived with him until his death Sept. 10, 1907. Sarah m. Murray, 1st marriage Arthur Rose May 19, 1872, separated, she m. 3rd Henry C. Rutherford Nov. 18, 1908, marriage annulled Apr. 11, 1911, Johnson Co., Mo. Was pensioned as Murray's widow, and dropped on her marriage to Rutherford. Now seeks restoration as the soldier (Murray's) widow, her marriage to Rose standing in the way.

Affidavit: Jennie Roberts, Oakland, Iowa, says she never met Arthur Rose, knows nothing of him whatsoever. Were told by his mother long deceased that she did have a son Arther but we know nothing of him.

Affidavit: 4 Feb. 1915, Farmington, Van Buren co., Iowa, before J. J. Horrigan, Special Examiner, came Martha M. Vincent, aged 64, po Farmington, hotel keeper, widow of S. E. Vincent, I knew Rose family

who lived at Mt. Sterling, Iowa, moved there soon before the war closed, married in January and peace declared following summer, etc., as I recall Arthur Rose was not with his mother at the time I became acquainted with her, but later he came home on a visitand brought a woman he called his wife, she had red hair, not long with his mother but went to Pleasant Hill across the river, etc. Signed: M. M. Vincent.

Deposition: 4 Feb. 1915, Elizabeth Miller, at Mt. Sterling, Van Buren Co., Iowa, am 73, po Mt. Sterling, widow of John Miller, not related to claimant, knew Samuel Rose and heard him preach many a time, prior to the time of the civil War, do not remember what became of him, Arthur Rose lived here with his parents and I think he served in the army, my daughter who lives with me will be 47 in April next, prior to that time Arthur Rose came to our house, that is, before daughter was born, and he had a woman he called his wife but people did not believe they were married, do not recall her name, etc. Signed: Elizabeth A. Miller.

Letter: Nov. 26?, 1921 to Mr. A--, House of Representatives, in matter of Sarah M., widow of George A. Rose, you are advised that this claim for pension was rejected on the ground that claimant has been guilty of open and notorious adulterous cohabitation since the soldier's death and since the passage of the act of Aug. 7, 1882 and thereby forfeited her right to pension as widow of Mr. Rose for all time.

Letter: Apr. 10, 1925 to Mr. C. E. Lindsey, Leaton, Mo., claim rejected upon the ground that claimant was never the lawful widow of the soldier, George W. Murray for the reason that at the time of her attempted ceremonial marriage with said Murray she was the lawful wife of George Arthur Rose.

Letter: Sept. 26, 1917, to Mrs. Sarah Rose, Leeton, Mo., pension rejected on ground that you have been guilty of open and notorious adulterous cohabitation since the soldier's death, etc.

Deposition: 4 Feb. 1915, Mt. Sterling, Van Buren Co., Iowa, Wm. M. Tharp, aged 74, po Mt. Sterling, not related to claimant, knew Rose family, they came here about 1854 or 1855, later to the central part of this county and later to Albia, Iowa and later the family, except the father, came back here. I do not recall the name of the father. He was a blacksmith and I was in his shop many a time. He preached some also. I understood he went into the army. I do not know whether Arthur Rose went into the army, he was a little younger than I. Malinda Rose married a man by the name of Blackledge lived out here in the country for some years but they separated and the last I heard of her was a couple of years ago when she was said to have been in Ottumwa, Iowa as the wife of a colored man, once she lived there as the wife of a colored man by the name of - Hatter, perhaps George Hatter, and I was at their house. Alfred Rose came back here with his mother and lived a number of years and married a girl known by the name of Parker, Jennie, there was a rumor that Alfred Rose was killed, someone saw in the paper that a man by name of "A. Rose" was killed, but there was nothing to identify the man as Alfred. Downey Parker, Mendota, Mo. who is the father in law of Al. Rose may be able to give information, etc.

Deposition: 18 Mar. 1915, Kansas City, Jackson Co, Mo., Charles T. Rose, aged 24, motorman, address 4611 Forest Ave., Kansas City, Mo., do not know the claimant, I am son of Alfred Rose, do not know where my father is if living, he is believed to be dead, we got word that he died at Mt. Sterling, Iowa about eight or nine years ago, he and my mother separated when I was about twelve years of age and I never saw my father after he and my mother separated, we were living in Washington, Iowa when they separated, my mother has remarried, she married a man by the name of J. V. Roberts, my mothers name is Jennie Roberts, they are at present at Oakland, Iowa, my stepfather is a traveling salesman for the Ohio Oil Co., Cleveland, Ohio and my mother travels with him a great deal, I remember hearing my parents speak of Arthur Rose but I was too young to remember anything, I have no brothers, have two sisters, my oldest sister is named Mary Elana? Rose, she has been married and divorced and is off some where at school, this sister is two years older than I am, my other sister is Annie May Rose, is is twenty, the last time I heard from her she was in Wichita, Kans. but I am sure that neither of my sisters would know any more about uncle Arthur than I do. Signed: C. T. Rose, Deponent.

From the file under the name of George A. and George Arthur Rose:

Jacket: GEORGE A. ROSE; GEORGE ARTHUR ROSE. Co. D 22nd Reg. Iowa Vols.

Form: Alleged that George A. Rose enlisted May 1862 as Priv. in Co. D 22nd Reg. Iowa Inf., discharged at Davenport, Iowa 1865, that while on duty at Mustang Island, Tex. disabled by diarrhea and etc., in 1864.

Affidavit: Powell Co., Ky. 22 Apr. 1895, Arthur Rose, aged 51, identical Arthur Rose who enlisted as Priv. 26 July 1862, Co. D 22nd Reg. Iowa Vols., discharged Savannah, Ga. 25 July 1865, is 51, 5' 9", dark complexion, dark hair, blue eyes, gives disabilities, etc. Signed: Arthur Rose. Wit.: J. M. Kennon, Joe Williams. Residence of claimant is Clay City, Powell Co., Ky.

Affidavit: Fleming Co., Ky., 15 Feb. 1890, George Rose, aged 44, resident of Hillsboro, Co. of Fleming, Ky., gives enlistment, description and disabilities, never treated in hospital. Since service has resided in Iowa, Missouri and Myers? in state of Ky., blacksmith, is partly disabled. Gives power of attorney to Hubbard & Case, Albany, Mo. Signed: George Arthur Rose. Wit.: E. R. Cumings, P--? Cull?

Affidavit: Fleming Co., Ky., 10 July 1890, George Rose, aged 44, Priv., etc., po is Hillsborough, Fleming Co., Ky. Signed: George Arthur Rose. Wit.: J. P. Huff, David R. Nealis. Dated: 10 July 1890.

Affidavit: Fleming Co., Ky., Affidavit of Mrs. Mary Rose states that she is wife of George A. Rose "now of Columbus, Ohio," that said George A. Rose had no opportunity to appear before the board of Medical Examiner at Flemingsburg, Fleming Co., Ky. within the time prescribed in the order, she therefore prays that he be granted an order from your department to be examined at Columbus, Ohio. Signed: Mary (her x mark) Rose. Wit.: J. W. Crain. 18 Feb. 1891.



Affidavit: Ohio [blank county], George Rose alias Arthur Rose, no [blank] of [blank] 1891, that I am claimant etc., unable to comply with the order for my examination before the Medical Board at Flemingsburg, Fleming Co., Ky. dated Aug. 23/90 for the reason "I cood Not goe befor the Medical Board at Fleming burg Co Ky —-? be?case I wase in olvio? and got in this trobel over at Chelele? and got in jale that it is the resent I did not Complye —-?" Signed: A. Rose.

Prays that order be given for an examination before the Board of Medical Examiners at Columbus, Ohio My present place of residence.

Copy of Marriage Certificate: Certify that on 8 Sept. 1900, rites of matrimony legally solemnized between A. G. Rose and Mary E. Jones at residence [something missing in the paper fold] and state of Ky. [probably says Owen County] in presence of Eugene S-- and Mrs. Jesse C. Caldwell. Signed: Jesse C. Caldwell.

Affidavit: Owen Co., Ky. 3 June 1904, Mary E. Rose aged 52?, resident of Town of Sparta, Ky., widow of George Arthur Rose who enlisted etc., she married under the name of Mary E. Jones to A. G. Rose 8 Sept. 1900 by Rev. Jesse Caldwell at Owenton, Ky., claimant married Fountain? F. Jones who died more than 8 years before, says of Rose he ws never married but the one time. She has not remarried since his death. No children under 16 listed, says never had children, but it is unclear if she means him or her. Signed: Mary (her x mark) Rose, her po Sparta, Gallatin Co., Ky. She appoints Geo. Welby Van Pelt at Vevay, Indiana power of attorney.

Affidavit: Owen Co., Ky., 29 Mar.? 1905, Mary E. Rose, resident of Sparta, Co. of Gallatin, Ky., aged 53, widow of George Arthur Rose, who enlisted Monroe Co., Iowa etc., he died at Springfield, Indiana 31 Oct. 1903, she married him at Owen Co., Ky. 8 Sept. 1900, her name was Mary E. Jones, that she remains a widow, that she has no children, that her husband left no minor children by a former marriage. Her po Sparta, Gallatin Co., Ky. signed: Mary E. (her x mark) Rose. Wit.: J.? D. Lillord?, T. A. Perry.

It seems clear that Arthur Rose while living in Kentucky was hiding some of the facts relating to his previous life. For what reason is not known.

William Rose, son of Samuel Rose, born ca 1847, Ohio.

From his pension file (which was rejected), he served in the Civil War, enlisted from Albia, Monroe Co., Iowa, as Private Co. K 36th Iowa inf., discharged 25 May 1864. In his Certificate of Disability for Discharge it shows that he served under Lt. W. H. Cliftins?, registered at Troy, Iowa 1 February 1864 to serve three years, was born in Hamilton County, Ohio, was 17, 5 ft. 1 1/2 inches, fair complexion, blue eyes, light hair, when enlisted a farmer. States he was but fifteen years of age, and received \$5 from an officer to swear he was 17. Has

been unfit for duty, hospitalized, and discharged 25 May 1864 when a surgeon signed a certificate. The last record is 23 July 1864 when it is stated that he was discharged for hyperthropy and vascular disease of the heart, and was totally incapacitated.

From his military file, it is states that he was born in Hamilton, Ohio, farmer, enlisted February 1, 1864 at Albia, Iowa, was aged 17, etc. In his Volunteer Enlistment it shows he was of town of Troy? (or Gray?), Iowa, born in Hamilton County, Ohio, etc. The Declaration of Recruit states he is 17, signed by him, and also signed by Mary Ann Rose who states she is the mother of William Rose, and that he is 17. She signed by an x mark 1 February 1864.

Jane "Jennie" Rose, daughter of Samuel Rose, born ca 1849, Iowa. It would seem that she is the Jennie who married, license 8 November 1865, Monroe County, Iowa VR, Charles Lee (Mar. Bk 2 p. 159). Yet, affidavits in the Civil War file of Arthur Rose indicate she married Jacob Lanam. [Her first name may have been Virginia since Jane and Jennie are both nicknames for Virginia.]

Children: unknown.

Alfred Henry Rose, son of Samuel Rose, born 3 October 1855, Lee County, Iowa (father's C.W. pension file), said to have died at Mt. Sterling, Iowa, perhaps ca 1907 (Civil War file of Arthur Rose, from affidavit of Alfred's son Charles T. Rose). There is a Certificate of Death of an Al Rose, male, died 23 June 1911, Keckuk, Keckuk County, Iowa, aged 53 at time of death, filed June 1911, died of heart disease (Bk 2 p. 98). It is possible this is the same person.

He married, 21 May 1883, Van Buren County, Iowa VR, Elnora Jane

Parker (the record shows he was 28, white, born Iowa, restaurant
keeper, father: Sam'l Rose, mother Mary E. Blumin, his 1st marriage,
also shows that wife was 24, daughter of Downey Parker and L. C. Grubb,
1st marriage.) She was born 27 September 1859, Greensburg, Indiana,
died 11 January 1926, Independence, Missouri (James T. Rose records).
She married 1st, 20 November 1876, Decatur County, Indiana, John Whittaker, from whom she was divorced. After the death of her second husband Alfred Henry Rose she married 3rd, W. P. Ratherford. She evidently
married 4th, or somewhere in between the above, to J. V. Roberts (affidavit of her son in 1915, Civil War pension file of Arthur Rose).


