The residue of my Estate Real and personal of every Kind I Give and bequeath unto my beloved Wife MARGARET SINCLAIR, to have and to hold the Same for her proper use and Support during the term of her natural life or widowhood, and at her death or on her again marrying then I Give and bequeath the Said residue of my Estate Real & Personal of every Kind to my relatives next of Kin, to have and to hold the Same to them and their heirs forever. First, I recommend my soul to God who gave it; my body I desire to be decently buried and, after my just debts are paid. I

dispose of my worldly estate as follows, that is to say:

First, it is my will and desire that my beloved wife, Mary, have and enjoy all my estate not heretofore given and bequeathed during her natural life, and at her death to be equally divided among my children. That is to say, my son John Sinclair, Thomas Sinclair, Mary Snelling my daughter, and Susannah Brown, and I give and bequeath the same to them and their heirs forever.

Secondly, I give to my grandson, Amos Sinclair, son of Thomas Sinclair a bay mare or the value thereof at my wife's death. And it is my will that Mary Snelling, my daughter, should receive so much of my estate so as to make her up or near with Susannah Brown, my daughter, who has received to the value of fifty pounds in land and then my estate to be equally divided among the whole at my wife's death.

Lastly, I ordain and appoint my son, Thomas Sinclair, my executor to this my last Will and Testament, whereof I have hereunto set my hand and seal this sixteenth day of July 1813. Signed sealed and acknowledged

Note: This Sarah migrated with her family to Warren County, Kentucky by 1810. According to marriage records, there were two daughters: Sarah Sinkler who married William Hill and Ann Sinkler who married Tilman Melton.

A descendant of this line wrote that there was another daughter. Elizabeth. I have no documentation of this, but the 1790 Census for Pendleton District, S.C. does show four females which would indicate a third daughter.

I have wondered if this Charles Sinkler, Sr. could be the son of Charles of Sinclair Bottom, Virginia. In addition to this Charles, the 1790 Census of Pendleton District, S.C. also lists a Robert and an Alexander - also names of sons of Charles of Sinclair Bottom.

In the Name of God amen, I CHARLES SINKLER of the County of Orange and province of North Carolina. (Farmer) being very sick and weak of body, but of perfect mind sound memory, Thanks be given to God. Calling to mind the mortality to die and after death to come to judgment. Do make and ordain this last will and testament, that is to say that principally and first of all, I give and recommend my soul unto the hands of Almighty God, that gave it me and my body. recommend unto the Earth to be buried in a decent manner at the discretion of my Executor. Nothing doubting but that at the General Resurrection I shall receive the same again by the mighty Power of God, and as trusting such worldly estate, wherewith it hath pleased God to bless me in this life, I give divise and dispose of the same in the following manner and form. First I give and bequeath a certain tract or parcel of land lying in Augusta County in Virginia or being situated on the South Fork of the Holston River - otherwise called Indian River, containing nine hundred and sixty acres to be equally divided among all my children BEING SEVEN IN NUMBER and if they cannot agree amongst themselves to be divided by lots and if any of them should die before they come of age to inheret land their part to be equally divided among the living. Also, I leave to ANN SINKLER my beloved wife, a certain improvement or tract of land lying in the County and Colony of, aforesaid lying and being situated on Reed Creek, a branch of New River which I allow to be pattoned by my Executors out of my personal estate for the use and support of my wife during her natural life or after her decease to descend to my youngest child then living -- I likewise leave the improvement I now live on to be sold by my executor and the money to go to my wife, for to support her and my children. Also I give and bequeath unto my well beloved dauthter, CATHERINE, one sorrel mair five years old. Also I leave unto my beloved wife two work horses and what other horses and cattle she may think proper to keep for the support of her and my children and the remainder to be sold at Vended(?) and the money to go to educate the children as they grow of age as my wife thinks proper and according as she is able to spare. I also order my beloved son CHARLES be put to school for two years and the cost of his schooling to be paid out of Personal Estate, the Remainder of my Personal Estate as before mentioned, I leave to my beloved wife to support her and raise my children, During her Natural Life or Widowhood and after her decease or marriage, what is left, to be equally divided amongst all my children. I do likewise Constitute make and Ordain my trusty and well beloved friend JOHN BUCHANON of Augusta County in Virginia with my Beloved Wife, my Executor of this last Will and Testament to settle my affairs in that Province or Colony. and I do also Constitute Appoint and Ordain, my trusty friend AMOSS EVANS with my Beloved Wife my Executor to settle my affairs in this province & I do hereby whooly Disallow revoke and disannul all and every other found testament wills and legacies bequests and Executors in any wise before named Willed and Bequested.

Be it Remembered that on the Twenty third day of September 1800 a lapins and Referendum was issued Commanding the Sheriff of KNOX COUNTY to take the Body of Felix Gilbert TO ANSWER Charles Sinclair a minor who sues by JOHN SINCLAIR HIS FATHER and next friend of a plea of Tran from the Court his damage Two Thousand Dollars.

And now at this day to wit at a Court held by the Justices of the Court of Pleas and Qualor Sopians for the County of Knox at the Court house in Knoxville on the second Monday of October one thousand eight hundred comes the Plaintiff by JOHN SINCLAIR his father and next friend by High L. White his attorney and filed his Declaration in the following words to wit (see file for Declaration). Wherefore the Bail of the Defendent produced him in Court the Body of this principal and surrendered him according to their Undertaking and therefore are discharged from their Bond in this Suit. And thereupon Marmaduke Bookout and James Robertson of this County comes into Court and undertakes for the Defendant that in case he shall be cost in this Suit he shall satisfy and pay the condemnation or render his body to prison in Execution for the same, or that they the said Marmaduke Bookout and James Robertson will do it for him.

And now at this day to wit at a Court held by the Justices aforesaid for the County aforesaid on the second Monday of January 1801 the Defendant having had time to respond and the Plaintiff by John Sinclair his father and next friend Hugh L. White his Attorney as the Defendant by Davy W. Brazeale his Attorney and by their consent the matters in difference between them in this suit is referred to the final determination of William Webb, Joel Herrick, Jonathan Robins, Hugh Mills, John R----, Simon Shinrock, Tipton William, Henry Williams, Lemarr Mathews Smith, J Andover, Paul Harriman and John Parks, and their award or their award of such person as they shall choose for an umpire thereupon is to be made the Judgment of the Court, and the same is ordered accordingly.

And now at this day to Wit at a Court held by the Justices aforesaid for the County aforesaid on the Second Monday of April 1801 come the parties aforesaid by their attorneys aforesaid and the Arbitrators to whom the determination of the matters in difference between the parties were submitted returned their award in the Words to Wit - "We the Jury find for the Plaintiff Ten Cents with all costs;

given under our Hands this the 24 day of January 1801 by a Majority JOHN PARKS, WM. The list came from a family group sheet filed in the LDS records in Salt Lake City, Utah by Mary Edna Mattox Melvin who is now deceased. "My grandfather and one of his brothers came from Scotland to America about the year 1760. They remained in New York for some time. My granduncle remained in New York, of his descendants I know nothing. My grandfather Duncan St. Clair (wrote his name Sinclair) came to Pennsylvania, where he married Mary Fulton a sister of Robert Fulton the inventor of the first steamboat. He afterwards removed to the Carolinas lived both in North and South Carolina, when war between England and the American Colonies broke out He promptly entered the patriot army and served through the war. I have in my possession his honorable discharge, written one hundred and twelve years ago. My father Rev. Dr. Elias St. Clair, thought we were descended from Sir John St. Clair the Companions of Bruce and Wallace.

I was born at Rockingham, North Carolina. My father was born in York District South Carolina. My uncles all raised large families. They lived in North and South Carolinas, Virginia, Alabama, Georgia, and Louisiana. Mrs. E. E. St. Clair of Tuskogee Ala. and Thomas St. Clair of Meridian, Mississippi are members. (of whom see later).

I have misplaced my file on Alex. St. Clair. I decided to go ahead and list him in this quarterly so I can number a file folder and ensure that I will have a place to put the records when I do find them. I have spent very little time on this branch as the descendants in Preston County, VA apparently have done a magnificient job of recording their family's history.

My main concern is to clarify the tremendous amount of land in Kentucky records. Alexander was apparently a land speculator and had agents go to Kentucky and file for land in his name. This land was mostly in Jefferson, Nelson, and Taylor Counties, KY. There was a court suit regarding this land and many documents are in Taylor County Court records. It was proven that Alexander was not and had never been a resident which was a requirement for getting land and he apparently lost most of the land that he had not already sold off.

Alex St. Clair did provide goods for the Revolutionary soldiers and therefore his descendants can file for membership in D.A.R. and S.A.R.

I am including in this quarterly letters which were written by Alex St. Clair to relatives in Ireland as they will be of help to the relatives who came later at Alex's urging.

As soon as I locate the lost records, I will include them in the next SINKLER-SINCLAIR-ST. CLAIR UPDATE.

TAZWELL, VA.-Among the papers of Miss Mamie St.Clair, whose death occurred recently, were two letters which no doubt played a part in the immigration from Ireland of members of the St.Clair family. The descendents have contributed in many ways to the development of Southwest Virginia, to its business and professional life and particularly to Tazewell County.

The letters were written in 1784 & 1788 by Alexander St. Clair, a merchant of Staunton, Va., and discuss the opportunities with his nephew, Alexander St. Clair of Belfast, Ireland. The letters to Alex of Belfast did not result in his coming to America, But like "bread cast upon the water" did bring several of his sons.

His oldest son, also Alex entered the mercantile business in his home city of Belfast, and as he accumulated money sent a brother to this country. After the others had reached these shores and established themselves he, in 1783, followed choosing to locate in Wytheville. A brother, James, was already there.

OPENS STORE

He opened a store and in a few years married Miss Martha Tabler. They moved to Tazewell in 1840 where he continued operation of a store until 1853 when he purchased the David Whitley farm and grist mill at North Tazewell. Four of their six children lived to adulthood. Among these were Elizabeth, who married Capt. C. A. Fudge, and continued her residence in the Whitley stone residence built in 1800. Rose Married George Spotts, owner of the fine farm adjacent to the town of Tazewell.

John C., father of Miss Mamie, was a farmer in Witten Valley and occupied the brick home "Battlemont" built in 1838 by Thomas Witten III, now owned by his son, Fred W. John W. operated an insurance agency in

Tazewell until his retirement. Alex engaged in coal mining.

The elder son of Alexander St. Clair, the emigrant, was Alexander, who married Mariah Jane Tiffany and they resided in the old brick home of her father on Bluestone. Their eight sons were all men of prominence in the area.

SANITARIUM FOUNDERS

Dr. Wade H. St. Clair in partnership with Dr. Fox, founded the Bluefield Sanitarium which has expanded to include the Stevens Clinic at Welch, W. Va., and the Clinch Valley Clinic Hospital at Richlands. He is one of the outstanding surgeons of the Virginia-West Virginia area. His son, Wade Hampton, Jr. has inherited much of the skill of his father, and the two work as a team in performing the more delicate operations. His son, Alexander was rising to iminence in the profession when lost on a military mission in the Orient in World War II.

Dr. Charles T. St. Clair specialized in ear, nose and throat diseases, whose eminence in the field was widely recognized. His son, Charles T. Jr., worked with his father until death dissolved the partnership, and is continuing the practice.

Rob Roy is a pharmacist located in Welch.

Otis, for a number of years a practicing attorney in Welch, became Judge St. Clair as a result of the November election in McDowell County.

John, Frank T. and Alexander held to the vocation of farming and possess a large acreage of Tazewell bluegrass pasture land, at St. Clair.

Glen Moore St. Clair chose banking for his career and was cashier of the Bank of Clinch Valley and after the merger with the Farmer's Bank of Tazewell held his post with the Farmer's Bank of Clinch Valley until his

George W. St. Clair, grandson of James, came to Tazewell and opened a law office and gained prominence in the profession in partnership with a Mr. Richter of Pennsylvania. They opened the Jewell Ridge Coal properties near Richlands, one of the prosperous operations of the area. His son, Dr. Huston St. Clair, is now president and head of the enterprise which he has expanded to include West Virginia and Kentucky plants. He is now exploring coal deposits in Alaska with the view of developing a productive field there.

EXCHANGE OF LETTER The letters follow:

Staunton, Va., July 22nd, 1784 Dear Alek

I received yours of the 25th of April last and have wrote you a few weeks ago, which I doubt not but will receive before this reaches you.

The more I reflect on your situation the more I am of the opinion that a trip to this country is most probably the best thing you can do. You are very young and must be inexperienced in business and in a country that would require experience and greater application to even make barely a subsistence should you then pursue business where you are, your expectations at best cannot be much and without any great degree of imprudence at this inexperienced time of life you might sink the little fortune you have. Therefore should you come here you can only lose that at worst, and if you were a little more experienced in business, and set up in this country, you have in my opinion a chance of making more in three or four years by application than you can make during a lifetime were (sic) you are. I am still in trade here, and if agreeable to you you stay with me till you get a little more acquainted with business. Should you determine on coming out I suppose it will not be before next spring, and woul (sic) be best I think in the early spring.

This much you can rely on, should you conclude on coming to this country, that I will be of every service to you that I can. Though I would not wish to deceive you, to make a fortune in this country requires attention and care, but where there is industry made use of here I think there is a greater probability of succeeding well with you in case you come to America. The only thing in my opinion best for your brothers at present is to be kept in school. By all means let them have a good education as that is absolutely necessary. Let them go to whatever business they may. If they can get some of the languages so much the better, but at any rate, let them learn the more useful branches of the mathematics, and be good English scholars.

Give my best compliments to them pritty (sic) little boys, your brother. Tell them I am proud to hear of their being such good scholars at their age and hope they will continue their attention to their education, for which, if I live, I hope to be able to give them a reward. I am just now going to set off for Cousin Gean, who I hear is safely arrived in Philadelphia. (1784)

God bles (sic) my dear nephew and direct you in what is best. Give my complunents (sic) to all relations you may see, and I am affectionately your friend and humble servant. Alexander St. Clair.

Addressed to Mr. Alexander St. Clair, Merchant, Belfast, Ireland.

LETTER OF 1788 Staunton, Va., Sept. 2nd, 1788.

Dear Alick

Your very much esteemed favour of the 30th of March last I received a few days before, and that of the 20th of May by Cousin James St. Clair, who arrived here the 28th of July in good health, and seems pretty well satisfied with the country.

I am very glad to hear from my relatives whose welfare and happiness will ever constitute no inconsiderable part of my own, particularly to be informed of your prudent conduct and probable success in your business.

About three months ago I opened store again, and finding James's inclination toward merchandise have taken him onto the store with me, from his attention I think he will probably soon make considerable profiency, and be of service to me, for which he shall be rewarded. He appears to be or very agreeable temper and ingenious turn, and I find he has made considerable progress in his learning for which he ought ever to be grateful to you and the rest of his relatives with you, for their care in this particular. As we live in a very healthy part of the country here. I hope it will prove such to Cousin James, but should it turn out otherwise, or his stay here become disagreeable to him, I shall not fail to comply with your request in sending him home.

Trade here is much more dull than formerly owning in some measure perhaps to the want of an effecient government to regulate the commerce of the country, but am in hopes in some time a favorable alternation may take place under our new government, which eleven of the states have now adopted, and the other two eventually must, which gives Congress the power of regulating trade former exercised by the legislature of each state.

We have exceeding fine crops in this country this year, and

consequently provisions are very low.

I should now have wrote to your uncle Mc. Elwrath and others but not knowing with any certainty of an opportunity of sending this, I shall defer writing them until October and if possible forward this knowing of your anxiety to hear from James. There has been no alteration in my family since you heard from us.

Your aunt and cousins all join me in their compliment to you and cousins John with their warmest wishes for your success and happiness.

Please present my compliments to your aunt Barnett and my brothers and sisters, and am with greatest esteem and regard.

June 1991 Quarterly, page 22: We now have proof that JAMES A. ST. CLAIR of LINCOLN COUNTY, TENNESSEE was the son of JOHN THOMAS ST. CLAIR of WILKES COUNTY, NORTH CAROLINA. Please write this information in beside the census record with Family #70 beside it.

We do not know who John Saintclair of Wilkes County, N.C. was. He is noted as being "of Virginia" in the N.C. records. One of his sons, Hiram, was in both Buncombe County, N.C. and in Iredell County, North Carolina. THE PLOT THICKENS!!!!!!! Thomas Crawford Sinclair (Family #17) was in both of those counties. There are probably valuable records in both Buncombe County and Orange County, N.C. that should be "dug out". If any of you have oodles of spare time, think about it.

Since we now have information on JOHN SAINTCLAIR of Wilkes Co. N.C. I have listed him as Family #70 in this issue as there simply isn't enough documentation to place him in Family #1 yet, although I feel there is a very good possibility that John Thomas could be a son of James Sinclair, and grandson of Charles of Sinclair Bottom. Note that the second son is named James Alexander. Scottish tradition is that the first son be named for the mother's father and the second son for the father's father.

"My father was Col. James Alex. St. Clair of Tennessee, but a native of North Carolina, and my grandfather JOHN ST. CLAIR a native of Virginia......

"I was born in East Tennessee July 30, 1830 and recd. an Academic Education. In Jan. 1848 I went to Aberdeen, Miss. to clerk in a dry goods store in which capacity I remained two years, and then went into the Mercantile business for myself. I married Jan. 20, 1853 and in Jan. 1854 I moved to Texas, where my father and family had preceded me. Before the war I lived at Austin the Capitol and was Chief Clerk of the Court of Claims of the State of Texas, when the state seceeded.

"When war was declared I was on the staff of Gov. Ed. Clarke and in the summer of 61 accompanied him on an inspection to Galveston and the coast country. We were also accompanied by EARL VAN DOM, then a Colonel in the state Service. He recd. his Commission as Brigadier Genl. while we were at Galveston, and then I was transferred from the staff of the Governor to the staff of the General, with the rank of Major. I soon tired of my position on General Van Dom's staff, and applied for and obtained a Commission as Quartermaster and Commissary of Subsistance, and was stationed at Tyler, Tex. Aug. 1862. Soon after a prison camp was established there and at one time over 8000 Federal prisioners occupied the crowded and packed Stockade. It was difficult at times to feed the numerous prisoners and their guards and the other troops stationed at the Post. owing to the great scarcity of provisions in the Country. However, I saw that the prisoners had the same rations that the soldiers had. including sugar which the Commandant of the Post prohibited, but I ranked him and paid no attention to his order and when he reported me to Genl. Smith, I was sustained and why not for I had more sugar than anything else, for I had all there was in the Trans. Miss. Department, for Genl. Taylor had sent it to me in advance of Banks army, and the battle of Mansfield. For this reason probably and one other, I was appointed by the Federal Commander on his arrival at Tyler, to collect all the abandoned and Stolen C. S. property, and afterwards made an agt. of the Treasury Department to collect and pass out the C.S. cotton. The other reason I may mention was this, When the Camp was first established, or Stockade, it was for officers alone, and the first prisoners brought there were Naval Officers who were well supplied with money. The first order of the Post Commander was to disposite them of their money and valuables, and made me the depository. I protested but was obliged to comply with the order, so far as the money was concerned. Although many thousands of Dollars passed thus through my hands, all but \$20 dollars was restored to the owners and this \$20 was drawn by a forged order. When the Officers were released, and on receiving their money, they held a meeting voting their thanks and tendering me a Souviner of Greenbacks, as bill of each denomination then issued, from 10 cts. up to 100 Dollars. Hence instead of being arrested by the officer in charge of the Federal Troops (Family #70) that first entered Tyler and made inquiries for me, as many supposed to arrest me, I was tendered a Commission, for it was Major Bradenburg, a former Stockade prisoner, a mess mate of Major Anthony, and the former only known to me as "St. Grant", as a prisoner, but both of whom I had befriended, Another proof of the old adage, "honesty is the best policy."

"But to return to the family, when I first went to Aberdeen, MIss. being a mere boy, Two good Christian Ladies took much interest in me. A Mrs. Bonner and her sister a Mrs. Goodwin. They were from Virginia and claimed to be relatives, and at the request of Mrs. Bonner I had my father give a history of the family as far as he knew, he sent me a MS (missive) of about a dozen pages, which I gave to Mrs. Bonner and have never been able to get possession of it since. I remember well however that he gave the same lineage as Mr. Morrison, and said we were related to the Genl Arthur branch, and that I had a brother ARTHUR who died in infancy.

"Just before the war I corresponded with a grand dau. of an Arthur St. Clair, Mrs. Geo. Weber, I think was her married name. She then lived at Fredericksburgh, Tex. Gillispie County.

"My father had three brothers HIRAM - THOS. H - and ELBERT and two Sisters. His oldest sister MRS ELIZABETH PHINEY was a remarkable woman. She md. JOSEPH PHINEY an orphan boy raised by my grandfather much against her fathers will. He had never had advantages. She educated him and made him Sheriff and did the work of his office herself. She left two sons, JOHN and ALFRED. who for many years were prosperous merchants of Charleston S. Carolina. I have heard many prominent people of N. Carolina say she was the best known woman in the state. Mrs. Gov Ca came to Tex in 1857, and she said Mrs. PHiney, was the most intellectual woman she had ever met, shough she had spent much of her life in Washington D.C and had met all the celebrities of her day. I had four brothers, Two I lost in the war and one soon after. Our father was an old time Whig and a Union man. His sons all voted for Sesession. He was right and we were wrong. He told the story in advance and indicated truly what would happen. He was a cultured gentleman and an Orator. My only brother living is THOMAS ALBERT ST. CLAIR of Sulphur Bluff, Tex. He was named for his two uncles, THOS, and ELBERT, but the Elbert was morrupted to Albert by his schoolmates and so he let it remain. He never married and is five years my junior. he is not fond of society and devotes his time to making money. Grandfather served many terms in the N. Carolina Legislature.

Of my own family I regret to say we are childless. Our baby boy died an infant. We raised a girl who took our name. She is married, and always known as MARY ST. CLAIR. She desired to be married under the name of St. Clair, so I had her name changed legally. She md. Dr. J. H. ALLEN of Wortham, Tex. and is very proud of her new name.

"I have held many offices, among them that of Major, and U.S. Commissioner, and though a Democrat was I was appointed by a U.S. Republican judge to rid the County of Train and stage robbers, by which this Country was infested in 1879. The stage was robbed twicewithin the Corporate limits of Fort Worth. There were ten in the gang, nine of whom we captured and sent to prison the other was killed in Colorado.

"There is a J. Walter St. Clair living here. he is a Postal Clk. There is also a J.D. Sinclair who is Stamp Agt. and a Burt Sinclair who is a passenger Conductor - Walter St. Clair has several brothers living at Dublin and Alexandria, Tex.

"I was over 30 years of age before I ever met any one spelling their name as I do, St. Clair, of course I mean outside of my family.

"The Hon. CHARLES SINCLAIR of Prince Williams Co Va. was appointed a district judge for Utah by Buchanan. He was a generous and every way good fellow. I was poisoned at the National Hotel at the inaugeration in 1857. Charlie and his wife who was a Miss SHACKELFORD of Va. nursed me as though I had been their brother. He had a brother then who was Clk. in the Dexter House, Washington D.C. Many years later I met him in Philadelphia he was full of the genealogy of the family

"There is no stain of dishonor attached to any of our name so far as I know. My wife also is proud of our name. She was a MISS CHILDRESS of Tennessee, dau. of Hon. Wm. G. Childress of that state and a near relation of Mrs. Jas K Polk".

NOTE: HISTORY OF THE ST. CLAIR FAMILY by Morrison was published in 1898. Mr. Morrison did a very thorough job of tracing the descendants of John St. Clair (Sinkler) of Exeter, New Hampshire. I have a copy of this book and have studied it thoroughly. I have found nothing that could indicate a descendant going to Virginia and he could not be the father of John of Wilkes Co., N.C. I have also studied the Arthur St. Clair lineage and found no possible connection. I have found that many people claimed lineage to these two line as they were the only ones publicized at that time. Mr. St. Clair of Morgan City, La. simply wrote every St. Clair/Sinclair he would find and asked for their family history. His handwritted copies of these letters are of great value today as they comprise information on many different branches.

HANNAH SINCLAIR was born in PENNSYLVANIA in 1804 which lends a little more credence to the story.

History of Cole, Moniteau, Benton, Miller, Maries, and Osage Counties; Goodspeed Pub. Co. 1889, pages 1119, 1120.

"LINDEN MARTS became a resident of Maries County in April, 1869, and purchased the place upon which he now resides in July, 1881. He is a farmer and stock raiser by occupation, and his farm, which is located in Jefferson Twp, contains 248 acres, about 1/2 of which is under cultivation. Mr. Marts was born in WOOD CO., OHIO, Feb 2, 1844, and is a son of Solomon and Elizabeth (St. Clair) Marts, the former of whom was a native of Metz, Prussia, and was born about 1821. When a boy Solomon Marts left the country of his birth and immigrated to the United States, first locating in Pennsylvania, where he learned the wheelwright's trade, in which he became a master workman and followed many years in the State of Ohio, where he accidently met his death while curbing a well in 1860.
