He stated that Fannie Tillett Aydolett, wife of Jacob Aydolett, married a Shaw after the death of Jacob and was not buried at the cemetery at Harbinger, but he did not know where she was buried. Ordered that Thomas Griggs, William A. Jarves and Thomas Woodhouse be appointed to audit and settle the accounts and vouchers of Thamer Dowdy (widow) administratrix of Spence Dowdy deceased.

On motion (Lewis or Luis) Mann was reappointed guardian to Lucy D. and J. H. Tillett orphans of Thomas R. Tillett deceased and entered into bond in the sum of two thousand dollars with Joseph M. Daniel and Samuel B. Jarvis sureties.

Bastardy personally appeared in open court Caleb Parker and entered into bond in the sum of one thousand dollars for the support of a bastard child begotten on the body of Polly Garrett with Caleb T. Sawyer and Hodges Gallop sureties.

County tax 20 cents on the Poll and 7 cents on each \$100 worth of land. Parish tax 20 cents on the Poll and 6 cents on each \$100 worth of land. School tax 20 cents on the Poll and 6 cents on each \$100 worth of land. State tax 20 cents on the Poll and 6 cents on each \$100 worth of land, making eighty cents on the Poll and 25 cents on each \$100 worth of land.

May 21, 1920

Miss Emily Seymour, age 63, was taken suddenly ill at the home of her niece, Mrs. D. D. Dudley on North Road St. on Monday and died Tuesday night. Funeral conducted Thursday.
