

A TRIPLETT FAMILY LINE

by M.L. McClanahan, fr., largely W.T. Triplett.

The Triplett family originated in Devonshire, England, About the year 1500 the name Henry Triplett appears on the Registrar, Oxford University, November 27, 1657, and W.T. adds: that G.M. Triplett of Denver, Colorado, claimed that the family originally came from France; in Normandy the name was spelt the same, and that the family emigrated to England in the eleventh century at the time William the Conqueror ascended the throne of England. He based his information on family records kept by his father, Captain Francis Fielding Coleman Triplett, WHO MARRIED SUSAN Taylor, niece of the President, Zachary Taylor, & who was appointed U.S. Commissioner of Patents under the latter. In the history of Jefferson County, Missouri by Goodspeed, p. #370, Major Alfred Basye was a first cousin of John Marshall (Ch. Justice), a second cousin of William Henry Harrison, a third cousin of Zachary Taylor. Boone County, Missouri Bar: p. #40: Major Benjamin Franklin Robinson descends from some of the proudest blood of which England and Scotland could boast; he was closely related to John Marshall, John Randolph, and others whose names have become landmarks in the history of the Union, etc. etc.

W.T. wrote: "The earliest triplett I can find after the marriage of William Triplett who married Eliza Smythe January, 1569 (Records of St. Botolphs' Church, Bishopsgate, England, is Reverend Thomas Triplett, who graduated from Oxford University May 16, 1620 - was Rector of Woodburn, Whitburn, and Washington, successively. Woodburn in Northumberland County. He was Pibendary, successively of York, Salisbury and Durham, and at the time of his death Pibendary and sub-dean of Westminster Abbey in 1670. His body lies in the Poet's Corner of Westminster Abbey.

John Triplett, nephew of Reverend Thomas Triplett, came to America ca. 1650 as an English Commissioner - his wife was Joan Yeo. It is significant that the Triplett & Yeo arms were quartered together, The Triplett crest shows A PELICAN STANDING ON THE EDGE OF A NEST WITH THE HEADS OF THREE LITTLE PELLICANS RAISED ABOVE THE NEST. The Yeo family was socially prominent in both England and America, The Triplett coat of arms was a hind courant shot through the neck with an arrow, a chief indented. The original coat was carried into Mississippi during the Civil War and lost. The crest was three young pelicans in a nest with their mother standing on the side, wings furled back to back in a protesting way." The legendary pelican was supposed to represent charity.

The late John R. Triplett of St. Louis of St. Louis has a piece of silver with this crest on it. Also, Mr. Stone Triplett of Richmond, Virginia (1815-1863) had a ring with the crest on it.

Francis Triplett, the first Triplett to remain in America, had children: Thomas, Francis, William, and Elizabeth. In the History of Loudoun County, Virginia, by James M. Hand, p. #135, in re Simon Triplett's (Col.) line of descent "the line goes back to Francis Triplett, emigrant from London, who married Judith Jackson.

. . . then from Wm. & Mary College Quarterly, v. #17, p. #82: Francis Triplett, Nov. 20, 1700- March 4, 1701: to wife Abigail and sons Francis and William; gr. son Francis, eldest son Thomas and in case he die to gr. son Thomas. Legatees: Francis Jett, son of John and Elizabeth his wife, Francis Triplett, son of Francis Triplett. Extrs.: wife, Abigail and Dr. Williams, Etc. Data Proved, Rappahannock Co., Va. March 4, 1701. He had patented 1050 a. of land there.

King George County, Virginia: April 27, 1765, March 5, 1767- Francis Triplett left land to second son, William, 300 a., to younger sons Reube and Daniel; to dau. Rachel Bötler; to dau. Betsy Triplett; to dau. Ann Dishman; to wife Mildred; to son SIMON (m. Martha Lane).

Note: Daniel Marmaduke, Westmoreland Co., Va., m. (1) ca. 1740, Winifred, dau. John Lamkin; (2), May 29, 1808, Westmoreland Co., Va.,

Ann Triplett Dishman, of Loudoun County Va., dau. Samuel and Elizabeth (Triplett) Dishman.

Captain William Triplett, a noted man, owned about half of the present Marine base and Gen. Philemon Richards the other half land on Quantico Creek. The old Triplett family graveyard is on that base.

Francis Triplett became restless after his father, John Triplett, went back to England, and in 1666 moved to Rappahannock County, Virginia, where he patented 1050 acres of land. His will, proved in Richmond County, Virginia, March 4, 1701, left to wife, Abigail, three sons and one daughter. V. Va. Co. Records by Crozier, v, 6, p. 194. *Francis J. M. Mays*

Brown Another statement was: the Triplett family emigrated to Virginia ca. 1714, or during the reign of King George 1 of England. Three brothers, Hedgeman, John and John Francis settled in Westmoreland County, Virginia. From them are descended all the Triplett in America. Tradition says that they were sons of Reverend Thomas Triplett, a graduate of Oxford University, sometime Vicar of Woodburn in Northumberland, Rector of Whitburn and Washington, Pabendary successively of York, Salisbury and Durham and at the time of his death Pabendary and Sub-dean of Westminster Abbey. V. above, as Thomas did not seem to be a well founded first name among descendants. M. McC.).

William Triplett, son of Francis Triplett, res. King George County, Virginia, and m. Isabella Miller. Will proved December 3, 1738, 6 children

William Triplett, his son, resided in Prince William County, Viro^a. At one time he was vestryman of St. Mark's parish, Culpepper County, Virginia. After he removed to Prince William he lived on an estate at the mouth of Quantico Creek (present Marine base, Dora Lee Wright, who promised to visit the family *g.y. there.* (M. McC.). A noted man. The William & Mary College Quarterly mentioned deed of July 19, 1753 - land from John Triplett and brother, William, land purchased from AUGUSTINE SMITH, by their father, William Triplett, in 1733 and 1735. William willed these tracts to sons John, Thomas and Nathaniel Triplett (D. Bk. A, p. 528). Meade's Old Churches & Families in Virginia, vol. #2, p. 215 - Triplett was a vestryman. In Dr. Slaughter's St. Mark's Parish, Culpepper County, Virginia, he was called Captain William Triplett, due to the fact that he served in the French and Indian wars.

The Smith deed is in Spottsylvania County dated November 6, 1733, to William Triplett of Brunswick parish, 515 acres of land. The sons deed shows that their father died in Prince William County, where he had removed and that will was dated July 15, 1748, recorded in Culpepper County Bk. A, p. 528. Children: John, Thomas, Nathaniel, James, William, and Abne.

The son, John, settled on a Culpepper County estate. His son, Hedgeman, who also resided on Mountain Run near Chicken Branch (8k. A, also gives (1749-'70). Duplicate by Dorman; lists are from his book; 2nd no's. are from original numbering. Vide Fragments of book "b," pub. by Ammisteard M. Pritchard as Abstracts of County Court Minute Book "B," dated 1763-1764, at Dayton, Ohio, by Joseph Ruebush, ca. 1930.

p. 1#5 = John Triplett one of the appraisers of William Clift's estate 25 (105-6) May 16, 1754, Estate of Keene Field ... sworn to before Abra. Field, signed by Wm. Field. Wits.: B(enja.) Roberts, Wm. Peyton, John Triplett.

36/7 Estate of John Cole March 17, 1757 by John Triplett, Thomas Triplett, Frederick Zimmerman.

34/77 Roger Abbott 2 July, 1762, St. Mark's parish. Wife Ann, Dau. Leucy Triplett and her children; Roger Triplett and sister Elizabeth Triplett - my land on so. side of Mountain Run bounded by Chicken branch. John, son of William Triplett, settled on estate in Culpepper Co.; was Public Surveyor under King George 111; md. Nancy, dau. George Popham, who had settled in a colony in New England and was descended from Sir Humphrey Popham, Chief Justice of England. He served as an officer in the Revolution; was at Yorktown with his four sons. Resided Culpepper until his death ca. 1790. The sons: John, Wm., Roger, Daniel.

William Triplett, son of John, after the Revolutionary war settled at Orange County, Court House, Va. ;. a Miss Miller. He also served in the War of 1812 and received a pension for wounds received. Chn., Eliza. dau. and sons William Hedgeman and James Catlett Triplett.

As this data is assembled piecemeal, it should be edited. COMPILED BY THE MEDIA RESEARCH BUREAU, WASHINGTON, D.C.: a variation of "Trippet," with various spellings, as Tripet, Trypet, etc. the spelling Triplett seems mostly as Americanization.

In 1379 in Yorkshire, England was one Johannes Trypet. the mg. of Francis Triplett to Judith Jackson was in Ste. Vedost's, Foster Lane, Cheapside, London. Another mentions John Triplett of County Cornwall, who m. Joan, dau. William Yeo of Devonshire; Henry of Oxford in 1561, Thos., who m. Alice or Alicia Sutton in 1567; Wm. Triplett m. Elizabeth Smythe of London, 1569; Edward Triplett of Oxford, 1587; Henry of Hampton Gay, 1595; Robert m. Ann Assison 1608; Rev. Thomas Triplett, probably b. in Oxfordshire but resided chiefly in London, and died in the latter half of the seventeenth century, mentioning in will, sister, Mrs. Katherine Warne, bro. Christopher and Richard Triplett of Oxfordshire, his cousin, Sydney Triplett (called a son of Paul Triplett of Hampton), another cousin, Ralph Triplett. Tho he mentioned no children, some believe the Virginia family was at least closely related to him.

Thomas Triplett by Abigail had: Thomas, Francis and others; sons Thomas and Francis settled in Prince William Co., Va.

Francis, son of the first Thomas, removed from Prince William to Fairfax Co., Va. (early a part of Prince William, M. McC.). by wife Elizabeth, he had: Thomas, William, Daniel, Mason, John, FRANCIS, Margaret, Elizabeth and Patty.

Of the sons of the first Francis of Prince William and Fairfax Counties, Thomas is believed to have been the father of Betty, Anne, and Thomas; William married Sarah, dau. of Robert Massey and had: George, Thomas, Penelope, and Lucy and others. Daniel is believed to have removed to Fauquier County, Virginia, but records on him are not complete; Mason and John left to record of their immediate families or dependants, if any; FRANCIS made his home in Prince William and Fauquier Counties, Virginia. and left issue by his wife, Benedicta, daughter of Robert Semnett of Maryland, of William, Hedgepore (Hedgeman), Robert, Elizabeth, Benedicta, Ann, and Frances Emelia.

William Triplett, son of the immigrant Francis, res. King George County, and m. Isabella, dau. Capt. Symon or Simon Miller, names appear to be for children: John, Francis, Daniel (Des'ts. if any, unknown), William, Elizabeth, and a dau. whose christian name is not known.

John, eldest of William of King George Co., res. there and in Westmoreland Counties, Virginia, and by wife, Catherine had at least one son, John, Jr., but the records of the family are not complete.

Francis, second son of Wm., above, res. King George and Westmoreland Counties, and is believed to have been the father by his wife, Mildred, of (Col.) Simon, William, Francis, Reuben, Daniel, Rachel, Elizabeth and Ann. Simon removed to Loudoun County, Virginia; m. Martha Lane and had: Simon, Philip, Wm. Harrison, James Kane, Katherine, Lucinda and Susanna. Simon (1752-1810) P.S. and Col. Va.

William resided in Westmoreland County, md, Elizabeth, . . but no record of any children if any has been found.

Francis removed to Loudoun County and m. (2) the widow Elizabeth Smith. records incomplete.

Reuben res, Loudoun and was a Revolutionary war soldier, n.f.r.

Daniel married 1753 Elizabeth Richards and resided Stafford County, Virginia; issue: John Richards, Robert, Philip, Harriet, Elizabeth, and Anne.

William, son of the first William of King George County, had: John, Thomas, Nathaniel (d.y.), James, William, and Annie. He married a dau. of George Popham (v. pre M. McC.) and had John, William, Roger, Daniel, and Hedgeman Rev. War service under Gen. Thomas on the northern frontier, I had, but now where? Pensioned. v. post.

Thomas resided Culpepper County and by Hannah had George, Peter, Thomas, Milly, Jean, and Frances.

James is believed to have made his home in Prince William County, and left issue there at least son Nathaniel Hedgeman Triplett. Note, I think this James came to Pike County, Missouri in 1823; had 12 sons and a daughter. He was not the James you mentioned: Aline McClellan.

William also resided Prince William County, but records there are incomplete.

Frankfort, Ky., newspaper of 12-1-1836, taken from the Scott Papers by Hattie M. Scott. Vide Green County Orders for her death date. Chn. mainly taken from Mrs. Dunn Mastin's papers (she was b. 1763). Emma Dunn Mastin's papers in John Fox Library, Duncan Tavern, Paris, Kentucky.

The Biog., p. #119: This family, which is so well and favorably known throughout Chariton County, Missouri, is of Irish (?) descent; it was during the Colonial history of this country that the family tree first took root on American soil. The paternal grandfather of the subject of this Sketch (J.E.M. Triplett) Major Hedgeman Triplett, attained the rank of MAJOR DURING THE Revolutionary war, being a member of Thomas' Virginia volunteers (on the northern frontier, ref. not at hand, M. McC). He emigrated from Culpepper County, Virginia, to Franklin County, Ky., with his wife whose name was Nancy Popham, and there pur. a home on which he made his home until 1833(9-22-1837) D.A.R. when he paid the last debt of nature at the advanced age of 99 years 8 mo. Of his five sons and eight daughters; the following are worthy of mentioning to the extreme old age they attained: Elizabeth died in Kentucky, aged 104 years; Mildred passed from life in Morgan County, Illinois, aged 102; William died in Platte Co., Mo., aged 101 years; George W., was called from life in Davis County, Kentucky, aged 91 years. The latter served as Quartermaster and was Representative from Kentucky to the Confederate Congress; was also a member of the Kentucky Legislature and at one time held the rank of Adjutant General. One of his brothers, Hedgeman, Jr., was the father of J.E.M. Triplett.

Hedgeman Triplett (Jr.) was born in Culpepper County, Virginia, but when a boy removed to Kentucky with his parents and located at Briant's (Bryan's) Station with Boone and Others. ? M. McC.

He was brought up in Franklin County, which was by then wholly in a state of nature, and upon reaching man's estate married Margaret .. day. of Joseph Eddins a Virginian. He eventually became a wealthy farmer and was highly respected by all who knew him. He and his wife became parents of five sons and two daughters, the latter dying in infancy. The sons were: Harrison, who d. in Kentucky; John E.M., whose name heads this sketch.; George died in Kentucky; Alexander died in San Francisco, California, and Thomas who died in July, 1892, at Austin, Nevada, where he had founded the town and there operated a quartz mill, being also interested in silver mining. The father of these children attained the age of 56 years, dying in Kentucky in 1845; his wife in Missouri about a year later. They were a worthy couple and had many friends.

John E.M. a native of Franklin County, Ky., where he was born Dec. 2, 1818, received a practical education in the schools of the country, becoming sufficiently well qualified to become a teacher, an occupation which received considerable of his attention during his early manhood. After the death of the head of the family he, with his widowed mother and brothers, came to Carroll County, Missouri, but owing to the death of his mother the same year (1846), his brothers returned to Kentucky. Thomas and Alexander did not remain there long, however, but soon returned to Missouri, and from there went west to California. J.E.M. purchased land in Carroll County, Missouri, which he continued to till until 1847, when he sold his property and once more returned to the State of his birth, where the death of his wife occurred March 19, 1847. Shortly he went to Chicago, Illinois but in 1849 once more took residence ... and has since been a resident of Chariton County, one of her active and leading citizens,

in 1852 our subject purchased a tract of land, to which he has substantially added by purchase of adjoining lands. upon which at a later date was laid the village of Triplett. Here, for many years, he carried on farming and stock-raising, . . . until aged 82... he has since been a resident of Triplett, where he has a comfortable home and enjoys a competency which his early efforts won for him. He still continues to manage 75 acres of land adjoining the village on the east, and he and son, William, own 160 acres in Idaho, and in the village of Triplett, a brick store building, five houses and forty vacant lots. Altho he at one time owned about 2,000 acres of land, he has sold some and divided a large portion among his children. The township of Triplett was named in his honor and in 1868, when the township of Triplett was named in his honor, and in 1868 when the present village of Triplett was laid off a portion of his land, being surveyed by himself and L.A. Cunningham, it also received his name. Our subject has contributed more to the upbuilding of the town and surroundings than anyone else.

Before coming to Missouri Mr. Triplett held the office of County Judge in Franklin County, Kentucky, and for 32 years he discharged the duties of Justice of the Peace in the locality where he is now living.

Having a taste for law, he was admitted to the Bar, after some preparation, in 1865, and has since practised in the Court of Common Pleas and the Justice Courts of the vicinity ever since. Until 1862 he was a WHIG in politics, but later became a Democrat and was an active worker in that party's conventions until 1876, when he joined the Weaver party since which time he has not taken a very active part in politics. In 1846 he was initiated into the mysteries of Masonry in Kentucky, joining Owen Lodge #328 of Owen County, Ky., but he is now a member of Dagon Lodge #374 of Menon, Missouri.

He was first married in Kentucky in 1843 to Miss Selina Eddins, who died in March, 1847; his second wife was Miss Frances Littrell, dau. of John W.D. Littrell of Chariton County, Mo., whom he married in May, 1849. She died in 1852, leaving one child, Georgia A., wife of D.L. Wood of Triplett. He had, his present wife, Juen 28, 1853, in Carroll County, her maiden name being Nancy Cawthorn, dau. of Asa Cawthorn, and is a Kentuckian by birth. Their children: George W. of Texas; William of Idaho; married; and Martha, wife of S.F. Powell of Texas; Emma; Benjamin B., married; and John A. Triplett, married. The last two live on the old home farm near Triplett. The Cawthorn family were from Va., and of Scotch-Irish descent, her grandfather, Asa W. Cathron, was born in the old Dominion January 1, 1796., but spent his boyhood days in Clark County, near Lexington, Kb. He was a soldier, War of 1812, and at the time of Dudley's defeat, was captured by the British in Ohio and sent to Canada as a prisoner, and kept in captivity for a year. Exchanged at Quebec he was sent home. He was soon afterwards married to Miss Eliza Canote of Kentucky, a German by descent, and in 1825 moved with his family to Howard County, Missouri. where he engaged in tilling the soil. Three of his ten children are still alive. Alexander R. resides Triplett; Harriet, wife of James Smart, res. in Carroll County; Nancy (Mrs. Triplett), Tyre died in Livingston County in 1891, aged 73 years. The others were Martha, Elizabeth, Matilda, Eliza Ann, Emily and Araminta.

all of whom were married. Mr. Cawthron was a Whig, later a Democrat; a member of the Baptist Church, in which faith he died in 1881, his wife having passed from this life in 1863.

Captain William Triplett died two miles north of Platte City. He was a son of Hedgeman Triplett of Franklin County, Ky. (by Nancy Popham).

He was b. November 22, 1797 in Scott County, Kentucky. His ed. was acquired on the log school house of the day. His father was independent, not wealthy - a patriot soldier in the War of Independence, rose to the rank of Captain and drew a pension of \$320. The family moved to Franklin County; there his father died 1837. William married June 17, 1827 Diana, dau. John Balew of Jefferson County, Kentucky, and was born August 7, 1807, and died April 10, 1879. She was a large, intelligent, and dignified old lady. In 1842 they came west, reached Weston March 27th and settled two miles north of Platte City, where they died. Captain Triplett acquired his title from commanding a company of militia in Ky. But he had by nature the military bearing of an officer, and the characteristic of an old Virginian. He was chosen to preside over the Society of Old People, and the Whigs at one time ran him for the Legislature in Platte, Children:

My great aunt Lora told me about the last two on this list. I am trying for a death certificate for her father, which should name HIS parents. When I asked grandma T. in 1942 about W.T. Triplett in 1920 letter, all she said was "that's a different set of dogs" and didn't explain further.

My grandfather, Frank, written to by W.T. Triplett in 1920, was born 1867, New Hartford, Missouri or Illinois. Do you know if Elizabeth and William had other brothers by these names. 2 boys and 3 girls are missing of Maj. Hedgeman Triplett's children.

J.E.M. Triplett was supposed to have died 1833, aged 99 years 8 mo. This would give him a birthdate of 1732/3 instead of 1756-58 (D.A.R. rec. Just older than Francis, b. 1728,

Another Hedgeman Triplett died in Kentucky 1839, aged 99 years, 8 mo. Sketches of Wood County, (W.) Va., by C.S. Shaw, p. 128: Mr. Hedgeman Triplett, Sr., was shot and killed by Indians in 1792.

It is not known how the Hedgemans and Triplett's intermarried, or when. Peter and Nathaniel Hedgeman - the upper part of the Rappahannock River was named for them. In the part of Prince William apparently near (now) Rappahannock County. Fauquier from Pr. William 1759.

Peter Hedgeman was listed about five times in Casey's index to Hennings (Va.) Statutes. Hedgeman's River ran from the Aestham northwards above Jefferson (called Jefferson quite early); from that area was organized a Baptist Church called Hedgemans; its constituents being from Carter's Run in Fauquier near (now) Midland. John Pickett was pastor there until 1790. Hedgeman's Quarter was north and west of Tinn Pott Creek of the main River.

Rev. (Capt.) William (Smith?) McClanahan married Mary, dau. of John and Elizabeth (Markham) Marshall, b. April 28, 1737, d. Ky., June 22m 1809. In Notes on Virginia Baptists by Morgan Edwards, Mr. William McClanahan, b. February 23, 1733, Cople Parish, Westmoreland County, Va., bred a churchman, embraced the sentiments of Baptists, bp. by Samuel Harris in 1760. "his convictions were without means, and very strong. Moved to pray when he heard singing. ... children: Thomas, William, Peter (John Marshall), Elvira, Ann, Mary, Alice (Susan b. later).

He and brother in law, Rev. William Marshall, were among those jailed for preaching "contrary to the laws & Usages of the English Crown." And consequently tortured, in 1773. He organized one of the eight companies in Culpepper County, became Captain of a Minute Company (later, militia). He did not become a Lt. Col., and tho he received land in Kentucky for his services, it was given to sons Thomas Marshall McClanahan and Capt. William McClanahan, Jr. After his house burnt, he apparently followed the John Robinsons to Greenville County, South Carolina, where he died, leaving the home lands to son John Marshall McClanahan, also said to have served at Valley Forge by the renown Kansas City, Missouri, geologist, Mary Rebecca Ellis.

His daughter, Mary, married 1782 by Reverend John Pickett, pastor of Mt. Poney Baptist Church, Culpepper County, Virginia, to Lt. Hedgeman, son of Col. Francis Triplett born Prince William County, Virginia, 1728, died 1794, Fauquier County, Virginia. married 1750 Benedicta, dau. Robert Sennett of Maryland. On September 28, 1778 he took the oath of Allegiance as a Captain of Militia, Fauquier County, serving until the end of the war, being Major, then Colonel of Cavalry militia of Fauquier. He won distinction at the Battle of Monmouth, and for swinging the tide of battle at "The Cowpens, in 1781 under General Morgan, he was presented with a sword for that service; his militia obeyed orders, wherein most militia ran away, at the battle of Guilford Court House, the first line fled in panic without firing a shot.

He also served with General Gates and under General LaFayette in the last campaign.

Pamela Head, b. 1810, d. 18--; George was a son of Hedgeman Triplett, b. 1786 md. Culpepper County 1782, Mary McClanahan, above.

Colonel Francis Triplett died Fauquier County December, '94, will dated 12-24-1794.

Petition of Francis Triplett, setting forth that he entered as a vol. of Prince William militia, sent out last June for the protection of the frontier, where, in a skirmish with the enemy he received a most dangerous wound in his right arm, for the cure of which he was at considerable expense. Praying consideration of the House. Resolusion passed: was allowed £ 55. He was vestryman of Leeds parish in Fauquier and a J.P. He died in January, 1794 (5?) M. McC. (D.A.R. gives '4/5).

James Catlett Triplett married Nancy Oliver in Culpepper County, Va., 1790. Shortly after 1800 he removed to Bourbon County, Ky., where he lived a number of years.

In the early 1840's he removed to Buchanan County, Missouri, then to LaFayette County, then to Pike County, Illinois and finally to Pike County, Missouri, where he died and is bu. on his own place within one and a half mile of where I was raised. Children:

Frank died in 1929. His father was Marcellus Triplett (m. Lucy? Montgomery, dau. Jennie Clark and Jesse Jefferson Montgomery of Ky. Lucy had a half brother named James Smith. She was liv. in Linn Co., Mo., when "Mart" married her. She came to Mo. after Jennie and Jesse's death, possibly with the Jerry Smiths, or Clarks. Jesse Jefferson d. 1855, Jennie m. Jerry Smith, then Jennie and 4 chn. all died at one time (Nancy, Liza, Jerry, and Louise), of "spotted fever." (Typhus epidemic). About the same time Thomas M. McClanahan died.
