# TURPIN

Michael Turpin, the emigrant, came from Yorkshire, England, about 1655, bought lands in 1656 from Col. Wm. Farrar, of Farrar's Island, called "Henrico." He is the emigrant ancestor of the Turpins in Virginia, Kentucky, &c. His will is dated July 4, 1663, or 1673. He had several sons, among them being:

——Philip, born Yorkshire, England, 1655; married Martha Skirm, of Henrico and died 1717. He left issue. (See forward.)

——John, born about 1660.

—Matthew, born 1664; married Sarah Hatcher, daughter of Edward Hatcher and died 1689. He had sons, Henry and Mathew; daughter, Cicely. The widow married, October 16, 1689, Jos. Tanner. Mathew Turpin's estate divided December 2, 1689. (Deed Book 5, page 104, Henrico County Records.)
—Michael; married probably, a Farrar. Sons: Michael and John.

Goochland County was formed from Henrico in 1727. Cumberland County was formed from Goochland in 1748. Chesterfield County was formed from Henrico in 1748. Powhatan County was formed from Cumberland in 1777.

Michael Turpin, the emigrant, settled in Henrico County with his family; but in time, as the counties were cut off from Henrico we find members of the same family, or their descendants, owning property in all the counties mentioned above.

From the early records of Henrico County, Virginia, we have the following notes:

Philip Turpin, born 1655, gave depositions in 1688. Book 5, page 25.)

John Turpin, born 1660, gave depositions in 1685. (Book 4, page 338.) 1689. (Book 5, page 107.)

Will of Mathew Turpin mentions wife Sarah. Eldest son, Henry; son to be named Mathew, also Mr. Thomas Osborne. (January 15, 1688, and April, 1689, pages 41 and 106.) (Book 5, page 246.)

October 1, 1691-Philip Turpin, a landlord.

1691—Michael Turpin married Elizabeth ———, granted land 1687.

July 4, 1663 or 1677, Michael Turpin's Will: sons, Philip, Michael, and John.

(Book 5, page 189.)

April 1, 1691—Michael Turpin to Wm. Whitley 215 A. granted to Michael Turpin, April 20, 1687. Elizabeth, wife of Mathew Turpin, relinquished her rights April 1, 1691.

(Page 660-October 1, 1696.) Michael Turpin sells to John

Davis 200 A. on north side James River.

John Turpin in will dated September 7, 1795, page 343, mentioned children: Betsy Talman, John, Sarah, Beverly, William, and Thomas.

Appointed Michael Turpin and Austin Talman, Executors.

Michael Turpin in his will dated May 1, 1796, and proved June 6, 1796, page 377, mentioned wife, Betsy (probably Redford), sons: John, Miles, Elisha, and Henry; daughters: Mary, Martha, and Elizabeth, and brother John. (Note: this Michael and John above were brothers.)

Lusby Turpin, married Martha Bullington, May 8, 1786 (must have been second wife). His will dated January 2, 1791; proved March 7, 1791, mentioned sons: Michael, John, Thomas, Alex., and Lusby; daughters: Mary Goode, Sarah Depriest, Priscilla Vendike, Elizabeth Royster.

(1710-1714, Old Record Book, Part 1, page 51.)

Deed Thos. Turpin & wife Obedience and Joseph Wilkinson & wife Priscilla of Henrico sell to Richard Dennis of Charles City 101 acres on which Mrs. Jane Gower lately lived on south side James River.

From Chesterfield County records:

(Will Book 4, page 454.)

November 25, 1763—appraisement Estate Phil. Turpin. (Will Book 2, page 211.)

February 19, 1767 — Elizabeth Turpin's will — sons: Phillip, Thomas, Elisha, Josiah, daughter, Mary Winfree, granddaughter, Sally Winfree, granddaughter, Elizabeth Ashurst — "My two daughters, Martha and Mary." Mabel Turpin, wife of Josiah.

(Will Book 2, page 212.)

Will of Josiah Turpin, mentioned wife, Mabel—brothers, Elisha, Philip, Thomas, and daughter, Sally Turpin.

(Will Book 2, page 214.)

Inventory Josiah Turpin—February 8, 1768.

(Deed Book 10, page 1.)

September 24, 1781, Thomas Turpin, of Chesterfield sells to Richard Elam land next to Josiah Turpin dec'd. being now in possession of Thomas Turpin.

(Will Book 3, page 402.)

Will of Henry Turpin, Sr., wife, Ann, made October 18, 1782 (no probate) daughters: Frances Banton, Ann Turpin, Mary Turpin; sons: Hezekiah, Obediah, George, and Jeremiah. "My two sons, George and Jeremiah all my land at Kentucky and my land in Chesterfield." Henry, land I live on. Jeremiah was not 20.

(Hezekiah Turpin married, October 9, 1773, Jane Cheatham, daughter Francis Cheatham.)

(Will Book 2, page 389.)

Will of Philip Turpin, dated August 1, 1794; no probate—wife (no name given) son, Henry (under 15); daughter, Nancy Turner. Executors, Wm. & Philip Turner.

(Deed Book "D," page 368, Bedford County records.)

June 3, 1772—Deed between Thos. Turpin, Sr., of Cumberland County and William Turpin of Bedford County for and in consideration of the natural love and affection which he beareth unto the said William Turpin a certain tract of land containing 2240 Acres, more or less, situated & lying & being on Branches of Ivy Creek of Black Water in Bedford County and bounded by the lands of Thos. Jefferson, Harden Perkins, Sherwood Gaddy and Robert Hardwick.

Survey for James Turpin, March 2, 1774, 120 Acres situated in Bedford on north fork of Blackwater River.

(Deed Book "C," page 173, Bedford County Records.)

October 14, 1765, Thomas Turpin, of Southern Parrish and County of Cumberland sold to Richard Callaway, of Bedford County 700 Acres lying near the Blue Ridge Mountains, crossing Tuckahoe Creek to John Dorson's corner and Samuel Cobbs' line.

(Deed Book "E," pages 168, 169, 170, 171, Bedford County Records.)

November 23, 1773—William Turpin of Cumberland County sold to the following, land situated in Bedford County on Ivy Creek & Wolf

Creek: Micajah Moorman, 210 acres; Charles Moorman, 100 acres; Silas Moorman, 50 acres; Andrew Moorman, 200 acres. (Deed Book "O," page 341.)

December 5, 1815—Wm. Turpin & Sarah, of Cumberland County deed to their son, Edwin Turpin, of Cumberland County, a tract of land lying in the County of Bedford containing 904 acres on Ivy Creek. They also deeded their son Wm. Archer Turpin of the County of Powhatan a tract of 907 acres lying in Bedford County. (These two sons never lived in Bedford County.)

In the census of 1783 we have Henry, Hezekiah, Obadiah and Phill Turpin mentioned as heads of families in Chesterfield County. Horatio, Thos., Jr., and Thos. Turpin, III, in Powhatan, and Wm. Turpin in Cumberland County.

Among early settlers of Prince Edward County, Va., was Thos. Turpin, 25th September 1746—400 acres on Sandy River.

Page 257, Virginia Historical Magazine, Vol. 2, 1894, Virginia Troops in Continental Line.

Horatio Turpin, Ensign.

Page 68, Virginia Historical Magazine, Vol. 1, 1893, Officers of the Virginia Navy during the Revolutionary War. John Turpin, Midshipman.

Horatio Turpin was officer in Revolution in 1780 in Cavalry from Powhatan.

John Turpin was Captain of a company from Henrico County in 1781 and Sugly Turpin was Second Lieutenant of same.

William Turpin was sworn in as Ensign of a company from Cumberland County, August 26, 1777.

Martin Turpin was a Revolutionary pensioner residing in Pulaski County, Kentucky, in 1835.

(McAllister's Virginia Militia in the Revolutionary War.)

The following is a copy of the will of Obedience (Branch) Turpin proved June 17, 1746, Goochland County, Virginia.

In THE NAME OF GOD, AMEN. I, Obedience Turpin of Goochland County, Widow, being weak in body but of perfect mind and memory, Blessed be God, do make and ordain this my last will and testament in manner and form following.

Imprimis. I first of all give and bequeath unto my son, John Cocke, and to his heirs forever, one negro boy named Farthing.

Item. I give unto my daughter Martha Friend five shillings.

Item. I give and bequeath unto my grandson William Moseley one negro boy named Pompey but not to be delivered till Christmas next.

Item. I give and bequeath unto my grandson Benjamin Moseley one negro boy named Frank to him and his heirs forever but not to be delivered to him until the said Moseley shall arrive to the age of eighteen years.

Item. I give and bequeath unto my grandson Alexander Trent one negro girl named Dicey to him and his heirs forever.

Item. I give unto my son-in-law Alexander Trent five shillings.

Item. I give unto my daughter Obedience Branch five shillings.

Item. I give unto granddaughter Obedience Branch one negro girl named Sallie to her and her heirs forever.

Item. I give unto my daughter Mary Goode one negro boy named Matt to her and her heirs forever.

Item. I give unto my granddaughter Obedience Turpin three negroes to witt, Amy, a girl, Lucy, a girl, Harry, a boy, to her and her heirs forever.

Item. I likewise give to my said granddaughter Obedience, one feather bed, a pair of blankets, two pair of sheets, one rug, one bed quilt, half dozen new leather chairs which I have now by me, four new dishes, half a dozen new plaits, one chest and one small walnut table.

Item. I give and bequeath unto my son Thomas Turpin three negroes to witt Pompey, Simon and Hannah to him and his heirs forever.

Item. I give unto my daughter Mary Goode five shillings.

Item. All the rest of my estate which I have not before disposed of I give to my son Thomas Turpin and do appoint him sole executor of this my last Will and Testament revoking all Wills by me heretofore made and do order that my estate be not appraised. In witness whereof I have hereunto set my hand and Seal this Twenty sixth day of January 1745/6.

At a Court held for Goochland County, June 17, 1746. This Will was proved by the oaths of Benj. Mosby and Peter Bondurant and ordered to be recorded.

The following compilation of the Horatio Turpin family in Kentucky was submitted by his granddaughter, Mrs. Nannie Chambers Abbett, of Louisvile, Kentucky.

Horatio Turpin left Powhatan County, Virginia, shortly before 1820 for Lexington, Kentucky, where he remained a short time before purchasing a large tract of land in Gallatin County, Kentucky, lying between Eagle Creek and Craigs Creek. The home which he called "Beech Park" was about seven miles from the Ohio River. After buying the land he went back to Powhatan County, Virginia, and returned to Kentucky with a large number of slaves in the spring of 1820.

They cleared ground, built cabins, then cultivated the cleared land and burned the brick with which the home at "Beech Park" was built.

The following fall he again went to Virginia to conduct his family to their new home.

His wife, who is referred to as "Pretty Mary Bancroft" in "Reminiscences of Wilmington, Del.," was many years his junior.

Their children were:

Edward Augustus; Philip Osborne; Mary Elizabeth James; William Henry; Horatio Harris; Peterfield; Powhatan Virginius Americus; Harriett; Thomas Jefferson; Anna Cornelia; and two infants William and Thomas, who died and were buried in Virginia.

All of the children were born in Virginia except Thomas Jefferson and Anna Cornelia, my mother, who were born at "Beech Park" in 1823 and 1825, respectively.

The journey from Virginia to "Beech Park" was made overland, Horatio riding his horse while the family, including "Virginius," a child of three years, and Harriett, a babe of three weeks, rode in the carriage. They were accompanied by the house servants and came over the mountains, camping by the way.

Horatio Turpin died in 1826 leaving his widow to raise her ten children, which she succeeded in doing with credit. The home was a center of social life, and the sons were all college men, Edward Augustus attending Transylvania at Lexington, Kentucky, and the others going to Hanover College at Madison, Indiana.

Edward Augustus and William Henry married the Satterwhite sisters of Louisville, Kentucky, and became the owners of a line of steamboats running from Cincinnati to New Orleans. President Buchanan appointed Edward as Minister to Venezuela and he later ran a line of steamboats on the Orinoco River in South America. While at Caracas his daughter, Teresa Langhorne, died of yellow fever. He returned to the States and with his brother, Virginius, amassed a fortune in pork packing in Chicago. Edward later went to Philadelphia to live while Virginius went to New York.

Phillip Osborne married Mary Ellen Butler, of Carroll County, Kentucky, and they had a large family at Carrollton, Ky. The only surviving member of this family is Dr. Thomas Jefferson Turpin of Chihuahua, Mexico.

Mary Elizabeth James married Jesse D. Bright of Shelby County, Kentucky, who had gone to Madison, Indiana, as a young lawyer. He entered political life there and was elected Lieutenant Governor of that state, and afterward United States Senator. While acting as speaker of the Senate he addressed a letter to Jefferson Davis, who had been a classmate at Transylvania as "President Davis" and was expelled from the Senate on this account. Mrs. Lawrason Riggs of Baltimore, Maryland, was their daughter, and Miss Georgie G. Bright of Baltimore, Md., is the only surviving child. Another daughter, Sarah Virginia Bright, married Dr. William Henderson and their daughter Jessie married Hugh P. Colville and still lives in Covington.

Horatio Harris lost his health on a surveying expedition to Washington Territory and died at Carrollton, Ky., shortly after the death of his wife. He had married Mildred Hawkins and they had no children

Peterfield died at the age of eighteen.

Harriett married Benjamin Murrill and died in less than a year afterward.

Thomas Jefferson married Harriett McIntyre of Madison, Indiana, and went to Indiana to live.

Anna Cornelia, my mother, married Dr. Absalom B. Chambers in March, 1852. In 1853 they went to Peoria, Illinois, to live, taking my brother, Horatio Turpin Chambers, then an infant with them. I was born in Peoria. Illinois was a "free state" and the negroes had been left in Kentucky. They returned to Kentucky and my father bought "Beech Park" and they spent the remainder of their lives there or at Warsaw, Kentucky, where my grandmother Turpin and her son, Horatio Harris were charter members of the Baptist Church.

My grandparents and some of the children are buried at "Beech Park."

My father was a prisoner in the Civil War much of the time, finally finding refuge in Canada until after the troubles were over. He died at the age of 52 years, a prominent and influential citizen of his county and state. My mother died at the age of 67 and a year later her brother, Virginius, died leaving a widow but no children.

My father and mother had four children,

Horatio Turpin Chambers who was older than I, my youngest sister, Mary Bright Chambers, who died at the age of 19, my younger brother, James Whitfield Chambers and myself.

My brother, Horatio Turpin Chambers, died many years ago and his widow, Sallie Bond Chambers and the four grandchildren of Thomas Jefferson Turpin are the only representatives of the family, who still live in Gallatin County. My brother left two daughters, Mrs. J. K. Bannister, of Lima, Ohio, and Mrs. W. S. Corkran, of Milburn, New Jersey.

My younger brother, James Whitfield Chambers, married and has one son, Moreau B. Chambers, who is now 18 years old. They live on their plantation at Clinton, Mississippi.

I married Everett Edwards Abbett at Warsaw, Ky., December 10th, 1878. Mr. Abbett died in 1913. Our children are:

Anna Gibson Abbett, who is not married and who lives with me in Louisville, Ky., Harry Jefferson Abbett, married Jean Tilney Jackson, of Lethbridge, Canada. They lost their only child, Harry, Jr. My son, Harry was graduated from the U. S. Naval Academy, Annapolis in February, 1907, saw service in Mexican waters and commanded a flotilla of destroyers operating out of Brest in the World War. He was awarded the "Distinguished Service Medal" by our Government and the cross of The Legion of Honor with the title of "Chevalier" by

the French Government. He is still in the Navy, holding the rank of "Commander" and is the Executive Officer at the U. S. Naval Training Station, San Diego, Cal.

My son, Edward Bancroft Abbett, married Sophie Rogers Lee, of Louisville, Ky. They have two children Ann Preston Abbett, born in 1924 and Mary Bancroft Abbett, born in 1925. Edward is General Manager of The Newport Culvert Co., of Newport, Ky., and they live in Covington, Ky.

My youngest son, Leon Gill Abbett, married Lillian Julian, of Lexington, Ky., and they have one son, Tarlton Julian Abbett who was born in 1925. They live in Clearwater, Florida, where Leon is in the general insurance business.

Both Edward and Leon served overseas in the World War as Captains in the 325th Field Artillery.

Philip Osborne Turpin, son of Horatio and Mary (Bancroft) Turpin, married Mary Ellen Butler, of Carroll County, Ky. Their children were:

Thomas Turpin, whose will was probated in Bedford County, March 27, 1826, came to Bedford from Chesterfield County, Virginia, sometime after the Revolutionary War. He was born about 1758, a descendant of Michael Turpin, the emigrant, and was, probably, the grandson of Philip and Elizabeth Turpin, of Chesterfield. (The will of Elizabeth Turpin (widow) dated 1769, Will Book 2, page 211, Chesterfield County records, mentions children: Philip, Thomas, Elisha, Mary Winifree, Josiah, Martha.) Thomas Turpin married, about 1779, Rachel Cheatwood, daughter of William Cheatwood, of

Powhatan County, Va. (William Cheatwood's will in Powhatan County, 1777, Will Book "I," page 129, mentions children as follows: John, Daniel, Billy, Lotty, Alexander; nine daughters: Clara, Sillah, Rachel, Beckie, Alice, Patience, Polly, Charity, and Betsy.) (Sillah Cheatwood married Jesse Spinner, and came to Bedford County to live. See Spinner-Burks families.) Thomas Turpin died in 1826, and his wife, Rachel, several years later.

In Will Book "F," page 313, of the Bedford County records, we find the will of Thomas Turpin as follows:

I, THOMAS TURPIN of the county of Bedford, Va., do make this my last will and Testament, in the form & words following, to-wit: 1st, Immediately after my decease, that my executors hereafter named, do pay my just debts. 2dly, I lend unto my beloved wife Rachel Turpin, my negro woman Rhoda, and one third part of my estate, except a small tract of land which decended to me by the death

of my son Elisha Turpin, for & during her natural life. 3dly, My children, Elizabeth Hally (formerly E. Turpin), Josiah Turpin, Thomas Turpin, Phillip Turpin & John Turpin, having received what I consider their portions of my estate, heretofore in advance, I make no further provision for them, or either of them, in this my last will. 4thly, I give unto my daughter Milley Turpin, one third part of my estate, not otherwise disposed of. 5thly, I give to my son William Turpin one sixth part of my estate, not otherwise disposed of. 6thly, I give unto my son Vincent Turpin, one sixth part of my estate not otherwise disposed of. 7thly, I give unto my son Roland Turpin one third part of my estate not otherwise disposed of—and Lastly, I constitute and appoint my friend Martin P. Burk as Executor of this my last will and testament, hereby revoking all other or former wills, heretofore by me made.

In testimony whereof I have hereunto set my hand & affixed my seal this 27 day of January, one thousand, eight hundred and twenty three.

The preceeding last Will and Testament of Thomas Turpin dec'd was proved by the oath of Albert A. Sherman, and ordered to be recorded as a will of personal estate; and on motion of Martin P. Burk, the executor therein named, who made oath & executed a bond with security, according to law, certificate is granted him for obtaining a probate thereof in due form; and afterwards, to-wit, at a Court held for said County, May 23d, 1826, the said will was further proved by Jesse Spinner another subscribing witness, and ordered to be recorded as a will of real estate.

The last Will and testament of Josiah Turpin deceased was produced in Court proved by the oaths of John A. Reynolds and Harrison Wright, subscribing witnesses thereto, and ordered to be recorded, and on the motion of John Turpin the executor therein named, who made oath and together with Thomas Turpin and Vincent Turpin his securities (who justified) entered into and acknowledged a bond in the penalty of fourteen thousand dollars according to law, certificate is granted him to obtain a probat thereof in due form.

Philip Turpin was a soldier of the War of 1812, serving in Eastern Virginia. Thomas Turpin, Jr., of Bedford County, Virginia, son of Thomas Turpin, Sr., and Rachel (Cheatwood) Turpin, was born October 1, 1788, and married, January 2, 1818, Mary Polina Clayton, born October 22, 1802. She was a daughter of John Willis Clayton, Jr., and Lucinda (Douglas) Clayton, who were married, March 21, 1797, in Bedford County, Virginia. Lucinda (Douglas) Clayton, was a daughter of George and Mary Douglas, of Bedford County (formerly of Amherst County—a Revolutionary soldier from that county) and a sister of David Douglas, who married Sally White, daughter of Captain Jacob and Hannah (Spiers) White. (See White and Douglas families.) John Willis Clayton, Jr., was a son of John Willis and Mary (———) Clayton, Sr., and a direct descendant of John Clayton, the Attorney-General of the Colonies. (See Clayton family.)

Thomas Turpin, Jr., like his father, was a planter by profession, owning large landed estates in Bedford County. He was a man of fine mind, honorable and highly esteemed by all who knew him. He

died March 18, 1858, and was buried in the family burying ground. His wife died January 23, 1875, aged seventy-three years. He left a family of worthy sons and daughters. His will dated September 16, 1853, and probated April 26, 1858, Will Book "Q," page 554, of Bedford County records reads:

I, THOMAS TURPIN of the County of Bedford being of sound mind and memory, do make and ordain this my last Will and testament hereby revoking all former Wills by me heretofore made.

Item 1st, I direct all my just debts to be paid.

Item 2nd, I give to my beloved wife during her life or widowhood all of my estate of every kind with the following exception. I wish each of my children, Mary Frances Turpin, Thomas N. Turpin, Paul A. Turpin, America Turpin and George W. Turpin to receive from my estate a Slave as near the value of five hundred dollars as may be, the said slave to be delivered to them by my wife as soon as they severally attain the age of twenty one years to be accounted for by each of them in the final distribution of my estate.

Item 3rd, At the death of my wife I direct that the whole of my estate be equally divided among all my children to-wit, John D. Turpin, Lucy Ackerly, Sarah P. Wilson, Ann Eliza C. Reynolds, Mary Frances Turpin, Thomas N. Turpin, Paul A. Turpin, America Turpin and George W. Turpin, but in such division each of them are to be charged with advancements made to them according to the accounts kept by me against each of them in my book, and that portion of my estate herein given to Ann Eliza C. Reynolds, I hereby direct to be held by my son John D. Turpin in trust for her support and the support of her children, it being intended that her husband Micajah Reynolds shall have no interest therein, and that the same shall not be in any way subject to his debts and contracts, and at the death of my said daughter Ann Eliza C. Reynolds, the same is to be equally divided among all her children then living.

Item 4th, If my wife should marry again, then I give her such portion of my estate as she would be entitled to under the laws of the State of Virginia; and the residue thereof to be equally divided among my children as directed in the third clause to this will, and at her death the portion of my estate held by her for life to be divided in like

manner in every case however the portion of my daughter Ann Eliza C. Reynolds to be held by my son John D. as trustee for the purposes and on the terms herein before mentioned.

I constitute and appoint my sons John D. Turpin and Thomas N. Turpin executors of this my last will and testament.
