







I. FROM THE EDITOR

A. SOJOURNS OF THE EDITOR.

Except for two trips east, travel has been light recently. On one of the trips to Washington, DC, I had tentative plans to have breakfast with our cousin, Mrs. William Patrick Kennedy, Jr. (nee: Eleanor U.), a dau of James Taylor U., Sr. of the William U. IV/Abel U. Sr. Subclan. Our schedules refused to match but there will be another time. She has a keen interest in genealogy and retires next fall so we can expect to hear more about her. On one of the trips I went to Raleigh for a very brief stop to ship two family antiques to Barry Upchurch, my son who lives in St. Louis. They were an old pine chest and a large antique mirror. They belonged originally to my gf Eugene D. Cross and to my mg Mattie Edwards.

B. PROJECTS SUPPORTED BY THE UPCHURCH RESEARCH FUNDS.

General and memorial contributions to the Upchurch Research Fund continue to arrive and are greatly appreciated. I will list here the major projects which have been set in motion with the funds. They are:

1. General search on missing links (\$60 to Fay Byington - Salt Lake City).
2. Documentation of all Upchurches on the 1850 census of all the states (\$294 to Fay Byington - Salt Lake City).
3. Search for the ancestors of Kelley U. (\$60 to Fay Byington - Salt Lake City).
4. Purchase of records of Upchurch marriages in the various states.
5. Search for the parents of Upchurches who changed their name to Carpenter in Franklin Co., NC in 1803.

In due course we will be presenting the results of these studies in the UB.

C. BARTERING IN GENEALOGY.

In November 1983 my sister, Mrs. Ray Arnold of Raleigh, NC, sent me a clipping from the 29 JUN 1983 issue of the News & Observer newspaper about the hobby of Don Upchurch of Ahoskie, NC. Donald Paul U., Sr. is the son 2615 of Harley Wilkerson U. of the Moses U./Murray U. Subclan. He is a radio announcer and as a hobby makes miniature biplanes and other objects out of tin cans. He sells the objects from his home and from the local crafts center. Naturally, I contacted Don and he suggested that he trade me a biplane for copies of the UB. It is now in hand and it is indeed a very handsome rendition. Don's letter of 16 APR 1984 reads in part - "Just a short note to let you know I received all the Upchurch Bulletins intact. I am completely fascinated by them and can't put them down long enough to do anything else. Your airplane will be shipped sometime this week along with my check for \$10.00 to make up the difference in our deal"

Such are the joys of genealogy.

We cannot wait any longer to brag about our cousin Avery Council U. being the current Mayor of Raleigh, NC. He was elected in 1983. An article in the 25 MAR 1984 Raleigh News & Observer giving him good marks as Mayor prompted us not to wait longer for a tribute. The article relates Avery's own words as to how hard he had to work in the fields as he grew up in western Wake Co., NC under the watchful eye of his father, Auba Merrimon U. and his gf, Rufus Merrimon U. They told him "You gotta save a nickle, boy, or else." As a young farm boy, Avery caught the bus into Raleigh six times to see the movie on the life of President Woodrow Wilson. Perhaps this led to his becoming Mayor. Along the way Avery went into business in Raleigh as a young high school graduate. He came to own two service stations and a heating oil business. He still works actively in his stations and many people feel more comfortable with a real working Mayor. He prepared for the role as Mayor by serving three years on the Raleigh Planning Commission (1976-1978) and five years on the City Council (1979-1983). We have heard nothing but favorable comments about his performance as Mayor.

According to a Bible record that was preserved in the family of Ennis Loftin who married one of Burwell's daughters we know that Burwell was born 2 March 1782, probably in Brunswick Co., VA, where he is named in the Last Will and Testament of his grandfather, James Upchurch in June 1784, apparently the only child of James (the younger). There have been no indications that Burwell had any siblings and we do not know the name of his mother.

Nothing is known about the goings-on of Burwell's life for the next seventeen years or where they took place. Presumably his family remained in Brunswick Co., but at some point he removed to Franklin Co., NC where, on 12 MAY 1803 when he was barely 21 years old, he sold the Brunswick Co., VA land that had been bequeathed to him by his grandfather. The land had actually been loaned to Burwell's father during his own lifetime after which it was to pass to Burwell, and, because of this detail, it has been assumed that Burwell's father James must have died. This writer questions that theory because the Tax Lists of Greene County, GA indicate the residency of Burwell there in 1805 and both Burwell and James for the years 1806 through 1810. It cannot be said for certain, of course, that James Upchurch of Greene Co., GA is Burwell's father but he certainly could be, and he could have legally relinquished his rights to the Brunswick Co., VA land so that Burwell could then sell it to finance their move to Georgia.

Because Burwell paid taxes on Wilkinson Co., GA land in 1810 while a resident of Greene Co., and because both he and James do not appear in subsequent Greene Co. Tax Lists after Burwell sells his Greene Co. land in 1809 and 1810 it would seem reasonable to guess that Wilkinson Co., GA, became the next place of residence. This theory is further reinforced by the fact that there are indications that members of the Riley family lived in Twiggs Co. which is adjacent to Wilkinson Co., and there has to have been opportunity for Burwell to have met and married Eleanor Riley about this time because their children begin appearing as early as 1813 when Harriet was born on 7 March. It may never be known for sure because the Courthouse in Wilkinson County burned in 1828, 1854 and 1924, the Twiggs County isn't in much better shape for the extant early records.

At any rate, a subsequent daughter, Elizabeth, was born ca 1814 and a son, Moses on 19 April 1816 (GG-Grandfather of this writer) -- all indicated by census records to have been born in Georgia. The 1830 census returns indicate a son born between 1816 and 1821, of whom more later, who was probably born in Mississippi along with Burrell Miles who was born on 5 July 1821. The last child produced by Burwell and "Ellender" (A Southern version of the name Eleanor) was John Tillman Riley, born 19 FEB 1829 in Alabama. If there were others born in the 1821-1829 time-period then they must not have survived to adulthood.

Although the reason for choosing that particular time is not known the fact is that Burwell removed to Greene Co., Miss. by 1817 -- probably to that part that was cut off to form Perry Co. in 1820 because he is a resident of that county from 1820 to 1825. Almost certainly, however, the move to Mississippi was in connection with the Riley family's move to the same location, including Burwell's father-in-law, Edward Riley, and most, if not all, of the Riley siblings-in-law

who appear in Perry County along with Burwell. It is not known whether they trekked together or, if not, who left Georgia first since this aspect has not been researched.

A curious census conducted by the State of Mississippi in 1823 which, among other things, indicated the names of individuals over the age of 70 years divulges that among the residents of Perry County in said age-group there was a certain Mary Upchurch. The 1820 census returns show a female "over 45" in the Burwell Upchurch household and this Mary is enumerated in 1823 next to Burwell's listing. Her identity, the relationship to Burwell, is a mystery although it is extremely tempting to think that she is his mother. We can't know for sure. For one thing, if she is why aren't there siblings for Burwell?

Another fact concerning the movements of Burwell Upchurch about which we are ignorant is why he decided to remove to Wilcox Co., Ala. For whatever reason he can be found enumerated in the 1830 census returns for that county and it is known that his youngest son, John T. R., was born in Alabama. In 1831 that portion of Wilcox Co. lying west of the middle of Range 4 in Townships 11 & 12 was made part of Clarke County and subsequent, numerous references to Burwell made in various records of the county indicate that the family lived in that area -- the extreme northeast section of present-day Clarke Co. In May 1968 this writer was led to an old grave located in the woods on "the Old Tompkins Place" at Atkinson, Ala., about a mile-and-a-half from the Wilcox Co. line. The worn, handcarved sandstone marker is engraved "E Upchurch, died Feb 1831" and is without question the burial site for Burwell's wife. An indication that the family had some affluency: "Among the lime hills, in the Bashi or Loftin neighborhood, the first family carriage was introduced about 1830. In this Mrs. Upchurch and her two daughters were accustomed to ride when going to make visits or to attend church." (Clarke Co., Ala. and It's Surroundings by Rev. T. H. Ball, pp. 192-193).

During this time-period the Upchurch children came of age and married into various of the local families. Elizabeth M. Littleberry Champion, 3 August 1831; Harriet M. Ennis Loftin, 14 February 1833; Moses M. Lucinda Dickson, 15 Feb 1834 and, after her death Nancy Lary, 20 September 1852; Burrell Miles M. Margaret James ca 1843 and John Tillman Riley M. Sarah Dudley Mary Hester Margaret Scott Bryan McGregor, 16 December 1847. Jordan, the presumed other son, does not appear to have married. Of these children the movements of the Champions are unknown after 1850 when they were residents of Choctaw Co., Ala.; the Loftins went back to Georgia; Moses, Burrell M. and Jordan went to Grimes Co., Texas after 1850; and John T. R.'s widow took her family, after he died in 1851, to Red River Co., Texas.

Burwell Upchurch does not appear in Clarke Co. records after 1834, probably because he is subsequently in evidence over in Sumter Co., Ala., apparently barely inside that part that was cut off to form Choctaw Co. in December 1847. He died there, 31 DEC 1847. Fortunately for us his probate proceedings were initiated in Sumter County before being transferred to Choctaw County because that county has lost it's records. In May 1968 this writer and a cousin, Robert E. L. Upchurch of Bedias, Grimes Co., Texas were led to the site of a completely overgrown and abandoned cemetery near Yantley in Choctaw Co. Virtually all of the stones had

been removed over the years for re-use, but we located, buried in the leaves a fine, marble headstone for John T. R. Upchurch. The elderly colored man who guided us there and had lived nearby for most of his life "remembered" that there used to be an identical, second marker with the same Upchurch name on it. How tempting to think that we located the final resting place for Burwell Upchurch.

In January 1858 a certain Jordan Upchurch died in Grimes Co., Texas 4945 whereupon Moses and Burrell Miles Upchurch were appointed as administrators of the estate by the county court. There were only a few personal belongings and no heirs were named nor was the relationship to Moses and Burrell M. divulged. Unfortunately, Jordan has not been found in the 1850 census returns nor has a marked gravesite been located so his age cannot be determined, but he is the most logical prospect available to be the missing sibling who appears in the 1830 census record. It is interesting to note that in August 1842, when Burwell and most of his children were residents of Sumter Co., Ala., a certain Jordan Upchurch was elected to the Office of Constable in Lauderdale County, Miss., adjacent to Sumter Co.

He is said to have had 22 children." Unfortunately, Mrs. West was not able to provide more about this son of Moses U., Head of Upchurch Clan No. 1. By reading between the lines of documents and recalling off-hand comments of descendants and individuals who knew about Ruffin U. we have concluded he was a real character. The problem is we have not yet decided what kind of character he was. Some of the comments about him center on the fact that he had 22 children. Beyond this, we are left to wonder if his reputation as a "character" came from an enjoyment of alcoholic beverages, from possibly being lively at gatherings or possibly from giving special attention to the ladies. We have no documentary proof that his reported 22 children were not borne by his two wives but then we don't even know the names of all of the 22 offspring.

Ruffin U. would have been about 17 years old when he moved with his father from Franklin Co., NC to the eastern edge of Chatham Co., NC in about 1804. We presume he was single at the time of the move. Sometime before 1810 he married Elizabeth Kelley but no record of the marriage at the time it took place has been found. We have not been able to substantiate the affidavit of Ora (Upchurch) Lewter that Ruffin U. was md. to a _____ Williams.

We speculate that Ruffin U., after his first marriage, continued to live on one of the parcels of land owned by his father in Chatham Co., NC. This arrangement became more binding when on 10 JAN 1824 Moses U. sold to his son Ruffin U. for 100 lbs. 150 acres of land in Chatham Co., NC on the waters of Pitts Creek (Book AAI/34). Ruffin U. appears on the Chatham Co., NC census as a head of a household in 1810, 1820, 1830 and 1840. In 1850 and 1860 he appears on the Wake Co., NC census and is presumed to have lived in the community around Olive Chapel Church and New Hill which is 5 or 6 miles south of where he and Moses U. originally lived on Pitts Creek in Chatham Co. Ala (Wilson) Yow, a gggd 3678 of Ruffin U. reports that he was buried in Wake Co., NC two miles south of Olive Chapel Church.

A substantial body of information about Ruffin U. comes from a packet of papers generated in 1878-1879 when his widow Martha (Goodwin) U. 10 applied for a pension. These pension papers are internally contradictory to some extent possibly because the papers were completed for Martha by others who may have been careless in their construction or possibly they were given different information at different times. Martha was not literate which complicated the matter. It is likely that all involved in the process were more interested in getting the pension for a deserving widow than they were in recording accurate information for genealogical purposes. Here is an abstract of the pension papers with commentary:

20 MAY 1878 Martha (Goodwin) Upchurch, age 66, widow of Ruffin 10,9 U. applies for a pension based on Ruffin's service in the War of 1812. Application made through R. McAllister, Jr., a lawyer of Washington, DC. Details: Ruffin U. drafted 1 SEP 1814 for 6 mo. and served 5 mo. as Pvt. in Company of Capt. John Green in 1st NC Regt. Col. McDonnal commanding. Discharged Portsmouth, VA 8 FEB 1815. Martha Goodwin md. 16 MAR 1829 Ruffin U. by Alsey Goodwin, Magistrate, in Chatham Co., NC in home of Henry Goodwin. Elizabeth Kelley was the 1st wife of Ruffin U. He d. 14 MAR 1866 at home in Wake Co., NC, PO New Hill. Ruffin had earlier obtained a warrant for bounty land. Sworn testimony of Martha U. by her mark (X) witnessed by Engley Council & Calvin Goodwin.

8 JUL 1878 Department of Interior acknowledges receipt of application. File designation "Ruffin Upchurch - WC 27149 1812".

2 MAY 1879 Martha (Goodwin) Upchurch, age 65, widow of Ruffin U. reapplies for a pension based on Ruffin's service in the War of 1812, and declares her prior application of 20 MAY 1878 to be void. Executed by L. B. Seagroves, JP of Wake Co., NC. Details: Ruffin U. served in Company of Capt. Evans in Regt. of N. C. Militia commanded by

Seagroves, JP to testify that they heard the marriage ceremony of Ruffin and Martha on 18 MAR 1823 and that Ruffin d. 12 MAR 1866 and that Martha and Ruffin lived together from marriage until Ruffin died and that Martha has not remarried. PO for both testifiers - New Hill, Wake Co., NC.

Conflicting dates from the above are that:

Elizabeth (Kelley) U., 1st wife of Ruffin U. d. in 1818 or 1823.

Martha Goodwin md. Ruffin U. on:

16 MAR 1829
or 15 MAR 1819
or MAR or APR 1828
or 18 MAR 1823.

Ruffin U. d. 14 or 18 or 12 MAR 1866.

It seems clear that Martha Goodwin was born about 1812 (confirmed by 1850 and 1860 census and by above petitions). Accordingly it seems that we may rule out the 1819 and 1823 marriage dates for her. This means she likely married Ruffin in 1828 or 1829. This means that the female of wife age on the 1810 and 1820 census with Ruffin U. must have been his first wife, Elizabeth (Kelley) U. and that she most likely died in 1823. Of course, there could have been another wife, common-law or otherwise in the period 1810-1830 but if so, the petitions extracted above are silent on the matter. At the time the petitions were submitted

the 1810-1830 era was 50 - 70 years in the past. In 1878-79 few living souls would have personally remembered the events of 1810-1830, but some would have. Certainly word-of-mouth (gossip) would have brought all kinds of 1810-1830 happenings to the ears of those present in 1878-79. Until more facts can be gathered we may choose, as we please, from among the possibilities that:

The petitions are basically accurate except for incidental errors in memory that crept into the records.

That some facts are different, such as the presence of another wife in the 1810-1830 period, and that the petition participants did not know of such "other" facts or did know or suspect and elected to tell what seemed best at the time.

Thus we have accounted roughly for 20 of the presumed 22 children of Ruffin U. There are tentative names for all of the 10 sons and for the youngest 5 of the 10 daughters. We presume son, William U., b. ca 1820 - 25, d. young or left the home prior to the 1840 census.

Ruffin U. was a small land holder all his life. We do not know how or why he disposed of the 150 acres he acquired from his father in 1824 but presumably he farmed it until he acquired new property in Wake Co., NC between 1840 and 1850. On the 1850 census he is shown with real estate valued at \$100. In 1860, presumably at the same location,

he had real estate valued at \$825 and personal property valued at \$1155 at which time he was 74 years old. Only once was he shown to have owned a slave and this was in the 1830 census. The slave was age 10 - 24.

Other incidental notations relative to Ruffin U.:

The WILL of Ruffin U. was written 31 MAY 1858 and probated AUG 1866. Left all to his wife Martha U. Names some children. Refers to his home place where he now lives as the New River land.

On 23 AUG 1820 Ruffin U. was a bondsman when his brother Murray U. md. Nancy Scott. Ruffin signed with an X.

The ledger for an old county store near the residence of Moses U. for the period 1827-1829 shows purchases by Ruffin U. APR, MAY, SEP, OCT 1827 and FEB, MAR, APR 1828.

See UPCHURCH BULLETIN, Vol. 3, No. 2, Pg. 77, for speculation on the prospects of Kelley U. being the son of Ruffin U.

In some ways one could say we have a lot of information on Ruffin U. and in some ways one could say we don't have much. In any case, one hopes for more details in due course.

2. Feature 2 - "CHAPTER DESCRIPTIONS

Chapter 1, Early Ancestry of Mississippi Upchurch's (7 pages) is composed mostly of charts and takes the Upchurch family from England to Virginia and then brings the family up to its Mississippi connections.

Chapter 2, Settlement of Mississippi and Upchurch Migrations Therein (7 pages) gives a background of Mississippi's development, complete with maps, and a brief description of the Upchurch migrations to Mississippi.

Chapter 3, Burwell Upchurch (4 pages) briefly covers the family of Burwell Upchurch and Eleanor Riley while in Mississippi. This family did not live in the state very long.

Chapter 4, Benjamin Upchurch (9 pages) covers the family of Benjamin Upchurch and Cinderilla Tant. Their known children are Churchwell, William, Frances E., Noah P., Amma C., and Benjamin Newton. These children married into the McGraw and Bass families.

Here is another new Upchurch book. It is compiled and privately printed by Ruth Nielsen with a 1984 date and bears the subtitle "An Upchurch Update For The Brady Bunch". The front cover bears a handsome picture of William Brady Ford U., the gf of Ruth Alice (Westley) Nielsen. 9788,9858
They are members of the John U. III/John U. Subclan. Ruth Alice 157/4168
derived the title of her publication on the basis of her earliest memories which included fiddles being hand carved and finished by her gf Brady U. and a birthday breakfast plate with a beautiful squash blossom placed there by her gm Dora (Church) U. The release which 9835
Ruth has provided on her publication is as follows:

"Ruth Nielsen has had an interest in genealogy since she was a small girl, when her grandmother started teaching her the oral history of the Norwegian ancestry. It wasn't until years later, during high school, that the information began to be compiled and verified with that same grandmother.

Several years ago, quite by accident, Ruth met a twelfth cousin, who was also linked into the same Norwegian ancestry. That chance meeting helped spur her on to her goal of professional genealogist. The lineage has been traced to the year 70 B.C. on one branch of her family tree, with additions still being found.

As a volunteer at the Southern California Genealogical Society's annual "Jamboree" last year, she chaired the Dakotas table, and compiled a book for genealogists: "Searching in the Dakotas."

A history of the Upchurch side of the family is being published in March, 1984, covering the descendants of her grandfather, Brady Norman Upchurch and his wife, Dora. Additional information on the ancestry is included in this compilation, and includes the inventory of estate of Michael Upchurch; linkage to 1607 in the Virginia colony; and a previously unpublished marriage record dated 1670. Complete with an index of about 300 names, this forty page book, titled "Upchurch Update, Volume I - Fiddles & Squash Blossoms" will sell for \$15.00, and will provide some valuable new material to Upchurch descendants.

As Ruth is very interested in family history, she publishes a quarterly newsletter on the Westley/Herigstad family, and is currently sharing the lineage back through the Norwegian kings; information about the immigrant families who came from Norway in 1881; and providing current information about numerous connecting branches including a distant living cousin in Norway. The cost of subscription to "Remembrance" is currently \$10.00 per year.

She organized, as a volunteer, a genealogy club where she was working. With her contagious enthusiasm, practical advice, and encouragement, many who joined the club are actively pursuing the search for their roots.

The Los Angeles area provides a wealth of genealogical information, and with her resources there, plans to continue her own research, and also assist others. Contact her for rates (which are reasonable) and she will be happy to work with you or for you on your ancestry. SASE, please.


