Early Birth Vital Statistics from Alaska – 1897 –

(continued from Volume VIII, Number 4) contributed by Janet Seitz

Alaska Statute 18.50.310, Disclosure of Records, states that Alaskan birth records become public 100 years after the date of birth. The main set of records is kept by the Bureau of Vital Statistics in the Alaska Office Building in Juneau, Alaska, while other sets pertaining to various recording districts are in the pertinent recording district.

These records are basically delayed filing for births since centralized vital statistics registration was not prevalent in Alaska until the mid 1900s. These birth records consist of affidavits filed concerning a birth and many contain interesting clues to extended families since family members are frequently attesting to the birth of the individual. Many of the records also reference other sources (census records, church records, etc.) that may provide further research possibilities. The records below are recorded in the first volume of births (1897-1900) on file at the Bureau of Vital Statistics, Division of Public Health, Department of Health and Social Services, PO Box 110675, Juneau, AK 99811-0675.

Researchers should be alerted that not all birth records are apparently at the Bureau of Vital Statistics. While doing some research at the Alaska State Archives in Juneau during the winter of 1994, I found that entity has some early birth records; however, since those records are batched with non-public birth records, I could not view these documents at this time.

Note: Unless otherwise indicated, all locations are Alaska. Records are listed in the order they appear in the bound volume. Information on parents is given in following order: birthplace, and occupation. Unless otherwise indicated, mothers' occupation was listed as housewife.
